Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue 5f the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Our 2009 Web site totals are as follows: -Total Unique visitors for the year – 13455 July 1664 unique visitors - August 1684 -463 as of Sept. 8th - Our most popular pages were the Meeting Search , Calendar of Events, followed by the Meeting pages.

Hello Area 35. I have been busy making some minor improvements to the web site. I have created a form for uploading files for the Event Calendar. The form asks for an email address so I can get back to the sender if there is a problem with the file or mistakes in the flyer! Also has a CapCha box so bots can't upload with scripts.

A hacker from Brazil was able to change our homepage to show their hack signature "Audrey S. got a Help-Line call reporting it and called me". I had to re-upload the homepage and lock it so they could not do it again. I reported the incident to the proper authorities.

I also added a re-direct to the homepage so if a user put in area35.org it will re-direct to <u>www.area35.org</u> – this is important for indexing by the search engines, goo- gle, ya-hoo etc. so they don't index both and cuts down on bandwidth usage! Also simplifies it for users not web savvy. area. It is my hope that we have people willing to stand at all levels of service so we can carry the message and hope to all who have as desire to stop drinking.

I attended the Area 35 & 36 workshop held at Central Lutheran Church in Elk River. The workshop was attended by 68 people. Area 35 had 54 people in attendance at the workshop. We broke into groups as we do at our Area 35 committee meeting. I attended the PI portion of the workshop. There were 6 people present, and we discussed the State Fair and anonymity breaks on the Internet. Area 36 has submitted a proposal to the GSO to change the 11th Tradition. They would like to add at the level of radio, press and TV to include "All electronic media." There are members who are breaking anonymity on MySpace, Facebook, etc. on the internet. We all realize how important anonymity is it is our second name. We must work harder within our fellowship to educate our members on our position regarding anonymity. At our committee meeting, Area 36 PI Chair Lisa G. asked if it would be worthwhile to have an Area 35 & 36 workshop on anonymity. I feel that this is a very important topic and could help to make sure we are all carrying the same message and the right message.

We also learned that all the Area's in our region use quicken with one exception.

Hopefully this information will help Area 35 determine the course they would like to pursue, and if the Area would like to setup a similar model. We will provide a detailed report on our finding at the Fall Assembly.

1) Yes we have an annual audit from an audit committee comprised of three volunteer members of the finance committee. This is always done on Saturday evening during our March Assembly to close the books on the previous year.(see attachment)

2) I believe that Quicken is the only software used by any Treasurer since computers have been used in Area 52.

3) No,to my knowledge we do not have guidelines for the format of the reports the Treasurer gives at assemblies.Under the Area Treasurer's duties in the Area 52 Service Handbook it states that the Treasurer is to provide accurate accounts of all contributions and disbursements to the Area Assemblies, with copies to be included with the Area minutes. I think if a new Treasurer decided to use Microsoft Money or some other software that this would be up to their own discretion provided the Assembly was satisfied with the reports given to them.

"WE SEEK NOT COMPROMISE BUT CERTAINTY"

(Remarks of Mr. Bernard S. at closing Conference session, 1952)

What we do here, and what we have done here, great as it has been, is not nearly or remotely as important, in my judgment, as the fact that we <u>are</u> here. For it is the existence and the preservation of this General Service Conference that is vital. The decisions we make here, important as they are, must in the last analysis, be subordinated to the greater significance of the existence of this Conference, for as long in the future as we can see, as a preserving arm of this great society of ours.

Actually, as I look back I feel the most important decisions that were here made were decisions to table decisions. To me that had a very, very profound implication. For here, unlike any political group, we seek not compromise by certainty. And in seeking certainty, it is frequently essential, as we found in the last few days, that motions be tabled because we were not yet sure.

I cannot reiterate too strongly my feeling that unless we are sure, unless we are certain, if there is yet time left to us to make a decision, I regard no decision as important as the willingness in an American society to postpone ultimate consideration. For again I like to reiterate those two words: We seek not compromise but certainty. If we can think of that concept, we will not fail, we will not err. We will be right and we will never, I trust, be wrong.

I cannot tell you how profoundly I was affected by the discussions that took place on the motion that related to the extension and length of office of delegates. I am sure that everyone here enjoys serving as a delegate for as long as people would have him.

But complete and utter selflessness was implicit in the discussion, the feeling that each individual who spoke never thought of himself but thought of this great society, and therefore decided that far more important than whether he should continue to serve, was the conscious-ness that it was far better for him <u>not</u> to serve than to take the slightest risk with this great and delicate instrument of yours!

And I might say standing here as your chairman that it was impossible for me not to sense the complete spiritual interpretation of your thinking here. I can't tell you (because I stand here) how that has come across to me in waves. And no one can stand here without being deeply moved by this selfless and spiritual impenetration of this entire Conference.

You in A.A. have done something with the concept, "Love Thy Neighbor," which has removed it from the cliché. For you have staked out a specific neighborhood. You have found it possible to create a neighborhood within which to work, within which to give full meaning and potency to words that, unfortunately, to a large degree in common parlance, have lost their full significance.

Out of the depth of your suffering, you have been given the light to see how black was the darkness from which you emerged, and to feel for everyone who still blunders along in that darkness, and what is more important, to do something about it. You in your own way have found that man is not a lonely, friendless creature, tossing helplessly about in a hostile world. You here in A.A. have found how deep are the roots of the wellspring of human love and friendship. And those roots <u>can</u> be tapped and the world <u>can</u> look upon you who sit here, and upon the groups all over this country, as evidence that human love and human friendship and human decency is still possible in this world of ours.

I have always found it difficult to know what A.A. is, how we can define A.A. It is probably the most elusive thing in history. It is some-

thing more than a movement. And yet not an order. It is a faith and yet not quite a religion. It is a society and yet not an organization.

For you have founded a society that is not divorced from life but has invigorated it and given it meaning. It is not removed from the Church but you have supplemented it, the Church, with an extra spire in your hearts that lifts just a little higher toward the heavens.

We are not free in one sense. We are bound by a faith that has succeeded in making us free for real, creative activity. We are dedicated to a single purpose, energized by a common need and dignified by human decency and humility.

We have learned that the spiritual <u>can</u> take hold of our material world and completely transform it. For A.A. stands before the world as living proof and evidence that in this industrial, mechanized, materialistic world of ours, Man need no longer cower in the shadows but, functioning effectively as an economic and social being, walk the earth fearlessly and erect in the sunlight before his God.

OFFICER REPORTS

Delegate-My last Delegate's report back was in Perham, MN for districts 3 and 4. I would like to thank all the districts for their kindness shown, great questions and support as I traveled around the area. I received the 2009 -2010 Conference Approved Literature and Other Service Material Catalog, also the updated pamphlet: "A Message to Teenagers." GSO staff rotation took place on July 13, 2009 and I emailed out a copy of the G.S.O. Staff Assignments. The deadline to fill the G.S.O. staff vacancy to replace Irene K. was June 21, 2009. It was hoped to have a new staff person in place by August. Steven D. is the new Associate Archivist. I received an email from Phyllis H., General Manager, of a managerial decision to not print the three 2009 Regional A.A. Directories (Canadian, Western U.S. and Eastern U.S.). Putting a hold on printing the three regional directories will save approximately \$35,000 this year. The following directories will be printed for 2009: 2008-2009 International A.A. Directory outside the USA and Canada, the 2008 Central Office, Intergroups and Answering Services for the United States and Canada, and the 2008-2009 General Service Offices, Intergroups and Answering Service Overseas. The intergroups and Central Offices have up-to-date meeting information as do some area Web sites. They are hopeful that the newcomer and our Fellowship will find direction and assistance through these service entities and by visiting the www.aa.org website. Markings, the Archives newsletter, will soon begin its first electronic-only version, joining Box 459, and Sharing Behind the Walls in digital format. This reduces expenses of \$4,000 per issue and provides greater on line services to the Fellowship. Contributions online from A.A. members by credit card via an internet website has been underway and is nearing completion. It is planned for roll-out early in August. A link will be sent to Area Delegates, Trustees and Directors prior to going "live" for use by the Fellowship. I have not received the 59th General Service Conference Final Report but expect it soon. So if I receive it between now and the August Area35/36 Workshop, I'll have copies available there or at the Fall Assembly. I'm trying to be prudent with the area's monies! The Regional Forum - September 11-13, 2009 - St. Cloud, Minnesota. Area 35 Northern Minnesota has been asked to moderate workshops and I've asked: Dee K. to do: Rituals and Chanting in A.A.; What "Trusted Servant" really means - Jay A., Communication, Communication - Krishna Z., Relationships Between A.A. Service Entities - Jon C., The Importance of a Home Group -JoAnne N., and Anonymity and the Internet - Dan R.. Others moderating workshops are: The A.A. Grapevine - Robin B., GV Executive Editor, Singleness of Purpose, Lorna O'C., Self-Support - Where Money and Spirituality mix - John T., and How Can G.S.O. Help You? - Doug R., G.S.O. Staff. Grapevine: I received a new 2010 One Day at a time 2010 pocket planner, the 2010 Calendar, the August Grapevine and the A.A. Grapevine, Inc, Catalog. Received an email from Robin B., Executive Editor, AA Grapevine, informing us that there was a printing error that resulted in the Grapevine's bulk subscribers getting the July issue with "AA Grapevine" on the outside of their packages. The magazine fulfillment house recently moved which required changing the return address labels on all magazine packaging. Unfortunately, when changing the return address labels for the bulk subscribers, the printer made the mistake of putting "AA Grapevine" in the return address instead of Grapevine. I received notice of a Class A Vacancy on the General Service Board from Ward E, chairman of the board after Jeanne S. W. tendered her resignation as Class A Trustee. A special meeting by conference call on Friday, June 5th was made to discuss extending Herb G's term of service for one year through the 2010 General Service Conference to fill the vacancy created by Jeanne S. W.'s resignation. After a lengthy discussion, the GSB decided to leave the position vacant, at this time, and requested that the trustee's Nominating Committee begin the process of filling the vacancy to replace Jeanne W. and present the nominee's name to the 2010 GSC for disapproval, if any. The GSB (2009-2010) will operate short one Class A trustee in addition to operating short one Class B regional trustee and one Class B General Service trustee. In October we will be holding elections for the Panel 60 Delegate in Area 35 and I will be sending in the information of area officers elected to Doug R. at GSO. Agenda Items - The agenda item deadline for the Conference is not until January 15, 2010 but if any items are going to be forwarded from our area assembly it is helpful to the process if some of the items for consideration come in time to be considered at the October meetings of the General Service Board so where applicable these can be worked on and considered again at the January Board meeting. The spring C.P.C. Activity Update: GSO's request for Fellowship sharing on the use of professional actors' full faces in video projects produced by A.A. World Services Inc. has received an excellent response. I emailed a letter from Area 35 Northern Minnesota after our June Committee meeting that our sense of the meeting was taken and the majority agreed and want to honor our Traditions by keeping the use of full faces out of videos. AAWS Finance Committee: Un-audited result for the first 3 months of 2009 reflected net sales of \$3,271,100, contributions of \$1,444,200 and a total revenue of \$3,312,500. Unaudited next income for the first three months of 2009 was \$290,700 compared with a \$359,400 budgeted profit and was approximately \$5,000 less than the \$295,900 profit reported for the same period in 2008. Publications: Total distribution of all books through April 2009 was 734,875, down slightly from the same period in 2008. Through March, total A.A. purchases amounted to 607,456 units, while non-A.A.s accounted for 127,419 units, or 17%. Gross sales for April were budgeted at \$1,187,060. Actual sales, unaudited, were \$1,111,919, or 6% under budget compared to \$1,087,972 in 2008. On Saturday, I received an email from Brooke C., Delegate from Area 76 Wyoming with two attachments that were sent to Ward E, chairman of the General Service Board regarding a formal petition and a Tradition Two Resolution. If anyone is interested in receiving a copy of this let me know and I'll send it out when I get home today. I'll be participating in the Zone IV Forum on August 8, 2009 somewhere up north! Area 35/36 Joint Workshop August 29, 2009 Central Lutheran Church Elk River, MN

Meeting opened at 1:00 PM with welcome by Jay A. (Area 35 Chairperson) and Steve K. (Area 36 Chairperson) and Introductions. We then broke into 8 breakout session:

Breakout Session Reports:

Area Officers Report-Sarah:

Discussion of Regional event on years we do not have a Regional Forum: Discussion centered on cost, time, and need. Concerns expressed about budget for the Region and if Areas can afford this. Jay questioned the need? Thought time might be spent connecting with the groups we serve. Do groups understand what we are doing-are we disconnected from them? Sarah suggested we are serving the groups in many different ways and ultimately serving the groups by going to Regional Forums. Suggested Regional Event might center on unity through discussion of past conference agenda items and getting groups involved in discussion of possible future agenda items. Money is issue but communication is important. Discussed using new technology such as a conference call or free broadcast to have a connection between all of us but save money.

How procedurally we run our Assemblies and Committee meetings: Area 35 uses Roberts Rules of Orders and suggested Robert Rules do not seem punitive and might be more positive and keep meeting in control. Rules can be rigid or laid back. Steve K. wanted Assembly to be informal but with larger groups thought it did not seem to be effective. Scott talked about the Trusted Servant Leadership Training and the GSR booklets. Suggestion made to educate GSRs on Robert Rules. Dan suggested a personal approach where someone would sit down with the person who needs help. Area 35 gives new GSRs stickers and pares them with a GSR who has been to a previous Assembly.

Handling of Area Officers or Committee Chairs who are not doing their jobs: Talk with the person. Is the person being more helpful or harmful in their position? Are we better off with or without person? Important to meet with the person who previously held the position and share information. Area 36 does a rotation meeting. Northern Minnesota goes to incoming chairs house and also do rotation at the last Area Committee meeting. Area 36 has a Trusted Leadership Training once a year.

Motivating DCMs to visit groups and provide services in the District: Believe there is indication of problem if Groups don't know what is going on in the Area. DCM might go to Area Functions and Forums but does not foster good communication to Groups. Encourage Area Officers to go to District meetings. Scott A. spends more time with DCMs. Be a resource for Districts. Angie suggested: If groups don't attend go to their meetings and create good will. Doug C. expressed concern about communication-is it more important to go to a District meeting or that he share with Treasurers on how to do there job. Sue thought Districts would be thrilled to see Area Officers. We are not there to run their meeting. Only help if asked.

Finding locations for Assemblies: Area 35 has 4 zones in there Area and they rotate their Assemblies. The DCMS go out and get information on places to hold Assemblies and bring the information to the Area Chair. The Area Chair makes arrangements and the Districts do registration, restaurants, etc. They do this with workshops, too. Voting assembly is in a different zone each time. Area 36 has one day assemblies and tries to have them at churches, hotels or schools because they are cheaper.

Miscellaneous: Discussed auditing procedure and use of Skype and MSN to do meetings via camera and microphone.

Archives Report-Bob:

Area 35 will have an Archives display at the West Central Regional Forum. Per Brad I. Area 35 is working on digitalizing tapes, working from the oldest to current. They are cataloging books and pamphlets. There is an ever growing pile of "I WISH THEY PUT A DATE ON IT" pile. Area 36 is unable to attend Regional Forum because of a Roundup in Mankato. Per Ken R. Area 36 currently has sorted 28 boxes with 54 boxes of unsorted archival material. They are currently talking about having an Archives Associate and also trying to poll past Delegates to be part of the committee. There will be a Zone 3 Archives workshop in St Cloud on Oct 17th from 12:00 to 3:00 PM with old timers panel and history talk.

Cooperation with the Professional Community Report-Heidi: Dee, the CPC chair for Area 35, started the meeting by explaining what CPC means. Discussed what to present at a CPC luncheon for professionals. Some ideas were to explain what A.A. is and is not, have two members of A.A. who were referred by the professional community speak, talk about the A.A. survey, explain what anonymity means, explain our singleness of purpose, talk briefly about the history, and provide literature and meeting schedules. Dave the CPC chair for Area 36 also discussed presenting to professionals at work. Many times organizations have monthly meetings (doctors and clergy) and we could present at these meetings. Ed from District 8 feels we need to do more follow up with places where we drop off literature and see if they need more and if they are using the literature. District 8 has started 3 meetings in a homeless shelter and is working to help the Hmong Community. Committee discussed getting into conferences and health fairs. Area 36 had booths at the MN Social Services Conference, the Physicians Conference, and the Social Workers Conference. The cost of having booths has been a problem but they have always had great participation and involvement from the professionals attending. The group felt we should work together to get to all of these conferences. Charles of District 8 wanted to know more ways to work with professionals. The group felt to reach professionals one might make an appointment and talk with them. Ended the meeting by discussing ways they can work together in the future and decided to write down email addresses and have Heidi email everyone the list.

Corrections Report-Sue:

In Area 35 main problem is getting volunteers; focus is on getting volunteers to take meetings to facilities and finding contacts for inmates getting out of prison. In Area 35 the DCM finds contacts for jails and prisons. Area 36 is currently fulfilling the commitment at Moose Lake and Area 35 will try to take this over. Area 36 has many volunteers in the Twin Cities but fewer in the outlying areas. Districts 21 and 22 and the Area 36 Corrections Committee will have a workshop on taking meetings into Corrections Facilities. Their hope is to replace fear with humility and gratitude. They wish to accumulate a list of contacts in Correctional Facilities and need a person to coordinate this. Additional ideas presented:

Look for volunteers within your groups to get people to the workshops: request everyone involved bring 1 new person with them. Challenge DCMs to challenge GSRs to get 1 or 2 people from their group to attend the workshop.

Showing Video: helps eliminate fear of volunteering in Correctional Facilities. Announce commitments at meetings. Have consistent commitments so everyone knows.

New idea: Have one person (besides the Corrections Chair) be the contact with the jail. On rotation we will still have a contact. Need consistent correspondence with jails; relationship is the key.

Area 35/36 Joint Workshop (continued)

Literature and Grapevine Report- Bill S.: Area 35 has started buying more literature and keeping it on hand. Groups email their requests for literature and the literature chair distributes literature at the Area Committee meetings. Small groups can get literature through him. Area 35 Pink Can Plan is left to the Groups and Districts and only one facility is currently being served. Some concerns on whether inmates are getting books. Area 36 Pink Can Plan is very active; have been discussing how best to purchase the literature (GSO vs. Minneapolis Intergroup). Discussion has focused on cost vs. service, support, and immediate fulfillment.

Literature Proposals: Area 36 has 3 proposals that have come out of the Literature Committee.

1. Change "Question and Answers on Sponsorship" pamphlet to add sentence to section "What newcomer should expect from a sponsor". 2. Produce and publish book on Pioneer Women in A.A.

3. Change Tradition 11 to add "all electronic media". Discussion included:

•Recent blog by member who is sober 30 years.

•Concern is not fear of breaking Tradition but fear itself that we need to pay attention to. The principle is already there.

•Changing all the literature is costly.

Traditions are not rules but spiritual principles-AA doesn't penalize-not police.

Grapevine: Discussion of Grey page, subscription prices and postcard that asks for credit card number. Bring Grapevines to Drs. Office, Treatment Centers, Correctional Facilities, Assisted Living Facilities and Libraries. Have your group subscribe to the Grapevine and use it to give meetings.

Public Information Report-Jon: Discussed moving the State Fair Booth from the Grandstand to the Health and Education Building. Might need to decide who we are trying to reach. Health/Education would be \$600-\$700 cheaper and might include more professionals. Grandstand might reach more drunks. Idea was proposed to have a statewide Area 35/36 workshop on Tradition 11. Currently many anonymity breaks through face book, blogs, and internet –people are unaware of Tradition 11 and anonymity workshop could provide information. Some thought we should wait for the need to be expressed before we offer a workshop. Offering unsolicited workshop may only draw General Service people-wouldn't necessarily garner interest. Let people know about anonymity breaks.

Treatment Report-Jim:

Good discussion. How can we better carry the message? How can we work together? What are we doing in our Districts? What kind of program are we working on? Talked about Bridging the Gap program - it still requires us to bring this program to Treatment Center. We also need to bring Informational Meetings to Treatment centers. Also talked about setting up workshops, enthusiasm, and carrying the message.

Website, Newsletter, Group Records & aameetinglocator.org ad hoc Report-Lisa:

Ad hoc Meeting Locator: They will be doing presentation of the meeting locator at the West Central Regional Forum. Audrey will bring a laptop and show the Group Records side of the website. Lisa will show the user side of the website. Only groups with active status are on the Website.

Group Records: suggested that the Treasurer could work with Group Records to identify gaps in data and discuss 7th tradition. Three versions of letter: One for active and contributing, one for active and not contributing and one for inactive and contributing.

Newsletter: Might include meeting locator and group record update process in each issue. **Website:** Discussed Web guidelines/policy. Does it follow GSO guidelines?

General Sharing and Questions from floor:

Alan N. –Regarding the meeting locator: why can't pending groups be listed? Group Records indicated they can be; we currently have it set up to only list Active Groups. Kelly from Area 35 said several groups recently registered. Thinks we should add pending groups. Alan N.-what type of additional Regional Forums might we want? Per Delegate-Scott A.; 2 other delegates and Scott were asked to put together a Regional event to develop unity in the Region.

Ken R.–Is there a date for next years Joint Workshop? Area 35 has put this on their calendar. Steve K.: Area 36 did not have many people participating today and needs to take their inventory and commit to this event if we were going to participate.

Bill S. - on expanding Tradition 11 to include (electronic media); in a recent blog, a well know person said he was a member of AA-should we expand the Tradition? Randy-all of our Traditions speak to this.

Thanked Kelly in District 5 of Area 35 for hosting this event.

THE STRANGE OBSESSION

It was a hot night in the midsummer of 1934. I found myself at a noted address in Central Park West, New York City. It was in Charlie Towns Hospital for drying out alcoholics.

Sobering and sweltering out a fearful hangover I laid abed in an upstairs room. Downstairs the doctor looked across his desk at my wife Lois.

She was saying, "Doctor, why can't Bill stop drinking? He always had great willpower. Yet here he is, facing ruin again, and still he can't stop. The more he struggles, the worse he gets. I am scared, heartbroken and confused. I know he is, too. He'd do anything - anything at all to stop. Tell me, Doctor, why can't he?"

Lois was asking the same terrible question that uncounted women had asked before. Her's was a riddle quite as old as man's first discovery that alcohol could be made from grapes and grains.

Again she said, "Please tell me the truth doctor. Why can't Bill stop?"

In his long experience with serious drinkers the good doctor had faced that terrible heartbreaker a thousand times. By nature compassionate, he never failed to wince whenever a distraught wife, husband or friend of a sufferer had profounded anew the burdened riddle of alcoholism. Bill's dilemma had interested and moved him deeply. How could he now bring himself to tell Lois the truth?

The benign little doctor's face turned grave as he began to speak. "When Bill first came to this hospital three years ago, I felt that he might be one of those rare cases who might recover. I hoped that when he better understood himself and the nature of his illness, he might win out. In spite of his several severe relapses since then, I have gone on hoping. For, as you say, he desperately wants to quit and his will to do so is very great. But now I'm discouraged. I'm afraid he's going to be like nearly all the other alcoholics who come my way."

"Well Doctor," cried Lois, "just what do you mean by that. Won't he ever get better?"

Gently, the Doctor went on, "Mrs. W.," said he, "As you already understand, your husband is a sick man. But I've never told you just how sick an alcoholic can be, nor have I ever explained this illness to you as I understand it from my long observation. I think the time is here to tell you more about his illness and how really serious his condition now is. There are a lot of theories about the underlying causes of compulsive drinking like Bill's. Of these we can take our pick. But there are some solid facts, too, which no one who has watched many alcoholics could well dispute.

"Fact one is that innumerable alcoholic men and women really want to control their destructive drinking and then find, to their dismay, that they cannot. They cannot moderate their drinking as other people do. Nor, even when faced with the most terrible consequences, can they stop altogether, no matter how desperate their plight. Never do the excuses they make for their sprees justify their pattern of continuous self-destruction. Their behavior becomes completely illogical and irrational - it really verges on insanity. And even when they well understand all this, they go on as before. Where alcohol is concerned, their minds no longer rule their emotions.

"A new spree can be started upon the slightest of excuses or rationalizations. Sometimes the provocations seem great, but it's always very small when the certain destructive results are considered. When for example life gives the average man a heavy bump, he doesn't seize a hammer and beat himself into insensibility. Yet, in effect, that's what the sick alcoholic does, over and over. All reason, all incentive, even the greatest desire to stop, seems to be swamped when the craving for alcohol takes hold.

"Therefore the biggest fact about alcoholism is its obsessional nature. It is one of the most subtle yet most powerful compulsions known. Once it's grip is firm, the chance for recovery is diminished. How to help the alcoholic to expel his obsession is the problem. But we doctors have had little success: I've seldom helped even one case in a hundred.

"Nor is the drinkers obsession the whole story: alcoholism is a physical malady too. In nearly all cases the bodies of problem drinkers become painfully sensitive to alcohol. In the early stages of their malady some alcoholics can drink quantities of liquor without serious physical reaction. But continued excesses finally cause them to lose that ability; they seem to get allergic to the stuff; so much so that hangovers produce great physical agony and sometimes delirium tremens or convulsions too often followed by brain damage and mental deterioration than can be permanent."

Again she asked, "Doctor, what can we do?"

So he had to tell her that I would have to be locked up or go mad and die. That it would all end with heart failure during delirium tremons, or that I would develop a wet brain, perhaps within a year. That soon I would have to be given over to an asylum or an undertaker.

Editor's note: Bill again relapsed, and on December 11, 1934, he was again admitted to Towns Hospital for the last time.

NORTHERN LIGHT PRIMARY PURPOSE:

The Northern Light (N.L.), is a general service newsletter that **EDITORIAL POSITION & N.L. COMMITTEE:** serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area • in a timely fashion.
- Encourage District reports and be available to work with • Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the N.L.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report - NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the Grapevine or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

- Editor The Editorial Chair is an elected position held during a two-year rotation.
- Desirable qualifications: Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Twelve Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
