

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:


- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue 6f the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.



1. Area Chair calls to cancel and/or re-schedule.


2. Based on DOT report, national weather service, individual safety being paramount

Not much more but the Journey continues and am glad and grateful to be able to be of Service. Robert (Butch) R.






2010 INTERNATIONAL CONVENTION OF ALCOHOLICS ANONYMOUS

Old Timer's

I think that sometimes the AA Old Timer gets a bad rap. What comes to mind when I hear someone call a member of AA an Old Timer is some old fart that has a comment for everything that is said, and it doesn't matter if they are right or wrong, everyone nods their head in approval because he or she has been hanging around the rooms of AA the longest.

I have a new perspective of the Old Timer and that's because I know Jerry W. He would probably consider his home group the 6:00 pm Thursday Night Big Book Study that meets downstairs in the First Evangelical Lutheran Church in Grand Rapids, MN. He is usually there around 5:30 or earlier, to meet with new and old friends and always ready to talk and joke. He attends his home group regularly and on a weekly basis, even though he recently celebrated 29 years of sobriety. He continues to work with new people who want to live a life without alcohol. He takes each person under his wing and together they attend his home group as well as meet weekly at his home and read the Big Book of Alcoholics Anonymous paragraph by paragraph. Together they study the directions to sobriety as outlined in the book. He teaches and encourages the new person how to live a sober life. He was recently called by the local hospital to help transport a couple of drunks to a local Detox Center. These two people had no one else to turn to for help. But Jerry and his wife drove them to Virginia and safely deposited them to a Detox that wasn't full.

I'm not saying that there aren't other members of AA in District 16 who do things like this, but I am saying that the number of AA members drop off as the number of years of sobriety increase. It's sad, but true. It's easy to take on higher positions in the program of AA or leave the program altogether because things are going well in one's life... and forget what it's like to be the newest person in the room. Those feelings of loneliness, guilt, low self confidence and battered self-esteem don't go away easily. The financial problems, the family problems and the job problems caused by drinking and spending more money than we earn create many untold problems. What brings the whole AA program home is when one drunk puts their arm around another drunk and says "...Welcome to AA... can I get you a cup of coffee?"

AA turned 75 years old this past June 2010, and Jerry will turn 75 years old July 2010. So, Happy Birthday Jerry – and many, many more.

OFFICER REPORTS

I was confident that I was prepared to discuss the agenda items in committee and at the Conference. Since the Spring Assembly we had our first Zonal Forum and we had around 25 people in attendance. I will be out of town for two week starting June 18th so I will need to get the minutes done before I leave so I can meeting the Northern Lights deadline. Please I am asking that you get me your June Committee reports to me by June 14th. I made flyer for the Fall Assembly and they are located on the table for people to take back to their groups. If anyone would like to get the flyer or minutes by email from me please write your name an email address on the tablet located by me. I am still having trouble with some of the email addresses not working so if you are suppose to be getting the minutes and are not come see me sometime today. The WCRAASC committee met a few weeks ago and I do have the notes from the meeting if people would like them. I only made a few copies but I can email them to you. Please just let me know. I have also emailed the three AA members who were willing to be a part of the committee to help with the Area Actions Booklet. I hope that I can have a chance to talk with them today about some ideas. I would like to give the Area the suggestion we have come up with by either the August Committee Meeting or the Fall Assembly. I hope everyone has a great summer.

TREASURER- Sarah K.- First and foremost, I owe the Area an amends. I somehow lost the cash bag from the Spring Assembly which contained the coffee money from Saturday's coffee sales. When I went to look through my stuff a month after the assembly, I found the cash box with the money from Sunday's coffee sales, but couldn't find the bank bag with Saturday's coffee money. I am so sorry that my carelessness resulted in this loss. In response to this I chose to replace your money. Total coffee costs for the weekend were \$591.99, we made \$182.75 on Sunday, so I wrote a check to the Area for the coffee fund for the remaining \$409.24 so there wouldn't be any loss to the Area. I really am so sorry about this, and I promise if you allow me to keep serving, I will try my upmost to NEVER lose your money again. I am sorry. So now, on to the financial reports. There are three reports available on the back table: Profit and Loss & the Balance Sheet, Detailed Expenditures & Budgets, and Group Contributions Listing. We'll start with the one titled "Profit & Loss" which shows a summary of our account activity for period 3, running from March 21-June 4, 2010. Our income for the period totaled \$6,912.48, under income you'll see we took in \$5,487.51 in Group contributions this period. We also had \$50 in birthday contributions! Yay! Now, here's my second amends: after I had made my bank deposit, and all the financial reports were finished, I found one last birthday contribution from JoAnne in my wallet. Sorry I missed it. It will appear on the next period's reports! Moving on, you'll see we received \$50.50 from the GSR sharing session, and \$13.97 from the buckets which were on the treasury tables next to the candy at the Spring Assembly. There is the \$591.99 for coffee, and \$21.26 in bank accrued interest. Then, there is a category titled "Less Returned Checks" what this consist of is monies returned to the area as they were not needed. During this period Butch (treatment chair) returned \$157 in monies unused/unneeded from the WCRAASC, and I found \$40.25 in cash in an envelope labeled with JoAnne's name which was amongst materials I received from Beth. Next, our event expenses totaled \$1,312.64 (Spring Assembly), and other expenses totaled \$3,644.76 (The Detailed Expenditures and Budgets report lists these other expenses out in more detail). So, we took in more this period than we spent. Very good. We are also under budget for the period. PTD budgeted expenses were \$6,176.83. Our YTD expenses total \$11,861.52, which is also under budget. YTD budgeted expenses were \$18,031.52. income is \$9,369.37 and if you turn to the "Balance Sheet" you'll see our current bank balance is \$12,710.15, plus \$5 from our savings account, equals our total equity of \$12,715.15 (all reconciled). So, taking away our \$6,000 prudent reserve we have \$6,715.15 available for service. Amazing! A huge thanks goes out to the groups for supporting the Area thus far! Again, we have an annual operating budget of \$35,860, so to maintain the services to Area 35, we need contributions totaling over \$2,900.00 a month. Here's a more detailed breakdown of what this would amount to for each group: each of the 555 groups listed with our Area would need to contribute \$5.38 per month, or \$1.20 per week. However, only 41% of the 555 groups actually contribute to the Area. So, this means that the 232 contributing groups would need to contribute \$12.88 a month or \$2.86 per week to help cover the groups who are not contributing. More importantly, as an Area, we need to work on spreading the message of the need for group participation in the Seventh Tradition. We also need to emphasize the importance of the Birthday Plan! As a way to show your gratitude for your sobriety, on your AA birthday, consider sending a contribution to your group, the Area, District, and GSO in the amount of your accumulated years of sobriety. If I can help in any way, please let me know! Remember, only \$13 A MONTH from each contributing group will help us remain self-supporting as an Area! Upcoming expenses include the Joint Area 35/36 workshop where we get the valuable opportunity to collaborate with Area 36 and share ideas, concerns and solutions. We also have the August committee meeting (approximate cost to the area: \$450.00), a Zonal Forum in Zone 3 in September (approximate cost to the area: \$140), the Fall Assembly (approximate cost to the area: \$3,500 - \$4,000), and the Winter Service Workshop (approximate cost to the area: \$3,500 - \$4,000) to consider. As for other actions I have been taking these past few months, bank account statements are being mailed to Jake J. our Area Chair to ensure another set of eyes are always on the bank account. At the suggestion of our finance committee I checked into the possibility of putting our prudent reserve into a separate account which could only be accessed with both parties on the account being present in the bank to make the transfer. This was a do-able thing, so now I'm just waiting for the go-ahead. Per a suggestion from Bob and Dee, I also checked on getting some sort of carbonless copy for area expense vouchers. I checked with a printing place about making up a set of forms based on our expense voucher, and they said they could do that for us. I'll report the exact cost of this at the August committee meeting if it's something the Area would be interested in doing. I'd also like to see a sample of what the other Area uses. For now I just bought a \$12 carbonless copy book and hand-wrote the expenses categories. I was also very privileged to attend and put on a presentation on the Area Treasury at a wonderful Zonal Forum in lovely Bemidji on May 8. I thought we had a good turnout (around 26 people?), and there was some great sharing of concerns and solutions by the members attending. We handed out evaluation forms, and I'm looking forward to hearing the results! OLD BUSINESS

SPRING ASSEMBLY FEEDBACK - There were 60 evaluations turned in with 48 people previously attending an Area 35 Assembly and 12 people were new to the Area 35 Assembly. GSRs reported that the most important items from the assembly were the breakout sessions, general sharing on the agenda items, the GSR orientation, fellowshipping, Area Chair reports, the experience as a whole, and the action committee meetings. <u>Suggestions for Improvement</u>: Better time management, a buddy system for new GSRs to help answer questions, committee chairs should be more knowledgeable, start the assembly earlier, clarity on which agenda items we vote on, cut off people who talk too much, and take out the GSR and DCM sharing sessions.

AREA 35 INVENTORY - Motion was made to have an area inventory at the Fall Assembly and that was 2nd.

Discussion: During the previous area inventory, we did not make any changes after the inventory was done. We need to make sure we have action taken from the information we get from the inventory. We also need to have people step-up and help get the process going for the Fall Assembly. A suggestion was to have someone from another Area conduct the inventory. The entire process we went through from the previous inventory is located in the Area Actions Booklet for us to use when setting up this inventory. At the last inventory we had someone from another Area conduct the inventory. One person wanted to make sure that when we do this inventory that we are honest and not worried about hurting other people. We need to look at what is best for Area 35 and Alcoholics Anonymous and how we can make them better. Minority: One was opposed because Area 35 did not follow through on the last inventory so why would we do the process again.

The motion to conduct an Area 35 inventory at the Fall Assembly passed with 24 in favor and 2 opposed.

The Area 35 Chair will be in contact with people to help get be inventory ready for the Fall Assembly.

FINAL FINANCIAL AUDIT - (This is the report submitted by Bill P. and Ted S.)

As requested by the Area we have conducted a review of all financial statements, records and audits available for the past years of 2008 and 2009. In planning and performing our review we also conducted interviews with the immediate past Area Officers we believed could be key contributors to the report. It is our opinion that the financial statement compilation provided by the past Area Chair, Jay A. is as accurate a report as could be constructed. It is our opinion the proposed amends figure and process is prudent and most of all, it is fair. We believe as, most Area AA Members do, in putting principals before personalities; we must forgive, provide an opportunity for amends, and move on. In performing the review we considered various internal controls and procedures which we believe warrant Area 35's attention. These comments and recommendations are intended to improve internal controls or result in improved operating efficiencies. They are being provided to you as items for future discussion and possible implementation. They are as follows: CONDITION- Area 35 Officers are not currently in a position to provide the focus oversight of the financial reporting process we feel is necessary to ensure accuracy. RECOMMENDATION- It is our opinion an Area Finance Committee be formed. The committee could be comprised of four (4) Area AA members. The Area Chairperson, the Treasurer (who would chair the Finance Committee), an Area DCM (appointed by the Area Chairperson), and a semi-permanent Auditor (based on Area Archives model). This semi-permanent Auditor position would be elected by the Area and would be a person who has the financial and accounting skills necessary to conduct proper analysis and review of financial reports. The person in this position would be able to provide a historical reference which may lead to increased efficiencies in the reporting processes. This person would also be familiar and proficient in the use of the financial software provided by the Area. CONDITION- Area 35 does not require dual signatures on checks issued by the Area Treasurer. RECOMMENDATION- We recommend Area 35 should immediately implement a dual signature system for all checks issued. We would recommend the Area Treasurer and the Chairperson be the signatories. CONDITION- The Area does not currently prohibit the use of cash cards and other withdrawal mechanisms issued by banks when new accounts are opened. RECOMMENDATION- In our opinion it would be beneficial for Area 35 investigate the possibility of using a large regional bank as the permanent banking institution for the Area account. This course of action would enable the Area to prohibit the issuance of cash cards, etc. and develop a relationship with the bank, leading to better internal control. Because of the various online products and opportunities most banks provide today, we believe it is not necessary for a treasurer to live in a community that has a physical branch of the bank. However, most large regional bank chains do have many outlets throughout Northern Minnesota. This type of bank relationship could possibly provide future opportunities for direct group contributions to the Area account and provide other efficiencies. CONCLUSION- We appreciate the opportunity to be of service to Area 35 and hope some of the observations presented are beneficial. We also feel this situation and process has been a learning and growing opportunity of the entire Area. The love, the commitment to the still suffering alcoholic, and the forgiveness displayed by all, is truly inspiring for us to witness and be a part of. We thank you for your service to this fellowship.

Discussion: How much money were we off and do we accept the \$2020.16 as the amount the past Area 35 Treasurer stole? One member felt that the information presented need to go back to the groups for them to decide if we are going to accept the financial statements and the information presented today. One Area 35 member stated that we need to remember that this was not just one persons fault. We all were not making sure things were being done correctly or having safe guards in place like having double signatures, duplicate voutures, and etc. One thing the same AA member felt we still need to work on is making sure we have a record of the amount of money coming in from groups. An Area Officer wanted to point out that groups have every right to bring their groups concerns to the Area and if they do not like something they can make a motion. Right now the Area 35 asked us to make a financial restitution from the past and that is what we have done and if groups do not like the information they have given they have the right to bring that to the Area. One member felt we need to move on from this and take what we have been given to make changes in what the Area is doing. One member asked if the Area spent \$10,000 more than we should. Another Area member felt that if we do not have concrete proof about an errors or stolen money we can make the changes. Are we over spending or did the money get miss placed? We need to make sure the Area is not over spending their money. The area needs to know what we can spend and what we cannot spend. Part of the past treasurer did not let us know we were below our prudent reserve. The records showed that the area had money to spend so we spent the money. If the records were correct we would have not over spent our funds.

FINANCIAL OVERSITE COMMITTEE - There's been communication amongst the committee members in regards to the area's treasury and how to implement a plan to oversee the finances. As of today, we don't yet have a plan of action on all the tasks and assignments to work out a process yet. This is still in the process of being incorporated, but we will be ready for review by year's end. We have excellent committee members that are willing to work in unity and function to restore confidence in our area treasury. We will be meeting as a committee in person and also continue to email each other to develop a strategy that works for all of us. The committee members are Area 35 Past Delegate Tom A., current Area 35 Chair Mike J., Area 35 Treasurer Sarah K., DCM Randy A., and Jeff L. District 13 Corrections Chair. We will start with developing a cohesive plan; define our main objectives or mission and review area finances on a regular basis. Hopefully this strategy will work for us. Thanks to Area 35 for being patient with us; we will have a much better report and information at the next Area Committee Meeting. Yours in Service, Randy A. NEW BUSINESS

WCRAASC HOSPITALITY SWEET - The cost of the hospitality suite will be roughly around \$200.00 for the weekend. This money would have to come from the Area if we choose to have one at the WCRAASC. There is the possibility that we may get more rooms for free from the hotel if we get a lot of people to stay at the hotel. A motion was made to have a hospitality room at the WCRAASC and this was 2^{nd} . <u>Discussion</u>: The money was made up by the contribution donated to the hospitality suite. Another suggestion was to have a room with bedrooms so that the people running the suite could stay in the room and share the cost. Another person felt we need to make sure someone is in the hospitality suite to collect the money. Rita will be the chair for the committee for the hospitality suite. <u>The motion to have a hospitality suite at the WCRAASC passed</u> 24 in favor and 0 opposed.

Service Experience Strength, and Hope from a Past Delegate

My service experience began when after a few months of sobriety I began to realize what a unique and wonderful organization A.A. is, and that there were little jobs in it that somebody had to do, and that I had the time to do them. Coffee maker was the perfect place for me to start. It made me demonstrate commitment, reliability, and consistency, because I was entrusted with the key to the meeting place, and if I didn't show up there would be no meeting and I would have to face a posse of grumpy alcoholics the following week.

I received the benefit of an increased sense of belonging; a feeling of being a member of a group rather than just an attendee of meetings. I made a brief attempt to be a General Service Representative (G.S.R.) before I had worked the 12 Steps and found that I did not yet possess the patience and tolerance and gratitude that is generally required to sit through a District meeting. That soured me on General Service for a while, but I was on the District mailing list, and I began to feel guilty every month when the minutes appeared in my mailbox.

After a year or so I went back to the District meeting and it had changed completely (or perhaps I had changed as a result of working the Steps!). I served as a G.S.R. for a while and learned about the A.A. service structure and found it interesting. I sat on my hands, however, when they asked for volunteers to serve as District officers. Somehow, despite all my best intentions, my hand went up and I became the District secretary. It turned out to be a great job for me, consisting of simple, yet time-consuming repetitive tasks that produced a measurable result in the form of envelopes of minutes. I would deposit them in the mailbox with a certain kind of satisfaction that came from doing a little something to give back to the fellowship of A.A., which by now I knew was saving my life.

When elections rolled around, I was asked to stand for District Committee Member (D.C.M.). I was going to decline the nomination because I was sure I couldn't possibly do the job as well as the present D.C.M. did. I asked a respected A.A. friend about it, and he suggested I put my hat in the ring and let God decide. So I did, and was privileged to serve as D.C.M. for two years. I think it was during that time that I realized more fully what an honor and a privilege it was to be an active participant in A.A. general service, and to experience the wonderful spirit of love and service that exists at the District, Area, and Regional meetings. All of these entities are part of the General Service Conference Structure, which essentially is a communications tool through with information flows back and forth between the A.A. groups and the General Service Board of A.A. It is usually free from politics, and is always in need of A.A. members to serve within it.

Most of us know the rewards that come from working with another alcoholic face-to-face, and the joy we feel when light begins to shine from eyes in which there had been only darkness. But there is a very special reward in general service that comes from helping alcoholics who we will never meet, but for whom we work by helping ensure that A.A. will be there for them when they need it.





- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the *N.L.*

EDITORIAL POSITION & N.L. COMMITTEE:

- **Editor** The Editorial Chair is an elected position held during a two -year rotation.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- **N.L. Committee -** The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Twelve Concepts for World Service (Short Form)


- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
