

### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:


- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

### **Treasurer's Report**

Greetings Area 35! Recently a DCM requested clarification on some of the Area's expenses on behalf of a group in her district, so I did a detailed analysis to try and answer her questions. Since she had questions, I thought others may as well, and that it might be useful to pass along the information I compiled for her. The question pertained to the following expense categories: printing & other expenses. So now for the explanation/breakdown. First, let me say that this is a rough summary of costs for printing items and if you want an exact explanation, please contact me with any specific item you are wondering about and I can answer that, or you can contact the appropriate area chair and ask them and they'll gladly answer that question for you.

Our Area's year-to-date printing expenses total \$2,935.93. Printing costs are incurred by the delegate for printing up the background information for the agenda items our area discusses every year. These usually total over a thousand dollars. In 2010 our delegate tried to cut those costs by distributing CDs instead and printing information only for those who requested it because they have no computer or something. The secretary prints flyers for all assemblies in the number of 500 or more a year as well as around 200 GSR packets distributed at Zonal forums and Area Assemblies. These packets contain relevant and important information for those new to service. All the action committee chairs also print flyers if they have a workshop. The treasurer prints 100-150 copies of several sets of financial reports (each consisting of multiple pages) for every area assembly and committee meeting, and very few go to waste. The archivist prints archival material to store for future generations. The group records chair prints the Northern light to inform the area groups about what is going on in area 35. This is printed and distributed to registered GSRs and a packet is given to DCMs to distribute in their districts in order to ensure the groups of area 35 are fully informed.

As for the expense category "other expenses," those numbers total \$3,651.87 (YTD). As for the breakdown of those expenses, again this is a rough outline. "Other expenses" that all chairs accumulate include things like the WCRAASC registration fee of \$12 and the Winter Workshop (January service conference) registration fee of \$10. The archivist's other expenses include the rent we have to pay to store the archives. The Alternate delegate's other expenses include the cost of bringing in and hosting our annual winter workshop speaker. The delegate's other expenses includes the cost of \$1,800 for attending the general service conference in NY each year where he carries our area's conscience. The Treasurer incurs other expenses for things like: contribution envelopes & the Area's post office box, and the annual fee for the website hosting. The PI chair has other expenses which includes the cost of hosting the state fair AA booth. The Corrections chair has other expenses including the cost of hosting a PI AA booth at a statewide probation officer meeting. The group records chair has other expenses for the mailing costs of the Northern Light.

Finally, as members of Area 35 we are right to question if the Area is prudently using funds. I believe there are several recent actions and changes made by members of the area that can be looked at to help us in assessing this. First, to lessen mailing and printing costs, the area minutes began being printed in the Northern light instead of being printed and mailed as a separate mailing. Also, the printing of the agenda items for each DCM and Area Chair has in the past cost the area over 1,000. But this last year our delegate, who was trying to be prudent with the groups' money, made the suggestion that he would only print hard (paper) copies of the background information for the districts and area chairs who requested a paper copy. Thus, he saved the area quite a bit of money, I would estimate over \$800. Another way the area chairs attempt to be prudent is by sharing rides and rooms when traveling to events. Finally, one of the longest running methods to ensure that we are being prudent with the group's funds is by creating a budget. Each year the area presents a budget of expenses they expect to incur based on service they hope to provide the area. This is reviewed by the treasurer and area chair and then that budget will be printed in the Feb. Edition of the Northern light for groups and members to review. All groups are encouraged to get that Northern Light article and review the proposed expenses for the area. Then, after discussing any questions or concerns, they should send a GSR or representative to the area spring assembly where all members of Area 35

have the opportunity discuss and question the details of the budget before it is approved.

1. Area Chair calls to cancel and/or re-schedule.


2. Based on DOT report, national weather service, individual safety being paramount

" If you have the urge to pick up the first drink: go to This is the time to remember how lucky I am a meeting; read your big book; call your sponsor; find another alcoholic to work with". Once upon a time you couldn't go to a meeting 24/7 there were 2 in the country and they weren't even AA meetings, they were Oxford group meetings. We didn't have a big book. We relied on each other and on working with the still suffering alcoholic. And these alcoholics were not cleaned up in a 28 day Rule 25 stay. They were shaky, sick and going into delirium tremens. The first 100 worked with these drunks lovingly and willingly because they knew that this work would keep them sober.

These first 100 are not just names on a page. They were real people with personalities and defects of character. They all have stories, some funny, some poignant, some horribly sad. And these stories are still relevant and useful. I have a suggestion for your next "topic discussion" meeting. Instead of doing gratitude or resentments read a story from "Experience, Strength and Hope" and discuss how the author felt.

Now for our history challenge. The answer to the last challenge, from the "To wives" chapter, now reads "thousands have been released to our care". In the first edition this was a specific number.

My challenge is for you to find that specific number. This information is readily available on the web. Keep in mind the first edition pagination is different from the 4<sup>th</sup> edition.

I have a second challenge. Who was the first AA member who broke anonymity on a national level and in what national publication did they break anonymity.

## **Northern Light Article**

### We Are Not Alone

Before I got sober, I always dreamed of traveling and seeing the world. My only problems were; I had no money because I would spend it all on alcohol, and I had no friends who would travel with me. Most of my friends drank like me so they never had money or ambition to go anywhere. When I finally got sober, I started to make my dreams come true. I first started out by backpacking through Europe for my honeymoon. Yes, my husband and I went backpacking through Europe for our honeymoon. We spent two weeks traveling to London, Paris, Rome, Venice, and Frankfurt. Part of the journey involved hitting AA meetings. We hit an AA meeting in London and Rome; which was an experience in itself. When at the London meeting, they started just like any other AA meeting in Minnesota with around 40 people in attendance.

The chairs were lined up in rows and people would randomly speak from the crowd for a few minutes. I never got the chance to speak; however I heard lots of stories that I could relate to. They had greeters and coffee. The only difference was the instant coffee; where you pour the grounds into hot water and they dissolve. When in Rome, we found an English speaking meeting. When you first walked into the room they had a picture of Bill and Bob on the wall. I thought seeing those pictures on the wall, in Rome, and half way around the world was so amazing. This meeting had a speaker who talked for half of the time on her experience, strength, and hope. The rest of the time people would randomly stand up and speak. At each of these meeting I felt as though I was not thousands of miles away from home. I felt so welcomed and it was good to know that I was not alone in this country.

A couple of years later, we went on a Caribbean cruise for 7 days. On this cruise they had meetings for "Friends of Bill W." For awhile I was avoiding the meeting because I was nervous to go by myself. I do not know why I was so nervous. I had been sober for around 5 years at this time. Finally, I decided enough was enough and I had to face my fears. I went to the meeting and there were 4 to 5 people in attendance. We had a normal meeting in which we talked about a topic and our own story of sobriety. Once the meeting started I realized I had nothing to be nervous about because these people were just like me. There were people from all over the country and they had such great stories. I would have definitely missed out on a great opportunity if had not attended. This June, I decided to go back to Europe for two weeks by myself. I started in Ireland, then Scotland, and finished in Paris. Before I left, I made sure I knew where an AA meeting was in each place I was staying.

The first day I was in Ireland, I went to an AA meeting in Dublin. As I was looking for the place where the AA meeting would be held, I saw some men and women standing outside a building. They were talking, drinking coffee, and smoking. I knew I had found my place. The meeting started with a speaker, who was a woman living in Dublin. Once she was done speaking, AA members around the room would share their experience, strength, and hope. There was no order to who spoke; you just quickly started talking before someone else. I was given the opportunity to speak. I let them know I was from America and this was my first time in Ireland. After the meeting people introduced themselves to me, welcomed me to the country, and talked about their sobriety. One woman I talked with was still struggling with her sobriety, and I could relate to what she was going through. I remember times in my sobriety were I was having the same thoughts and feelings. When I was done in Ireland, I headed to Scotland.

While I was in Edinburgh, Scotland, I went to another AA meeting. The pictures below are from that meeting. The meeting ran the same way as the meeting in Dublin, Ireland. I was also given time to speak at this meeting. When I let people know that I was from another country, they welcomed me and made me feel at home. I was all on my own in a different country and I knew there were people who would help me.

When I was in Paris, I found an English speaking meeting at a church called American Church. In order to get to the meeting you had to be let in by the front desk. I was not sure where the meeting was in the church, but then a woman helped me go to the right room. The woman was originally from America but she had moved to Paris some time back. The room was located in the basement of the American Church, which was very beautiful and much cooler than the 90 degrees outside. We had a great meeting that ran like all of the other meetings I attended on my journey. They had a speaker who spoke for half of the hour and then members of the meeting would speak.

The point of this story is that you can go anywhere in this world and not be alone. When I was drinking, I always felt alone and different from everybody else. Since coming into AA, I have never had to worry about people not understanding, relating, or accepting me. The family and friends I have gained is an important part of my life. Today, I am so grateful to be a part of AA and thank God for the people placed in my life.



#### **OFFICER REPORTS**

DELEGATE-Jon C.- Please accept my apology for not attending the December committee meeting. I will be in Florida from 11/29 through 12/6. I look forward to seeing you all at the January workshop. Jim has put together an agenda that should be very informative. Conley B. from the G.S.O. will be very interesting, and I look forward to hearing his story. I want to emphasize the value of the dollar. One dollar in 1945 is worth eight cents today. We must all look within to make sure we are being financially responsible to all of our entities. One dollar in the basket will not cover the necessary expenses for all of our entities to operate effectively. The price of beer today is over three dollars, and how many of us stopped and had one? Please consider trying to contribute more. This program saved our lives and we want to make sure that what was so freely given to us will be available to those in need in the future. Thank you. The Grapevine Board, with the approval of the General Service Board, made a decision to draw down \$300,000 from the reserve fund. Some of these funds are being used to implement the consultant's findings and suggestions. Remember, the consultant was hired in July at \$25,000 to evaluate the Grapevine and its operations. I would like to pass on some changes to the Grapevine and other literature that have or will be implemented during early 2011: 1) we have a new executive editor/publisher; 2) digital version of the magazine will be available; 3) electronic versions of the books will be available; 4) discounted prices; 5) new fulfillment provider; 6) new online catalog/shopping cart; and 7) a new website. These changes have all been made as policy decisions, not subject to conference approval. The best way to help the Grapevine is to subscribe. At this time, we would need 16,700 subscriptions to be self-supporting. Other ways to help are to visit the web page, hold writers' workshops, and have Grapevine meetings. I will keep you all informed of any new developments. At the G.S.O., the committee on literature is looking for stories focused on spirituality for the pamphlet, "A.A. and the Armed Services." Particularly, they are looking for stories that reflect the wide range of spiritual experiences of A.A. members and how members with any belief or non-belief have found a solution to the concept of spirituality in A.A. The committee is also looking for experiences from members in active duty for a section that will focus on veterans of the Armed Services. Submissions should be 500-800 words, double-spaced. I have received a sample "animation" DVD. I will bring this DVD to our January workshop to share with our area. You may order all five young people's videos (DVD-16) for \$13. I want to wish everyone in Area 35 the best during this Holiday Season. If there is anything I can do, please don't hesitate to ask. I am serving each and every member in Area 35. A huge thank you to the groups who are contributing! We also received \$163.00 in BIRTHDAY CONTRIBUTIONS, which brings our YTD total Birthday Contributions to \$1,143.00. (Again, amazing!) Your gratitude for your sobriety exhibited by your birthday contributions is greatly admired and appreciated! Other income: PTD Special contributions = \$400 from the Heartland Roundup, YTD Special contributions total \$3,350.00. YTD Amends made: \$1,700. PTD anonymous contributions \$2, YTD anonymous contributions total \$1,002. PTD sharing session basket is \$57, YTD \$159.07. YTD 7th Tradition Basket passed at fall assembly AA meeting \$23, PTD \$23. PTD Interest on deposits: \$23.28, YTD 91.62. We had one returned check and fee for -\$34. This brings our total period 6 income to \$5,201.55, and our YTD income to \$38,266.35. Our period 6 expenses totaled \$4,716.82. The expenses were mostly for the area officers and chairs to attend the Fall Assembly. If you are interested in a detailed breakdown of expenses, please contact me and I'll happily oblige! Including the contents and interest in our savings accounts, (\$5 in our savings account and our \$6,000 prudent reserve-which is in a dual signature protected savings account), and we have a total of \$19,365.13 in the Area Accounts. Skip from District 5 reported that they have started meetings again twice a month at the Sherburne County Jail. They need 4 men a night to go in and they have 9 volunteers signed up so far. They are still looking for more volunteers including the women's meeting. I am currently working on my Corrections budget for 2011, I have been diligently working on the programs and directory for the WCRAASC coming up in March and I received 7 more female names that need contacts that are releasing from Shakopee Women's Prison soon. I will be contacting individuals from those districts to get contacts for them. Thanks to everyone that has been willing to be a contact for the many inmates we have already received throughout this last year. I presented at District 5's Corrections, Treatment and Archives Workshop on November 6<sup>th</sup> and I would like to thank them for inviting me to be a part of it. Again if I can be of help or service in any of your distric

DISTRICT 3- Jim S. - We have two positions open, Literature and Corrections. Prior to the last district meeting we were short on our yearly budget and now we have more than enough 7th tradition donations to fulfill all of our obligations for the rest of the year. Our district made and approved a motion to start an annual roundup starting next July 2011. This will be a 2 or 3 day event at the local campsite. Flyers should be available in the next couple months. I was asked by a women's only meeting to distribute an invitation to other women around our district to participate in a private Facebook page. I spoke with the corrections chair at GSO regarding their thoughts on whether this would be a breach of anonymity, be an outside issue, etc. The thoughts from GSO are that it would essentially be a virtual Alano club as thus an outside issue. At our next district meeting the person requesting this invite will be present and we will have a discussion about this as I do not feel it is solely up to me to decide to not distribute the invite. This seems to be a topic that will continue to grow as opposed to fade away so we might as well start to discuss it. We have 5 GSR's preparing a workshop for the annual workshop in January.

DISTRICT 4- Dee Dee B.- Hello from District 4. I am glad the storms are over for now and I was able to make it here today. This is my first Area Committee Meeting as DCM and I am grateful for the opportunity to serve. District meetings are the second Saturday of each month at 5:30 p.m. in various locations throughout District 4. Our next District meeting is December 11<sup>th</sup> in Elbow Lake and we will be doing a District Inventory with the help of past Delegate Tim C. At our November 13<sup>th</sup> District meeting we had 18 people attending. Jeff C has agreed to be our PI/CPC Chair and he is working on a website for District 4. A motion was made to cover the expenses of those volunteers who help Dee Dee with the presentation. We plan to meet in December to start preparing for the presentation and get an outline to Jim K. We have a new AA meeting at the Wheaton Public Library on Mondays at 7:00 p.m. This meeting could use our support. Thank you to everyone for all your help and allowing me to serve.

C.P.C-Doug N. - District 3. Christ will have three CPC luncheon meetings. The first meeting invitations were sent out 3 weeks before the meeting and nobody showed up. They are going to try giving 3 months advance notice and maybe even an RSVP slip before the next CPC luncheon. District 12 will be working with Minnesota State Juvenile Officers for a conference to be held in January on the 26<sup>th</sup>, 27<sup>th</sup>, and 28<sup>th</sup>. District 12 has a speaker available to give a presentation at the conference as space was available in their agenda. We need more representation from district to attend the committee meetings because it takes too long to talk to district chairs over the phone and coordinate information between districts. DCMs can help by getting people involved in service maybe even the GSRs. DISTRICT 13- Gayle S. – Hello from District 13, we meet the first Monday of every month at Salem Lutheran Church @ 90 Riverside Dr. St. Cloud @ 7:30pm. We are happy to report we have a new ALT DCM, Steve J... We also have two nominations for district secretary. We would like to thank Alt Delegate Jim K. for assisting us with our district Inventory. We allotted one hour to conduct our inventory, after one hour we voted unanimously to continue, we finished at two hours twenty minutes. What we learned from conducting an inventory will strengthen us as we continue to grow as a district. PI committee is continuing to work with Area Group Records and Area Webmaster to make sure our meetings in both databases stay correct as well as making our open meeting available in the St Cloud Times. District 2, 3 and 16 plus group records secretary and Northern Light editor. Things we discussed: Troubles with the Map Locator Generator from Google not always getting the locations for an address right. Have to find out how to make a correction for that. The meeting fliers for people are to give important information in them. Where (an address) not everybody knows where the community center in town is also dates and times. And *Proof read* before printing or sending by e-mail. Also if you upload an event flier to me please use Word doc or Adobe PDF formats and if sent by mail please make copy on white paper (it scans in best). I placed the new Service Manual on the website. I reiterated the necessity to keep the communication and cooperation between the three positions to keep the information current and correct. Which we are doing a great job because Area 35 is a dynamic entity not stagnant. And we can only be as good as the information given us and passed between us all.

#### **OLD BUSINESS**

<u>WCRAASC-</u>The committee met over lunch today and everything seems to be going well. We are in need of volunteers to help with the registration table (Mary C.), coffee (Butch R.), greeting (Art A.), and the hospitality suite (Rita D.). If you want to get involved with the WCRAASC please sign-up. Please see the committee chairs if you are willing to help. This is a great conference to attend so please come and learn more about Alcoholics Anonymous. If you are staying at Grandview Lodge and sharing a hotel room, each person in the room has to fill out a registration form. You should try and send the registration forms together. They will only take the first nights lodging from one person. There is enough parking at the conference center and buffet area for you to drive from your lodge if needed. The \$107.19 per night lodging is the total cost (including taxes and no service fees). The Registration Chair for the conference is asking people to preregister so we can have the name tags made in advance. We are going to need at least 2 people working the registration table (1-preregistered guests and 1-2 for walk-ins) and currently we have no one signed-up. The sign-up sheet is broken down into 2 hour shifts and will be passed around during upcoming Area 35 events (committee meetings/workshop).

<u>AREA WORKSHOP</u> – The 35<sup>th</sup> Annual Area 35 Service Workshop is taking place at the Coates Plaza Hotel in Virginia, MN on January 15<sup>th</sup> and 16<sup>th</sup>. The Alternate Delegate has talked with the DCM about their presentations at the workshop. As requested from the Area Inventory, we changed the format for the workshop so it is more of an informational and/or educational experience. We ask that the DCMs and districts take some time and prepare a presentation before you come that weekend. Please try and avoid preparing your presentation right before you are supposed to present. Area 35 and the districts spend a lot of money on this event and we want it to be a useful experience.

<u>FINANCIAL OVERSITE COMMITTEE</u> - We met as a committee on December 5<sup>th</sup>, 2010 at the Aitkin Alano Club with members including a Past Area 35 Delegate, Area 35 Treasurer, District Corrections Chair, and DCM. We reviewed the financial records of the Area 35 treasury. We went over the bank statements, reconciliation reports, check registers with a year to date balance, beginning balance, and ending balance for period six (September 29<sup>th</sup> to December 2<sup>nd</sup>, 2010). One minor error existed in contributions of a bounce check that a group had sent was recorded in the deduction section of the checking account. The conclusion was that the committee found no errors or discrepancies existing in the account. The Area 35 Treasury is safe, accurate, precise, and current. The committee also discussed follow-up and responsibilities regarding time restraint and committees. If anyone has any suggestions or comments please feel free to talk with one of the committee is still looking for a GSR or a district treasurer. The current financial policy is that if they are not getting reimbursed to attend the Area functions, the Area would reimburse the members for attending the event. Another question for Area 35 to think about is do we want to assign DCMs to the Financial Oversite Committee when we start new a rotation.

<u>SPRING ASSEMBLY</u>– The flyers for the 2011 Spring Assembly are available and you can also find the flyer on the Area 35 website. The Spring Assembly is April 2<sup>nd</sup> to 3<sup>rd</sup>, 2011 at Fortune Bay Resort in Tower, MN. The rooms cost \$76.00 per night excluding tax. We do have blocked rooms available so make reservations before March 18<sup>th</sup> by calling 1-800-555-1714. There was a concern on name the blocked rooms are listed under. On the flyer it says "Northern MN Area 35 Workshop" and some people want to know if it should say "Northern MN Area 35 Assembly."

#### AREA 35 INVENTORY-

#### **NEW BUSINESS**

There was not a lot of information on the Area 35 Inventory since the Area Chair was not able to attend the committee meeting. The Area Secretary did state that the Area Chair contacted her to see if she was willing to sit on a committee for the Area 35 Inventory. The Alternate Delegate also mentioned that we are going to have two presentations on the Area Inventory during the January Workshop.

#### **INACTIVE DISTRICTS- RITA D. - DISTRICT 5**

This was a part of the Area Inventory asking if there was anything we could do to get involvement from the dark districts. There was some discussion about Foley, MN and whether it is a part of District 13 or District 5. Some felt that Foley, MN has always been a part of District 13. It was also mentioned that the group has the right to choose which district it wants to be a part of. A suggestion was made that a committee be formed to look into the matter of getting involvement from the dark districts. A few Area members felt that the Area Chair needs to be involved since this is one of his primary responsibilities. Some feel that there needs to be some people to go with the Area Chair to get these dark districts going. We need to make sure that if we make a plan to help the dark districts that we follow through with that plan. It was believed that either the Groups Records Secretary or the Delegate get a list of all of the meetings in Area 35. These lists are then passed out to the DCM for each district to check. The DCMs need to make sure they are checking these lists to make sure they are accurate. The Group Records Secretary did get a list of Area 35 meeting not that long ago and passed them out. We can get the list passed out again to DCMs if needed. One member felt we should start a committee to try again to resurrect the dark districts because if we quit trying it will never happen. One suggestion was if AA groups in dark districts are attending other districts, they should be talked with and guided through what can be done to get their district going again. There was some confusion about which districts are considered the "dark districts" since some of them have been absorbed into other districts. In the Northern Light the dark districts we shown to be Districts 10, 14, 17, 19, and 20. However, there was some discussion that Districts 10, 19, and 20 were dissolved into other districts. Area 35 had no clear consensus on the matter so the Alternate Delegate is going to do some research to find the accurate information. One of the Alternate Delegate's duties is to create or update a map of Area 35. There was no formal vote on the matter and the Area Chair was not present, so the item was moved to the February Committee Meeting. The Alternate Delegate plans to talk with the Area Chair and Delegate about this information before the February Committee Meeting. If anyone would like to be on this committee please see the Alternate Delegate.

#### ZONAL ROTATION

It was found in the Area Actions Booklet that the 2010 Fall Assembly was supposed to be in Zone III and not in Zone I. In the Action Booklet it shows that the 2011 Fall Assembly is also suppose to be in Zone I making Zone I have two Fall Assemblies in a row. The problems are that all of the Assemblies in the last rotations have been up North which makes it harder for Districts in the Southern part of Area 35. The other problem, however, is that the 2011 Fall Assembly is an election year assembly. If we move the 2011 Fall Assembly from Zone I, the AA members (that may typically not go to these events) in those districts miss out on being a part of a voting assembly. A suggestion from the Area 35 Officers was to change the 2012 January Workshop from Zone I to Zone III so that we are having an Area event in that zone. Also, the 2013 Winter Workshop would be moved from Zone III to Zone I. This would still give Zone I their right to have an election assembly, and changing the January Workshop is easier than changing an Area Assembly.

<u>A motion was made to move the 2012 Winter Workshop to Zone III instead of Zone I and move the 2013 Winter Workshop to Zone I instead of Zone III.</u> <u>The motion was seconded and passed.</u>

#### TREATMENT BRIDGING THE GAP

The Area 35 Treatment Chair was asked to create form similar to the forms created in Area 36 for temporary contacts for people coming out of treatment. The Area 35 Treatment Chair has created two forms to be used in getting contacts for alcoholics in treatment centers. One of the forms is for alcoholics in treatment who are looking for a contact in their home town for after they complete treatment. The other form is for AA members to fill out who are willing to be a tem-

porary contact for alcoholics completing treatment and moving to their area. A suggestion on the form filled out by alcoholics in treatment, was to take out the current Area 35 Treatment Chair's name and phone number so it only has the email address <u>treatment@area35.org</u>. The reason is the current Area 35 Treatment Chair will be rotating out in a year and the same form could still be used by the incoming Area Treatment Chair. We have the same type of forms used by the Area 35 Corrections Chair and are working. One of the guidelines in the service workbook for an Area 35 Treatment Chair is to create a temporary contact form to be used as service material. There forms should not have to be approved by the area to be used in Area 35. If however there were concerns about the form, members of Area 35 would have the right to talk with the Treatment Chair.

#### DONATIONS FOR AREA 35 ELECTRONICALLY

In the Northern Light on page 20 there is a chart and summary of the information the Area 35 Treasurer has found for starting online contributions. Currently, there are not a lot of Areas using online contributions. Since the information was only distributed to members of Area 35 in the past week, the Area 35 Treasurer er felt that the information should be looked over and discussed by groups and districts. The Area 35 Treasurer asked that we wait to make any formal action on online contributions until the Spring Assembly. At this time we could answer any questions people may have. Keep in mind that the information on the Northern Light has zeros that should not be there. Discussion: One question was do groups in Area 35 want online contributions or if this started because of a couple of people. Is this cost effective and/or an effective use of our time? The Treasurer pointed out that the groups cannot make a decision as to whether they want online contributions until they have the information. Currently, there has been no cost to the area for researching online contributions. One member stated that this was a request made by the area and not one person or the treasurer. How many groups would have to do this in order to make this cost effective? The Treasurer responded by saying that it can depend on the service providers. Some service providers have a monthly service fee that the Area would have to pay and others do not have a monthly service fee. Some service providers charge the person/group making the contribution a processing fee (about 2%) instead of having a monthly service fee. For example, if a group contributed between \$30 and \$50, they would have a 2% processing fee of around \$0.60 to \$1.00. This is about the same cost as sending a check in the mail (stamp, envelope, check, and receipt for contribution). One AA member mentioned that checks are not being used or accepted as frequently anymore and that everything is moving towards credit card and debit cards. Also, everything is starting to move toward

#### \$150 CPC REQUEST FOR BOOTH AT CONFERENCE

The Area 35 CPC Chair was told about a conference being held at the Holiday Inn in Duluth/Superior with a cost of \$150 to have a table display. The conference is called the MN Juvenile Officers' Conference. There is no registration fee, but only the cost of having the table at the conference. We currently have the literature and would only need to get a few people to sit at the table during the conference. This was something that was not budgeted for by the CPC Chair so we are asking the area to add this to the budget. One Area member felt this would be a great opportunity for AA to education officers that work with kids. Currently, the Area Chairs and Officers are under their yearly budgets. One Area member wanted to know if this was District 12's responsibility and should they be paying for the table? The response was that this is actually a joint effort by Districts 8, 9, and 12 who have volunteered to staff the table at the conference, but not accurately pay for the table. This conference was brought to these three districts attention by the Area CPC Chair. This conference is not only for juvenile officers in Districts 8, 9, and 12 but for officers all over Minnesota. This is a statewide event so some members felt that this should be paid for by the Area since we also pay to have a booth at the State Fair. The Area 35 CPC Committee was in support of attending this meeting and Area 35 paying the cost for the table display.

# <u>A motion was made that Area 35 pay \$150 to have a table display during the MN Juvenile Officers' Conference. The motion was seconded and passed with a majority of votes.</u>

#### AREA 35 2011 BUDGET

According to the new financial policy, the Area 35 Officers and Action Committee Chairs were all ready suppose to have their 2011 budgets to the Area Treasurer. However, this did not happen with the new policy starting in October. The Area 35 Treasurer is asking all Area 35 Officers and Chairs get their budget turned in as soon as possible so the 2011 Area Budget can be put into the January Northern Light. The budget will be presented for approval at the 2011 Spring Assembly so groups and districts need to review the budget in the Northern Light before the Spring Assembly.

We sacrifice discussion for decision...our pride is hurt if we are disagreed with....we react without spiritual guidance and seem to think that if its not done today it will never get done. This is the way of the rest of the world not the way we are taught in AA. We are taught that we must aim for perfection and to sacrifice the good for the best. AA is a fellowship that is concerned with recovery from alcoholism. We seem to be catering too making life easier for us rather than how we can best help the still suffering alcoholic. No wonder many people are confused with General Service and find it political and different from what the main body of AA is trying to do. I believe that we must integrate General Service back into the seats of AA and spend time together as a fellowship in AA not separate. My vision for the future of area 35 and all of AA is that we get to know each other and God better so that none of us feels apart from or different because our aim is the same...get drunks help that they so desperately need and want.

# **Northern Light Article**

### Emmet Fox and Alcoholics Anonymous

One of the very early recovering alcoholics who worked with co-founder Bill W. was a man named Al, whose mother was secretary to Emmet Fox, a popular lecturer on New Thought philosophy. When the early groups were meeting in New York, members would frequently adjourn after a meeting and go to Steinway Hall to listen to Fox's lecture. To this day there are AA groups that distribute Fox's pamphlets along with Conference-approved AA literature.

An account sets forth in "Dr. Bob and the Good Oldtimers" tells of the influence of Emmet Fox and his classic work, "Sermon on the Mount." An AA old-timer recollected: "The first thing he (Dr. Bob) did was to get Emmet Fox's 'Sermon on the Mount'....Once when I was working on a woman in Cleveland, I called and asked him what to do for someone who is going into DT's. He told me to give her the medication and he said, 'When she comes out of it and she decides she wants to be a different woman, get her Drummond's 'The Greatest Thing in the World.' Tell her to read it through every day for thirty days and she'll be a different woman.' Those were the three main books at the time; that and 'The Upper Room' and 'The Sermon on the Mount.'"

Perhaps the fundamental contribution of Emmet Fox to Alcoholics Anonymous was the simplicity and power of "The Sermon on the Mount." This book sets forth the basic principles of the New Thought philosophy that "God is the only power, and that evil is insubstantial; that we form our own destiny by our thoughts and our beliefs; that conditions do not matter when we pray; that time and space and matter are human illusions; that there is a solution to every problem; that man is the child of God, and God is perfect good."

Central to New Thought philosophy was the perspective which saw that love and personal forgiveness were the keys to fundamental transformation: "Love is by far the most important thing of all. It is the Golden Gate of Paradise. Pray for the understanding of love, and meditate upon it daily. It casts out fear. It is the fulfilling of the Law. It covers a multitude of sins. Love is absolutely invincible."

Fox went on to say that forgiveness was an integral part of the Pathway of Love, "which is open to everyone in all circumstances, and upon which you may step at any moment - at this moment if you like - requires no formal introduction, has no conditions whatever. It calls for no expensive laboratory in which to work, because your own daily life, and your ordinary daily surroundings are your laboratory. It needs no reference library, no professional training, no external apparatus of any kind. All it does need is that you should begin steadfastly to expel from your mentality every thought of personal condemnation (you must condemn a wrong action, but not the actor), of resentment for old injuries, and of everything which is contrary to the law of Love. You must not allow yourself to hate either person, or group, or nation, or anything whatever.

"You must build-up by faithful daily exercise the true Love-consciousness, and then all the rest of spiritual development will follow upon that. Love will heal you. Love will illumine you."

One of the cornerstones of Fox's philosophy was to live but one day at a time, to be responsible for one's own thoughts and to clear up resentments, just as AA was to teach that "resentments are our number one cause of slips." For Fox, one of the most important rules for growth was to live in the present: "Live in today, and do not allow yourself to live in the past under any pretense. Living the past means thinking about the past, rehearsing past events, especially if you do this with feeling...train yourself to be a man or woman who lives one day at a time. You'll be surprised how rapidly conditions will change for the better when you approach this ideal."

Emmet Fox emphasized the idea that thoughts are real things, and that one cannot have one kind of mind and another kind of life.

# **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the *N.L.*

### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- **N.L. Committee -** The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

### **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
