
# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • Remind G.S.R.s to inform groups and individuals about the A.A. goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situa-
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

# Treasurer's Report

Greetings Area 35! I am happy to report I attended our last zonal forum for this rotation and I hope it was as enjoyable for those who attended from zone 3 as it was for me! They had the grill going and burgers ready when we pulled up. We had some information shared, questions answered, and trivia told. I was impressed by the turn-out (we had multiple GSRs present). I was also pleased with the participation and sharing of information. I hope to see these members again at the Winter Workshop. While we were at the forum, the question was asked: how much would it take for the General Service Office and Area 35 to be fully self-supporting. It's been awhile since I shared this information, so here you go! We would need each member of AA to contribute \$6.29 per year, or each registered group to send \$137.45 per year, or \$11.50 per month, to AAWS to cover the costs of services provided by the General Service Office.

Next, we would need the 8,735 individual AA members of Northern MN to contribute \$4.60 to Area 35 per year to cover costs of services provided; or, we would need the 577 registered groups in Northern MN to contribute \$69 per year, or \$5.76 per month, or \$1.33 a week to Area 35 to cover costs of services provided.

So, you can see that it is in each of our interests to encourage every individual member to take advantage of the birthday plan each year, and every registered group to contribute regularly, for in doing so we reduce the financial burden on everyone! There will always be some times, some groups, and some individuals that are not capable of contributing, but if we all work together by sending a little extra for those who can't, we would have no problem becoming fully self-supporting at GSO as well as Area 35. So please, share this with the groups and individuals in your districts. Please help by encouraging each group and each individual to engage in the birthday plan, where you share your gratitude to AA as a whole once a year by sending in an annual individual birthday contribution to Area 35 (perhaps of about \$4.60, the annual cost of services to members), or to GSO (perhaps of about \$6.29 per year to cover costs of those services). Encourage your groups to support the entities that make many of our available services better, and provide other services we couldn't provide for ourselves, by sending contributions of \$5.76 per month to Area 35, and \$11.50 per month to GSO.

I attended the West Central Regional Forum from September 9-11 in Davenport, Iowa. Attending this forum allowed me to interact with and hear presentations from many individuals. These individuals included: Ken B.- West Central Regional Trustee; Ward E.- Class A Trustee and Chairman of the General Service Board; Phyllis H. - General Manager, General Service Office; and Ami B. - AA Grapevine Inc., Executive Editor. # **Correction's Report**

Greetings Area 35,

It is hard to believe that we are at the end of another rotation and this will be my last report to the Northern Light as your Area 35 Corrections Chair. It truly has been an honor and a privilege to serve. When I look back over the last two years I am truly grateful for the opportunity I was given to be just a small part of what we do everyday in Alcoholics Anonymous, carrying the message of hope to the still suffering alcoholic. My duties have taken me into some of the prisons in northern Minnesota where I have met many individuals that have asked for our help. I was amongst hundreds of inmates as they walked through the Transitional Fair's collecting what information they could in order to "make it on the outside." Many times I heard stories from some of those inmates that brought tears to my eyes. I am grateful that Alcoholics Anonymous was there to help restore hope to those that asked by offering our literature, our contact program and most of all our program of recovery. I also had the privilege to meet some of the wardens and several of the prison staff that I corresponded with during my rotation. I often heard from them what a wonderful program Alcoholics Anonymous is. They have always treated us with the utmost respect and thanked us for the service that we do and continue to do in the prisons. I also had the opportunity to work together with Larry F. 
# **Inclement Weather Procedure For Area 35 Events**



# In Memoriam Dr. Robert H. S.

August 8, 1879 - November 16, 1950 **Co-founder of Alcoholics Anonymous** 

"My good friends in AA and of AA. I feel I would be very remiss if I didn't take this opportunity to welcome you here to Cleveland not only to this meeting but those that have already transpired. I hope very much that the presence of so many people and the words that you have heard will prove an inspiration to you - not only to you, but may you be able to impart that inspiration to the boys and girls back home who were not fortunate enough to be able to come. In other words, we hope that your visit here has been both enjoyable and profitable."

"I get a big thrill out of looking over a vast sea of faces like this with a feeling that possibly some small thing that I did a number of years ago, played an infinitely small part in making this meeting possible. I also get quite a thrill when I think that we all had the same problem. We all did the same things. We all get the same results in proportion to our zeal and enthusiasm and stick-to-itiveness. If you will pardon the injection of a personal note at this time, let me say that I have been in bed five of the last seven months and my strength hasn't returned as I would like, so my remarks of necessity will be very brief.

"But there are two or three things that flashed into my mind on which it would be fitting to lay a little emphasis; one is the simplicity of our Program. Let's not louse it all up with Freudian complexes and things that are interesting to the scientific mind, but have very little to do with our actual AA work. Our 12 Steps, when simmered down to the last, resolve themselves into the words love and service. We understand what love is and we understand what service is. So let's bear those two things in mind.

"Let us also remember to guard that erring member - the tongue, and if we must use it, let's use it with kindness and consideration and tolerance."

"And one more thing; none of us would be here today if somebody hadn't taken time to explain things to us, to give us a little pat on the back, to take us to a meeting or two, to have done numerous little kind and thoughtful acts in our behalf. So let us never get the degree of smug complacency so that we're not willing to extend or attempt to, that help which has been so beneficial to us, to our less fortunate brothers. Thank you very much."

The voting members are the current Officers, Committee Chairs, DCM's and last but not least the GSR's or ALT. GSR's, you are the biggest body of members in the room, and you could, and should be the main body to elect our next rotation of Officers. I thank you all willing to stand for the positions and for the willingness to serve Area 35. This is not my quote, but Area 35 rocks! If you don't mind, I would like to spend some time on topics for the G.S.O. The Grapevine, what else? The Grapevine will probably show declines in subscriptions and products as we move forward with upcoming strategies. Factors are the downward trends of the print publishing issue and the lack of new and expanded engagement through the web. The Grapevine has not yet activated the new engagement initiatives. Because of my health, I was not able to give delegate report backs. I am sorry for that. I asked in New York what the definition of engagement is, and someone said promotion.

Area 35 contributions to GSO have been on a steady decline over the last two years. The first year our treasury was almost deleted, and must thank every member of Area 35 for stepping up and contributing to give our Area 35 capitol to do service work for the area. It is my hope that this next rotation can do better encouraging GSO contribution. I think some groups and members just do not understand services provided by GSO. One of our past delegates pointed out also that it is imperative that officers get out to local groups and workshops to explain those benefits from contributing so members can ask questions and get answers. Area 35 was also asked to participate in 2011 Public Information Survey Questionnaire. Seven groups were selected and four were active, so I sent information to the four groups, and they sent it back. The information has been forwarded to the GSO. Before I close, I will tell you that at times I could feel tension on the conference floor. There seemed to be friction between the GSB, AAWS and Grapevine Board. I got up and said something seems to be broken around here and it should be fixed. One staff member got and said there is nothing broken and nothing to fix. When the agenda item concerning the two Grapevine Director vacancies came up, then the pot got hot. The Grapevine Board's nominating committee interviewed and recommended two nominees to the full Board. Their names and resumes of nominees were forwarded to the trustee's nominating committee for approval by the GSB and GSC. The Board voted "no" and GSC committee never brought it to the floor. I was a very unusual set of circumstances. I believe there is trouble in paradise. I guess I rattled on long enough. I wanted to keep this report short but what the hell, it is my last hoorah. It was suggested by the committee to have the newly appointed members of the committee sit in on the final review process of the rotation at the Area 35 Committee Meeting in December. We send special thank you to our current Area 35 Treasurer, Sara K. for doing an excellent job in her respective duties for Area 35. Also, thank you to the "Financial Oversight Committee" for the dedication of their time and effort for service to Area 35 and Alcoholics Anonymous. ASSEMBLY SIGHTS DISCUSSION

The concern is about smoking indoors during the Area 35 Assemblies. When we have the Area 35 Assemblies at Casinos you can smoke inside the facilities and this can cause AA members not to attend due to health issues with smoking. A suggestion was that Area 35 set a new policy about locating facilities with no smoking allowed indoors. Discussion: We will have to spend more money on the facilities if we go away from using casinos. One member felt that if some people have health issues due to cigarette smoke, we should respect them and chose facilities that are smoke free. One member pointed out that having them at casinos also can be an issue for AA members with gambling additions. The cost is much less if we have the Assemblies at Casinos. If we do not have Assemblies at casinos this could limit the possibilities to have assemblies in Zone I. The cost is 1/3 less when we have assemblies at casinos. The cost of the rooms at casinos is \$150 to \$500 while rooms not at casinos can run from \$1500 to \$2000. Some felt we shouldn't put a money issue above the members of AA. A suggestion was to change or add to the action we have taken in the past. The statement that there would be no smoking in the assembly room could be changed to stating there would be no smoking inside the rooms and a certain amount of feet outside the rooms. A suggestion was to make signs letting members of the Assembly know where they can smoke and cannot smoke.

The Area 35 Chair will take the information presented today and use it when selecting the location for the 2011 Spring Assembly. The incoming Area Chair can look at creating an ad hoc committee with the incoming DCMs to work on this issue.

### **DISTRICT 5 PROPOSALS**

### Proposal #1

We of District 5 would like Area 35 to consider reverting to the old way of conducting the business at the Spring Assembly for the General Service Conference Agenda items. This would means we would like to eliminate the breakout sessions on Agenda items and do them as a whole body with Area 35 voting procedures to be followed. REASONS:

- There was no action taken by Area 35 to change the process of the GSC Agenda items. This should not have happened, we feel that since there was no Action taken to go to the new procedure that it should never have been implemented.
- Breakout sessions are very disorganized and redundant.
- Agenda items for the GSC are very important for our Area. With the way the Area changed the procedure it is duplicating the efforts, chaotic and it allows for all in attendance to vote. We feel that GSR's take time to go through this process with their groups, bring the group conscience to the District, and then we as a District go through them so the DCM can carry the conscience of the District. By allowing anyone in attendance to vote, it is taking away from the "TRUE" group conscience. The voting members of the Assemblies are Area Officers, Area Committee Chairs, DCM's and GSR's and these are the only ones that should be voting on the GSC Agenda items.
- Yes, it may take a little bit longer, but a suggestion would be to have Reports, GSR Orientation, GSR & DCM Sharing Sessions then GSC Agenda items as a body. Old/ New business as always.

This is something that came out of the Area Inventory at the Fall Assembly 2010.

Discussion: In District 8 they took a vote and had 7 in favor of the proposal and 17 opposed with lengthy discussion. The Area 35 Delegate felt that the way we are doing agenda items is working. However, he feels we need to make sure that no matter what come out of the breakout sessions, people can still going to the microphone and discuss an agenda item when we meet as a whole. One area member felt that having the breakout sessions helps the area have a more in depth discussion on the agenda items. The purpose of the Spring Assembly is to give the Delegate as much information as we can for the General Service Conference. Currently, there is no policy as to how the Spring Assembly is run and this is usually up to the discretion of the Area 35 Chair. One member felt that we ask our DCMs and GSRs to get their group conscience and then they come to the Assembly and it does not matter because everyone can vote. Before we make a policy we should try going through the agenda items without the breakout sessions and straw vote to see what works better. One GSR felt that when we do straw votes on the agenda items it can take away the GSRs vote. One member felt that we do the breakout session to model what they do at the General Service Conference. Also, if the intent behind the agenda items is to give an idea of what the area feels then everyone should have the right to vote that is a member of Area 35. If this is the case then the role of the GSR is not to protect their vote but to be the one who shares the information gotten from your group with the rest of Area 35. More people are willing to voice their opinion in the breakout sessions than in front of the entire Assembly. If we take that away some people may not be willing to share and only the same people will share all of the time from the microphone. Read the Quarterly Reports from GSO so you know what may be coming as agenda items at the General Service Conference. The breakout sessions can give you a starting point for discussions know what they are suppose to

We of District 5 would like to have Area 35 consider adding a procedure for our Election year of Area Officers (which is the Fall Assembly of odd years). We would like to see all members willing to stand for Area Chair, Area Treasurer and Area Secretary to be nominated and names submitted for publication in the August edition of the Northern Light. We are not asking that any of the current procedure's to change, just to make an addition to what we have in place.

REASONS:

- Since members are being asked prior to the election, it would help Groups (GSR's) and Districts (DCM's) to vote a true Group Conscience.
- This would give all an opportunity to get to know more about those willing to serve....especially new GSR's and other service members.
- It may encourage more participation from our members as some may not feel comfortable enough to raise their hand and say "yes...pick me, I want to stand for that position" if they have an interest in a position and have not been asked to serve.
- This would give past members of Service a chance to be known by the body. Someone for example that took a reprieve from Service for a few years and now has the time to dedicate to a position.
- It was part of our Area Inventory done at the Fall Assembly 2010.

It may actually save time during the voting process at the Fall Assembly as Groups and Districts would know the Group Conscience.

<u>Discussion:</u> One member of the area agrees with this proposal since she is a new GSR and does not know anyone at the area. We would still accept nominations from the floor at the Fall Assembly. One concern was if we start posting nominations for Area Officers ahead of time, will they show up at the Fall Assembly. If you post just a list of names for people willing to serve and no information about the people, then you still may not know how to vote. If we put resumes in the Northern Light, which will take up a lot of room, then it can become an ego thing. District 8 was unanimously opposed to the proposal. The primary concern from District 8's was that it limited the number of people willing to serve, and decreased the amount of time people had to decide if they wanted to serve as an Area Officer.

The motion was called to question and seconded. The majority were in favor of calling to question.

A motion was made to add to the procedures of the elections of Area Officers to have Area Chair, Area Treasurer, and Area Secretary be nominated in advanced but also allow nominations from the floor. The motion was seconded. Four were in favor and the majority was opposed. The motion failed.

### ASK IT BASKET (Past Delegates)

Would you please explain the reason for asking for the minority opinion? If there is someone in the minority who has a new piece of information to add that was not already mentioned. When the information presented is able to change someone's vote, the body is asked if they want to revote on the question. If a majority want to revote and new vote can be taken. You can only have the minority once for each motion.

Is an assembly an open or closed meeting? The Assemblies are closed meetings because we use full names.

Are non-alcoholics allowed to go to the microphone? Since Assemblies are closed meeting and they are not allowed to be here they cannot go to the micro-

Should non-alcoholics be GSRs for AA groups? No, the GSR should be a member of the fellowship.

Should non-alcoholics attend district meetings, committee meetings, or assemblies? Assemblies, Committee Meetings, and District Meetings are closed meetings so non-alcoholics should not be attending. AA cannot give membership to addicts; however, they are welcome to attend open AA meetings.

Why would you keep coming back after you have served your time in AA general service? Many of the past Delegates do not look at it as serving your time but as a privilege to participate. We need to keep coming back because what we have is a daily reprieve contingent on the maintenance of our spiritual

What should you do if you know something about a person being nominated for a position that would make them a bad choice if elected? Pray for the individual.

What is your favorite memory serving as delegate? At the General Service Conference we were able to get out one night at a reasonable time. Some of us at the conference went and saw a play about Bill and Dr. Bob. The next day we went to Bill's house.

Why does one person get to go over the 4 minutes and others are asked to stop? It was voted at the committee meeting that DCM would get 2-3 minutes and Area Chairs and Officers would get 4 minutes. At the microphone there is no switch to turn it off when people go over their minutes like they do at the General Service Conference.

Why do you ask to stand when saying prayers and is holding hands necessary? It is a group's choice if they decide to do these things or not. This is also an individual's choice.

In our 3<sup>rd</sup> legacy voting procedures, is there a special purpose for the 5<sup>th</sup> ballot? # **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

# **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
