The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:


- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Area 35 2011 State Fair Report

Area 35 staffed the AA State Fair Booth on August 27 and August 28, 2011. Our area contributed \$500.00 to the total costs of this booth. I will report the total costs when I receive this information. I would like to again thank all of our 2011 State Fair Volunteers for your service. All booth volunteers filled out a shift survey, when they were not busy talking to visitors. This report is based upon their surveys. Please note that these surveys are only estimates of activity at our both.

The move of the AA booth from the Grandstand Building to the Education Building continues to be successful. Approximately 80,000 people passed by the booth during our two days (first weekend) of staffing. This informed a lot of folks that AA is still active in our state.

A large amount of AA literature was passed out at the booth (see attached Area 35 State Fair Survey Data). Our literature plays an important role in carrying our message.

The number of friends and families of still suffering alcoholics (51) and still suffering alcoholics (18) are greater than observed in 2010. These numbers also indicate that our message was carried to those who need to hear our message of hope and solution. Other booth visitors included: professionals, AA members, friends/family of AA members, young people and. Visitors included both females and males. Visitors included all age groups. The greatest numbers of visitors were 25-54 in age.

This suggests we were successful in carrying our message at the Minnesota State Fair. Our message was carried both directly to still suffering alcoholics and indirectly through friends/families of still suffering alcoholics. We also carried our message to other important sources of references such as professionals.

Area 35 State Fair Shift Data can be found on the second page of this report. These data is based on estimates provided by both volunteers

6. Districts contact their DCM in inclement weather for updates on cancellation.







I Can't do it

When I came to AA, I knew I couldn't stop drinking. At the first meeting, I really knew I couldn't do it. Not only did I know I couldn't stop drinking but that I wouldn't fit in. Some of the people around the tables seem to be so happy and confident in themselves. I was so scared to read as I am not a good reader. I was so scared to talk as I am not good at talking in front of people before coming to AA.

When I went to my first meeting, the person who was telling his story seemed to be so professional at it. That just reinforced my thinking that I couldn't do it. I kept going and I started to open at meetings. Then I was asked to be GSR for a new group after only three months of sobriety. I said I would try to do my best, and I did.

I remember having to give the DCM report at an AA assembly. This was maybe two months into my being a GSR. Charlie, Jerry, and JoAnn met me and they gave me the confidence to give the report. I can't thank them enough for that. I was asked to tell my story for the first time. I was physically sick for six days before. The night I told my story, I asked my higher power for help to tell my story in my own words and in my own way. I've been in service work after only three months of sobriety ever since. It has been the best thing I have ever done.

As of today, I still can't do it but with the help of my higher power and the fellowship in AA, I have done things I knew I couldn't do. Thank you to all who have helped me in my journey. It has been the best one I have ever been on.

Excerpts from <u>AA Comes of Age</u>

When Bill W. stepped to the podium in Kiel Auditorium, St. Louis, Missouri, at four o'clock Sunday afternoon, July 3, 1955, it was a watershed moment in the history of Alcoholics Anonymous. The three days of the 20th Anniversary International Convention that preceded that Sunday afternoon were themselves full of historic significance.

The fifth General Service Conference met during the Convention: 75 delegates from all over the U.S. and Canada, meeting with the trustees and General Service Office and Grapevine staff members. This meeting marked the end of the five-year trial period for the Conference. The members had already adopted the permanent charter when they assembled on the stage in Kiel Auditorium on Sunday.

"From today's perspective," recalls Nell Wing, Bill's longtime secretary, "it's hard for people to realize what a momentous decision was made that Sunday morning 30 years ago. It was dramatic and very moving to us who knew what an effort of Bill's this was, over a lot of opposition." Bill had pushed through the idea of a Conference largely by campaigning for it vigorously and personally...Now he offered the Fellowship an example of personal and organizational humility: relinquishing his own leadership in favor of an absolute democracy. In light of all these moves toward maturity and responsibility, Bill was justified in declaring A.A. was about to "Come of Age."

Then Bern Smith introduced Bill once again, most movingly, for the final summing-up. Likening Lois and himself to parents letting loose of their offspring so they may "come of age," he offered some fatherly words of admonition:

I have great faith that we shall never embrace and persist in a fatal error; and yet we still might do so, fallible human being that we are. This is the area in the future life of A.A. where we can never be too prudent or too vigilant. Let us not suppose, just because A.A. as a whole has never had a grievous problem, that it never can have one. If such a difficulty ever comes, I feel sure that it will center about false pride and anger, the two most destructive defects that we alcoholics have.

As a society we must never become so vain as to suppose that we have been the authors and inventors of a new religion. We will humbly reflect that each of A.A.'s principles, every one of them, has been borrowed from ancient sources. We shall remember that we are laymen, holding ourselves in readiness to co-operate with all men of good will, whatever their creed or nationality.

Then, too, it would be a product of false pride to believe that Alcoholics Anonymous is a cure all, even for alcoholism Here we must remember our debt to the men of medicine. Here we must be friendly and, above all, open-minded toward every new development in the medical or psychiatric art that promises to be helpful to sick people.

We should always be friendly to those in the fields of alcoholic research, rehabilitation, and education. We should endorse none especially but hold ourselves in readiness to co-operate so far as we can with them all. Let us constantly remind ourselves that the experts in religion are the clergymen; that the practice of medicine is for physicians; and that we, the recovered alcoholics, are their assistants.

Let us never be a closed corporation; let us never deny our experience for whatever it may be worth to the world around us. Let our individual members heed the call to every field of human endeavor. Let them carry the experience and spirit of A.A. into all these affairs, for whatever good they may accomplish. For not only has God saved us from alcoholism; the world has received us back into its citizenship. Yet believing in paradoxes as we do, we must still realize that the more the society of Alcoholics Anonymous as such tends to its own affairs and minds its own business, the greater will be our general influence, the less will be any opposition to us, and the wider will be the circle in which our fellowship will be likely to enjoy the confidence and respect of men.

There are certain areas where anger and contention could prove to be our undoing. We know this because stronger societies than our own have been undone. The whole modern world is in fact coming apart as never before because of political and religious strife; because men blindly pursue wealth, fame, and personal power regardless of the consequences to anyone, even to themselves. These are the destructive drives that are inevitably spurred by self-justification, and in all their disastrous collisions they are powered by righteous indignation, then by unreasoning anger, and finally by blind fury.

With the most heartfelt gratitude I can report that we have never yet had to endure any such trials by fire in A.A. In all these twenty marvelous years no such thing as religious or political dissention has touched us. Very few have tried to exploit A.A. for wealth or fame or personal power. We have had great problems, but they have always been resolved. Never has a grave issue cut across and scarred the face of this far-flung fellowship. But, again, this is no earned virtue of ours. Too many of us in our drinking days have suffered the terrible penalties of proud and angry pursuits to forget them now. These very pains have been the beginning of whatever wisdom we have since incorporated in A.A.'s Twelve Traditions. Hence, I feel confident that these forces of destruction will never rule among us. We are prepared to pay the price of peace. We will make every personal sacrifice necessary to insure the unity of Alcoholics Anonymous. We will do this because we have learned to love God and one another.

Then, rising to heights of inspiration and eloquence, Bill concluded with these words which would be so often quoted in the decades that followed:

We give thanks to our Heavenly Father who, through so many friends and through so many means and channels, has allowed us to construct this wonderful edifice of the Spirit in which we are now dwelling. It seems as though He has directed us to construct this cathedral whose foundations already rest upon the corners of the earth. On its great floor 200,000 of us are now sustained in peace, and long since we have inscribed thereon our Twelve Steps of Recovery. The older ones among us have seen the side walls of this cathedral going up, and one by one they have seen the buttresses of A.A. Tradition set in place to contain us in unity for so long as God may will it so. And now eager hearts and hands have lifted the spire of our cathedral into its place. That spire bears the name of Service. May it ever point straight upward toward God.

OFFICER REPORTS

DELEGATE-Jon C.- Report submitted and given by Heidi R.

To all members of Area 35, as I write the report, I continually work on our 36 principles of Alcoholics Anonymous, our singleness of purpose, and the named duties of Area 35. Since my stroke on June 3rd, I have a lot to learn. The first phases of alcoholism reads in the Big Book, find a sponsor, and go to meetings. We need unity and we need service, but I have come to understand without good recovery, unity and service will not exist. When one pretty much starts all over, this program is easy when we stick to our principles and our singleness of purpose. But, to me, when you add all the expensive garbage (videos, PSA's, pamphlets, and etc.) it confuses the hell out of me. Thank you all for your prayers, thoughtfulness, and patience. We are holding a 2011 membership survey. Seven groups in Area 35 have been chosen to participate. No substitutions can be used in the survey. I've mailed these questionnaires out on July 12th, and groups will be asked to complete them at a regular meeting between August 1st and August 14th. I need to receive the groups' surveys by September 1st to mail them to GSO. I would like to take some time to go over the 61st General Service Conference. We authorized the Grapevine to use digital channels, current support, and distribution technologies for the sale of magazines, books, and products. Request was also asked that all provisions take place to protect our traditions with the option to discontinue any and all contracts at any time. A point of note: a staff member expressed concerns that the conference is micromanaging and we should allow Phyllis and Ami the latitude and freedom to operate their entities. The Grapevine Board interviewed candidates for the two vacant directors. They came up with two names and were voted down, as Don Massey claimed that neither was qualified. Dorothy Hurley, in her farewell remarks, claimed unfairness between the Board and the two corporations, as well as claimed racism issues at the GSO level. Another point that has been brought up in Area 35, year after year, is when are going to get big print of AA Comes of Age. I spoke to Valerie in her office and at the conference and she showed me where it is on the books as an unfunded project. As I was talking to Valerie, Don M., our CFO came by and told me to buy the book online and I can make it any font size. After that comment, it doesn't look good. Valerie told me that the priority in publishing literature in ASL and more languages. Another item that many of you may not be aware of is that the copyrights for our 12 Concepts were not updated and is now a part of public domain. In literature, we discussed at length the pamphlet on spirituality. After all the discussions, the vote was 107 "For" and 11 "Against." I spoke in the minority. We were given the opportunity just prior to this discussion to take any piece of literature from the literature table. I never made it back to the table, but the only book left was the Spiritual Awakenings. I spoke out that a majority of this conference voted for this pamphlet yet this book was left on the table. Do we know what we have anymore? I don't believe so. If we carried our primary example of one drunk talking to another drunk, we would not have to concern ourselves with micromanaging. We are committed to making a Spanish PSA that will not be tracked or distributed for now. The agenda items on PSAs and videos using full faces are okay if we follow the new policies. This conference voted in favor, with 15 opposed, of having the archives be a standing committee. There are so many items that I have that may answer any of your questions. My brain cannot organize my thoughts very well, so please bear with me. I am sorry to have had these health problems, which prevented me from doing the job I want to do. Greetings Area 35! Glad to be here with you today. I have three reports on the back table for you to review. I'll start with the Income Statement. Our period to date (PTD) group contributions total \$4,137.69 in group contributions! Amazing. Our budgeted PTD income is \$5,557.47. We also received \$79 in PTD birth-day contributions-wonderful! Happy birthday to you all. Please review the Group Contributions Listing report for further information. Interest totaled \$5.33 bringing our total PTD income to \$4,222.02. Our PTD expenses total \$1,013.08. Our budgeted PTD expenses are \$2371.72. Please see the Detailed Expenditures report for more detailed information on this. Thus, Area 35 has a total of \$21,003.45 available for service (including the \$6,000.00 prudent reserve.) NORTHERN LIGHT PRIMARY PURPOSE:

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L.*
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the *N.L.*

EDITORIAL POSITION & N.L. COMMITTEE:

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- **N.L. Committee -** The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Twelve Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
