


#### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.


## **Inclement Weather Procedure For Area 35 Events**

#### **DELEGATE'S REPORT**

Greetings Members of Area 35,

I don't know if it is possible to adequately express my gratitude to serve this fellowship and to be a part of Area 35. It is truly a blessing. Of course the large activity that I had the privilege to be a part of since our Spring Assembly was the General Service Conference (GSC). I am blessed to be a part of an Area that is so active and informed about the issues that we face as a fellowship. I look forward to seeing all of you as I get out to districts to give my delegate's report.

Here are some pertinent facts that were passed along to me at the GSC. A full report of happenings will take place at district meetings when I give my report. I sincerely hope that you will make an attempt to attend one of these reports back as it truly gives your group a better understanding of what takes place at the board level and how this affects our fellowship as a whole. It also allows for open communication from the fellowship to the General Service Board and vice versa. A net total of 972 new A.A. groups in the U.S. and Canada were listed at G.S.O. last year. A web site redesign is in initial planning stages. G.S.O. had a net profit of \$817,900 for 2011 and total revenue was \$14,226,400. Gross margin from literature sales was \$9,538,800 and contributions accounted for \$6,264,500. It is apparent that we need to look at what it truly means to be self-supporting in our districts, areas, and as a fellowship as a whole.

Concerns around the Grapevine have been ongoing for some time and I am sure that their financial status will continue to be an area of focus for much of our fellowship. Some new initiatives taking place with the Grapevine, Inc. include 2 eBooks now available, *The Language of the Heart* and *Best of Bill*. Other facts include the fact that Grapevine ended 2011 with a net income of \$22,838 and is budgeted for approximately a \$34,000 net income for 2012. The GSC did pass the proposal put forth by the General Service Board to devise a plan to restructure the current A.A. World Services, Inc. and A.A. Grapevine, Inc., corporate and governance structures. This plan will be brought forth to next year's conference.

I want to thank those districts that have contacted me to set up their delegate reports and encourage all other DCM's to do so soon. I am truly looking forward to getting out to see you all and passing on the information and experience I have received.

WCRAASC 2012- Jim K reported on the West Central Regional Conference in Billings, Montana. 13-14 attended from Area 35. The final report from Dan B. stated that they lost money which amounted to \$1,225.16. Aside from that, it was an amazing event, there was lots of sharing that went on during the weekend. The total number of registered attendees was 348 plus 3 guests. Jim has a full set of tapes that were recorded during the event and if anyone would like to listen to them, he would be happy to share them. The West Central Region account is passed on. The next event will be held in Southern Minnesota at the Double-Tree Motel in Bloomington, MN. Money moves onto the next Area hosting the event. It was questioned how the \$1225.68 shortfall gets made up and if that amount is in fact in the prudent reserve? Would they need to increase registrations? Perhaps raise the price of coffee or the price of rooms? A speaker from the floor stated that there was a surplus after the West Central conference in Northern Minnesota and they may have used that surplus to make up the difference. At one time there was a snowstorm in Nebraska which cut the attendance down significantly. By getting the delegates with more experience involved, there is a lot of negotiating that goes on to set reasonable prices as well as let the guests stay in the free rooms and the planners pay for their rooms. The areas may have to come up with the money to make up the difference. Coffee is always very expensive and it's difficult not to take a hit in that department.

#### **ASK IT BASKET (PAST DELEGATES)**

#### 1) What do you do about Groups using Hazelden Literature for their meetings?

Answer by Jerry S, Panel 56 ... Each group is autonomous. We can remind them that it is best to use AA conference approved material at AA meetings and that Hazelden literature is not approved.

#### 2) Can GSR serve another 2 year term if no one is willing to serve?

Answer by Charlie C, Panel 54... In the Spirit of Rotation it is best to give everyone a turn. Once in my group it was time to rotate and we went through everyone in the group and then asked someone if they would do this again? Once you have been a Delegate, you can't serve again. The position might sit empty for a while, but eventually someone will step up.

Charlie also wanted to correct an answer that might have been misinterpreted at the 2012 Area Workshop and the question was "Is it right to put GLBT (Gay, Lesbian, Bi and Transgender) in your group name? AA is an inclusive group and it wouldn't be wise to place a title in your group name that would exclude an alcoholic from coming to the meeting. This would be the same with groups that single out women, Lutherans, policeman etc... AA should always be inclusive regardless of who we are. We come together with common problems and common solutions.

# 3) "LaVina is not self supporting but is widely read. I understand that each issue sent out is read by about 21 individuals on the average. Is its distribution US only or more widely? How can we make sure that this "LaVina" will continue to carry the message?"

Answer by Tim C, Panel 52...LaVina is not self supporting but is widely read. It is distributed in the United States only. How can we make sure it will carry the message? We voted to subsidize it in the spirit to carry the message. It is a good magazine which is widely read and passed around. It could end up across the border in Mexico, although Mexico has their own version of LaVina published too.

#### 4) "Why is the Grapevine so Good?"

Answer by Tom A, Panel 50... Tom stated concerns about the Grapevine. The process that has been taking place regarding the Grapevine doesn't seem to fit the way agenda items are usually presented to the larger body of AA. Normally agenda items need to be proposed by January 15th. This proposal didn't follow the normal course and it seems odd that such a monumental change brought forth in AA was not brought about in the normal and proper way. If you look at History and the Concepts, Bill W would say this is not a good idea. The process is questionable. Bill W's vision has historically been very accurate. But the ultimate authority is here at the Area Assembly. We in AA need to support the Grapevine, we need to subscribe to the Grapevine. We need to purchase the Grapevine literature and books that are for sale and give there as gifts to those we are sponsoring.

#### 5) "Do you need to be a past or present DCM to be on an Area Committee? If not, what are the qualifications?"

Answer by Susie A., Panel 48 - A chair position is usually acquired by attending area events and attending the meetings that discuss the topics you are interested in. By becoming involved on an Area and District level, you learn a lot. You can also go to the Area Chair that fills the positions and let them know what committee you would be interested in Chairing. But once you obtain an Area Committee Chair position, you would have to give up your district position as GSR or DCM.

And as far as the Grapevine question is concerned.... If the Grapevine were incorporated with the World Service Corporate Board of Alcoholics Anonymous, it would produce so much more confusion than there already is. All the Trustees would be on one board which would be very chaotic.

#### 6) "The Area is divided into 4 Zones - Why don't we use the Spirit of Rotation for Workshops and Assemblies anymore?"

Answer by Bob J., Panel 40... Area 35 is divided into 4 Zones. In the Spirit of Rotation for Workshops and Assemblies we do rotate the Workshops and Assemblies in each Zone. That way all members can get exposure for the Assembly in all the corners of the Northern Area of Northern Minnesota. Experience has shown that an Assembly can revitalize the Area in which it is held. Our rotations are in different parts of the area when it's an election year. If you want to know when and where the rotations are, take a look at the Area Action Booklets which are published every two years and you will see the rotation schedules. And as far as the Grapevine is concerned... these problems have been around for a long time. The level of subscriptions were low back in time. It hasn't changed and yes, there are problems. Maybe this should be slowed down a little. We shouldn't jump too quickly to change everything about the Grapevine. Other magazines are being affected in our economy these days. The general interest in magazines are dropping. We can look at ourselves and ask... Are we subscribing to the Grapevine? Are we writing articles for the Grapevine? If we really want to know what the problem is, we can look in a mirror.

#### 7) What is AA policy for signing of attendance forms for court ordered meeting attendees?

Answer by Jerry S., Panel 56...There is really no policy regarding signing court ordered forms. It is not a function of AA, but we do try to cooperate with the Professionals. Our group signs the forms at the end of the meetings, though.

#### 8) "Is there an efficient way to have GSR's and district committee chairs put in an effort to come to workshops or assemblies?"

Answer by Charlie C., Panel 54...Well, some Districts don't have a lot of money and groups have even less. Groups and Districts can share expenses by carpooling, paying one night each or dividing a room by the number of people staying in a room. Remember that we are a Spiritual entity that does business, not a business that does Spiritual Work. We need everyone's experience and opinions, minority opinions are just as important. No one is too little or new to offer what they have to the larger entity.

As far as the Grapevine goes, it's our magazine and it's our articles. We all need to participate with the Grapevine. In 1989 - 1990 the subscriptions to the Grapevine were 130,000. Today we have 2-3 million members and our Grapevine subscriptions are at 80,000. A huge difference. Scott J. stated that if we change the Grapevine, then we are also changing the concepts, the charter and the structure of AA. He is against any discussion to make a motion to change conference structure. We, the body of AA need to be heard.

# **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

#### **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
