


#### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.


#### **Inclement Weather Procedure For Area 35 Events**

#### TREASURER'S REPORT

The IRS tax snafu is still ongoing. The IRS sent me another notice requesting more information for processing the late return. The requested information was faxed to the IRS.

Since the Assembly, the IRS has assessed our delinquent return and assessed a penalty for being late in filing our 2010 990ez tax form. The penalty is \$1992.90. I have submitted a letter of explanation for our delinquency and asked for removal of the penalty. This is not a surprise. I am jumping through the hoops as they show up to correct the snafu.

Four years ago there were some misappropriations of area funds. An ad-hoc committee was formed to investigate the misappropriation. The committee's findings were that Beth owed \$2020.16 and there should be a finance oversight committee to audit the area's books. During 2010 Beth repaid \$1700 and she recently repaid another \$50 leaving an amends balance owed of \$270.16. Beth is continuing to make her payments.

I was able to attend District 6's service workshop in Cambridge on Saturday October 27. Unfortunately it was light in attendance. I believe everyone attending learned something. I certainly did. Thank you district 6!


The balance sheet shows the Area's Year to Date expenses as \$ 14,275.97 or 42% under budget. Our Group

I was also privileged to attend two meetings with parole and probation officers in Crow Wing County and Benton County with Larry F. and Mary M. from Area 36. This was a brief informational meeting with professionals in the corrections field. The more we can educate the professionals in Correction and Treatment programs in Minnesota about the Temporary Contact Program and what AA can and cannot do the better chance we have of reaching the still suffering alcoholic. Many of the probation and parole officers were not familiar with AA's programs and they expressed interest in what AA has to offer. If any District would like assistance in presenting to PO officers in your area, let us know.

The Rush City MCF Transition Fair will be held in April of 2013, the final date is yet to be set. The Moose Lake Transition Fair was held October 4<sup>th</sup>. Denny J. from District 13 and I manned a table for AA. Moose Lake did an excellent job at holding a Transition Fair. We received 31 requests for an outside AA volunteer and handed out request forms to many more inmates with discharge dates more than a year away. Denny and I were happy to meet several inmates that had attended AA meetings at the St Cloud Correctional Facility. Some interesting facts came from the presentation at lunch:

- 90% of offenders in MCFs are diagnosed as chemically dependent.
- CD treatment in MCFs reduced recidivism by 17 to 25 percent.
- Treatment most effective when continuity of care went from institution to community.
- 50% of inmates go untreated in prison and community.

The Fall assembly was one of the best I have attended. We need to thank Kelly for the great job she did putting it on. I received a lot of input from the District Chairs and others attending the breakout sessions. Just a reminder - if you need assistance from myself or the Area CPC Chair, we are available - let us know.

The St Cloud prison continues to need donations of Big Books and Daily Reflections. We go through almost a full case of each every month. Of late we have not had books to distribute. Being the intake unit for all of Minnesota we get ten to fifteen new attendees every week with most of them needing our books. If you can help out please email me at jeffleverson@yahoo.com. This problem is one that may be corrected by the implementation of the second suggestion mentioned below.

Our Area Chair, Kelly and Area 36 Chair Lisa are working to set up a standing committee for Corrections to solve several difficulties we have working with the State of Minnesota and with the DOC. There are 3 points I want people to consider and ask the committee to take action on:

- 1. The work of Corrections Committees deals with a state-wide population. We need a permanent joint Action Committee composed of Area Correction Chairs and non-rotating members of Area 35 and 36 to address state wide issues. Please support this suggestion by encouraging the Area Chairs to establish such a committee.
- 2. The cost of providing books and literature to MN Prisons has in Northern Minnesota fallen on the Local District. This practice is unfair and cannot be sustained. Area 36 has a separate fund for Corrections and I believe the simplest and best way to support our prisons is for Area 35 to establish a fund for this purpose.
- 3. There already exists a state wide data base for inmates requesting an outside AA volunteer to help them. The more times a request is passed along the more chance for error. It would be better if the request was passed directly to the District Corrections Chair in the District to where the inmate is being released.

This last point is probably the most important thing facing not only Corrections but all of Alcoholics Anonymous. There is a great need in most of our Districts for AA volunteers to carry the message of hope to suffering alcoholics. The biggest problem we face today is getting volunteers to bring meetings into jails and prisons and to become temporary contacts for inmates being released from correctional facilities. We have the blessing of belonging to an organization that saved our lives and it is hard to believe there are so few who are willing to share this gift with our still suffering brothers and sisters. I beg you, please go back to your local groups and recruit volunteers until we fill the needs of our jails, prisons and treatment centers. I know that the rewards they receive will be much greater than the fears they have of doing this type of 12<sup>th</sup> Step work.

Providing Information
Or
Extending an Invitation?

Having attended many, many AA service functions/meetings in my 30+ years of service, I have yet to attend one in which the comment is not made that "we need to get more people involved." In one form or another, that yearning is always expressed. And very often it also provides the 'reason' why a greater effort cannot be made by the group hosting the meeting.

Just to be clear about this – I have made the same comment many times in my service life, lamenting that we could have done more had we enjoyed greater participation.

Over the years I have pondered this question, trying to see how and where we could encourage more of our fellow AA's to get involved. It seems almost incomprehensible to me that they wouldn't want join in with those of us already here to carry out those wonderful plans we have. Surely they also want AA to grow by leaps and bounds.

A few years ago I found my answer. Interestingly it was during a meditation on the Third Step – turning my life and will over to the care of God, as I understand Him. Not exactly where I thought I would find that answer.

I realized that when we provide information about service opportunities, either on a bulletin board, website or flyer distributed at our groups meeting – we are in essence asking folks to turn their lives and will over to us. This is because they truly don't understand what is all involved – so to volunteer is really them acting on faith.

However, when we go to them and ask them personally – extending an invitation - that is a completely different matter. By extending that invitation we are asking that they join us in a journey. A journey that we believe will be both enlightening for us and productive for the still suffering alcoholic. Now that is something another person can get excited about!

Extending an invitation doesn't convey a "go there", or "follow me" attitude – it does far more that that. It indicates that we have faith in them, rather than expecting them to have faith in us. It acknowledges their dignity, rather than allowing for our own exaltation. It offers then fellowship, community and sharing – rather than demanding a sacrifice form them up front.

Thinking back on my own experience, I realize that every time I was willing to go out and truly extend an invitation I had little difficulty gathering the needed people to accomplish the task at hand. But when I tried to accomplish the same thing by merely providing information – they rarely came.

Reminds me of a story in another Big Book. There was a wedding and the father of the bride put out a lot of information about it – but everyone was too busy. So he went out into the street and extended a personal invitation to all the street people. They all attended and enjoyed the most wonderful and enormous feast of their lives.

#### **OFFICER REPORTS**

**Delegate-Jim K.** It is kind of crazy to think that we are closing in the halfway point of this 2-year rotation. If I have gained any insight during this time, it is that there is a lot of work to be done and there is always room for improvement in how we are working to carry the message to the alcoholic who still suffers. There is much to do to give back to this life saving fellowship and I thank you for the opportunity to serve in this capacity. I encourage all committee members and officers to continue to update your title descriptions and think about setting up a procedure to effectively pass information to the next person who rotates into the position. I realize that this is a long way off but this appears to be an area of difficulty much of the time and nothing prepares like preparation. I would like to start out by thanking each district that sends me there meeting minutes. It is truly a moving experience for me to hear about how different individuals and committees are working to carry the message to those who suffer. If I can be of assistance to any district, please let me know and I will do my utmost to serve in whatever way that I can. There is a great deal of information regarding our greater worldwide fellowship. Here is a list of items in no particular order. First of all, each DCM was sent copies of the final report from the 62nd GSC. If you have not received a copy of the final report, there are a number left for members and are available this weekend. I encourage you to look through reports as both a way to better understand what took place at the 62nd GSC as well as a tool to look at areas we need to address in the future. I again want to encourage groups and districts to consider bringing forth agenda items for the 63rd GSC. Proposals need to be received by January 2013 at the latest. The GSO is moving from a Defined Benefit Plan to a Defined Contribution plan for all new employees starting in 2013. This will help address the large amount of funds currently being spent to support past and current pension plans for employees. There will be a staff opening at the GSO as Valerie O'Neill, long time publications director, will be retiring at the end of the year. If you are interested in information regarding this position, please let me know and I will share with you the job duties and application process. Both the trustees' Committee on Public Information and Corrections are looking for a non trustee appointed committee member. If anyone would possibly be interested in either of these positions or if you know someone who might be, please let me know and I will get you a list of qualifications and information for the application process. Unaudited figures for 2012, through August, show contributions at \$3,710,194 and gross profit on literature sales at \$4,694,726. AAWS Board recently discussed that they are looking at 3rd party vendors to distribute eBooks rather than continuing with creating our own eBook applications and agreed to forward an agenda item to the 63rd GSC on the selling of eBooks through 3rd party vendors. The theme for the 63rd GSC will be the General Service Conference Takes its Inventory, Our Solution in Action. To assist in the inventory taking process, I will be handing out inventory questions to all DCM's at the December Committee Meeting to share with groups. Members will be encouraged to bring their thoughts to the Spring Assembly in April so that I can better care our Area 35 voice to the GSC. The West Central Regional Service Conference is set for March 1st-3rd in Rapid City South Dakota. There are fliers available this weekend and reservations can be made by calling 605-343-8550. Special room rates of \$73 are available until February 15th, 2013. This is a wonderful opportunity to gain a much better understanding of the background material to be covered at the 63rd GSC and network with other AA members from across our West Central Region I thank each of you for your continued work with our fellowship and me and appreciate this opportunity to serve as the Area 35 Dele-

Treasurer-Steve L. The tax snafu is still ongoing. The IRS sent me another notice requesting more information. The requested information was faxed to the IRS. 4 years ago there were some misappropriations of area funds. An ad-hoc committee was formed to investigate. The committee's findings were that Beth owed \$2020.16 and a finance oversight committee will audit the area's books. During 2010 Beth repaid \$1700 and she recently repaid another \$50 leaving an amends balance owed of \$270.16. Beth is continuing to make her payments. The Area's Year to Date expenses are \$14,275.97 or 42% under budget. Our Group Contributions are also under budget by \$10,450.25 or 29%. Our Assets are staying flat; we have neither excessive growth nor extreme loss of cash. Most groups do a terrific job about giving the correct information to receive proper credit for their contributions. They give the group's service number, the group's correct name and the group's district number on their contribution. Unfortunately some groups do not. If your group doesn't know its service number, they can obtain it from Sandy, our Group Records Secretary. The USPS will be stopping the address forwarding service soon so please use the new envelopes with the new correct address or go to our web site and get it.

Webmaster-Robert B. Our entire Web committee meeting was spent talking about AAMeetingLocator. We reactivated the adhoc committee. Dennis B. Area36 webmaster has been appointed the chair. Webmaster in area36 is a technical position and does not rotate every 2 year which will bring some Web experience, history with the locator, and past delegate experience. Other formats will follow. There is currently a discussion about a spiral bound Big Book with blank pages after each chapter for notes. The majority of the literature committee did not feel this was needed.

<u>District 13-Scott B.</u> We have a new secretary. Our PI and CPC chairs are still open. The Beginners meeting is looking for Big Books. That's always a good sign. Our AA assistance lines have all 24 shifts filled. Our Corrections is going well. Treatment put on a Workshop on Aug 9th at the St. Cloud Library. <u>Corrections-Jeff E.</u> Thank you for your 12th Step work in Correctional Facilities in MN. I was privileged to attend the GSO workshop - Bridging the Gap. It was a great workshop hosted by Area 36 and presented by the GSO and the Minnesota DOC. Also at the workshop were the District 8 and 13 Correction chairs and the Area CPC Chair. Thank you all for attending and also anyone I may have missed. I was also privileged to attend two meetings with parole and probation officers in Crow Wing County and Benton County with Larry F. and Mary M from Area 36. The more we can educate the professionals in Corrections and Treatment programs in Minnesota about the Temporary Contact Program the Better. Many of the probation and parole officers were not familiar with AA's programs and they expressed interest in what AA has to offer. The Rush City MCF Transition Fair will be held in April of 2013, the final date is yet to be set. The Moose Lake Transition Fair was held October 4th. Denny J from District 13 and I manned a table for AA. Moose Lake did an excellent job at holding a Transitional Fair. We received 31 requests for an outside AA volunteer and handed out request forms to many more inmates with discharge dates more than a year away. Denny and I were happy to meet several inmates that had attended the AA meeting at the St. Cloud Correctional Facility. Some interesting facts came from the presentation at lunch: 90% of offenders in MCFs diagnosed as chemically abusive or dependent, CD treatment in MCF's reduced recidivism by 17 to 25 percent. CD Treatment most effective when continuity of care went from institution to community, and 50% of inmates go untreated in prison and community. Area Chair, Kelly and Area 36 Chair Lisa, are working to set up a standing committee for Corrections to solve several difficulties we have working with the State of Minnesota and the DOC. There are two points I want people to consider and ask the committee to take action on: 1) The cost of providing books and literature to MN Prisons has in Northern Minnesota fallen on the local district. This practice is unfair and cannot be sustained. Area 36 has a separate fund for Corrections and I believe the simplest and best way to support our prisons is for Area 35 to establish a fund for this purpose. 2) There already exists a state wide data base for inmates requesting an outside AA volunteer to help them. I believe a better way is to bypass the Area 35 Corrections Chair when distributing the inmate name to the region where they will be released to. The Area chair can be notified and be responsible for follow up to be kept in the loop. This last point is probably the most important thing facing not only Corrections but all of Alcoholics Anonymous. There is a great need in most of our Districts for AA volunteers to carry the message of hope to suffering alcoholics. The biggest problem we face today is getting volunteers to bring meetings into jails and prisons and to become temporary contacts for inmates being release from correctional facilities. We have the blessing of belonging to an organization that saved our lives and it is hard to believe there are so few who are willing to share this gift with our still suffering brothers and sisters. Please go back to your local groups and recruit volunteers until we fill the needs of our jails, prisons and treatment centers. I know that the rewards they receive will be much greater than the fears they have of doing this type of 12th Step Work.

<u>District 8-Rolene L.</u> We have 30 to 40 in attendance at our District Meetings. There are 15 to 22 groups represented at our District Meeting. Our District has been going through some changes in officers. We've had many elections. I also did a group inventory for A New Foundation Group in International Falls, Unity and Communication are so important. Our District is discussing having a District Inventory. Inventories are a good thing. Helps us become aware of what is helpful in service and AA as a whole. Principles before personalities. October 20th is Area Treatment Workshop in Virginia, MN. #### **GSR SHARING SESSION REPORT**

**How do we get more GSRs involved?** Presentations to each group in a district led by DCM and other GSRs talking about how important GSRs are, what district does, etc. may give people information about the position. GSR orientation open house hosted by district for anyone who wants more information; another way to educate people about what a GSR does is to invite member to attend a district meeting; good attitudes are contagious. Forum workshops; encourage others to learn about service (not just about what GSRs do). Sponsorship is critical to service; without good sponsorship, service will suffer. Bring Alt GSR

to the assemblies and district meetings, encourage them to join action committees; this exposure will help get the next person up to speed when it's their turn as GSR. Make going to district meeting a fellowship event; then take information back to group—sometimes, though, groups aren't ready for making the decision

to be involved at district and doing service; you may need to start a new group to fulfill a need in the community (to replace groups that close or fill a service need); ask for volunteers to attend district and the new meetings that are service-oriented. Get involved in a smaller group-level service position first that requires less outside commitment (coffee-maker, meeting chair, greeter); take on responsibility gradually; groups should choose GSRs wisely—don't fill a seat just to fill it.

Being a GSR is a way of doing service—you have to help other people to stay sober. Sponsors can bring sponsees to district and home-group business meetings and volunteer them for positions that the sponsees are ready for; actively ask members to serve—when asked to become part of service structure, they may say yes (especially if they've been taught to say yes to any AA request). Set an example for others; go to district meetings yourself; when you go, observe, ask questions, get information; be an active participant. Groups can provide job descriptions of their available service positions and give those descriptions to newcomers; when the duties of a position are defined, it may ease the fear of taking on the obligation. Previous GSRs (immediate and past) need to be involved in training incoming GSRs; go with them to a district meeting and help explain what is happening, what to do.

What are Regional Forums all about? Representatives from New York as well eight other nearby states—from areas and districts near and far—gather to talk about the problems that AA members, groups, districts, and areas have (or have had) and then share how those problems were solved. Excellent opportunity to meet GSO (General Service Office) representatives—learn what they do and how much they care about individuals and groups; they do the job because they love AA and alcoholics; you can share your ESH (experience, strength, and hope) with the GSO representatives as well; fun and good fellowship.

How do you fill your (committee) positions at the district level? GSRs need to step up after their terms are up and volunteer for action chairs and officer positions. Again, service is mandatory to survive and thrive in sobriety; a good attitude is required; forget about being afraid—ask questions; get involved with someone else's concerns and you quickly forget your own; you don't need to know everything about a position to get involved. GSRs can invite members to attend the district meeting, announce open chair positions at general and business meetings; show interest in someone by directly ask someone to step-up for a particular position who you think would be good; ask people who have served at district in the past to share at group's general or business meeting about the positions they have held and the benefit they received as a result; spark that interest; again, enthusiasm is contagious. GSRs must attend the district meeting to get information about open positions, what the positions are about; without GSRs, groups may never know that district meetings are open to all members, that positions are available, etc. Getting GSRs to district meetings also allows them to be assigned to an action chair's committee; being on a committee helps the action chair share the workload; GSRs who serve on an action chair committee help prevent chair burnout, become more involved, and may prepare a GSR to learn about a district position and then naturally step up to it when the next rotation comes. Consider where the district meeting is held; attendance may rise if the meeting place is centrally located and no group has to drive a longer distance than any other group (consider a time change as well).

What can be done to help or encourage groups to follow the Traditions? A group can alter its format (eg, dedicate a meeting once a month) so that members may learn the Traditions; groups fail because they do not make the Traditions a concern; show members that the Traditions are important by regularly talking about them.

Learn about the Traditions from the district meeting by doing GSR work.

Groups have the right to fail; groups are autonomous; as outsiders, we can't tell a group what to do; we can't preach to other alcoholics ("no lectures to endure"). Become an active member of a troubled group; take a group conscience during a business meeting and ask whether the group follows the Traditions; do a once-a year-inventory using the 13 questions from the pamphlet "The AA Group". Sponsors can help us learn what the Traditions are and how to practice them in ALL of our affairs so that we can learn to work well with others. Be explicit when sharing that the month of the year corresponds with the Step and Tradition; use literature in your meetings that covers the Traditions in this way. *Daily Reflections* cover these principles in their literature using this correspondence between the Step/Tradition and month. *The Grapevine* is another good resource for learning the Traditions. Teach people that the Steps are about saving our lives from ourselves; the Traditions are about keeping others from killing us.

#### DCM SHARING SESSION REPORT - Heidi Reported:

We had thirteen DCMs and one Alternate DCM in attendance at the sharing session. We started the meeting by coming up with three questions for discussion. The first question was on how to we get GSRs involved in the district and area when they take the position. The second question was on how to get the focus back on AA service and the importance for sobriety. Finally, the third question was on how to explain to groups the intention of the money collected for the 7th Tradition. For question one a suggestion was to call GSRs if they miss a district meeting. If the GSR misses another meeting, go to the meeting and find out why. Districts members can also visit groups so they are getting a visit more often. When we speak at AA meetings talk about our experience with service, what service has done for our sobriety, and how we want AA to be there for future generations. Question two ended up being discussed during question one. With question three we had lots of discussion on what the money should be used for when we put in the basket for the 7th Tradition.

#### **OLD BUSINESS**

Financial Oversight Committee Report - The financial review committee met at the 2012 Fall Assembly, Saturday, Oct. 6, over lunch. After a thorough analysis of the Area's bank accounts and financial reports, we are pleased to announce that with reconciling a couple of discrepancies (inconsistent numbers), which we were able to do very quickly with Steve's help, the books are accurate and reflect the current Area 35 bank account balance of \$27,766.17. In detail: the first discrepancy involved \$4.15 in interest that was recorded in the bank's records, which didn't show up on the Area's treasury reports. It was verified that this had be remedied in the Area's accounts, but that the reports had been printed prior to this correction. The second discrepancy involved a \$0.50 data entry error pertaining to two action chair expense checks. This was also easily reconciled within the Area's records. The second matter of business the financial review committee addressed was balancing the prudent use of area funds to support the travel expenses of the committee members with the obligation to provide the best oversight of the Area's finances. On this issue, we discussed whether we should meet less frequently, and whether an alternative meeting format (computer) might work. The committee recognized that by meeting regularly (ever period/every area event) the financial review committee has been able to quickly and easily catch and reconcile errors in the books. This resolution would have been delayed, and could have caused more errors, if meetings were less frequent. Additionally, while it is recognized that the current treasurer is extremely adept in matters of finance, it is not certain that all future treasurers will possess this know-how, and they would benefit from frequent contact and oversight by the committee. Meeting face-to -face seemed to be the best and easiest option to ask questions and get changes made, and doesn't assume everyone has computer access. As such, per the previous discussion, we recommend that at this point the financial review committee continue regular and frequent face-to-face meetings when each period report is presented at all of the Area meetings (every area committee meeting and assemblies). We also recognize the authority of the body of Northern MN, Area 35, and encourage the members to continue to provide additional recommendations and guidance to the committee.

<u>Area 35/36 Workshop</u> - Kelly mentioned that she had the opportunity to meet with area 36 on July 21st. Lisa and Kelly set up a meeting for next year. Kelly is not sure who the next area chair will be as they start their new rotation. Out of the workshop came concerns about corrections and the AA meeting locator. **Area 35/36 will meet again on** July 20th, 2013 in St. Cloud. It will probably meet in the same place. Scott was a huge help with the combined workshop.

<u>January Workshop</u> - Jake presented his information regarding the General Service Workshop which will be held at Chase on the Lake in Walker, MN. The facility is very nice. Dave from District 21 will talk to the groups in the area and Jake is contacting groups and districts to present the workshops. Please bring friends and sponsees and new people to the Workshop.

<u>Area Assemblies 2013-2014</u> - Assemblies are arranged for the next two years. Kelly booked all the sights at very realistic prices for coffee and room rates - The Sawmill is booked in Grand Rapids Spring 2013 and Fall 2014. They arranged the reservations for the Area Assembly so that if everyone books their motel room at the Sawmill they will take the price for the meeting room off. So if you can, try to reserve your room at the Sawmill. The flyers are done and posted on the websites www.area35.org and you can download them and hand them out to your groups as soon as possible.

#### **NEW BUSINESS**

<u>Area 35 Inventory Committee</u> - Heidi R, Neil F and Sean D. will make up the Inventory Committee, review the results and bring a report back to the Area 35 Committee meeting in December.

#### 2013 Area Budget Approval -

After much discussion a motion was made to accept the 2013 Area 35 Budget which was submitted to the Assembly by Steve L. The motion passed.

#### Motion on travel & lodging responsibilities for Delegates report

Motion made requiring Area 35 to assume responsibility in paying for the travel and lodging expenses for the Delegate, Alternate Delegate, or for a member of Alcoholics Anonymous action on behalf of the Delegate or Alternate Delegate, related to the "Delegate's Report Back" to a district, but limiting the expense of the venue where the Delegate's Report Back is being hosted, the hosting District, except in circumstances where the Delegate or authorized party, by the Delegate deems necessary."

This was proposed at the August Aitkin Committee Meeting so the DCM's could go back to their Districts and ask their GSR's to ask their group what they think of this idea. It would become clearer when the Delegate comes out to a District. For instance, should the Area pay the Delegates expenses or should the District pay the Delegate's expenses. It's easier when the Delegate is from central areas of the area, but the next Delegate could come from the far NE or NW.... some Districts might not have the money in their treasury to pay the all the expenses if they drove a long way and perhaps needed lodging as well.

Opposing Views: AA members are putting money in the basket for service work. Some would hate to see the local AA groups and Districts become too dependent on the area. It is part of the Delegate's position description to go out to the Districts in Area 35 and talk about his or her experiences in New York. It's

the job of the DCM to go out and talk the 7th tradition to the groups and review with AA groups in their district where the contributions go and how they are used. Contributions to the Area come from the Groups, the Area Districts rarely send money to the Area. The question was called and put to vote:

2/3rds of the majority raised hands to cast the vote -

For the proposed motion: More than 2/3rds of the vote

Against the proposed motion: No count, but much less than the numbers of people who were for the motion. Motion carried

<u>District 14 and International Falls</u> - There was much discussion regarding issues around the fact that District 14 has gone dark. There is a group that elected to become a part of District 8 and have started to attend District 8's District meetings. There are AA groups meeting in the International Falls area that are not participating in District meetings. And there is a group in Effie that is on the edge of what used to be District 14. They could easily become part of District 16 if they wanted to. International Falls has 8 AA meetings, Effie has 1 and Nett Lake has 0. District 14 would like to become District 8 and dissolve the idea of District 14. 3 of the 8 meetings in International Falls are going to District 8's business meetings.

Motion made: to table this discussion so District 14 GSR's will discuss with their AA groups District 8 GSR's will discuss with their AA Groups and then discuss this at the Spring Assembly. A vote was taken and the motion did not pass by a majority show of hands at the Fall Assembly. Motion Failed

Motion made: to form a committee in Area 35 to look at our area map with the possibility creating new District lines and to bring a plan of action back to the Area Action Committee meeting in December. A vote was taken - A show of hands passed the motion - 48 individuals supported the motion, 5 opposed. Motion passed.

#### **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

#### **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
