


The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.


Inclement Weather Procedure For Area 35 Events

- 7. Post procedure in Northern Lights.
- 8. Chair remains available and in close contact as he or she is the focal point and main contact he or she must make the decision, and be available for calls.

AREA 35 & AREA 36 JOINT WORKSHOP JULY 21, 2012

Area Officer -The group came up with 6 topics and they are as follows:

Dealing with Ad-hoc requests through email - Officer's getting a lot of email and looking for feedback or suggestions on how to handle them – i.e. Info on where meetings are or I want to get my license back Suggestions from various officers:

If I get an email as the Area Secretary that I am not sure how to handle, I will send it to either the Delegate or the Area Chair but I make certain to copy all of the Officers so they know it's being addressed. We will also discuss during the monthly Officers meeting.

If it is sent to all Officers at one time, people may be responding differently. Was suggested that all officers are copied on the response as well.

Some will send the email to the DCM if it is a question related to a specific Group in a District. They will provide input if asked but try to use the guidelines rather than personal opinion.

One officer shared that she does not have her Officer email forwarded on to her personal email and finds this help-ful. She has to log onto the Area Email and concentrate on that and doesn't get distracted by personal email.

All agreed that it comes down to communication and coordination amongst the Officers.

Utilize new technology to get info passed on to others – More specifically utilizing web-cam/teleconference to connect with outstate to allow more voting members to participate in Area Assembly's.

The main topic was utilizing a "Skype" type product at the Area Assembly. This came from Area 36 who does

move the meetings around but still felt that if there was web access it would allow more to participate.

Area 35 has 4 Zones and they rotate Assembly's and workshops in the different zones. This allows people to drive to all parts of the Area and shares the burden of travel.

All agreed that using a teleconference/video meeting can be technically challenging and that this is a "futuristic" idea.

Website Management: Changes going to web site making it worse vs. better, People who are volunteers without technical skills, very little guidance on how to do it

There was a lot of discussion and everyone agreed that help is needed with the meeting locator

Suggestion to have both Area Officers work together to form an ad-hoc committee to reiterate the Statewide purpose of the AA meeting locator and also create a new non rotating committee to handle this.

Need to have consistency from Northern and Southern MN with regards to Corrections

There are inconsistencies with regards to the two Area's and what is provided to the Correctional Facilities

Discussion on the Pink Can Plan in Area 36 which is utilized to provide literature to the Correctional facilities.

Area 35 does not have the Pink Can Plan and does not agree with it as the money is designated for a specific purpose and Area 35 does not agree with this.

Area 36 Corrections contact has been working with some Area 35 Prisons/Jails and providing literature through the Pink Can Plan. This gives mixed messages about what AA can provide since Area 35 does not do this.

Suggestion to improve the constancy is to have a joint meeting every year with the Corrections Area Chair.

Need to define the baseline that both area's would agree too

Corrections, Website and Area Chairs meet and work together on this

Develop an ad-hoc committee to get a solution to this

How do we make it so newcomers can relate to us? How to make it simple and easy for Newcomers to General Service?

The older members of AA are talking about topics that a Newcomer wouldn't care about

Service shows a new person that there is a structure that is bigger than them and that they can grow towards

Things seem to be getting more complicated at workshops and Assembly's

We can't forget the newcomer and can't leave them behind

Providing literature and resources to Prisons - Pink Can Discussion

A group in Area 35 heard about a jail in their Area that needed Big Books so their Group bought a case of books and dropped them off.

When a job is too big for a District then the Area helps out

Need to have a consistent view of AA in MN from the perspective of State and County corrections

If Moose Lake needs Big Books, who is going to buy them? Why does Southern MN know about Moose Lake needing BB and N. MN doesn't know?

What needs to be done in order for Area 35 and 36 to be more consistent?

Work needs to be done in terms of communication through Area 35 and 36

Newsletter/Website/Group Records – Held a combined meeting

NL request – exchanging articles that may be pertinent to the whole State. Should the Area's receive each other's newsletters when they are mailed out?

Spent a lot of time on the Web – If you are on the Web and you find a meeting that is listed wrong on Google Maps, you can submit a request to Google to have it changed.

Discussed how the AA Locator is updated and the recommendation is to update every 2 months

Is it time to put Meeting locator in a maintenance mode? Should we get GSO to do this nationwide? Create a proposal to have GSO do this?

Web site Ad-hoc committee will be started back up again and make some recommendations on what should be changed.

If Area 36/35 are going to update is there any synergy on having common set up?

Literature/Grapevine - 4 items discussed

Agenda Item #14 – No background material will be brought until January

Don't have any background material but want to hear through the Delegate what Plan B is before January.

GSO promising that the Grapevine will not go away. 2225K readers but only 85K subscriptions.



Next was a problem check from a small town. The check stated a Wednesday night meeting with no service number, Group name nor phone number. There was no Wednesday night meeting listed for that town in the Area FNV data base. I could only find a Tuesday and a Thursday night meeting for that town. After some detective work I found a phone number to call. The gentleman to whom I spoke was very informative. He stated that this was the first time the Area had ever acknowledged that his group had sent a contribution and that the only way he knew the Area received their contribution was with the canceled check. He stated that his group didn't like to send contributions without getting a receipt. He would like to be able to bring some kind of acknowledgement to his group. His group is going to update its records and I will be sending a thank you. The last questionable contribution I received was a five dollar bill in an envelope. No service number, no group name, and no phone number. Again after clever detective work I found a phone number and called. The Lady I talked to wanted to give a little bit to AA because her daughter has been sober in AA for four years and she was grateful to us for giving her daughter back to her. I explained why we couldn't take the cash and sent it back to her.

I am in the process of sending Contribution Thank You letters. Currently I've received a total of 404 Contributions this year. So please have patience.

They give the group's service number, the group's correct name and the group's district number on their contribution. Unfortunately some groups do not. 

ARCHIVIST

Hello everyone. I have had some busy months.

I did a joint display with Area 36 at Gopher State Round Up in May. I presented at the District 9 Workshop in June in Hibbing. I attended and recorded both Area committee meetings in Aitkin. In August I used a new set up with a wired microphone. 4g phones have a stronger transmitter then the wireless microphone so they were causing reception problems. I attended the joint committee meeting in July in St. Cloud. I taped a Saint Cloud long-timer in July. I am continuing to catalog and develop a data base of the Archives collection. I had an article written for the last issue but forgot to send it then went on vacation and missed the deadline. The next display will be in Duluth for the Duluth Round-Up in September. I am also displaying at the Saint Cloud Round-Up in October and doing a joint display with Area 36 at Founders day in Saint Louis Park in November. We are planning a joint Archives workshop with Area 36 for 2013. I am bringing 8 speakers and 2 amplifiers to International Falls for Fall Assembly and have adaptors to plug into the house system in Detroit Lakes with-out noise. I hope I can get in on Friday night to set up because it is going to take some time.

Recent contributions to the Archives are a 1936 "Time" magazine with an article on the Stockbridge MA. Oxford Group House Party, a 50's vintage "The Wife of an Alcoholic" by Lewis Presnall, a 1945 book "Alcohol, Science and Society" with the talk Bill Wilson gave at the Yale School of Alcohol Studies that was reprinted in the "Three Talks to Medical Societies" pamphlet. In the Q and A section Bill talks about singleness of purpose. A 1913 book "The cure of Alcoholism" by Austin O'Malley and a 1967 book "the Use of LSD in Psychotherapy and Alcoholism" by Harold Abrahamson M.D.

The answer to the last history question is "the common Sense of Drinking" This issues history question is: On pages 138 and 139 who is the bank executive who is undoubtedly an alcoholic.

COOPERATION WITH THE PROFESSIONAL COMMUNITY (C.P.C.)

CPC- Cooperating with the Professional Community is a very important function in our Area. Many alcoholics come into contact with professionals prior to attending their first AA meeting or making contact with AA. Therefore it is critical to carrying our message that many different types of professionals are well informed about AA.

While the CPC function is important is appears to be one that often falls behind in priority to other more pressing Treatment, Corrections and Public Information tasks in our Districts. It is also my observation that the pool of AA members who are willing to work to carry our message and engage in service activities seems to be decreasing in size.

So what is the solution to the dilemma posited above? I believe that it is time for a **call to action** in our Area and in our districts. As your CPC Chair I am going to encourage, support and assist each District in completing one major CPC project before December 31, 2012. For example: A major District CPC activity could be having a number of AA members or home groups hand deliver information on AA to Family Practice and Internal Medicine Medical Doctor's offices. There are many different types of professionals in our Area and Districts that we need to reach.

I will also support and assist Districts in setting goals for the number of CPC projects they can complete in 2013. I have also made a decision that to accomplish this I will need to take action to contact PI/CPC Chairs and DCMs in our Area.

I attended the Area Committee Meeting in August and enjoyed a lively break out session at that meeting. I worked the Area 36/35 State Fair Booth on August 26 and held several constructive talks with local professionals. I was encouraged to see that Area 36 has adopted a "State Fair Shift Survey" that we worked on with Area 36 in the past rotation.

If we searched for a city in Minnesota the search returned a list of AA meetings in that city. The list displayed headers were not aligned with informa-Days of the week were displayed as numbers and not Mon, Tue, Wed, etc. Hours were in one column and minutes in another. i.e a meeting on Monday at 8:30 PM was displayed as 2830 Yes2 is Monday, hour is 8, minutes are 30, and Yes for yes this is a PM meeting. In "map" view the map of the city was displayed and meetings were flagged. Selecting the flag displayed the meeting information. If there is more than one meeting at the location only one meeting is displayed. On the search pages days of the week had to be displayed as numbers. Many fields on this page used confusing input data. When enter data in a format that the tool did not expect, the tool did print a good help message. If Mon was entered for meeting day on the search page the tool would return an error and the help message: Day From must be a number (with or without a decimal point) Using a decimal point confused the tool and results vary. The Advanced Search page should not be part of AAmeetinglocator. The search fields on the advanced search page have nothing to do with AA.As a newcomer in AA I would have loved to have this tool. This tool loaded with ways not to find an AA meeting. I could have used this tool and told my counselor that there were not meetings on Friday nights at the alano club. My counselor would have told me to find a better AA meeting list. As a professional software developer I feel that this tool is a good example for what can be done. In its present state I do not feel that this tool should be on the public WEB. AAmeetinglocator has an excellent future. Let's fix the user interface and display. Then we would be ready for a good WEB page. The database for AAmeetinglocator is GSO's FMV data base. AAmeetinglocator could support the entire US AA meetings and the database for all these meeting is already available. Every area web site probably maintains a separate database for the meeting on their WEB site. We could take all the effort it takes to keep up with their area meeting list and focus that effort on keeping the GSO FMV database up to date. During our breakout session we talked about activating and updating the AAmeetinglocator ad hoc committee to drive updates to AAmeetinglocator. Area36 WEB committee was going the head this up. - 3. How well is information regarding Agenda Items, Financial Reports, Archive Items and Grapevine materials being relayed to the Districts and Groups?
- 4. How well are Districts and Groups concerns, ideas and needs being addressed by the Delegate, Treasurer, Archivist and Grapevine Chairs?
- 5. Are the Action Committees doing enough to assist Districts in committee work?
- 6. Are we spending money prudently as an Area? Consider the following:
- Expenses
- Committee Work
- Communications (Northern Light, Mailings)
- Accommodations (Coffee, Room Rates at Assemblies, Workshops, Area Committee Meetings)

- 7. How well is information regarding Area Workshops, Group Records, Literature availability, and Public Information materials being relayed to the Districts and Groups?
- 8. How well are Districts and Group concerns, ideas, and needs being addressed by the Alternate Delegate, Group Records, Literature and PI Chair?
- 9. When Area decisions are made, is there the correct balance between group conscience and the "Right of Decision?" (Concept III)
- 10. Are Assemblies conducted expediently and effectively? Consider the following:
- Length of reports
- Saturday night Open Meeting or conducting business
- Taking a lunch break on Sunday or ending at noon
- 11. How well is information regarding Area Assemblies/Committee Meetings, Northern Light distribution, CPC materials and Treatment Facil ity needs being relayed to the Districts and the Groups?
- 12. How well are District and Group concerns, ideas and needs being addressed by the Area Chair, Northern Light Chair, CPC Chair and Treatment Chair?
- 13. Is adequate opportunity given to all to speak and participate in Area Assemblies, Workshops and activities?
- 14. Are Area Workshops worthwhile? How about the format?
- 15. How well is information regarding Area minutes, Web Page updates, Correctional Facility needs and Archives information being relayed to the Districts and Groups?
- 16. How well are District and Group concerns, ideas and needs being addressed by the Secretary, Webmaster, Corrections Chair and Archives Chair?
- 17. What other concerns do you have that are not addressed in this inventory?

It is important that we do all we can at any and every level of service in carrying the message. It is this Committee's hope that at this inventory, not only do we point out our deficiencies but also offer suggestion on how to improve our Area. We feel that a good Area inventory will be healthy for Area 35.

ADDITIONS TO THE AGENDA

District/Area Expenses in Regards to Delegate coming out to Speak – District 5 is proposing "Area 35 to assume responsibility in paying for the travel and lodging expenses for the Delegate, Alternate Delegate, or for a member of Alcoholics Anonymous acting on behalf of the Delegate or Alternate Delegate, related to the 'Delegate's Report Back' to a district, but limiting the expense of the venue where the Delegate's Report Back is being hosted, to the hosting District, except in circumstances where the Delegate or authorized party by the Delegate deems necessary." The intent of the proposal is so that the burden of financial responsibility falls on the Area 35 purse as a Delegate's Report Back is viewed as an essential accountability service. This proposal allows the Delegate to budget for providing this service, as well as spreads out the financial burden of such a service over the Area instead of a hosting District. Having enjoyed a Delegate from a nearly central location within Area 35, this is not a tremendous problem at present, but in the future, it could be a large financial burden on a District located in one extreme extents of the Area. For instance, if a future Delegate is elected from Ely and the District covering Moorhead would like a Delegate's Report Back, travel and lodging would need to be provided for and in this era of expensive gasoline and sometimes limited lodging options, these expenses could be considerable.

Area 35 has had a history of doing a fantastic job of meeting District requests for Area services, even covering expenses when a District could not, and it could be construed that this proposal is unnecessary in light of these informal arrangements, but this motion is meant to clarify the responsibilities of the service being requested as well as to give a clear understanding to both the Districts and Area 35 what to expect with a Delegate's Report Back.

Area 35 Inventory at Fall Assembly: Motion made by Heidi R. to do an Area Inventory at the Fall 2012 Assembly in International Falls for Area 35, Seconded by Jeff S. Discussion followed. Motion passed – 18 in favor/6 opposed. A list of the questions will be mass distributed to all DCM's by e-mail so all DCM's can run these questions by their Districts.

Expense reports/budgets will be needed by the October Fall Assembly for Treasurer to complete the 2013 Budget.

Steve L. asked the Area is he could purchase another printer for \$85.00. Jim made a motion to agree that he could buy a printer, Sandy seconded the motion, discussion followed. Motion Passed with 19 votes yes and 1 vote no.

NORTHERN LIGHT PRIMARY PURPOSE:

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Twelve Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
