

The Delegate's Duties				

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to


- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service
 meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.


Inclement Weather Procedure For Area 35 Events

- 6. Districts contact their DCM in inclement weather for updates on cancellation.
- 7. Post procedure in Northern Lights.
- 8. Chair remains available and in close contact as he or she is the focal point and main contact he or she must make the decision, and be available for calls.

Communication

Clarify the Roles of Area Chairs and Officers

The guidelines of the Area Officers and Committee Chairs are posted on the Area 35 website at www.area35.org. They are updated by the Area Officers and Committee Chairs and sent to the Area 35 Chair by June of the 2nd year of each rotation.

Procedures for Area Chairs and Area Officers visiting District's

Under the Area Officers and Area Chairs guidelines it states, when asked, for Delegate, Alternate Delegate and Chair. Be available for Web, Treasurer and Secretary. It states work with Districts for Treatment. The rest of the Chairs do not have anything listed on their guidelines for visiting Districts. There is no set procedure for this in place but if the Area would like the Officers to develop such procedures, a committee could be formed to do so.

Understanding what Area Chairs and Officers can do for Districts and Groups

This would be covered in the outline of duties for Area Officers and Chairs but if Districts and groups would like to see things added, they could offer suggestions to add to the Area Officers and Chairs duties.

Want to see more action taken to reach the dark districts in Area 35

On November 24, 2012 the Area Officers went to International Falls and held a meeting with groups in that District to offer our help to get their District up and running again. A positive outcome was that there are individuals that are willing to do this and will be starting their District again in the near future. Officers are available at any time to help them with this process. Area Officers may consider setting up a meeting for District 17 as well to address needs in the District.

Passing on information from outgoing Chairs/Officers to incoming Chairs/Officers

This is part of the Area 35 Officers and Chairs guidelines that are posted on the Area 35 Website. When researching their guidelines it was found that not all serving on the Area in positions had this in their guidelines. We will need to add it to Group Records, Literature, Grapevine and Northern Light.

Want to see more Archives Material

We can have more displayed at our Area 35 Assemblies, sometimes space available for this can be an issue. Request can be made to Brad our Area 35 Archivist to bring items to various Area 35 events.

Getting more involvement from District and Groups

This was one of the main purposes of the Zonal Forums. If there are other suggestions as well, the Area officers would be open to them.

WCRAASC attendance and expectation for Area Chairs and Area Officers

Attendance at Conferences (WCRAASC) are listed on the Area 35 Chairs and Area Officers guidelines and posted on our Area 35 Website. This may be a topic that is worth adding to the January Workshop or Committee Meeting in the future to get the Area view on who should attend.

Updating Websites

Updating AAmeetinglocator.org (user friendly, easy access to meetings)

The Area 35 and Area 36 Chairs met on this issue in 2012. The result is that the Adhoc Committee will be meeting again from both Areas to work on this. This is an ongoing process and the committee has begun to visit and provide direction in this area. This has been added to the Area 35 Agenda's for ongoing updates.

Updating Area 35.org (user friendly, easy access to meetings)

This is an ongoing process that deserves regular consideration. Current Webmaster has done an excellent job but needs to insure the future Webmasters have the same knowledge base.

Procedures

How and when to order Literature

The Area may benefit from doing a better job of passing information on to the groups regarding literature ordering. Current Chairs have been doing a lot of ordering for groups which is not necessarily a part of their duties. News from GSO indicates that online ordering may be available in the relatively near future. Once online ordering is available, minimum order for "Free Shipping" will be \$500.00

Area Officer, Area Chair and DCM reports (purpose and time)

Page S39 of our AA service manual states (Typical Non-Election Assembly) The Agenda for a regular assembly might be something like the following:

A moment of silence followed by the Serenity Prayer.

Chairperson's report on committee activities since the last meeting.

Delegates' Conference report or recent communications from GSO.

Secretary's Report.

Treasurer's report (usually a good time to remind everyone of the leaflet, Self-Support: Where Money and Spirituality Mix, a useful guide for helping each group decide how to plan its regular contributions to AA services).

Report from chairs of special committees, correctional facilities, treatment facilities, public information, cooperation with the professional community, Grapevine, literature, convention, etc. District reports from committee members-on district meetings, district problems, growth etc. The purpose of the reports is to let the members know what activities Officers and Chairs have been doing for the Area. A DCM report let the members know about what is happening in each District and provides an opportunity to share with others things that are working well or not working well in each District. Area Officers and Chairs are allowed 4 minutes and DCM's are allowed 3 minutes for their reports. We may benefit from better timing each report to insure that they stay within set time limits.

Literature and Grapevine Inventory and procedures for ordering literature from the Area

The Grapevine and Literature Chair should be able to provide an inventory of items in stock on an ongoing basis. The current Literature Chair has provided a service of ordering literature for groups

but this is not necessarily the purpose of this position.

Understanding and following Robert's Rules of Order. Have a workshop or presentation on Roberts Rules of Order and how they apply to Area 35

This is a fine suggestion and may be worthwhile to have a presentation at our January Workshop on new Chair years to insure understanding of incoming Chair and Area members.

Agenda Items

Using a Straw Vote or Binding Vote (DCM'S, Area Officers, Area Chairs, and GSR's) on Agenda Item at the Spring Assembly

This has been the current practice that has taken place at the past number of Spring Assemblies. If this practice should be changed so that only voting members of the Assembly should be allowed to vote on agenda items, a motion should be made at either the Area Committee Meeting or Assembly and voted upon for a change to be made.

Having breakout sessions on the Agenda Items or only going through Agenda as an Assembly

Current procedures have allowed for current Delegate to discuss this with the Area Chair to set Agenda for Spring Assembly. The decision to go to breakout sessions was to increase time efficiency and allow members to share in a smaller venue. It also allows for the breakout session Chair to report back to the body what the session came up with for each item. If there is a wish to go to a whole group rather than a breakout session format, this should be brought up and a motion made at either the Committee Meeting or Area Assembly.

Distributing Agenda Item background information

The process was reviewed at the December Committee Meeting and it is suggested that it be reviewed by Delegates in the future to insure DCM's understand the process and get appropriate back ground material at the December Committee Meetings. (Delegate does not receive the Agenda Items no earlier than February 15th)

Area Finances

Emailing Treasury Reports

Treasury reports are available at all Area committee Meetings and Assemblies. Emailing these out to Area Officers, Chairs, and DCM's after each meeting could be done. A list of past Officers can be made also.

Presentation and/or report on budgets

This could be added to a committee Meeting or Area Assembly per bodies request if they thought it would be beneficial. It may be somewhat time consuming for such an event but perhaps Officers and Chairs could provide a brief description of what they would like to do during the upcoming year in the Northern Light reports to allow members to see what activities they plan on doing as the Chair or officer.

Financial Oversite Committee reviewing the Areas spending (prudent?)

This has been a topic that the Oversite Committee has reviewed and just gave direction on at the past December Committee Meeting (reducing the number of times they meet, not to include Assemblies) Does the Area body want the Oversite Committee to review the spending of the Area as part of their duties?

Northern Light hard copy expenses

There is a draft report in the Northern Light on this. Perhaps an overview of yearly expenses of the Northern Light could be included in the Northern Light editors report at the end of the each year of their rotation.

Meetings

Area Assemblies (length of time format/agenda) Currently the Area Chair has the duty to set the Agenda for each event. If topics should be added, any member can request to bring something up. For efficiency purposes, it is the current practice to have the Chair set the Agenda. Members can provide suggestions on evaluation forms.

Purpose and direction of Zonal Forums

The brief purpose of the Zonal Forums is to provide a venue for local members contained within a zone to meet the Area Officers and see what activities they currently do and to see what other activities they could do to serve Districts. They also allow an opportunity for members to see how the Area functions without going to an Area Committee Meeting or Assembly. The basic function is to act as an outreach on a more local level.

Purpose and direction of Action Committee Chair workshops

Workshops are not listed on any of the Area 35 Committee Chair guidelines. Area Chair Workshops are activities that each committee Chair has the opportunity to do to carry the message in their perspective area. There is no set procedure in place that directs Chairs to either hold or not hold Workshops. These activities should be left to the discretion of the respective Chairs and reflected in their yearly budget.

Year End 2012 Area35 Northern Light Treasurer Report


Great Job Area 35! The balance sheet shows the Area's Year to Date Income to be \$34,134.90. Group Contributions for the year were \$27,307.79 under budget by \$15,202.21 or 36%. Area's Year to Date expenses were \$30,054.88 or 42% under budget. So, we increased our overall cash assets by \$4,080.02 so we have neither excessive growth nor extreme expenditures. The tax snafu is over (HOORAY!). The IRS sent me a letter stating the \$1,992.90 due for penalty, late fees and interest was adjusted and reduced down to nothing owed (ZERO!).

I attended the 2013 Area workshop in Walker. The presentations were very informative. I thought all the presenters did a bag up job doing the research and back ground information needed to give an informative presentation, not just read out of a book. Expenses were minimal; coffee was the only major trouble spot. The problem was professionally handled by the District 21 host volunteers. I want to thank the District 21 volunteers. They did a beautiful job in making the workshop a smooth success.

Most groups do a terrific job about giving the correct information to receive proper credit for their group contributions. They give the group's service number, the group's correct name and the group's district number on their contribution. Unfortunately some groups do not. Facelift: www.area35.org:

Our WEB site had a facelift. Have your seen it? I'm still running spell check on all the files and fixing the typos. A bug was discovered using IE version 7. Working with Neil F., DCM district 7, we were able to fix the bug within 30 minutes. The calendar on our WEB is a big challenge. The current software is so outdated it cannot be updated. New software will require all calendar events to be re-entered. We have 208 event schedules in 2013. Events are being added weekly.

District WEB Pages:

Each District in area 35 has a district WEB page on www.area35.org. Take advantage of your district page. Let me know what you would like on your pages and I will make it happen.

Moving Forward: Area 41, Nebraska, has meeting mapping software. They were willing to share and I have a copy of their software. I have converted what they had to our WEB site. This software was not complete. The database end was missing. Area 41 took the data from GSO database and seeded a MySql database. They did this over a year ago and have not updated their records or their mapping software database. No software was written to update their database when group information changes. I am working on a design that will seed our database and allow updating all from our FMV database. Work continues and I expect to have this finished sometime this year.

AA Meeting Locator Ad-Hoc Committee Report January 15, 2012

Is it time for AA to have a North America Meeting Locator? Today I use my cell phone to find restaurants, auto repair, hotels, and even pet kennels. All I have to do is ask my cell phone to find pet kennels and it will find and map local pet kennels. To stay sober I need to attend AA meetings. Technology is to the point that I should be able to ask my cell phone to find AA meetings and I should have a map to the local AA meetings or AA meetings anywhere in North America. GSO has a database of all our AA meetings. GSO prints meeting directories. I can read the Big Book on my cell phone. Its time for GSO to listen to our needs and get our meetings on the map! On December 29th our AA Meeting Locator Ad-Hoc committee meeting finally met. We learned that GSO is not interested in taking on a project the size of AA Meeting Locator and refuses to even look into a project of this size. Per www.AA.org under How to find AA meetings GSO writes "This Web site does not provide A.A. meeting information directly. For meeting information, contact a local A.A. resource that provides this information" As a committee we felt that a meeting locator would be an excellent tool for GSO to directly help the individual AA member and AA as a whole.

We discussed redoing Minnesota Meeting Locator. After much discussion we determined that the size of this project is beyond the scope of 2 year web volunteers and should be designed and maintained by a professional web design company. We came up with a list of requirements and will solicit bids for a professional Minnesota AA meeting locator. Our committee is also pursuing other members of the West Central Region to include them in an expanded West Central Region meeting locator.

What about our current AA Meeting Locator. The company that hosts and maintains www.aameetinglocator.org was not invited to our meeting. The owner of the company that supports aameetinglocaotr.org needs direction and we are not providing that direction. Area 35s access to aameetinglocaor.org is through area 36. For the past year and since the demonstration of aameetinglocotor.org in July, no effort has been made to fix our current joint effort web site. I have learned that the day/ date formatting issues are beyond the technical capabilities of the hosting/ support company. The advanced search page that allowed searches for family members plus other non AA related items has finally been removed. Only one meeting shows up per map location. It is still my opinion that area 35 should stop supporting the web site aameetinglocator.org. The site should be taken down and visitors redirected to sites where they would be able to find AA meetings. Your input on the current AA meeting locator at our next assembly in April.

Our next Ad-Hoc Meeting Locator Committee meeting is scheduled to be held at the West Central Regional Alcoholics Anonymous Service Conference (WCRAASC). This would allow other areas to participate in a meeting locator discussion. Our delegates have decided not to add new sessions to the WCRAASC. If our Ad-Hoc Committee meets at the WCRAASC it will not be a WCRAASC scheduled meeting. I have a work scheduling conflict and will not be able to attend the WCRAASC.

The Great Debate and the Future of A.A.

By Bill W., General Service Conference, 1954

This is the closing hour of the Conference, one of the greatest hours that I have ever lived because, I believe, it marks the date when this Society has really gone on its own, and will become forever saved from any or all power that may threaten it.

Each Conference has its own distinct personality and achievement. More than any other, this Conference, I believe, had confidence. More than any other, it envisioned its responsibility now and for all time to come. Confidence and responsibility have become the keynotes.

As recently as six or eight years ago, my own confidence in our destiny was terribly shaken. Among us there had arisen a terrible risk. Like all of the risks and struggles in A .A., however, this was concerned with the universal question:

"What is best for A.A.?" The debate was about whether or not we would have a Conference. Back in those days the Traditions had taken form and had just been put on paper, but there still remained this terrific question of how to guarantee our overall function, how to create a structure that could withstand power drivers and ravages of time and of adverse circumstance.

So I took the problem to the Trustees of The Alcoholic Foundation, the board of A.A. members and friends of A.A. that we had put together in 1938. We were sitting there as an incorporated board, providing service that would enable this Society to hold together to carry its message; and we still assume the right to be the guarantors and guardians of its tradition and general welfare. We had aggregated a self—assumed authority, and quite properly during the infancy of the movement. We had aggregated the authority to print the literature, to help resolve group problems, to be answerable to the public, to administer your funds, to provide your mirror of A.A. life in a monthly magazine. All of this authority we had simply assumed and by common consent in 1945 the movement was only too glad to have us do this job.

But the day might come when a great blunder would be made; when there might be a great scandal, when there might be a great religious or political division. And the day might come when from sheer remoteness and lack of interest or understanding, the support of this overall function might melt away. Moreover, the movement, out in the group and area level, had begun to say that they wished to take their affairs into their own hands, even as men

coming of age.

So the debate turned on how A.A. as a whole could take its affairs into its own hands and be secure. How could Service Headquarters and the Board of Trustees, custodians of the vital authority the movement had delegated, and with demonstrated capacity to perform movement-wide services - how could they be linked to the movement and to the world outside? When I began to appreciate how little real linkage there was, I get scared to death. I went to my friends the Trustees and said: "There has to be a hook—up. This movement has now grown to the point where there must be some means by which it can look after its own affairs, if it wants to. And even if it doesn't want to, it is entitled to a look."

Well, my old friends said to me what many an old—timer around A.A. still says: "Let's keep it simple." To me, the real issue was: should we keep it simple by getting you people in here to see that it lasted, or would we make it complicated by keeping it so simple that it would break apart. The result of this debate, which lasted until late 1950, was the Third Legacy Program, in which the General Service Conference is the vital force.

To overcome the objection that there would be terrible politics in the selection of Conference Delegates at the grass roots, we had to go in for a species of political invention. We had to eliminate hotly contested elections that leave behind hostile minorities. And we had to do away with personal nominations from the floor. The final process did just that. It was the process that got you here feeling like servants, not senators — and without leaving much, if any, hostility behind you.

Then came another question: How would the Delegates be related to the Board of Trustees who already had legal rights, who possessed responsibility for our public relations, who had title to our publications and who served as custodians of A.A. funds? Legally, what power could the Conference exercise over all these things? What influence could you have upon the selection of future A.A. Trustees themselves?

The answer is that, legally, the Conference could not take away the authority granted to the Trustees, if the Trustees chose to hold on to it. But, as you know, the Trustees have wisely consented to make themselves amenable to the desires of the Conference. They said, and rightly: "Let us keep the legal form of the things we need to transact business. But let us, on any two-thirds vote of this Conference, in which we also participate, be traditionally under a mandate from this Conference. Let us be part of this Conference, but a minority, and let us hereafter, when we name successors to A.A. Trustees, submit such names to a committee of the Conference. And when an out-of-town A.A. Trustee is sought, let us make appropriate inquiries within A.A. in the region under consideration."

And thus, in general principle, there came into being the structure of the Third Legacy. Today in the last hour of the time of this experiment, I share with you the promise of its certain success and am more moved than at almost any time in my A.A. life. The moment of the transfer of authority to serve, from us old-timers to the movement, is at hand and will be certified, let us trust, in 1955.

We have had under construction all these nearly 20 years a way of life, which we might say is housed in the A.A. Cathedral of Spirit. Standing on its floor are 120,000 who stand in safety because the Twelve Steps, the principles on which we stand and by which we live, are inscribed thereon. And this floor is of ever—expanding, illimitable dimensions. Four years ago in Cleveland, with the validation of the Twelve Traditions, we realized that we had placed 12 wonderful buttresses as insurance that the great walls of the Cathedral would not fall. Now we are at work on the final construction, the spire of our Cathedral of service, wherein shines the beacon light to those who are still in the dark. The work on the spire is not yet complete, but our confidence is that it will shine throughout the world, touching the most distant beachhead, for so long as God wants it.

On Cultivating Tolerance By Dr. Bob S.

During nine years in AA, I have observed that those who follow the Alcoholics Anonymous program with the greatest earnestness and zeal not only maintain sobriety but often acquire finer characteristics and attitudes as well. One of these is tolerance. Tolerance expresses itself in a variety of ways: in kindness and consideration toward the man or woman who is just beginning the march along the spiritual path; in the understanding of those who perhaps have been less fortunate in education advantages; and in sympathy toward those whose religious ideas may seem to be at great variance with our own.

I am reminded in this connection of the picture of a hub with its radiating spokes. We all start at the outer circumference and approach our destination by one of many routes. To say that one spoke is much better than all the other spokes is true only in the sense of its being best suited to you as an individual. Human nature is such that without some degree of tolerance, each one of us might be inclined to believe that we have found the best or perhaps the shortest spoke. Without some tolerance, we might tend to become a bit smug or superior - which, of course, is not helpful to the person we are trying to help and may be quite painful or obnoxious to others. No one of us wishes to do anything that might act as a deterrent to the advancement of another - and a patronizing attitude can readily slow up this process.

Tolerance furnishes, as a by-product, a greater freedom from the tendency to cling to preconceived ideas and stubbornly adhered-to opinions. In other words, it often promotes an open-mindedness that is vastly important - is, in fact, a prerequisite to the successful termination of any line of search, whether it be scientific or spiritual.

These, then, are a few of the reasons why an attempt to acquire tolerance should be made by each one of us.

Delegate - Jim K: Greetings, Area 35. It is overwhelming to think that it has been nearly a year since I began serving as your Area Delegate. It has been a true pleasure and has flown by. I assume that the next year will fly by as well which means there is a lot of work to do in a short period of time. As a follow up to the Fall Assembly, I attended a meeting with the other area officers in International Falls to discuss how we can best serve our primary purpose in the geographical area of District 14. There was great participation by those who attended and it was a truly inspiring experience to be a part of. Based on the overall feedback from the attending group, the local members decided to make an effort to revitalize the District 14 service structure. A follow up date is to be determined by the local groups to meet again and discuss the best way to move forward with elections. This year's WCRSC will be held in Rapid City, South Dakota March 1st through March 3rd. Webmaster - Robert (Bob) B: I added all the district meetings to the area35 calendar for 2013. I am still working on District 8. I have backup software to replace our calendar software should the software we are using becomes outdated. I started looking at mapping software to see what it might take to map our meetings. I did district 7 by hand one meeting at a time. This works for a small number of meetings. I have used this map times. I found serenity in the pines in the fog by driving to the dot on the map on my iphone. I took a class in PHP and MYSQL. I wrote some demo code. I can take our FNV database, pull the records out, and move selected fields to a MYSQL database. I was able to get the address query a geodatabase and add the longitude and latitude to the records. Area41, Nebraska, is using their FNV database to seed their meeting locator and create maps. I have been in contact with area41 and they are willing to share their software. I should have a copy of their software in January. Our WEB site is centered around service work. The public is not divided into northern and southern Minnesota. Do we need and entry WEB pages for AA New Comers, Professionals, The general Public, Corrections, and others? Should we have a page to new comers that explains to the new comer how to find AA meetings in Northern Minnesota, how to contact and talk to someone in AA and direct them to aa.org for additional information? The same could be done for other professional in the public sector.

Archives - Antonette F: I attended the Assembly in International Falls. Again, another learning experience. The Discussions about AA as a whole and each District is invaluable information to know. I had the opportunity to attend a meeting in Ely. AA is alive and well up north. They expressed some interest in service involvement. One year down... one year to go. We decided that volunteers should read the pamphlet "Speaking at Non-AA Meetings" and "Information on AA."

We had 7 Districts represented with 2 new chairs present: Tammy from Dist 12 and Barb from Dist 21. Welcome to both of you. Dist 5 - Jack has 2 facilities that he covers with the assistance from southern MN. He provides speakers and directories for both - Riverplace-3rd Thursday and New Beginnings - 4th Thursday. Thus, the ending balance on the balance sheet of \$25,609.10 is the accurate amount of assets possessed by Area 35. We continue to commend Steve on his dedication, hard work, and diligence. He does a wonderful job. Additionally, the committee discussed our desire to fulfill our responsibility to ensure the accuracy of the area's finances in the most cost effective manner possible. The YTD cost of the financial review committee totals \$889.55. The majority of these costs were incurred for members attending the Area Assemblies. The committee decided to exercise the right of decision, in accordance with the Area financial policy, and reduce the frequency of our meetings from six per year to four per year. Of course, future committees will be free to revise this as they see fit. At this time, the committee feels we can adequately fulfill our responsibility to the area by limiting our meetings to the four Area committee meetings (ACMs) each year: Feb., June, Aug., and Dec. It is our hope that meeting at the four ACMs will continue to ensure the treasurer has enough support and also provide adequate oversight of the Area's finances while reducing the costs to the Area (approximately equal to the hotel and meal costs for two additional members to attend both assemblies). The private company is using AAmeetinglocator for their self promotion. (linkedin) The private company is not using AAmeetinglocator for their other AA WEB site maps. Area35 has no direct input to this company to get AA Meeting Locator fixed. We have to go through area36. On July 27th AAmeetingLocator was demonstrated at our area35 & area36 joint workshop. A list of updates to AAmeetinglocator was identified. The AAmeetinglocator Ad-hoc committee was re-activated. To date the Ad-hoc has not met. Area35 is available to meet. To date there have been not updates to AAmeetingLocator. As a committee do we think it time to go back to our groups and see if they want to continue supporting AAmeetingLocator.

Proposal

Go back to our groups and get their conscience. At our Spring Assembly ask the Assembly if they are willing to continue support for AAmeetingLocator.

Plan: Continue to support the ad-hoc area35/area36 AA meeting locator committee. Our DCM will discuss AA meeting locator with their groups. At our Spring Assembly in April, I will ask the assembly if they want to continue support the web site aameetinglocator.org in the condition that it is in today. NORTHERN LIGHT PRIMARY PURPOSE:

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the *N.L.*

EDITORIAL POSITION & N.L. COMMITTEE:

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- **N.L. Committee -** The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Twelve Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
