


# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.


# **Inclement Weather Procedure For Area 35 Events**

Our income for the year was 21% less than expenses. The first quarter of the year is the most expensive part of our yearly financial plan. Do to the expenses incurred for our Winter Workshop, Spring Assembly, WCRAASC and Delegate expenses to the GSC (General Service Conference) in New York. We had a net loss of \$ 1982.61 for the year. So right now we are 34% under budget for the year (this is good). I expect that if contributions keep at the same pace through the year we will meet all planned financial obligations along with any unforeseen expenses for the year.

# Jake's Story

Aanlin! My name is Jake J. I was born on February 8<sup>th</sup>, 1993 in Bemidji, MN. My clan is Loon and I am a Leech Lake Band Member. I have three brothers and three sisters in my family. Growing up I moved back and forth living with my Mom and Dad due to legal issues which involved alcohol use. In my younger years, I lived in Bemidji, Minneapolis, Duluth, Akeley and Walker. My family moved to Onigum when I was six years old and I have lived there most of my life. I went to school in Walker, Bug-O-Nig-Ge-Shig, and Cass Lake ALC. I played football, boxing, and basketball. My sport playing was always interrupted by being put in Northwest Juvenile Center or by being put in treatment due to using alcohol.

I started smoking cigarettes at the age of ten, marijuana at 12 and then started drinking at 13. When I was hanging out with friends my own age, in Onigum. My maturity level was higher than the rest of my friends so I started hanging out with the older group who were around. Mostly sixteen to nineteen year olds. Then at parties I would get into fights a lot because I was an outcast. Through fighting I gained a lot of respect because I wasn't afraid to fight for what I believed in. So other showed me respect. Throughout it all I was on probation. At the age of thirteen until I was nineteen for two second degree felonies of burglary for stealing and kicking doors down in the winter of 2007. I robbed a resort full of mobile homes called "Old Agency Bay Resort". I did this because I never had money because my parents were struggling to support me and the rest of my siblings.

Through all my teenage years I was in and out of Jail and treatment more than I was in my home. Every time I had a period of sobriety I would relapse and say "forget it!" and go get drunk. It could be big or small problems that could give me a reason and being in treatment centers at Mash-ka-wisen, Douglas Place and in Redby let me learn a lot about alcohol. One thing I remind myself every day is I have to keep my thoughts and feelings good and I have to control my actions which could get me stuck back into the cycle of my old ways. I am in treatment again now until May 1<sup>st</sup>, then I am in the halfway house in Redby, MN called "Northern Winds". I'm 4 months sober and aiming for the 6<sup>th</sup> month medallion then the 1 year and so on. But I want you to know that recovering is not easy. What I do to keep myself occupied is lifting weights, playing Xbox, rapping, and playing basketball. My dreams and goals for right now are to get my license and pay off my DUI fine. I got my DUI when I was 15 years old. I would like to get a job, and to go to college for music production and hopefully create my own record label and music. But in order to do that I have to stay sober and in good health to maintain my will power and mental toughness. For all people reading this all you want to do is possible if you just believe in yourself and understand that it is not going to happen overnight. You have to be patient and believe.

Thank you for reading my story.

District 12 -Rodney S., for Servando...After being informed that I needed to represent him at the Spring Assembly, I met with Servando to go over his notes regarding the District's conscience on the agenda items and discuss new concerns. We have a lot of activity taking place with our PI / CPC and Treatment Committees. We are getting signs put up on the DTA buses with messages directed at attracting the still suffering alcoholic. We have established 3 meetings per month at CADT. Both the men's and women's meetings at Bethel were suffering from inconsistency with people chairing the weekly meetings, which we caught just in time, with volunteers stepping up to take on those responsibilities. We are looking into similar possibilities to support the 2 meetings at Miller Dwan. We held a very successful long timers event in January. We started the year with a group information project with multiple purposes of updating the Twin Ports Area Directory, helping newcomers find a better fit in their first groups, and to attract more involvement in district service. The biggest issue we face in this second half of rotation is, once again, a decline in service, at a time when we would like to be helping the new people stepping forward to get oriented with the district process. We are again in need of a Corrections Chair and our Alt. DCM has resigned. We are at a complete loss as to what else to do to get more district involvement. The importance of our last District Meeting to go over the agenda items and hot topics list and to make arrangements to get the background material was well emphasized and was met with a disappointing attendance. Possibly have a page for a District Webpage and Area Webpage, where to go for free download and pamphlets, possibly do some webinars to post on Area Websites... how do we carry our message one on one or in person to reach our professionals .Bring a new person with you, they like to hear about what works and what doesn't work. Only those with a desire to stop to drinking may attend closed AA meetings.

<u>Corrections-</u> Jamie - No new recent studies since 1974 so maybe take that date out. This pamphlet goes to Professionals, not to the inmates. The things that they think should be taking out are dated. There's another section on re-entry and parole - maybe cut the statistics out. AA in the correctional facilities - should be in the section that is titled AA in the Facilities. No discussion. No vote in the committee was taken, but they were pretty unanimous. Change the word directory to Listing. The Grapeving and Lavina - They might be looking at the entire pamphlet rather than just a few statements.

Vote taken - the body was in favor of draft replacement in correctional facilities - was unanimous

The committee did not discuss the entire pamphlet - but the body voted to review the entire pamphlet.

Discuss how we engage AA Members in Corrections service - the committee ended up talking about specific things happening in our Area - what can we do to get information back to G.S.O. Committee stated that no one was in favor of this proposal we need to keep our principals in this.

Much discussion regarding this proposal 17 people on a Board would be a lot of people on one board.

Area 35 is strongly against this proposal

Jim asked the body to email their thoughts and feelings to Jim asked the Assembly to read Concepts 8, 9, 10 & 11 and study them. E-mail concerns to Jim, the sooner the better, as he wants to make sure that he's representing Area 35 correctly. He will voice Area 35's opinions.

<u>Archives-</u>Video "Markings on the Journey"... Committee felt that it's old and would cost \$7,100.00 to fix it. Changes seem to be appropriate - Jim felt the changes were good ones. In favor - 100% Opposed - 0%.

-One benefit of a "75th Anniversary Edition" is to raise revenue - Our Area just voted to decrease revenue through literature but rather increase contributions - Since the fellowship is not asking for it - why do this? One of the benefits is that it would sell like hotcakes and make a lot of money. Jim feels that it is being considered for raising revenue rather than for the still suffering alcoholic. It's felt that we should stay away from this idea. It's considered a trinket" This same literature is in the book, Experience, Strength and Hope sold for \$5.00. Jim felt if they did produce this item, it should be sold at cost. In Favor - 1/4 Opposed 3/4

-Consider request to post audio archives on the Website - what they want to consider is vague - for the members is a good idea - to raise revenue is a bad idea....

In Favor - 50% Opposed - 50% Jim will use the right of decision when this comes to a vote.

#### International Conventions/Regional Forums - no discussion

#### **GSR SHARING SESSION REPORT**

- Q- Why is there an Ice-Cream Social at the Fall Assembly and not at the Spring?
- Q Why are the hotel rooms in the AA block for the Assembly more expensive than those that are outside of the block?
- -Concern: Expensive hotel room may upset group's members or make it difficult for groups to support GSR in attending conference now or future.
- -The block of rooms were all around the pool; rooms around the pool are likely more expensive.
- -Area chair or Alternate Delegate are responsible for negotiating the price of the facilities talk to them.
- Q-Roger R. CPC Chair has circulated a handout "12 Steps to Building a Healthy Group", which has been a valuable resource to build or improve a group. Can we get more things like this?
- Q- As a new GSR, am I responsible for supplying literature to my group?
- -Elect a literature chair for your group and order the literature directly.
- -Go through the literature chair of your district; pulling your orders with other groups may help you eliminate additional expenses by processing a larger order per item, shipping costs, etc.
- -If the group relies on the GSR to get literature from district or area meetings, the group must reimburse the GSR.
- -Another option is to send a second basket to cover the literature costs, such as funds for Big Books that are given free to newcomers.
- Q-What can be done to help or encourage individuals to follow the Traditions, namely to become involved in service?
- -Talk to your sponsor about how service plays a part in her/his recovery.
- -Ask your sponsor to study the Traditions together.
- -If your sponsor isn't involved in service, find a "service sponsor" to expand your notion of service. This partnership will allow you to keep the service element part of recovery separate from personal issues.
- -Some members think of service as only working with groups such as coffee-maker, literature, chair but service through district and area is service too.
- -Some members want more out of AA than working at the group level-to be able to ensure that the message of AA goes beyond the group. Refer to the reason why we have area conferences.
- Q-I'm not a newcomer, but what do all the acronyms in AA mean?
- -Get a service manual. Ask a sponsor. Ask questions at the GSR sharing session.
- -Refer to the GSR Orientation package that we receive at the fall and spring assemblies.
- Q-Are there different expectations about GSR's in different Areas? States?
- -I didn't know how busy AA was during the month of March. This is a busy month for me personally. AA needs to get the work out earlier to GSR's about what is involved during this month in preparing for the spring assembly namely, extra meetings for the group and at district to review, discuss, and vote on agenda items.
- -Districts ought to be the entity to prepare GSR;s for this time; DCM's ought to make this information known.
- -Group business meetings may help prepare the GSR and the group those who have done the work of preparing for agenda items before can share about the process with the new GSR.
- -Make flyers more informative about the process for the Spring Assembly
- -Outgoing GSR's have a duty to help prepare the new GSR's for what occurs during that time, when it occurs, and how to do it.
- -The learning is in the doing. We can't know what it will be like until we experience it ourselves. Trust the process and enjoy the ride.
- -Isn't there a website for downloading the agenda information ahead of time so we don't have to wait for the District Meeting discussion?
- -Past GSR's who serve as an action chair may be able to share their experience, knowledge about what happens at district with new GSR's.
- Q What do we do when no one will stand up for the GSR position when our term is over?
- -If no one runs for the position, emphatically and repeatedly announce it at the beginning of every meeting. This shows members that it is an important position and an issue that must be resolved. Announcing it repeatedly keeps the position (and the need to fill it) in the minds of members. At my group, after making the announcement over a year, someone finally stood up when their life schedule changed.
- -Tell the group that you are finished; give members advance notice, offer to train the next GSR, inform them the importance of having someone serve as GSR.

# DCM SHARING SESSION REPORT

14 District's were present - 1, 2,4, 5(alt),6,7,8,12,13,14,15, 16 &: 21.

Topics Discussed - Importance of Singleness of Purpose, Unity between Districts and Spirit of Rotation. District 5 - Todd was the group facilitator.

- 1) Spirituality of AA Treatment Centers are putting everyone together and because of the AA Meetings are having to deal with Alcoholics and Addicts it's our responsibility to be an example and talk to them those that attend meetings who are not alcoholic and our responsibility is also Sponsorship in the Program of Alcoholics Anonymous. AA Members need to explain Chapter 2 in the Big Book Which talks about this. Find their own spirituality. Read the Card at every meeting. Educate members what AA is and is not. AA Literature approved is the only literature we have at AA meetings non alcoholics come to the meetings non AA's can attend at open meetings. Chairperson's responsibility to talk about AA Closed Meetings. IF Everyone comes to AA there isn't a need to start NA meetings. Each community needs NA for Addicts and AA for Alcoholics.
- 2) Zonal Forum work together, not enough interest for the AA groups to attend Zonal Forums. Perhaps have a Zonal Forum in combination with PI Luncheons. Work together like we did with the Agenda Items. This helps us become more informed. Also, Bring Sponsees to the jails, invite them to volunteer and help others. Reach out to other Districts. Responsibility starts with me we can all do more than we're doing and that provides growth for us personally and in

the program in general. Just because it didn't work before, doesn't mean we shouldn't try again. Plan different things something fun - try unique ideas. Also - why do Districts split up? What can we do to help Districts stay cohesive?

3) Can't seem to get new AA members to come to District Meetings. This can be done through Sponsorship, Just keep asking and inviting, All give of themselves and bring newcomers to AA with you to a District Meeting. There is a whole different side of AA than just going to meetings. Again, strong sponsorship and getting active.

**Corrections Proposal** – Jeff E. was not present to present his proposal.

#### **NEW BUSINESS**

Minnesota State Fair AA Booth - August 24th and August 25th - If you want to volunteer a shift, you can talk to Butch and he'll let you know the time slots that are open.

Neil F. presented a Dist 7 request for nationwide meeting locator. If GSO took over this service then we wouldn't need to create our own in each area and we wouldn't need the paper directories. GSO considered this idea but did not add it to the agenda. GSO thinks it's better suited for the Areas to do this but District 7 feels it would be better suited for GSO to create and keep this site up and going. Discussion followed... 2/3rds majority vote required for a proposal from an area.

Neil F. made a motion for this idea to be brought to the GSO to create and maintain a North American wide computer generated meeting locator at the 63<sup>rd</sup> – 2013 service conference.

Friendly amendment – To clarify, Neil meant United State and Canada and this would exclude Mexico.

Voting Yes -55 Voting No – 10

**District 5 proposal** - "We of District 5 and AA group members would like Area 35 to consider or open for discussion that GSR's and Groups within Area 35 have access to the proposed Area 35 budget 60 days prior to the Area's Budget approval vote. Below are some reasons for the request.

-GSR's would be able to talk about it with groups. This is important to us to keep AA members informed beforehand as to where and how much it will cost to keep AA here for the newcomers.

-To have more time to ask about any increases decreases, or where is the money being used.

-To approve the budget for Area 35 the yearly budget should be done by all AA members. Especially since the groups are the most important members and the Area is supported financially by the groups. During the discussion, Jim K., Area 35 Delegate brought up the fact that this is already in the Area Actions Booklet ... after discussion from the floor; Todd withdrew the motion/proposal.

**District 5 Proposal**: We of District 5 and members of AA would like Area 35 to consider that Area 35 officers and/or committee chairs not be the ones to make a motion to pass the area 35 proposed budget as they are part of the Budget. The motion should come from a DCM or a GSR.

-Some GSR's may feel pressure from others

-We feel that a motion should not be brought forth by someone who is a part of the budget.

-So it doesn't come across as if we are pushing the budget through because we need it approved immediately when it's brought forth for discussion. The discussion that followed concluded that Area Officers and Area Chairs all get a vote on the budget proposals. After discussion from the floor, Todd withdrew the proposal/motion.

Jim K. made a motion that the General Service Board of A.A. devise and implement a yearly budget plan that decreases reliance on profits made from literature sales by 5% per year, for the next 10 years, therefore becoming 100% self-supported by AA Group contributions by 2024. Jim K. made the motion and the motion was seconded.

Area 35 Inventory Questions/Discussion - Kelly reviewed the Inventory Process and the changes that have occurred and opened the floor to discuss the inventory and their feelings about it. She reviewed some of the positive outcomes i.e. District 14 was dark and is not active. When a new person takes over a position the outgoing officer or chair should help the incoming officer or chair which is certainly encouraged and should be added to the job position descriptions. The Ad hoc internet AA Meeting Locator Committee with Northern and Southern MN has been implemented and is running smoothly. The Roberts Rules of Order comment will be done this Fall Assembly for an hour workshop. Using a straw vote for agenda items VS only voting members was implemented at the Feb Committee meeting and utilized at this Assembly. Having the budget sent out before the Committee meeting or Assemblies has been implemented and the budgets are now being sent out before the Committee Meeting and Assembly. Area Responsibilities are listed on the Website now and it's the job of the officer or committee chair to update their job position description, but if anyone would like to see some changes, feel free to contact the person and make suggestions. No further discussion continued regarding the Area 35 Inventory. Kelly D., Area 35 Chairperson asked if this should be on the Fall Assembly agenda and no one responded that they wanted it to be on the agenda, so the consensus was to not place this item on the Fall Assembly Agenda.

There is a compendium of advisory actions that is published by the General Service Office and is available for purchase by AA members."
- 4) Why do we do a comparative balance sheet/cash flows for only 2 years back? Why are we not showing at least the last 5 years? Susie responded with "The number is arbitrary. If you want 5 years ask for them."
- 5) Are there more "Open Meetings" today then there were in the past? Why so many? Bob J. (Panel 40) There seem to be more open meetings now than in the past. In the Duluth area there are not that many. I have visited areas where almost all meetings are open. They may want to appear to be open to all. Newcomers may prefer closed meetings because of the anonymity. It was later pointed out that non-alcoholics who attend must be "observers" but not participants.
- 6) When a group is having Big Book study's what do you think about them going through and discussing the stories in the back? Or do you recommend the first 164 pages only? Jerry S. answered" Each group is autonomous and can do as they wish but the stories are just that. If it were me I would stick with the 164 pages plus Bob's nightmare"
- 7) What is the funniest thing said or done by a delegate? Jon stated "I tried to get out and meet some new delegates and was all fired up for this task and wouldn't you know, I sat at a table where they only spoke FRENCH."
- 8) What good have you seen/heard about happening from PI/CPC Luncheon Banquets? Charlie C. answered The good I have seen come out PI Lunches Is it Lets Alcoholics Anonymous be visible in our communities, and gives us an opportunity for us to explain what AA is and isn't. It also puts a face on Alcoholics Anonymous and gives us a chance to sit down face to face with the Professional and listen to their concerns, gain their confidence, and let them know AA can be a resource among other resources.
- 9) Why is Area 35 so against the Pink Can?"It is my (Tom's) impression that the discussions in the past within Area 35 on the Pink Can Plan centered around the issue of Concept III, The Right of Decision, notably that by "earmarking" contributions for a specific purpose or committee prevented the Area Committee from having the right to decide how best to use the finite resource that are the contributions from the groups. Rather than see it as what are we against (Area 35) I'd like to see it more as "what we are for" and that is a firm application of the Concepts in our area. The next delegate, Susie, has a question specifically about Concept III."
- 10) How much sobriety should a person have before being allowed to chair a meeting? Suggestions? Tim C. answered "it should be a group conscience remembering a loving God as he may express himself is the sole authority."
- 11) Please explain "Right of Decision". Susie responded "The right of decision is Concept 3. The simple answer is if you are the GSR and your group told you to vote a certain way at the Assembly. When you got there you heard a different view of the issue and decided to change your vote. You have that "right of decision" but you do have to go back to your group and explain why you changed your vote.
- 12) Where can one download the Background Information for the agenda items? (when is it available)
  In one of the breakout sessions it was stated that there was a website where the background information was posted. What is that address? Is other information posted on this site?-Bob J. said there is no website to download the background information on agenda items because it contains confidential information. Therefore it was only distributed to the delegate who made it available to the area committee, including DCMs, who then made it available to GSRs.

# **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

# **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
