goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Though the high point is the Conference meeting, the delegate's job Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
 - Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Area 35 Alcoholics Anonymous Trusted Servant Guidelines

Approved: October 2013

WEB TECHNOLOGY

Description:

The Web Technology position is a non voting and temporary technical position. This position does require a knowledge of HTML, PHP, MySQL, and other programming skills. This position will require the use of a computer, access to the WEB and email.

The primary goal of the Web Technology position is to complete aameetinglocator.org and design a support plan for aameetinglocator.org. Propose a plan to allow other Areas within the West Central Region to join aameetinglocator.org. Present the plan to the 2014 Fall Assembly.

Follow recommendations by the Area 35 assemblies. Follow GSO's website guidelines.

Make a physical backup copy of the aameetinglocator.org database once per month.

Make physical changes to the website as requested by the Webmaster, Area Committee, or Area 35 Assembly.

Designate one person on the web committee to have a backup copy of all passwords and access codes pertaining to the website. With the exception of this one person, all passwords should be kept private.

Respond to any email inquiries in a timely manner. Area 36 will assist in inquiries that are best handled in Area 36.

Review usage reports from our aameetinglocator.org web provider, and share them with the committee. Reports will also be shared with Area 36 Web Chair and Area 35 Webmaster.

Make sure all copyright and other laws are adhered to regarding our website.

Keep all billing/registration records up to date with current names, addresses, phone numbers, and private registration. LinkSky is our current WEB host and domain name registrar.

Support and participate in training opportunities at the Area, District, or Group level.

Support ad-hoc committees as appropriate.

Responsibilities:

Attend all Area 35 Committee Meetings, all Area Assemblies, Area 35 Service Workshop, Area 35/36 Joint Workshop and Annual Service Conferences.

Attend Regional Forums and/or West Central Regional Conference where fully reimbursed.

Provide leadership in the area.

Read and become familiar with "Suggestions for Area Action Committee Chairpersons."

Read and become familiar with the Area Finance Policy, the Area's Statement of Financial Responsibility, Trusted Servant Guidelines, the Area Past Actions and Recommendations Book, and any other documents the Area has developed from its experience.

Manage committee activities within the Financial Statement of Responsibility requesting additional funds if necessary.

Clear over budget expenditures with the Area Chairman and Treasurer prior to incurring the expense.

Submit for reimbursement of expenses in a timely manner to ensure a consistent and more predictable disbursement of Area funds.

Be available to committees, Districts and groups to provide experience, strength and hope with respect to the committee chairperson.

Report committee activities and information in each issue of the Northern Light Newsletter, all Area Assemblies, and Committee Meetings.

Keep accurate minutes of all meetings and distribute to Area 35 secretary in a timely manner.

Keep an accurate record of tasks and technical level to complete the task. This will help Area 35 make an informed decision on the support needed to maintain aameetinglocator.org

Keep all payments up to date for aameetinglocator.org WEB site and domain names.

Keep Area 36 informed about aameetinglocator.org expenses and their suggested share of the expenses.

Update the Trusted Servant Guidelines for the Web Technology. Submit the updated guidelines to the Area 35 Chairperson no later than the June Committee Meeting of your 2nd year.

When rotating out help the incoming Webmaster/Technology Chair with experience, records, information, and any other helpful suggestions for serving.

COOPERATION WITH THE PROFESSIONAL COMMUNITY (C.P.C.)

I attended the Area 35 Fall Assembly in Detroit Lakes on October 5-6. Our PI/CPC break out session was informative and productive. My report on this session is detailed in this edition of the Northern Light. I am confident that our newly elected officers will do a fine job representing Area 35. I would like to express my gratitude to Area 35 for electing me to the position of Area Secretary for the upcoming 2014-15 rotation.

On October 16, 2013 I participated on an "Alcohol and Other Drugs Awareness and Prevention Community Panel at the University of Minnesota Duluth Campus. My presentation covered: What is AA's Singleness of Purpose, What AA Does Do and What AA Does Not Do.

Following our Area Fall Assembly I completed preparation for our CPC booth at the 2013 St. Louis Health and Human Services Conference. I created a tri-fold CPC display for our booth. Bill Calls On A.A. To "Look Out Upon Its Destiny" As A Society By Bill W., General Service Conference, 1961

The 1961 Conference, like its predecessors was illuminated by several formal and informal presentations by Bill W., surviving co—founder of A.A. A recurring theme in these talks during the four day meeting was the importance of the Conference structure to assure sound growth of the Fellowship. Bill also emphasized the need to be realistic in evaluating A.A. activities to date, warning that humility and a spirit of cooperation should mark the Society's relations with others who share A.A.s concern with the problem of alcoholism.

Key excerpts from Bill's follows:

Contrast Between Good, Evil Societies

Since the beginning of recorded time, many societies and nations of civilizations have passed in review. In those great ones that have left their mark for good, in contrast with those who have left their mark for evil, there has been always a sense of history, a true and a high and a constant purpose, and there has always been a sense of destiny.

In the societies which failed to leave a bright mark in the annals of the world, there was always a false or boastful sense of history, always a mistaken or inadequate purpose and always the presumption of an infinite, a glorious and an exclusive destiny.

In the societies that left their mark of goodness on time, the sense of history was not a matter for pride or for glory; it was the substance of the learning of the experience of the past. In the purpose of such a society there was always truth and constancy, but never a supposition that the society had apprehended all of the truth-or the superior truth. And in the sense of destiny there was no conceit, no supposition that a society or nation or culture would last forever and go on to greater glories. But there was always a sense of duty to be fulfilled, whatever destiny the society might be assigned by providence for the betterment of the world.

This is the crossroads at which we in A.A. stand. This is a good time to re-examine how well we have looked upon our history and how much we have profited by it, what false insights or false glories we may have been extracting from history—to our future detriment. It is a moment to examine the purpose of this Society. Indeed, we are very lucky to be able to state as the nucleus of that purpose a single word: sobriety.

Need For More Quietude

Quite early we saw, however, that sobriety in abstinence from alcohol could never be attained unless there was sobriety and more quietude in the false motivations that underlay our drinking.

When the Twelve Steps were cast up- without any real experience and therefore under some Guidance, surely- we were given keys to sobriety in its wider implications. We have been blessed with a concrete definition of purpose but, for all its concreteness, we could still abuse it and misuse it in a very natural way.

Some times we begin to think that perhaps, according to the Scriptural promise, the first shall be last and the last- meaning us-shall really be first. That would indeed be a very dangerous presumption and never should we indulge it. If we do, we shall compete in history with other societies who have been ill-advised enough to suppose that they had a monopoly on truth or were in some way superior to other attempts of men to think and to associate in love and in harmony.

We may look out upon our destiny with no violation of our principle that we are to live one day at a time. We mean that, emotionally, each in his personal life is never to repine upon the past glory too much in the present or presume upon the future. We shall attend to the day's business but we shall try to apprehend ever more truth from the lessons of our history, not the lessons of our successes but the lessons of our defections, failures and the awful emotions that can be set loose upon us. For these, indeed, are the raw materials that God has used to forge this still rather little instrument called Alcoholics Anonymous. So we may look at destiny and we may ask ourselves about it and speculate upon it a little — if we do not presume to play God.

Fresh Freedom Under God

By this singular Providence which has been ours, it has been our privilege to walk through a new door that opened a quarter of a century ago. This quarter century, this brief span of life of Alcoholics Anonymous, has been characterized by exactly the reverse of what has been going on in the world around us. Each turning point in our history has opened up to fresh freedom under God for greater numbers of people.

When I was asked to write a greeting to this Conference, I think I used the word "family" in describing A.A. for perhaps the first time, it occurred to me that we were more than a therapy, more than a group of alcoholics trying to get along in the world. We here in this room were small fragments of a huge and growing family, a fragment collectively designated for the time being as "trusted servants" for the rest and appointed to a mission which would further our purpose and destiny.

Need To Establish Conference

You will remember that at St. Louis a huge transference took place. We old—timers realizing that we couldn't last forever, also realized that a linkage had to be made between you and this vital beacon of service right here. We realized that this Conference had to be established firmly and that you had to be given the opportunity to look after your own affairs worldwide. We had to apply Tradition Two to ourselves, formally passing the ultimate authority and responsibility over to you and to the generations that will follow you. This powerful experiment had to be tried. One of the most glorious moments in my whole A.A. career was the day when I first realized that in spite of my weakness and your weakness, we are going to do this—and that it would succeed. But there is more that has to be transferred than past authority and responsibility. And that this transfer has been going on a long time, I speak to you of the transfer of service leadership.

OFFICER REPORTS

It has been a busy time since we last met as an assembly. I attended the 63rd General Service Conference, reported back to all of the districts, attended various district workshops, participated in a zonal forum, attended the West Central Regional Forum, and mailed out final reports to all districts. It is truly a privilege to be able to serve as your delegate and I am looking forward to the next couple months as we continue to serve together. The 63rd General Service Conference was an experience and I am thankful for the opportunity to attend. I was able to report back to all districts following the conference and I want to thank all DCM's for assisting in setting these up. Current AA Highlights include that total gross sales for the first 8 months through August are \$8,774,270, AAWS suggested that e-book versions be kept under print version equivalents, and that a soft-cover, abridged, largeprint edition of the Big Book be produced in early 2014. Contributions through July were \$3,845,796. I want to offer a special thank you to all those who were willing to stand for delegate for Area 35 and for all those who will be standing for our other Area Officer positions. I also want to thank all the GSR's and DCM's that are serving their groups and districts. There is much to work to be done to carry this life saving message to those who still suffer. Finally I want to thank all of the districts who continue to send me their district minutes and for all the work that you are all doing to carry the message.

On the back of that form is the other income that we have for special contributions and special events - We got a contribution for the Gopher State Round-up. The amends payment has been paid in full. The total income so far for the last period is \$5652.00, and Contributions for Year to Date income is: \$23,257.71. The expenses are listed, the officer's expenses and you'll notice year to date expenses are 33% under budget and our income is 3% under budget. You can get a good picture of our fiscal status by looking at this expense sheet - We're \$534.55 less than what we started the year with. You can also see the details of the expenses for the events that we have been doing this past year and how much everything costs. We haven't gotten a State Fair bill yet but that one will be for \$500.00. There are also envelopes on the back table with my address on them. Remember that beginning in January there will be new addresses and new envelopes. Please remember to pick up the new envelopes with the new addresses. We have open positions that we hope to fill at our next district meeting which are Secretary, Corrections Chair, and Literature/Grapevine Chair. At our last district meeting we also agreed to have a permanent contact person with the Sherburne County Jail. This was a request by the coordinator at Sherburne County Jail. We will still have a Corrections or concerns and cannot contact the current Corrections Chair. I want to thank Skip D. for being our male contact and Margo for being our female contact with Sherburne County Jail. Rita, CPC/PI Chair, is getting volunteers for the next rotation of the Sherburne County Probation Orientation Meeting. She is also updating our meeting schedule and plans to have enough schedules to make it through the end of the rotation. Our Literature/Grapevine Chair continues to have literature for groups to purchase and promote the Grapevine. We are still providing speakers for two treatment centers once a month. Finally we have made guidelines for all District 5 positions to assist the new rotation. I am going to have them in the District 5 Actions Booklet I am in the process of creating. The guidelines helped us when we had elections. Do AA members considering a position know what they would need to do? I continue to work with the Area 35 Group Records Secretary on updating group information.

TREATMENT – Randy A. - We attended the WCRAAF in Bloomington, MN on Sept 6, 7 and 8th, 2013. What an honor and privilege to participate in this prestigious service event. Despite some of the vague information given by the General Service Board during the question/answer sessions, the topics and sessions were quite informative and interesting. Saturday evening I attended the Treatment/Special Needs Accessibility Workshop with 42 members present. The discussions intrigued me a bit, as there was a dominance of members from Area 36 present. They talked about self support and the 7th tradition. They have what's called a "Gold Can" or "Green Can Plan" in addition to the "pink can plan" which is used for funding literature. The gold Can and Green Can are used to support ASL (American Sign Language) interpreters, and a 7th Tradition basket or kitty is collected at meetings in addition to the Pink Can and regular 7th Tradition basket. So in some meetings, they pass around three baskets or cans. I question whether this is a violation of our 7th Tradition. There were also concerns about anonymity involving American Sign Language (ASL) interpreters at meetings and affiliation with other entities. There is an ever growing need for ASL Interpreters for deaf Alcoholics in Alcoholics Anonymous. Some of these ASL funds are budgeted at the district level and are included with other financial services. There were members present that also had mental disabilities and physical handicaps. They stated that some meetings are oblivious to the alcoholic with special needs and there needs to be more awareness from our fellowship. The attendance for the Forum that week-end was 518 with 305 newcomers. On September 25th I was invited to speak at a function at Fortune Bay/Resort Casino in Tower, MN that was sponsored by the Bois Forte Chemical Dependency and Human Services Program from Nett Lake. GSR SHARING SESSION: 5 October 2013

My home-group hosts three meetings but we only have one GSR for our one group. Should we have a GSR for each meeting or only one for our single group? We used to have regular business meetings-and recently attempted to have a business meeting to discuss this idea—but a long-timer at our meeting has prevented us from meeting to talk about the issue. I'm not sure what we can do about any of it?

• Perhaps it is time to get a new chairperson, especially if the long-timer has been serving in that position.

• Consider the "Bleeding deacon" from "Tradition Two" in the 12x12 (p. 134-5): This brings us straight to the question "Does A.A. have a real leadership?" Most emphatically the answer is "Yes, notwithstanding the apparent lack of it." Let's turn again to the displaced founder and his friends. What becomes of them? As their grief and anxiety wear away, a subtle change begins. Ultimately, they divide into two classes known in A.A. slang as "elder statesmen" and "bleeding deacons." The elder statesman is the one who sees the wisdom of the group's decision, who holds no resentment over his reduced status, whose judgment, fortified by considerable experience, is sound, and who is willing to sit quietly on the sidelines patiently awaiting developments. The bleeding deacon is one who is just as surely convinced that the group cannot get along without him, who constantly connives for reelection to office, and who continues to be consumed with self-pity. A few hemorrhage so badly that-drained of all A.A. spirit and principal-they get drunk. At times the A.A. landscape seems to be littered with bleeding forms. Nearly every oldtimer in our society has gone through this process in some degree. Happily, most of them survive and live to become elder statesmen. They become the real and permanent leadership of A.A. Theirs is the quiet opinion, the sure knowledge and humble example that resolve a crisis. When sorely perplexed, the group inevitably turns to them for advice. They become the voice of the group conscience; in fact, these are the true voice of Al-coholics Anonymous. They do not drive by mandate; they lead by example. This is the experience which has led us to the conclusion that our group conscience, well-advised by its elders, will be in the long run wiser than any single leader.

• Consider the section "What is an Informed A.A. Group Conscience?" from the pamphlet

The AA Group: The group conscience is the collective conscience of the group membership and thus represents substantial unanimity on an issue before definitive action is taken. This is achieved by the group members through the sharing of full information, individual points of view, and the practice of A.A. principles. To be fully informed requires a willingness to listen to minority opinions with an open mind. On sensitive issues, the group works slowly—discouraging formal motions until a clear sense of its collective view emerges. Placing principles before personalities, the membership is wary of dominant opinions. Its voice is heard when a wellinformed group arrives at a decision. The result rests on more than a "yes" or "no" count—precisely because it is the spiritual expression of the group conscience. The term "informed group conscience" implies that pertinent information has been studied and all views have been heard before the group votes.

• Are there different service opportunities that are sponsored at each meeting? If so, and all the meetings are registered as one meeting with GSO, you may consider each meeting separate with its own business meeting and GSR.

• One function of the GSR position is to collect a group consciousness at the business meeting. The majority should rule how the group operates; no single member has the right to direct the will of the entire group. You should hold a business meeting regardless of what the long-timer says, have a discussion amongst the home-group members (including the long-timer) and vote.

• This is how new groups are formed: A pot of coffee and a resentment.

As a GSR, am I responsible for supplying literature to my group? [Question (and some answers) from the Spring 2013 Assembly]

• Elect a literature chair for your group and order literature directly from GSO.

• For groups that aren't big enough to have someone hold a literature chair, the responsibility may fall under GSR duties if the conditions suggest that it is easiest for her to do the job.

• Go through the literature chair of your district; pooling your orders with other groups may help you eliminate additional expenses by processing a larger order per item, shipping costs, etc.

• If the group relies on the GSR to get literature from a district or area meeting, the group must reimburse the GSR.

• Another option is to send a second basket to cover literature costs, such as funds for Big Books that are given free to newcomers.

What do we do when no one will stand up for the GSR position when our term is over?

[Question (and some answers) from Spring 2013 Assembly]

• If no one runs for the position, emphatically and repeatedly announce the opening at the beginning of every meeting. This shows members that it is an important position and an issue that must be resolved. Announcing it this way keeps the position (and the need to fill it) in the minds of members.

• At my group, after making the announcement over a year, someone finally stood up when their life schedule changed. Perseverance works.

• Tell the group that you are finished; give members advanced notice, offer to train the next

GSR, inform them the importance of having someone serve as GSR.

• Sponsor members into the position.

• My group expected me to continue as GSR, but, when I told them I wasn't, they asked why I wasn't serving again. I told them I couldn't because I would be serving at a district-level different position.

• If possible, elect an alternate GSR with the expectation that, when the GSR's term is finished, the alternate will become the incoming GSR.

• Our group reverses the alternate GSR/GSR positions—the alternate GSR is the outgoing GSR. This gives the incoming GSR the security knowing that someone with experience is available to help show the ropes and cover district meetings.

• Get people to know the benefits of the GSR position. Service provides the opportunity for personal growth. Not to overstate it, but the GSR is the first protector of the program. GSRs may be the most important protectors—the guardians of the Traditions—but over the past 40 years, we've forgotten them. Without the Traditions, nothing works. When we pass motions at an assembly allowing the Area to promote itself using the Internet, we're violating the 11th Tradition.

• Public service announcements are a violation of the 11th Tradition as well; AA is blowing

It's own anonymity.

• The 11th Tradition is concerned with personal anonymity, not anonymity of the organization. Neither our online meeting locator nor our PSAs promote a specific person; they promote the meeting, the solution, the Program.

• Read long form of the 11th Tradition: Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.

OLD BUSINESS

Minnesota Statewide Corrections Report given by Skip D., - Since the Joint Area 35/36 workshop the Committee meet on Sept.30th in Golden Valley. We went over the joint workshop minutes and to prioritize what we need to work on. Our next meeting will be on Nov. 13th in Maple Grove. It was mentioned that G.S.O. was going to watch what happens with Area 35/36 for this is groundbreaking (has not been done before) that two Areas are working so close together, said it is incredible. **Minnesota State Fair AA Booth Report** - Butch R. reported on the state fair - it was a huge success, we had a lot of people that went by the booth and a lot of people that viewed the booth. I had a great experience and I met a lot of folks who told me their stories. I hope that area 35 continues to be a part of that, please sign up for slots next year because you won't regret it. Thank you.

West Central Regional Forum Report - Jim K. gave this report. There were over 571 and 375 new time attendee's. It was a great opportunity - Andrew W. chaired the event. There was a lot of information regarding finances. The fact of the matter is that most groups don't participate to the Region that they belong too. Most groups in Northern Minnesota don't make contributions to their own Area or District. It's important for the groups to see where their contributions are going to and what they are being used for. You might want to consider sending a thank you note to the groups who contribute Grapevine contributions are given to the Grapevine by subscribing to the Grapevine - so the way to support The Grapevine is to subscribe to the Grapevine. Consider purchasing a subscription for your group, your local jail, a friend's birthday or your own birthday. Also, there is a current practice in place when we order literature regarding the shipping and handling - that puts a burden on the little groups. We know that we can get our literature from our Area Literature Chair - The Literature person becomes the supply and demand person and it's questionable if that's the best way to use the Area Literature Chair. I would suggest that you take back to your Districts and AA Groups the idea of writing the GSO about the high cost of shipping and handling for smaller orders and what that means to your Groups and District. GSO will read your letters and respond. They want to know what you are thinking. We can also draft a letter as a body to GSO and we can do that in December at the December Committee meeting regarding the Shipping and Handling costs for Big Book Literature. Please go back and talk to your groups and find out what they are thinking and we'll bring this topic up again in December. We will go ahead and add this to New Business and add the discussion about shipping and handling costs at our next Committee meeting. Thank You.

Ask It Basket (Past Delegates)

How are the Trustees selected? (Susie) There are 8 nominations in 8 Areas. The voting assembly is on the Wednesday Afternoon - 133 people. Quarantine off the West Central Delegates, 4 Trustee's - 16 votes - all vote, which is the 3rd legacy. All Trusted Servants have recovering alcoholics and AA's best interests at heart.

Would moving GSO out of New York save lots of money - how would we go about that? (Tim) that's been tried before, we have a 10 year lease. The lease is reviewed every 10 years. Last time they got a good rate compared throughout the country. If you want, you can bring it forward as an agenda item - it was cost effective last time around.

What is your favorite Conference Approved literature? (Bill P.) The Big Book. Use Conference Approved literature at each meeting. A lot of meetings are based on the Big Book.

Just a sharing - Great to have all Past Delegates and Area Trustee's at our Assembly - Great deal of satisfaction to return and see friends and see how the Area Assembly continues on (Tom A.)

Just wondering why that Grapevine Literature is so good. (Tim C.) The most fun I've had in AA - Grapevine literature chair - most stories from ordinary drunks like us. It was the only meeting in print and it's used for the rural area's meetings for a person who can't

drive to a regular AA meeting.

Why do they update conference approved literature? (Jon C.) I'm not sure that I have a lot to say about GSO. Not happy about the cost of "Handling" for the smaller groups.

How have you used the book "As Bill Sees it?" (Bill P.) Every group is autonomous. It's important to use conference approved literature, though.

How can Area 35 add Special Needs Committee to it Roster of Committee's?

Add a motion - this type of thing comes up from the groups to the District to the Area. the usual method of making decisions at the Area Level.

Any Comments on reviewing a way to reenergize a group?

Good Sponsorship - Sponsor into service - newer folks always are the most excited. What you don't want are the same people making all of the decisions. New input is healthy.

Is it wise to put our group service numbers on the web pages? (Tom A.) Group service number is like a serial number. Being just a number is not a problem with anonymity. The number is almost better than a name, a group name or a person's name.

The issue of shipping charges and sending a letter from Area 35 addressed to GSO - would it be great if groups and districts wrote the letters as well? (Bob J.) If groups and districts are concerned, yes, they should write a letter to GSO with their concerns. If a group of voices come up - they would consider the issue at GSO.

Can a person who served for DCM - can they serve again if others are running? (Charlie C.) If others are willing to serve, it's strongly recommended that you serve 1 rotation and let someone new who wants to serve do this.

Are there actions we might take to get District 17 back into service? (Bill J.) Yes, we can. District and Area Officers can plan an important role. Go to the District meeting, gather up representatives from their groups and see if they can get a DCM elected. Bill and revived a district - it does work.

Why does the Archivist keep doing Archives - Why doesn't this position rotate? (Bruce B.) Archives position was created because we felt we should have an addition to the Archive Committee to take care of all the "stuff".

Which Book is a great resource to learn about the History of the Fellowship? (Scott J.) Alcoholics Anonymous has lots of history in its introduction. AA Comes of Age, Dr Bob and the Good Old Timers and Pass it On are all good history books.

What is the best way to approach a group or individual that does not respect our 5th Tradition? (Tim C.) Share our own experience strength and hope. People who come to AA who have a drug history...well that's a tough one, because AA might help them. It's not our place to judge a dual addiction. The best thing we can do is help them get where they need to be to get healthy. (Bill J.) The best way to approach a group that doesn't respect the 5th Tradition - primary purpose - we need to follow the traditions, period.

Is each meeting supposed to have a GSR? (Bill B.) Let's say there are 2 meetings meeting on the same night and they have one GSR, one treasurer, one secretary... Groups are autonomous. Leadership grows out of responsibilities taken on at a group level. This would mean there would be fewer opportunities for members to learn responsibilities at a group level. Not sure if this is good or bad, it's for the groups to decide.

Understanding Anonymity - (Charlie C.) - Is anonymity broken when things are discussed within the family of AA? No - look at our 12 X 12 and pamphlet understanding anonymity - let your Doctor know that you are an Alcoholic - You give your last name at a closed AA Meeting, at an open meeting you give your first name only. But how will others be able to call you if they don't know your last name.

Why are committee members chosen by the Chairperson? (Tom A.) Before 1985 they were voted in, but it took such a long time, and a long election, so in 1987 it was voted at the Area Assembly that Area Chair chooses the committee. They have a large pool of people to choose from. There is a lot of work that goes on in the selection process and they are selected based on their qualities.

Is it possible to be "too" welcoming to the First Time AA person? (Bill P.) I suppose being too welcoming could frighten a new person or intimidate them. On the other hand, not welcoming them at all could have the same effect. It is definitely scary to attend your first AA meeting.

I attend several AA meetings - so am I only supposed to attend one business meeting? (Charlie C.) - One Person - One Vote - One Group. You can attend other business meetings, but you should only vote at your home group business meeting. You can have a voice at other business meetings, but not a vote, if it is not your home group.

If a group is not registered with GSO, they have no GSR, can the group vote at Assemblies? (Charlie C.) Yes, they can vote.

Can we "over welcome" a person? (Tim C.) The new person is the most important person in the room. (Scott J.) Any welcome was frightening to me - I wanted to be left alone.

When you went to New York - What happened that you didn't expect? (Jon C.) Area 35 sends you prepared, go through all the agenda items with the Assembly, Services Conference with other regions. I couldn't believe some of the Delegates who came. They were completely unprepared and baffled, not just one or two of them, but many of them. When the Assembly was almost over, there were books left and we could take any of the books we wanted. The Southerner's picked up everything but there was one book left. It was an Agnostic Pamphlet and Spiritual Awakening which was the only book left.

If the La Vina keeps losing money, why continue printing it? The Lavina gets passed around and read 3-4 times for one issue. It's the Spirit of carrying the message. It's funding is a service of the Fellowship and that's been the precedent since it was first printed.

# **NORTHERN LIGHT PRIMARY PURPOSE:**

The *Northern Light* (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the *N.L*.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the *Grapevine* or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the *N.L.*

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

- **Editor Editor -** The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.
- **Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- **N.L. Committee -** The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### N.L. COMMITTEE MEETINGS:

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

#### **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
