The Delegate's Duties

- Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee •
- Remind G.S.R.s to inform groups and individuals about the A.A Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
 - Visit groups and districts in the area whenever possible.

members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.

- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to . better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

AREA CHAIR'S REPORT

Hello! I hope your summer is finding you well! On June 7th I presented on the Traditions at a Singleness of Purpose workshop in Bemidji along with Roger R. and Bob B. of the Area, and a couple local AA members. It was a good turnout and we had great participation and questions. I have also been communicating with Area Chairs and DCMs since the June Area Meeting via email with suggestions and reminders for carrying the message and meeting the needs of the Districts (a copy of this correspondence is included below).

A DCM and I were recently discussing a great request for a GSR Service School. We talked about some ideas and came up with the following. I thought it might be worth including in the Northern Light, with the hopes that it will give the Area chairs, DCMs and AA members some ideas on how the Area Action committee can be of service to the Districts. I'd love to hear your own brilliant plans/ideas too! Feel free to send me emails or call regarding any ideas or questions you have. Possible Service Event ideas: It would be good to have around 4-5 people present at one event. You could have each presenter invited talk for a select time and then provide time for questions and answers. Some options for what Area Officers could do: we can share our experience on traditions, concepts, service work, troubleshooting service issues, encouraging the seventh tradition, etc. Then, we could be joined by (select) Area Committee Chairs who can share how to carry the message through their respective committee work (e.g. CPC) chair could talk about what is a CPC event, what would it look like, what information would you want (they may even provide a model (CPC) event). So, it might look like this: 2-3 area officers at one event along with 2 area action chairs to present. Then next year or at another event you could have more area committee chairs present. One option is to have group themes.

As for specific presentation ideas, I am sure the individual chairs will have their own wonderful ideas (feel free to contact them and ask!), but it might be something like:

1. CPC and PI present together - they could do brief

Here are some questions that might help your committee explore ways to inform local AA members about this vital principle:

- \Rightarrow What can be done locally to ensure that AA members are well informed about the multiple reasons AA members maintain anonymity (as a safeguard for the newcomer, to practice humility and preserve sobriety for the existing member, and to protect AA as a whole)?
- How does your committee strive to share information about anonymity with all local groups, not just those who attend service events?
- \Rightarrow How does your committee utilize a variety of ways to share this information?
- \Rightarrow How does your committee regularly share information about anonymity, so that existing members are reminded, and newcomers are quickly informed, about this vital principle?
- \Rightarrow What has your committee found to be effective? Not effective?

Report on MN Association of County Probation Officers Table top event. Greetings. My name is Jacob C. and I am the CPC/PI chair for District 5. I don't know how to keep this brief and offer the report you deserve so just cut me off when you get bored. I will start with, thank you for allowing me to serve, the coffee was wonderful, so we should go back to MACPO next year! I attended the Minnesota Association of County Probation Officers event at the Breezy Point Resort on May 22nd and 23rd, 2014. Along with Arden A., the Corrections Chair for District 7. We spoke with around 65 individuals over the two days. We handed out over 382 pieces of literature at the event. This includes 3 Big Books, 2 Spanish Big Books, 24 packets that I made up geared towards probation officers interested in making contact with AA in Minnesota, and the rest being our conference approved pamphlets. I gave away over 40 Grapevines to treatment facilities and private social service companies, for their waiting rooms. This did not include the 300 AA Meeting Locator cards handed out!!! Yeah! Between literature that Servando mailed me and excess CPC related literature from District 5, we were covered. I forgot to count the literature on hand from Area 35 that we handed out, so my numbers are on the low side.

DOC programs representatives, and the representative for the Minnesota Corrections Association, who happens to be the administrative assistant to the warden at the Lino Lakes DOC compound.

It was good to get the positive feedback from many of the county probation officers, but on a sad note, a Chisago County probation officer let us know that AA used to do a Public Information Meeting for people on probation in Chisago County, but that we stopped showing up. I've chatted with the DCM in District 6 about this as he lives in that county and understands the issues there. It's a border county and really is literally a blurred line between Area 35/36.

Probation Officers speak a particular dialect of English that is confusing, so forming a relationship with one who can translate, is worth the effort!

The representative to the Minnesota Corrections Association, is also the assistant to the warden of the Lino Lakes prison, and took a great interest in our contact programs. She also insisted we go as a vendor to the MCA event this fall. None of the halfway houses, nor the several programs represented at Lino Lakes were aware of our Bridging the Gap program, or appropriate AA contact programs. Nor are there any AA meetings going on at Lino Lakes in ANY of the youth facilities. I have the information for contacts available for Skip.

Most of the vendors did not understand how AA cooperates with professionals, and so a great deal of public information work was accomplished while the probation officers were in their various meetings. This event was as much as a meet and greet among we vendors as it was for presenting to the probation people. We have a lot of work to do, given the feed back received. Most of the literature given out, was given with an extended hand of cooperation, and a phone number/email address of who to contact where.

I had some sample newsletters posted on a board, and pressed heavily the F-2, *Information on AA* flyer. It was two pages of a six page packet I made up. There was a page explaining how we are organized and why we are that way. The goal of the pamphlet was to give information on what we are and are not, and how to contact us in Minnesota. An obnoxious lime green, large print, short and direct, pamphlet, specific to Minnesota, seemed to be an effective local tool to add to our otherwise great collection of pamphlets. There was a bag culture as far as collecting free stuff, and since we were all out of AA labeled beer bottle openers, it

Attending this event were mostly probation officers from all over the state, representing both County and State probation/parole agents. As for the vendors present, they varied greatly, but roughly represented various halfway houses, other professional associations, Breathalyzer manufacturers and installation/ monitoring services, treatment facilities, MN DOC programs, boys ranches, private social or mental health services, and a number of college recruiters. I did my best to make sure to talk to most of the halfway house representatives, boy's ranches, MN

The new DCM from District 15 sent this to me with a brief message that the ideology behind them is that if everyone would abide by the "musts" found in the text of Alcoholics Anonymous then we would have no need for any of the "rules," thus distinguishing any controversy over what we can and cannot do.

A big thanks to Melissa M. for contributing and Pat M., also from District 15, for coming forward with the article.

- 1. Pg. 62. Above everything, we alcoholics must be rid of this selfishness.
- 2. Pg. 62. We must or it kills us.
- 3. Pg. 69. Whatever our ideal turns out to be, we must be willing to grow toward it.
- 4. Pg. 69. We must be willing to make amends where we had done harm, provided that we do not bring about still more harm in so doing.
- 5. Pg. 73. We must be entirely honest with somebody if we expect to live long or happily in this world.

Where does the money go? Essentially Area 35's purpose and responsibility is to perpetuate Alcoholics Anonymous. In its beginnings, our society expressed many needs of which were born many services. There were pleas for help, guidance, and support at the group level. We needed literature, updated meeting lists, good publicity, and cooperation with hospitals, legal entities, and treatment centers. And, we needed someone to facilitate all these services. It became clear very quickly to Bill that in order to ensure the health of AA as a whole, we needed a General Service Structure that could help meet the varied and ongoing needs of the group. Our ultimate goal in Area 35 is to ensure that AA groups in Northern MN (and worldwide) have the ability to continue to thrive, and carry the message to the still suffering alcoholic. To do this, it is obvious we still need many services: archives, public information, corrections, literature, Grapevine, Cooperation with the Professional Community, and treatment facilities.

This, then is the function of Area 35: to build a healthy environment, that AA may continue to flourish

and meet the needs of alcoholics, for so long as we are needed. One way we do this is through providing a venue and opportunities for the groups (through their representatives) to communicate their wishes, concerns, and questions through the service structure, as well as addressing the needs of AA locally. In order to do this, the Area Committee (Area Officers and Area Action Committee Members) was formed and area events (Winter Workshop, four Area Committee Meetings, and Two Assemblies) were set up. (More about this can be found in the AA service manual).



Clearly we need people to oversee the successful and ongoing functioning of our Area Committee: a treasurer to pay bills and collect contributions, a secretary to record the minutes and Area actions, an Area Chair to set up and facilitate all the events, an Alternate Delegate to set up the Winter Workshop and Zonal Forums and be informed on eve-



rything the Delegate knows in case they need to stand in for the delegate, and a Delegate to carry our conscience to the General Service Conference once a year in NY to share our Area's conscience and fulfill the responsibility given to us by Bill and Dr. Bob: *to be responsible guardians of our world services and Alcoholics Anonymous as a whole.*

Then we have Area Action Committee chairs who also provide various services and fulfill duties that help the Area to function successfully as a whole. **The chairs' purpose is to serve the groups by ensuring that AA, as it relates to their committee, is healthy.** The group records chair records all Area 35 group information and updates GSO as well as encourages groups to get registered; the webmaster updates and maintains the Area websites which list all the registered groups and events in the Area; the archivist maintains an awesome stock of archival materials for the Area; the literature chair orders and provides literature; and the Northern Lights editor compiles and edits our newsletter which

we use to communicate with the groups. The Area also prints and distributes the Northern Light, a newsletter outlining the activities of the Area. Other Area Action Committee chairs regularly chair meetings with participants from the districts to discuss issues related to doing Twelfth Step work and meeting the groups' needs. These include the archives chair, public information chair, corrections chair, literature chair, grapevine chair, CPC chair, and treatment chair. You will find these chairs meeting at the four area committee meetings (located in Aitkin) and two assemblies. They also frequently hold workshops to assist and inform AA members.

Maintaining a strong service structure through self-support and participation is vital, for without it the groups become disconnected from the Area and from the General Service Office. Then, the groups can no longer communicate their thoughts, opinions or ideas to the Area or the General Service Office. When this happens, we are no longer responsible for our third legacy; instead of a fellowship, we have the seeds of a dictatorship or tyranny where the few govern for the many.

Perhaps one of our most important services to our groups is our role of the link to the General Service Office. It is our responsibility to ensure that the General Service Office and Conference remain committed to the Traditions and serving the fellowship, while never becoming the "seat of perilous wealth or power." This is only accomplished

TWELVE CONCEPTS for WORLD SERVICE (Short Form)

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."

VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal

IV. At all responsible levels, we ought to maintain a traditional sonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

> XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of ungualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
