





The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.

Grapevine and Conference-approved literature.

- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.
- Remind G.S.R.s to inform groups and individuals about the A.A.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

AREA CHAIR'S REPORT

As I write this, not more than a month has passed since our Spring Assembly, and yet it appears I still have much to say!

First, I want to reiterate something stated at the Spring Assembly: the primary role of **all Area servants is to help perpetuate Alcoholics Anonymous in Area 35.** That is, to ensure that AA can continue to flourish and that AA groups can continue to carry the message to the still suffering alcoholic. To this end, we (the area committee) have the responsibility to the Districts and Groups to work toward the health of Alcoholics Anonymous through our specific committees or assigned roles. There are many ways to ensure the health of AA in Area 35, among them: I have encouraged the Area Action Committee Chairs to make frequent contact with the Districts near them to see how we can assist them in building a healthy area. The DCM outreach and communication should include visits and phone calls to the districts. If

you are not seeing or hearing from an Area Committee member on a regular basis, please let me know and I will get you a contact.

As the Area's primary duty is to look specifically at what we can do in Area 35 to strengthen AA for future generations, I have



also asked all action committee chairs to consider and discuss how we can better meet the needs of AA in our respective positions. One specific way area chairs have been asked to meet this duty is to discuss with their committees how to utilize (or improve) the website (so that PI would come up with content and ideas for the website that might be useful for professionals treatment would consider how to better meet the needs of treatment facilities archives would consider interesting ways to encourage awareness of AA history, and so on.). I expect there will be some extensive and intensive discussions on this at the June Area Committee Meeting.

At the Spring Celebration of Recovery on May 2, I was able to touch base with several Area Committee members. Pete (Archives Chair) and I talked about things he could do to encourage awareness of the history of AA, and I'm looking forward to seeing what he comes up with! Paul (Treatment-Remote Communities chair) and I discussed the role his committee might play in reaching out to the American Indian populations in Northern MN. There is a vital need to reach out to the reservations and see if we can be helpful. I hope we can assist districts in making those connections locally. Please contact Paul or I if you have any ideas on this.

I have also set up our fall Zonal Forum which will be held Saturday, September 13^{th} in Zone 3 which consists of District's 5, 6, 7, 11, 13 and 18. It will be held at the Fort Ripley Town Hall from 12:00 - 4:00 and I would like to thank District 7 for hosting. I have been in contact with those districts and have asked them to take our format to their district meetings for discussion and have their GSR's also take it to their groups for any added topics or concerns they may have. We want to be of service in any way we can during our time at these forums. They are so important to have because they allow Area 35 to communicate directly with those districts and their groups. Please mark your calendar and plan to attend, we look forward to seeing you there!

As you also may know I have set up our Area 35 January Service

Due to the drop in contributions from previous years, Randy and I brainstormed some ways to encourage self-support in Area 35, including the creation of a Seventh Tradition flyer to explain the use of and need for contributions to the Area, and the need to emphasize the Birthday Plan. We also discussed the importance of sending thank you letters to every group that contributes, and you should expect to see those thank you letters soon. We also decided to put together Seventh Tradition packets with Area 35 envelopes and pamphlets about the Seventh Tradition to hand out to DCMs at the area committee meetings and assemblies. I shared these ideas (emphasizing the Birthday plan and the explanation of

what the Area money gets used for) with our Area webmaster for possible inclusion on the "Contributions" page, and I intend to continue working with him on improving this page. Stay tuned! And, if you have any other ideas on how to raise awareness of the Seventh Tradition, please let me or Randy know!

Per the discussion at the Spring Assembly about assisting District 17 in becoming active again, I visited the District 7 meeting (where District 17 members attend) and offered the Area's assistance to the D17 GSRs present. They are a new bunch in service



and currently busy working with District 7 on a Founder's Day for June (which Brad will be attending with an Area Archives display), but intend to pose the idea of starting up the district to their groups soon. Of course, each group is autonomous and has the right to make their own decisions, including whether or not to be involved in the service structure. I'm hoping there will be some interest though, as it would be beneficial for the health of the AA groups to stay connected to the service structure.

I communicated with a member in the Florida area regarding how we structure our assemblies and whether or not we let the GSR's make and second motions at Area Assemblies (we do, and I found out they currently don't. Interesting). And, I did some good old Twelfth Step work made possible by the Service structure! I was put in contact with a still suffering alcoholic through the use of our Area website-thanks Jake for forwarding me her contact information! It is great to see the service structure lead directly to Twelfth Step work. **However, this also raises the question: how the Area can best meet the needs of the still suffering alcoholic through the Area website?** The Area Officers will be considering this issue at the June committee meeting, but I would also love to hear your suggestions or ideas.

After speaking with Neil R. (DCM District 18), who expressed a desire by his District to see an Area event near them, I reviewed the locations of past Area events and selected districts for upcoming events that haven't hosted an event in many years. Hopefully we will be able to rotate events through the districts in the assigned zones, and get an Area event held in each district. Of course, that is provided the district has an event center that can hold us. This has been the reason some districts with smaller towns, like District 18, haven't hosted Area events in awhile. I forwarded all this information to the event scheduling service recommended by the Area to set up events for the next 2-3 years and she'll be getting back to me soon.

As always, I am grateful for the opportunity to serve and strengthen Area 35. Sarah K. In closing, here is a quote that summarizes our fellowship quite well: *"Coming together is a beginning; keeping together is progress; working together is success." Henry Ford* smaller and participation is limited and some positions are harder to fill." The DCM, Alternate DCM and Archives Chair attend and visit many of the groups to encourage participation in the District. We let them know that the Area would help out in any possible way for service activities, questions, concerns or problems they might encounter for future reference.

We also went over the Conference Agenda Items and assisted with items that they were not informed of stressing the importance of an "informed group conscience." The DCM did an excellent job presenting the material.

There are still many Districts that need to be visited and informed of the "7th Tradition" – self-support and where the money goes and what services we provide. In my latest report, I stressed the importance of the groups stepping up to the plate to contribute to the area as our services have increased with the addition of some much needed equipment and software for the committees and the addition of an extra service position. Currently, contributions are down and services are up. So we need to make constant effort to encourage the 7th Tradition. It is not only the Treasurer's duty and responsibility but all of our responsibility to encourage self-support.

The Birthday plan is also an essential service that is provided and should be utilized on a more frequent basis. In 1955 the General Service Conference approved the Birthday Plan, under which some members of the fellowship send a dollar a year for each year of sobriety they have in AA. Others use a figure of \$3.65, a penny a day, for each year. Some give more, but the amount cannot exceed \$3000.00 for any year. Please encourage use of the Birthday Plan in your Groups and Districts.

In addition, here are some notable Facts to think about: 42.4% of groups contribute to the General Service Office—Costs of Services provided by GSO are \$6.43 per member per year—Cost of Service per group per year is \$138.69—Contributions per member per year \$4.67—Contributions per group per year \$100.69—Costs of Services **NOT** covered through contributions (that must be made up by using literature profits) per member per year \$1.76; AA Literature sales account for 56% of GSO's income.

Personal thought for you to think about: What is the value of your sobriety? The word "support" has to do with sharing, people, self-respect, gratitude, and what we are privileged to give—not take in material terms.

maps.google.com and enter the address. When google finds the address check the map. Did google get the correct location? If google has the wrong location find and click the "?" on the map. Click the "Report a data problem" Answer the questions and google will fix the location. Events on our calendar will use google maps to pin point the location. To use this feature we need an address that includes street, city and state.

It is a good idea not to use local information for the location. Examples are "Debs, MN" or "The Bagley American Legion."These places have addresses and full names. "Debs, MN" is really The GPS Roosevelt Town Hall, 25053 Debs Rd. NW, Shevlin, MN, United States. The Bagley American Legion" is located at 112 Main Avenue North, Bagley, MN, United States. By using the full address, all AA members will be able to find the event.

When possible include contact information on the flyer. The contact needs to know and approve of putting the information on the WEB. Contact information should never include a last name. Use an e-mail address that does not include a name or a private business name. Use a gmail.com e-mail address vs. mybusiness.com. Before allowing a phone number on the WEB it is a good idea to search the WEB for the phone number. Searching a phone number on the WEB may return full names and address including all family members. One can get a free google phone number. This is a good number to use for AA purposes. A google phone number can be forwarded to another phone. When I see my google voice number on my phone I know that the incoming call is probably about AA. If is not convenient for me to talk about AA I can let

ARTICLES

Does the Area 35 Committee, along with the current rotation of GSR's belong in congress instead of Alcoholics Anonymous?

It would appear so, as the voting members of the Area 35 Spring Assembly continued to approve more spending despite the threemonth decline in group contribution. At one point during discussion of a proposal to purchase a new computer and several software programs Steve L., past Area Treasurer and current Financial Oversight Committee Chair approached the mic to ensure that the voters understand that when they voted in favor of these various items they were also agreeing to shoulder the responsibility to go back to their groups and state their position that these various proposals were indeed, valid needs, and to encourage them to get their contributions up. For the most part, this is what inspired me to write this article.

I had been reflecting on our changing needs, problems, solutions and at times wondering what we seemed to be missing—although I am reasonably certain everyone ever involved with any type of service work has asked themselves that question. I was reading from Alcoholic Anonymous Comes of Age on AA's Third Legacy (see accompanying story), when thoughts about our specific needs coincided with the words I was reading. I believe most of us are the most passionate about the program when we are "in the literature," and further believe that the reason for this is our strong connection with anything involving our history and those who have come before us, and our gratitude and awareness of how difficult things were in the beginning and of the recognition of spiritual forces at our aid during those difficult times.

From pages 140-141, Alcoholics Anonymous Comes of Age:

...Regarding any particular service, we need to ask only one question: "Is this or that service *really needed*. If it is not, then let it be eliminated. But if it *is* needed, then maintain it we must or fail in our mission to those who want and seek A.A. For twenty years now we A.A.'s have been trying to determine what are needed services and what are not. As I tell the stories of A.A.'s services, I hope that the **vision** of our Third Legacy will come clear.

Let's begin with my own sponsor, Ebby. When Ebby heard how serious my drinking was, he resolved to visit me. He was in New York; I was in Brooklyn. His resolve was not enough; he had to *take action* and *spend money*. He called me on the phone and then got in to the subway.; total cost, ten cents. At the level of the telephone booth and subway turnstile, spirituality and money began to mix. One without the other would have amounted to nothing at all. Right then and there, Ebby established the principle that A.A. in action calls for the **sacrifice** of **much time** and **little money**.

Now let us have a look at one of those little meetings we held that

I am not alone in saying that I feel a lot better about spending money when I see where it's going and that it is being used in the most efficient manner to fulfill whatever need it was intended for. Most of us have family members and friends who are in some way touched by the work we do—directly or indirectly—in jails, prisons, treatment facilities, hospitals, courts, health fairs and other venues throughout society, and because of that we are able to see the necessity for Area expenditures. I hope you read the adjoining article, and after reading I would like to challenge you to ask yourself two questions: "Am I really doing my part in sacrificing 'time and money,' no matter which of the quantifiers little, some, much—I put in front of those two words?" and "Is it really a sacrifice, considering what I receive back?"

The first paragraph of my article, though completely factual, is worded in a farcical manner and as editor of the Northern Light, I first summer in Akron. We gathered in Dr. Bob's living room. Anne made her home ready for us, so we had shelter over our heads. There was some expense for coffee and Dr. Bob paid it. If Dr. Bob and Anne had not given these hospitable services, no meeting could have been held.

As the Akron meeting got larger, it moved over to the house of T. Henry and Clarace Williams. They purchased a lot of chairs, served many suppers, and stood for much wear and tear on their house too. We alcoholics did not pay a cent. T. Henry and Clarace **sacrificed** a great amount of **time** and **some money.** If they had not done so there could not have been any meeting.

In these obvious examples I think we can see what the test of an A.A. service really is. Whether it is a book, a translation, a service conference, or a twentieth anniversary convention, the principle is the same; the test is identical: *Do we need this particular service* or do we not. That is the only question.

THE LONELY EMBER

A member of a certain AA group, who previously had been attending meetings regularly, stopped going. After a few weeks, a home group member decided to visit him. It was a chilly evening. The home group member found the man at home alone, sitting before a blazing fire. Guessing the reason for his AA friend's visit, the man welcomed him, led him to a big chair near the fireplace and waited. The visitor made himself comfortable but said nothing. In the grave silence, he contemplated the play of the flames around the burning logs.

After some minutes, the visitor took the fire tongs, carefully picked up a brightly burning ember and placed it to one side of the hearth all alone. Then he sat back in his chair, still silent. The host watched all this in quiet fascination.

As the one lone ember's flame diminished, there was a momentary glow and then its fire was no more. Soon it was cold and "dead as a doornail."

Not a word had been spoken since the initial greeting.

Just before the visitor was ready to leave, he picked up the cold, dead ember and placed it back in the middle of the fire. Immediately it began to glow once more with the light and warmth of the burning coals around it.

As the visitor reached the door to leave, his host said, "Thank you so much for your visit and especially for the fiery reminder. I shall be back next week."

The moral of the story: whether it be AA groups or individual alcoholics, together we burn brightly. Alone we die.

From our Area Secretary Roger R.:

In working on a PI project with a reporter from the St. Cloud Times and Terry B., Chairman of the General Service Board of Alcoholics Anonymous, I was asked to provide questions and answers on the concept of anonymity in the digital age. This article was published as a front page story on March 30 in the St. Cloud Times and also appeared on the newspaper's website. The questions and answers I provided for this story follow.

1. How big is AA today?

A recent estimate provided by the General Service Office indicates there are 114, 642 groups world-wide with an estimated 2,131,549 members. There is an AA presence in 170 countries. In the St. Cloud, MN area there are approximately fifty weekly group meetings and an estimated 1200 AA members.

2. The name of your fellowship is Alcoholics Anonymous. This suggests anonymity is an important aspect of your organization? For the past 78 years our primary purpose has been and remains the same: to carry our message of recovery to still suffering alcoholics.

of AA members may, if they wish to do so, disclose their full names.

AA members do not need to be anonymous with friends, family or neighbors. At this level disclosing AA membership is right and good. AA members are often approached on an individual level by potential members seeking a solution to their drinking problem.

Before the general public i.e.: press, radio, films, television and books etc., individual members are strongly discouraged from revealing their full names and pictures.

This discourages individual members from the temptation to gain fame or monetary advantages as a result of their AA affiliation. Also, if an AA member publicly announces his/her AA affiliation and subsequently falls off the wagon so to speak- this occurrence could damage the good reputation of our fellowship.

AA has enjoyed a positive press relationship for many years. This relationship has assisted AA in attracting many members on the basis of positive press. The fact that AA does not publicize its leaders or members has lead to both media intrigue and positive press perceptions.

4. Has AA's tradition of individual anonymity at the level of press radio, film and television been extended to digital communication?

Yes, the theme of the 2012 General Service Conference of AA was: "Anonymity our Spiritual Responsibility in the Digital Age." This annual conference is attended by representatives of areas throughout the US and Canada, as well as AA board members and staff from the General Service Office. Presentations at this conference strongly suggested that communication on the internet is public and at the level of press, radio and film.

5. What about websites?

AA entities at local, regional and national levels maintain websites. In guidelines on internet published by the General Service Office these websites are discouraged from linking to non- AA websites. This protects the anonymity of AA members visiting these sites and eliminates perceptions of AA affiliation with non-AA entities and organizations.

6. How does AA address anonymity on General Social Networking Websites?

Communication on Facebook, Twitter and other socialnetworking websites is considered to be public. Although users create accounts and enter via usernames and passwords, these are public media in which AA members and non-AA members interact. Individuals are discouraged from identifying themselves as AA members on social networking websites. "Experience suggests that in keeping with the Eleventh Tradition, AA members are encouraged not do disclose AA membership on social networking sites as well as on any other website, blog, electronic bulletin board etc., that is not composed solely of AA members and not password protected, or is accessible to the public. (A.A. Guidelines, Internet, General Service Office, NY, NY.)

Lessons learned by our fellowship, in our early years, lead to the development of twelve important traditions. These traditions serve to keep our fellowship alive and well. Tradition Twelve is: "Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities. "Thus anonymity is a critical part of all of our important traditions.

While the individual AA member is anonymous, Alcoholics Anonymous as a spiritual fellowship is not anonymous.

3. How is anonymity important for individual AA members? When current members and new members attend AA meeting, their anonymity is protected. Members do not talk about whom they see at AA meetings. This form of anonymity encourages attendance in meetings and membership in AA. At closed meetings 7. How does AA handle anonymity and E-Mail?

E-mail is used regularly as a service tool in AA. Many members find it best not to disclose direct AA affiliation in email subject titles. It is also important to consider the anonymity of recipients of messages. Thus it is a good idea to obtain an AA member's explicit permission before using his or her email address for AA correspondence. (A.A. Guidelines, Internet, General Service Office, NY, NY.) May / June 2014

8. What about anonymity of AA members on online audio, video such as YouTube and webcasts?

These media are also considered to be public. In these media AA members are also discouraged from showing their full picture and/or disclosing their full names as AA members?

9. What happens when AA members do break their anonymity at the public level?

If the General Service Office becomes aware of the anonymity breach, a staff member may contact a service representative in that member's local area, to contact the individual AA member with concerns about traditions. It is also likely that an individual in that member's local area will contact this AA member.

10. How do individuals who wish to contact Alcoholics Anonymous do so?

On a local level in St. Cloud, AA members maintain a 24-7 assistance line: 320-202-1895.

On a statewide level in Minnesota: aameetinglocator.org; area36.org (Southern MN); and area35.org (Northerm MN)

On a national level: AA.org

Early Public Information Work

When in 1941 the *Saturday Evening Post assigned* Jack Alexander to scout A.A. for a feature story, we had already learned our lesson. Therefor nothing was left to chance. Had Jack been able to get to St. Louis for the convention he himself could had told how skeptical he had been of this assignment. He had just finished doing a piece on the Jersey rackets, and he didn't believe anybody on a stack of Bibles a mile high.

After Jack checked in with us at Headquarters, we took him in tow for nearly a whole month. In order to write his powerful article, he had to have our fullest attention and organized help. We gave him our records, opened the books, introduced him to nonalcoholic Trustees, fixed up interviews with A.A.'s of every description, and finally showed him the A.A. sights from New York and Philadelphia all the way to Chicago, via Akron and Cleveland. Although he was not an alcoholic, Jack soon became a true A.A. convert in spirit. When at last he sat down at his typewriter, his heart was in it. He was no longer on the outside of A.A. looking in; he was really inside looking out. As soon as the article appeared, 6,000 frantic inquiries hit our New York post office. Jack's piece made Alcoholics Anonymous a national institution, and it also made him one of our greatest friends and, finally, one of our Trustees.

The kind of help we gave Jack Alexander—our organized service of public information—is the vital ingredient in our public relations that most A.A.'s have never seen. But in the St. Louis pressroom the visitors did see one aspect of it, working this time for the convention itself. There sat A.A.'s Ralph, handling our contacts with the press. He was surrounded by phones, typewriters, piles of releases, clipsheets, telegrams in and out—all the gadgets of his trade. Now what was he doing and why? Could this be a ballyhooed promotion stunt, something quite contrary to A.A.'s Traditions?

Not a bit of it. Ralph was handling this job simply to help out friends of press, radio, and television. The whole world wanted to know about our twentieth anniversary. Newspapers and magazines wanted interviews and press releases. Radio and television broadcasters wanted to arrange for interviews. People wanted us to explain what we meant when we said A.A. had "come of age."

A prudent reserve is an emergency contingency plan to help meet the group's needs in the event of an unexpected shortfall of the groups finances. There were also discussion on various methods of contributions which included the birthday plan: which are contributions for an individual's number of year's sobriety. Contributions for \$1.00 per year or as much as he or she wishes to contribute up to \$3000.00 annually. At the Area level, you can also request that your group be credited. In other business, group contributions have been on the decline the last 2 years as well as the last 2 periods of this year. Groups need to step up the contributions for this year to meet the needs of our services we provide. We all play an integral part and need to go to the groups and inform them of the importance of our 7th tradition. Jerry S. Q: Why do we not do agenda items before area chairs and DCM reports? Agenda for assemblies is done by Area Chair and Delegate. Past area practice, chooses to use this time for reports because it is the only time that GSR's get to hear area officers, chairs and DCM reports.

Tom A. Q: Do we get ice cream? A: We should get as much as we want?

Bruce B. Q: What makes a person want to serve as delegate? A: It is not about wanting to be delegate. Area elects the person who has best served you, has skills and traits necessary and is willing to serve. Wanting to be in a position isn't part of AA service.

If someone asks you – you need to be willing to serve.

Susie A. Q: Do late meetings on Saturday night become counter productive/ Late night meetings and input from the assembly is really appreciated by the delegate. Jake is very grateful that we talked about all the agenda items, so he can understand the area's feelings and thinking on the agenda items.

Bruce B. (Wartime Delegate). If you want to have last word- Try saying "you are right." Q: Did anyone else get a blank computer disc, yes (2).

Bob. J. Why would anyone want to be delegate? A: Need to have a willingness to serve.

Jim K. Q: Could we ask past delegates to do a concept workshop during the assembly? A: Yes

Jerry S. Q: Can we have our archivist to do a presentation during an assembly? A: Yes

Tom A. Q: Is the article in the St. Cloud Times violating traditions, is it on the edge/ A: Reporter wrote in SC Times on SC Susie A. Q: Will GSO come out with a large print AA comes of age.

A: Not yet, don't know when?

Bruce B. Q: Why don't we pass an area-contribution basket at area functions? A: we pay for area functions through group and district contributions

Bob J. Q: What can we do to assist District 17. Yes an area can help a district to get up and running. Just ask an area officer for help.

Jim K. Q: On hair modifications required for past and current delegates. A: Spiritual growth- leads to major hair loss.

Susie A. Q: Got flyer from Gopher State Round-UP. Haven't ever attended. Did this come form area 35? A: No, may have come from other round-ups. Can't speak to how this happened. Need to check with Gopher State- don't know how they get names on their list.

Jerry S. Q: Why not start agenda items discussion earlier. Attempted this once but break out reports were not ready. This comes up from time to time- are open to suggestions. Tom A.been coming since 1988- got done early last night. It is a good problem.

Tom A. Q: Are area contributions less than they use to be? For first three months- 2012 -\$8,800, 2013-\$6600, first three months of 2014 \$3,900. Yes they are down.

Susie A. Q: If clubhouse accepts more than one kind of group, how does this support singleness of purpose? A- Keep talking about the third tradition and singleness of purpose.

Bruce B. Can we use the three leg stool as our official trademark? See if its open legally- than bring it up.

Bob J.Q: Many groups don't have anything to do with district, area or GSO. A: This is the essence of service. Go to groups and talk about the importance of general service, also talk with our sponsees, get out to groups. Building of Northern MN Are Assembly began with a couple of people- we can get active in our districts. Invite someone to go to a district meeting or area workshop.

Jim K. Q: It appears our fellowship was confused or not informed on agenda items why? How to improve? Wording of items could be improved? What the item is asking for is confusing at times. A: Our job is to help with that process. Time for review is a challenge today. Ask area folks who attended WCRAASC to help with your group and district group conscience.

Tom A. Q: Can we get agenda items at fall assembly- no.

Round Up, on addicts attending the round-up. Asked reporter to come over to my office and discuss. Gave writer idea - to write a story on Anonymity in our current Digital Age. Reporter got ok to investigate story from editor of paper. Butch R., PI Chair brought up at December 2013 ACM. Roger R. (past PI Chair) was asked to meet with St Cloud Times Reporter. He met with reporter several times to orient. Reporter said he needed last names of AA sources, said we could not provide last name in press. We did say he could talk with Terry B., AA General Service Board Chair (non- alcoholic). Publication of our first name and last initial is consistent with our traditions. A new service piece, on anonymity in digital age was shared with writer. We did everything we needed to do to ensure we were following traditions. Article was also about St. Cloud State Recovery Program and NA. Individual pictured was not identified as an AA member in the article. Our quotes followed AA traditions very closely. We were not anywhere close to the edge in breaking anonymity in this article.

Can get board minutes from committees that will give us knowledge of some of the potential items. Dec 15 is deadline for submitting items to GSO.

Closing remarks from Scott.

TWELVE CONCEPTS for WORLD SERVICE (Short Form)

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.

XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

SELF SUPPORT FLYER

Where does the money go? Essentially Area 35's purpose and responsibility is to perpetuate Alcoholics Anonymous. In its beginnings, our society expressed many needs of which were born many services. There were pleas for help, guidance, and support at the group level. We needed literature, updated meeting lists, good publicity, and cooperation with hospitals, legal entities, and treatment centers. And, we needed someone to facilitate all these services. It became clear very quickly to Bill that in order to ensure the health of AA as a whole, we needed a General Service Structure that could help meet the varied and ongoing needs of the group. Our ultimate goal in Area 35 is to ensure that AA groups in Northern MN (and worldwide) have the ability to continue to thrive, and carry the message to the still suffering alcoholic. To do this, it is obvious we still need many services: archives, public information, corrections, literature, Grapevine, Cooperation with the Professional Community, and treatment facilities.

This, then is the function of Area 35: to build a healthy environment, that AA may continue to flourish and meet the needs of alcoholics, for so long as we are needed. One way we do this is through providing a venue and opportunities for the groups (through their representatives) to communicate their wishes, concerns, and questions through the service structure, as well as addressing the needs of AA locally. In order to do this, the Area Committee (Area Officers and Area Action Commit-

tee Members) was formed and area events (Winter Workshop, four Area Committee Meetings, and Two Assemblies) were set up. (More about this can be found in the AA service manual).

Clearly we need people to oversee the successful and ongoing functioning of our Area Committee: a treasurer to pay bills and collect contributions, a secretary to record the minutes and Area actions, an Area Chair to set up and facilitate all the events, an Alternate Delegate to set up the Winter Workshop and Zonal Forums and be informed on everything the Delegate knows in case they need to stand in for the delegate, and a Delegate to carry our conscience to the General Service Conference once a year in NY to share our Area's conscience and fulfill the responsibility given to us by Bill and Dr. Bob: *to be responsible guardians of our world services and Alcoholics Anonymous as a whole.*



Then we have Area Action Committee chairs who also provide various services and fulfill duties that help the Area to function successfully as a whole. **The chairs' purpose is to serve the groups by ensuring that AA, as it relates to their committee, is healthy.** The group records chair records all Area 35 group information and updates GSO as well as encourages groups to get registered; the webmaster updates and maintains the Area websites which list all the registered groups and events in the Area; the archivist maintains an awesome stock of archival materials for the Area; the literature chair orders and provides literature; and

the Northern Lights editor compiles and edits our newsletter which we use to communicate with the groups. The Area also prints and distributes the Northern Light, a newsletter outlining the activities of the Area. Other Area Action Committee chairs regularly chair meetings with participants from the districts to discuss issues related to doing Twelfth Step work and meeting the groups' needs. These include the archives chair, public information chair, corrections chair, literature chair, grapevine chair, CPC chair, and treatment chair. You will find these chairs meeting at the four area committee meetings

(located in Aitkin) and two assemblies. They also frequently hold workshops to assist and inform AA members.

Maintaining a strong service structure through self-support and participation is vital, for without it the groups become disconnected from the Area and from the General Service Office. Then, the groups can no longer communicate their thoughts, opinions or ideas to the Area or the General Service Office. When this happens, we are no longer responsible for our third legacy; instead of a fellow-ship, we have the seeds of a dictatorship or tyranny where the few govern for the many.




Perhaps one of our most important services to our groups is our role of the link to the General Service Office. It is our responsibility to ensure that the General Service Office and Conference remain committed to the Traditions and serving the fellowship, while never becoming the "seat of perilous wealth or power." This is only accomplished through the sharing of our group's consciences at Area events, which are only possible with the ongoing financial support received from the groups. So you see, all area chairs are there to serve the groups, but to fulfill our duties of service, funds are required.

If each registered group would contribute **\$1.00 a month to GSO**, our Office would be fully self-supporting. Similarly, in Area 35 if each of the 232 actively contributing groups (41% of the 555 registered groups) would contribute **\$12.88 a month or \$2.86 per week to Area 35**, it would fully cover the Area's monthly
