



#### **AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE**


- ♦ Area Chair calls to cancel and/or re-schedule.

#### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
   If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and
   G.S.O.
- Provide leadership in solving local problems involving the A.A.
   Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation
  - Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
  - Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

#### **AREA CHAIR'S REPORT**

Greetings! I am grateful for the ongoing opportunity to serve Area 35, and learn how to put the principles in action. During the last month a lot has happened. Our Alternate Delegate, Kelly, had to step back from serving for awhile to deal with personal and familial medical issues. We send our prayers and wishes for her and her family. In the meantime, Jake and I stepped in to plan and host the Winter Workshop. Having the current GSB Publishing director, Greg, as a speaker was quite a treat! I think I almost ran him ragged during his time with us by trying to get him to visit with as many Area 35 servants as possible! His presentations were informative and he was open and welcoming during the sharing session he chaired. I know I certainly felt that our thoughts and concerns were heard, and taken seriously. In fact, I know he has already connected with one individual in response to a question posed during the weekend's discussion. The GSRs and DCMs, as well as other individuals also had the opportunity to ask further questions of the speaker during the weekend as he sat in on the GSR and DCM sharing sessions. We extended an open invitation to dine with him, and so he was well accompanied at every meal.

At the Workshop I also had time to look into the Area Treasurer's period 5 reports, and I'm happy to report that with some help, I was able to correct all of the expense classification errors noted at the December Committee Meeting. The expenses should now be classified correctly, but this serves as a good reminder that every area chair should check their expense details against their vouchers to ensure proper classifications. Just before the winter workshop our current corrections chair, Skip D., notified me that he would be stepping down due to irreconcilable differences. I'm sure I speak for all when I say that we appreciate his hard work and service these past three years. Fortunately, I was able to find another willing and qualified servant, so please join me in welcoming Jake C. from District 5 to his new position as our Area Corrections Chair. I have also had the privilege of conferring with some DCMs and individuals on salient district and area issues. What a blessing to have so many people passionate about A.A. and making it better!

I want to include a few reminders I sent in an email to the Area Committee as well. First, any proposals groups or districts might want the area's conscience on at the Spring Assembly should be submitted to me or the DCM for inclusion in the February committee meeting agenda to allow time for an informed group conscience. Second, with the WCRAASC coming up, if any districts or groups are interested in having one of the Area servants attending the WCRAASC assist the district/group with their discussion of the GSC agenda items, you may want to consider connecting with them at the February Committee Meeting. Third, anyone interested in putting forth an agenda item through the area for consideration by the 2016 GSC, please consider submitting the item by the Spring Assembly so that there is time for the groups to discuss the issue and return with an informed group conscience to the fall assembly. This will allow time for a proposal to be submitted by the January deadline. I also asked our area chairs to be thinking of future trusted servants for the Area. If you have an interest, getting involved in Area committee work is a good way to learn how the area operates and test if it might be a good fit for you!

I have nailed down the location of our upcoming 2015 Fall Election Assembly. It will be held at the St. Cloud River Center. I am just waiting on the contract to be finalized. I believe travel plans are being arranged for the WCRAASC, and will be discussed at the February Area Meeting. I noticed that the site selection policy in our Area Actions Book does not match current practice. I have asked our secretary Roger to take a look at and revise it to

reflect current practice. I am also trying to locate the "action book guidelines" referenced in the secretary's guidelines. If anyone happens to know of such a thing, please send them to myself or Roger! The Area Officers conferred at the December Area Meeting and requested the Financial Oversight Committee meet only at the four Area Committee Meetings (or fewer if feasible) in 2015. We also requested that the treasurer review the statement of financial responsibility for its continued viability, and if necessary submit any proposed changes to the body. The Statement of Financial Responsibility was revised when the Financial Oversight Committee was created to include this committee. We suggested that since six years have passed we are in a better position to make recommendations regarding the scope and composition of the Oversight Committee. On a different note, at the request of Mike, DCM District 2, I visited with the 40 Club, a hotel in Aitkin, MN, and negotiated a reduced hotel room rate of \$77 a night plus tax for those who might want to stay overnight for area committee meetings. If you are interested in this option, please let me know and I will set aside more rooms.

Finally, I am still working on putting together a document that more accurately reflects our projected expenses for 2015. I anticipate it will be completed by the February Area Committee Meeting. I think this document will be helpful in planning for future events and budgeting. It is also symbolically important as a way to acknowledge that the minority voice was heard at the Fall Assembly, and even with the budget passing we can still make a good faith effort to reconcile the disagreement. As previously stated, Trusted Servant Guidelines and Area Actions Book will be updated to reflect that Area budgets should predict expected expenses that servants actually expect to incur so that our budgets will hopefully be more in line with our actual expenses. In the end, this is your Area, and we serve you, so if you or your group wants to see something change (or stay the same!) with the Area, please use your voice through the structure to make a proposal and submit it to me for inclusion on the appropriate agenda.

#### TREASURER'S REPORT

Greetings! It's been a nice warm winter thus far and everything seems to be going well. I attended the Area 35 Workshop this past week-end in Superior, Wisconsin and was able to go to the morning presentations until noon both days as I also had to work during the week-end, which was quite exhausting to say the least. The presentations were well prepared by the groups and I was impressed by how many groups did their presentations in PowerPoint. In the brief time I was there, I also got to meet our GSO Publications Director. I had little conversation with him but was quite impressed by his demeanor and his knowledge and expertise of AA.

Most of the groups in the Area seem to be doing well in sending in contributions, although we could do much better. I have re-

ceived contributions from groups that have not sent at all during the year which is a good sign for future reference.

We have also converted to new software of QuickBooks Premier 2015 version which seems to be more efficient for the books. It may take a little getting used to. I have received some contributions with wrong group service numbers and there have been some that have different group names and some with no return addresses or contact information. It is really hard if a group has no information on it and it can be hard to track where it came from. I also received a contribution and returned fees from a group in District 12 that had changed accounts where there was a mix-up of changeover of accounts at the time. It has since straightened out. Total contributions for the period were \$1407.07 and total current assets are \$22,961.81. Total in savings are: \$6,039.46 . Group Contributions information and other financial reports will be brought to the next Area Committee Meeting on February 22, 2015 with the Period 1 Reports for 2015.

I think my favorite is "When the spiritual malady is overcome, we straighten out mentally and physically." Big Book pg 64. When I found a sponsor and worked the steps of the program and learned the program of recovery my life changed. I am grateful that I have remained engaged in the process of learning. Another of my favorite promises comes from the Twelve and Twelve, "There is a direct linkage among self-examination, meditation and prayer. Taken separately, these practices can bring much relief and benefit. But when they are logically related and interwoven, the result is an unshakable foundation for life." page 98

We often hear that the traditions are for groups as the steps are for individuals. I personally find that the traditions apply to me individually as well as groups, but I'll save that conversation for another time. However, there is a great parallel to the quote from the eleventh tradition that I believe applies to the groups in much the same way as the principles of recovery apply to members. I would propose that there is an unshakable foundation for our third legacy of service for groups that practice singleness of purpose, anonymity and self-support as spiritual principles. We had some great presentations at the Service Workshop in Superior on all of these topics. I hope that each member brings their thoughts and passion back to their groups so that we in Northern Minnesota can be a "Society of Alcoholics in Action."

I am looking forward to serving Area 35 at the upcoming general service events and I invite you to attend one or two of them yourself.



#### **Definitions:**

#### **Unique Visitor**:

A unique visitor is a person or computer (host) that has made at least 1 hit on 1 page of your website during the current period shown by the report. If this user makes several visits during this period, it is counted only once. Visitors are tracked by IP address, so if multiple users are accessing your site from the same IP (such as a home or office network), they will be counted as a single

The period shown by AW Stats reports is by default the current month.

However if you use AW Stats as a CGI you can click on the "year" link to have a report for all the year. In such a report, period is a full year, so Unique Visitors are number of hosts that have made at least 1 hit on 1 page of your web site during the year.

#### Visits:

Number of visits made by all visitors.

Think "session" here, say a unique IP accesses a page, and then requests three other pages within an hour. All of the "pages" are included in the visit, therefore you should expect multiple pages per visit and multiple visits per unique visitor (assuming that some of the unique IP's are logged with more than an hour between requests)

#### Pages:

The number of "pages" viewed by visitors. Pages are usually HTML, PHP or ASP files, not images or other files requested as a result of loading a "Page" (like js, css... files). Files listed in the Not Page List configuration parameter (and match an entry of Only Files configuration parameter if used) are not counted as "Pages".

#### Hits:

Any files requested from the server (including files that are "Pages") except those that match the Skip Files configuration parameter.

#### Bandwidth:

Total number of bytes for pages, images and files downloaded by web browsing.

Note 1: Of course, this number includes only traffic for web only (or mail only, or ftp only depending on value of Log Type). Note 2: This number does not include technical header data size used inside the HTTP or HTTPS protocol or by protocols at a lower level (TCP, IP...).

Because of two previous notes, this number is often lower than bandwidth reported by your provider (your provider counts in most cases bandwidth at a lower level and includes all IP and UDP traffic).

#### **Underwear Check**

He woke up one morning and decided to get up for the day. It was still very dark out as the result us all going back to standard time. His wife was still sleeping and he did not want to wake her up, so, he decided to quietly get dressed in the dark. He got dressed and went into the kitchen to make some coffee and begin his day. Later in the morning, he needed to relieve himself of some of the coffee and went to the bathroom. In the bathroom, he quickly realized that he had put his underwear on backwards. He took off his pants and made the correction to his underwear. He asked me if I thought he might be getting senile or losing his mind. I told him that I did not believe he was becoming senile. I think he just made a mistake and when he became aware of it, he made the correction.

Some of us are not as lucky as my friend. I explained that some of us put our underwear on backwards and never realize that we made an error. When we find it difficult to go potty, we blame it on the manufacturer designing underwear poorly, or we blame it on society making the change to Central Standard Time and causing darkness at 6:00 AM which effects our accuracy as we dress ourselves. I explained to my friend that for 57 years I had my underwear on backwards. My life was miserable. I was angry. I was shackled by self pity. I was restless, irritable, and discontented. I had no peace of mind and I was drunk much of the time. I did not understand that the cause of my discomforts were of my own making. Although the solution for my issues were simple, I instead came to believe that my difficulties were the result of mistakes made by other persons, places, situations or facts of life. I was in a delusion. The truth was not clear to me. As a result, I lived a life of resentment, fear, and dishonesty.

Near the bottom of page xxviii in the Big Book, Dr. William D. Silkworth writes: "Men and women drink essentially because they like the effect produced by alcohol. The sensation is so elusive that, while they admit it is injurious, they cannot after a time differentiate the true from the false."

I needed help to see the difference between the true and the false. The help was available in Alcoholics Anonymous. The help I needed was abundant and pervasive. All I needed was a little bit of willingness, open mindedness and honesty. I was very lucky and the truth became apparent to me. For that I am extremely grateful.

I have a favor to ask of all my friends in A.A. If you ever notice that I have my underwear on backwards, please let me know.

#### Is AA free?

I was speaking with an A.A. friend a few days ago and he told me Is A.A. free? The preamble states there are no dues or fees for A.A. membership, we are self supporting through our own contributions. What are fees? Fees are a set amount of money usually paid on a yearly basis for the privilege of becoming a member to a club or organization. When fees are not paid the privilege of being a member to the organization or club is forfeited. What are dues? Dues are a set amount paid at specific intervals for use of services for being a member of an organization or club. Since A.A. has neither dues or fees this still does not make it free.

> In A.A. we have a tradition (seven) that we are self supporting. I believe we have the potential to live up to this ideal in its purest form, but more progress is needed. If we are not taking outside donations or imposing on the charity of others we have to pay the full price for services received.

> Question: Is your group fully self supporting or does it impose on the generosity of others? I ask because I doubt that very many groups pay full expenses. Is your rent sufficient to cover its actual cost? Does it really meet the entire outlay for heating, air conditioning, lighting, janitorial and maintenance costs to cover the time while your group meets? Are you allowing your meeting host to cover some or all of these expenses? Do you pay your GSR their actual expenses to attend service functions example; food, lodging, fuel, coffee and registration fees? Or do you expect the GSR to cover these out of pocket? Does your District pay full cost of sending people to Service Functions or pay actual meeting costs? I would suspect about 20% or more of A.A. expenses are paid by individual members for incidentals.

> By not having dues or fees we can make the new person feel comfortable and not have to worry about being embarrassed or kicked out of A.A. for not coughing up cash to be placed in the donation basket that they might not have. In other words, financial status is not a determination for A.A. membership. That way the less fortunate "like you" when you first came into A.A. can find their way, then pass it on.

It's been quoted many times that the Basket is where spirituality and money mix.

#### Area 35/36 Joint Workshop

Open and Introductions at 10:08 A.M.

Cooperation and Communication throughout Minnesota: Missy W. talked about the differences between the Area 35 and Area 36 service structures and even though we are one state divided into two areas we seem to cooperate to help the still suffering alcoholic who may not care that we aren't one Area. One great example is the Corrections program where we have to cooperate because the facilities fall under all of the corrections for the whole state legally. The PI Committee cooperates for the State Fair Booth and the Special Needs committees also need to cooperate. And Terry from Area 36 and Jake from Area 35 shared a cooperation hug at the GSC.

#### **Breakout Sessions:**

Area Officers: Chair of the Meeting is Roger, Secretary of Area 35. Area 36 had their Area elections: Delegate: Lisa G., Alternate Delegate: Curt K., Area Chairperson: Missy P., Alternate Chairperson: Mary M., Secretary: Jeannie H., Treasurer: Karl R.

Question: How do you handle rotations, do you have a meeting to hand off information and materials?

- In Area 36 we have done it differently: Last rotation we did it in conjunction with an Area Committee Meeting which was not effective. This year we are having a separate rotation meeting, where the outgoing will meet with the incoming. We are also going to go over the budget and Trusted Servant Guidelines. That way they will have at least one to two hours to talk. People really want to give the incoming a really good idea of what the job entails. The Area Chair needs to have the Committee Chairs (filled) for the next rotation by then. I just got a meeting room in a public library where it is free rent for nonprofits. I think the best piece is the one-on-one time you get with each other. Two hours isn't the end all, you still need to have communication with others. Having a connection with the outgoing chair where the budget is concerned is invaluable. We have some positions that are non-rotating, but there is a proposal to change those to rotating every four years.
- In Area 35 we don't have a set meeting. The outgoing chairs and officers get together on their own. We have job descriptions for each position. The one on one could be emails and phone conversations. At December Committee Meeting the new chairs are introduced and they have a chance to meet. I find myself going to the past delegates for guidance in my job as well. One of the hardest things is when we share our experience as everyone does the job a little different. It is hard to do it the same way as the previous position holder. We do more one on one than meetings. I don't believe we talked about budgets though. Does Area 36 have job descriptions? Yes. Area 35 doesn't have an Alternate Chairperson. The Area 36 Alternate Chair backs up the Area Chair, chairs the Finance Committee and is the chair of the Recovery, Unity, and Service Conference. Also in Area 36 the Area Committee Chairs have Alternate Chairs, the only positions that do not have alternates are the Secretary and Treasurer.
- How often in Area 36 is the Alternate Chair elected as Chairperson? About half the time.
- If someone is nominated by a District to stand for Delegate they submit a resume by June of the election year and it is put into the Northern Lights. Voting is at the Fall Assembly. Those who were not voted as Delegate can stand as Alternate Delegate. Nominations are not taken from the floor. But, the other officer's positions are taken as nominations from the floor. Past Delegates in Area 35 do not have a vote. Area 36 is in the process of updating the Trusted Servant Guidelines. That process is done by the Structure Committee and taken to the Area Committee to be ratified.

How do we do budgets?

Area 35 would like to get away from the word Budget and go to Financial Statement of Responsibility. One of the problems we run into is that everyone does their own budget, submits it to the chair and it goes to the body for the vote. We always go higher with our budget by budgeting to go

- to the events alone. It makes it look so much higher. We budget for worst case scenario. It makes it difficult for a GSR to get the idea of what is going on when we end up way under budget. It is good to explain the budget when presenting it.
- In Area 36 the Area Chair does the budget with input from officers and committee chairs. We have a variance because we always plan for those to share rides and hotel stays. We have an 11,000 deficit budget for next year. We are under by 10,000 in the budget so far this year. It is important to plan what we need to do and let the money come in. We don't want to let the budget drive what we do. It is important to let the groups know that if we are going to do all of this stuff, they need to support it. In Area 35 we like to talk about the big expenses, such as the West Central Regional Service Conference. We like to plan that so all of the officers can go, instead of only be able to afford sending 3. We talk about what we are getting out of those events as well. Sometimes that changes depending on what we need for equipment, etc. Area 36 has their Committee Chairs budget to do whatever round ups who ask for the Committee displays. When your budget is presented does it get a lot of discus
  - sion? Area 36 does, my first year as Area Chair I had to present the budget from the previous rotation that didn't pass it was a lot of discussion. This year is was a five minute discussion. We take the last 3 years average of income and the actual expenses from last year. I took the committee chairs budgets; we planned to fly to Wyoming for the Forum and to drive to the West Central Regional Service Conference in Nebraska. Our financial policy asks us to be prudent with the Areas money. If there actually is a deficit at the end of the year, we do have a reserve and operating fund. In reality we won't spend that much money. Our budget is really based on what we are going to do and not what we are going to get. Our treasurer has done a good job of painting a picture of how we spend throughout the year. What role does the Treasurer have? He has done a great job of giving our assembly a good picture of how we are doing. They really are in charge of our accounting. In Area 35 the treasurer tends to encourage the 7<sup>th</sup> Tradition. Is there a line item in the budget for the Past Delegates reimbursement? Yes, Missy called all the past delegates to get an idea when they might come. Why did Area 36 decide to reimburse the Past Delegates? Because we value their input, experience, and participation, therefore we should support them financially to attend. Area 36 puts 1000.00 towards the Delegate attending the International every five years.
- The Area 36 Chairperson has a formula based on past experience to do the variance for the budget. In A.A., we don't look at our budget in the same way businesses do—we want to be spending money and our budget is a guide
- What does the Area do to carry the message to the still suffering alcoholic? Do we have a list for the newcomer to see? Individuals have asked what the area does—how can we communicate what we do. Perhaps our purpose isn't to carry the message to the still-suffering alcoholic. We support the service structure. The Assembly does the business of alcoholics anonymous. I disagree because in our area finance policy is to carry the message. The work that the committees do goes to the correctional facilities, treatment centers, professionals, etc. We reach them indirectly. We set the structure for individual members to do the work. While doing my Delegates report I had an opportunity to talk to members not involved in Area service about what we set up as an Area to make it possible for members to do service work. I don't think we discuss that enough. We need to reach those who don't always come to us.
- Are we effectively communicating with those people? Do we think to put a list together to show what we do? We have our guidelines. Our committee chairs should be communicating to the GSR's at the Committee Meetings. We also have our newsletters to do that. The Area 36 Delegate writes an article on a concept each month and have it put into the Mirus (Intergroup Newsletter), where there is an

opportunity to reach them.

Do you find there are enough people willing to serve? That is still a conversation at our District level. We have a continuous conversation on how we might get the chairs to do what they say they will do. I think we need to give them something of substance to do. Create opportunities outside of meetings. Our District PI chair picked 5 things he wanted to accomplish, and got a group of people busy doing it.

It seems that at Area 35 we have people that serve and unless they are elected into a new position or an Alternate Delegate, they are gone and you won't see them again. I ask myself why they lost interest.

Do you list anything in your finance letter anything about what the Area is doing? It goes in our Northern Lights, so they can see based on reports from officers and committee chairs what has been going on.

If I send a contribution to the Area, do I receive a thank you letter? Yes we use the return address on the envelope. We are considering doing this at our District letter. We want to send a thank you to those who sent contributions. There are ways other than mailing the thank you; you can give that to the GSR of that group. It tends to have an impact and makes a different in contributions.

How much interaction does the Area have with the Districts? We do zonal forums so that the Districts can meet the officers and learn about Area Service. Our primary interaction is through the Area events, however the officers and committee chairs offer to attend any District meeting. Area 35 seems to be asking more if they would like them to come to their District. It seems to work better to have a certain presentation to give when they come to the District Meeting. As Area Chair I seem to be asked more to give presentations at District Workshops. Our Archives is asking districts to combine to do presentations. I was asked to present at a District on why it is important to attend Area Committee Meetings. Some can't send all of their chairs because they can't afford it. Some people may not continue in service because they aren't being reimbursed for service work.

How do we ensure that the triangle truly is inversed? We rotate our assemblies to encourage participation. It is our responsibility to operate at our position humbly. Area folks really have an opportunity to impact A.A. If we always know our position it will work out fine.

Does Area 36 use the board minutes for anything? Because we have been told that those are possible agenda items for the next GSC. Dennis B. does it for District 18 a couple weeks after the Board meeting. Anyone can come and we always have about 8 to 10 people there.

I guess I would offer a suggestion that there isn't a lot of meaningful stuff in those minutes for the individual member. I read those minutes as a Delegate, but I don't think it would be a center discussion at an assembly.

Newsletter/Web/Group Records: Bob: We talked about the importance of keeping group records updated. We get requests for updates from the meeting locator. It will be going to the DCMs first to check on it then to the Group records Chair. We are looking at a better way to handle general questions. We have two names for the meeting locator and we are looking at forming an ad hoc committee on how to handle this and where we want to go with it. Area 36 website has been updated. We discussed why a District would want a web page and what to put on one. We want to discourage copy and pasting on those. We need to concentrate on getting a meetings for Group Records and we need to work from the Districts on down. The Group Records data base is used to send out the Area Newsletters and if the information is incorrect and gets sent back it is a double mailing cost. One of the interesting thing about group records is that when you enter a groups address if it is incorrect it won't go through because GSO is cross checking those addresses with the Post Office.

<u>Literature/Grapevine:</u> Antoinete: We also had great discussion and spirited. We talked about the State Fair is more done by Area 36 more than 36 due to location. We also talked about the participation where the Pink Can Plan is concerned. We talked about

what we can do to help the other Committees where literature and Grapevine subscriptions are concerned. How do we ensure everyone gets a big book? And we talked about what fun literature party would be (literature jam festival). And how are we there for the newcomer that stands at the literature rack. We seem to be limited at treatment centers and correctional facilities. Can we give subscriptions to them? Cooperating with other committees is the big question. Sometimes a newcomer can't get to a meeting but we should encourage them to pick up the grapevine. District 13 AA Workshop and how it Came of Age is a great workshop.

Archives: Brad: We discussed what the primary purpose is and how to cooperate with each other. Area 36 is doing Archives Alive sessions. They have 3 Districts that share their history of AA 3 times a year. Area 35 has a full repository and is hard to organize. Area 35 could use help building a searchable data base which would require a lengthy inventory. Cost isn't a restraint but time is. Paul and I do joint displays when possible. To do a joint workshop gets difficult when trying to coordinate dates. We also talked about focusing on Districts having their own chairs to organize their own archives. We have talked about history talks. Our biggest focus is on where we came from, where we are today and where we are going in the future. Come to the Archives Alive next Saturday the 8th in Glencoe at the Area 36 Repository.

**Public Information/CPC:** Jeff: We had 10 people discussing 5 topics the first one being the State Fair, which is the longest cooperating function. People have been talking about should we be spending the money on this and the time split isn't in favor of Area 36. We talked about having shift evaluations done about who visited our booth and why. AA meeting locator was the second one and keeping it current and accurate. It is the calling card for AA in MN. The conversation came up on how to make consistent contact with professionals as a unified state. AA hotlines: some have them- some don't. Are they working for the still suffering alcoholic? Jeff checked updated the hotline numbers on the AA MN sheet passed out by highway rest-stops (with service counters). We need to use current technology to assist us. The role of the Area In this committee: A district went to do a fair booth and the fair committee wanted them to have insurance. Maybe the Area could take out insurance in those cases.

<u>Treatment/Special Needs:</u> Sooze: Small but lively committee. We were able to educate some GSR's. Most discussion was on the temporary contact program. Area 36 has a maintained data base to help us make those contacts. We would like to share information between Areas about folks going from a treatment center in one area going home to another. Remote Communities and Special Needs: Carla was sharing the challenges between the two. January 17<sup>th</sup> there is a workshop in Area 36 that Area 35 is invited. It is on "AA is for everyone". Location and time are pending. We talked about increasing participation in the treatment committees. They talked about hand picking attendees. The MAARCH Conference just happened this week that Sooze attended on behalf of Area 36. It is a state wide organization for treatment professionals and happens once a year. A lot of traffic at the AA booth and a lot of literature went out. When I was at the booth a Native American man was there and I was able to give him the pamphlet on Native Americans.

Corrections: Mary M.: Area 35 and Area 36 have a joint workshop committee. They had 13 people at the table for discussion. The joint committee has been meeting over the year to share struggles and challenges about the work they do. How do they find out who to contact at jails and what are the requirements to go in. Finding consistent people to show up can be a struggle. We need to remember that it's their house so their rules or don't go. We also discussed a draft of an AAI format for facilities in Minnesota. We think we should be carrying the same message in Minnesota. Some think we are paid or that we work with addicts. We would like your input on the Format. The other thing we talked about is a joint state wide workshop for corrections. We would like to do it in September of 2015. We would like to do this in St. Cloud. We would have people sharing their experience with an open microphone to ask questions. We have a lot of ideas around that

General Sharing: How did it get started that the rotations of the two Areas aren't the same, and wouldn't it be beneficial to get us on the same rotation? The odd numbered Areas have an election on the even numbered years and the even numbered years have an

election on the odd numbered years for the GSC so they aren't recreating the wheel each year. They will have half veterans' half newcomers

- I have a plan for the pink can plan issue: She recycles her cans at home and that money goes into the pink can plan. Use it at your groups.
- If there is anyone in District 13 who would like to drive down to the Archives Alive, I would fill their tank when we get back to St. Cloud.
- In regards to the State Fair booth: I think it would be a benefit to talk about this next year at this workshop to really look at the benefits.
- When we ask people to speak on behalf of our program we should introduce them to the literature that speaks on this and how they might dress. We should look like we are recovered alcoholics who can articulate and form thoughts. We are judged immediate on what we look like and sound like.
- I like the idea of a joint workshop in corrections. It would help those who don't know how to do it. Why aren't we cooperating in more of the committees in this way to save the work for one area?
- When I first got into service as a corrections chair for the district I was putting literature out and had the thought that a drunk might want to call intergroup instead of sending questions to GSO. So I stamped the number for intergroup on the literature to be of help.
- There is getting more opportunities to cooperate with each other. Go because we are getting together to talk more. If

- we have something that fits into our traditions to help each other let's do it. In Area 35 we spend most of our budget on travel reimbursement due to the distance between places. Could we do better?
- In regards to the A.A. meeting locator, how many people have gone to the meeting locator to check the accuracy of their meeting? Now, go out and ask other groups to do the same. The more I talk about it the more I realize people like it. So, let's get the information correct so we aren't sending someone to a bad location.
- On the meeting locator, trying to get the information correct is a big task. So when you go to your meetings ask those people to be responsible for their group's information. Tradition 4 is a great way to explain that.
- As a Grapevine Chair at a District: how many of you think that the Grapevine is A.A.'s meeting in print? The Grapevine is one of the A.A. entities at the tip of the inverted triangle. It is almost as large as a publishing arm as AAWS. It publishes many books, and a lot of what you see on Literature tables is Grapevine material. It is more than just our meeting in print.

#### Area 35 December Committee Meeting Minutes Aitkin, MN - December, 2014

Sarah K. Called meeting to order and opened with the Serenity Prayer.

Recognition of past delegates in attendance: Tom A. Panel 50; Susie A. Panel 48; Bruce B. Panel 44.

Recognition of First Time ACM attendees.

Minutes from the August Area Committee Meeting were approved.

#### **OFFICER REPORTS**

**Delegate-MIKE J.** It is hard to believe my first year serving as your Delegate is almost at an end. It has been a fantastic journey so far with many more ups than downs. At times it seemed like I would never get through the many hours of traveling, but with each journey came great moments of spending time with the fellowship that has brought me so much peace and love. I am glad to say that I tried not to make things worse. I look forward to my second year, serving Area 35 (the best Area ), going from being the new guy to the outgoing Delegate at the conference. Serving as Delegate Chair should be interesting although involving more duties. I keep thinking, this is your last year serving work hard and enjoy the blessings.

I rode to Clarissa for a workshop with Randy and although the numbers were small both he and I felt it was our duty to share as though we had a full house. Thank you District 18 for allowing me to share my experience on responsibility to the still suffering. The only reason we do any of our general service. May God keep us strong in our purpose and keep A.A. healthy.

I am preparing for the board meeting at the end of January in New York and am excited as I will finally be given my assignment as Delegate Chair. I participated in two conference calls. One with our Regional Trustee and Delegates from around the region. We talked of the WCRAASC coming up in Nebraska and received word from Bill (from Nebraska) that all is going well and ready. It sounds like we sold a lot of literature this year which put us ahead of budget, we still must work hard on bringing up contributions, although Area 35 has been going up each quarter. We had Carol B. from Group Services with us and she talked about some things happening on sub-committees she is on. She talked about corrections and how we can get more sharing from each area on how they deal with their corrections work. She sent out a survey which I forwarded to Skip (a little late) asking about different aspects of trying to deal with facilities. She is also on a subcommittee that is trying to find better ways to use our class A Trustees in bringing awareness to the public and in facilities.

I also had a conference call with the Grapevine staff, new and outgoing committee members and Amy B. from the Grapevine shared what they have been doing to help bring about growth in subscriptions in both the Grapevine and La Vina. Both of which are doing financially better again this year. The mobile app for the Grapevine should be up soon and they are also encouraging the purchase of gift certificates as a way of raising funds to send subscriptions to those in need. She is trying to set up a meeting with Area Grapevine Chairs to talk of ways to encourage more subscriptions. One Area has a raffle that raises money just to give away subscriptions.

Some highlights from the board meeting were:

Dear Delegates of the West Central Region and Western Canada Region,

Here is a list of some of what went on at the GSB meeting (and AAWS and AAGV meetings) over the weekend:

- 1. Phyllis H., General Manager, will retire in October, 2015.
- 2. Doug R., longtime GSO staff member, will retire in December, 2014.
- 3. Registration for the 2015 International Convention thus far is over 27,000 registrants and over 12,000 rooms have been booked. There are still more rooms available. We have been assured that we won't be as far out as some folks were for Seattle and Toronto.
- 4. Your General Service Board adopted a mission statement: Our mission is to serve the Fellowship of Alcoholics Anonymous.
- 5. Through September 2014, AAWS has a net profit of \$2.2 million; Grapevine has a net profit of \$232,000. The Reserve Fund is \$14 million or 9.4 months of expenses. The AAWS profit is due both to the 75th anniversary reprinting and to large literature orders coming in before the price increase went into effect.
- 6. The floor plan for the remodeling of the 11th floor of our offic-

es has been agreed upon.

- 7. There is a change in Conference procedure: At the January Board Weekend meetings of Trustees' Committees, the Conference Committee Chairs will be active participants in their corresponding Trustees' Committee meeting and will review proposed background for their Committee.
- 8. At the 2015 International Convention, there will be a large space focusing on A.A. service named "Carry the Message". Shortly, Delegates will be requested to provide names of servants from their Area to staff this space.
- 9. Ed M., past Delegate from the S.W. Region (Area 38, E. Mo.), is recommended to be a General Service Trustee at the next Conference, serving on the Grapevine Board to replace Nancy H. Ivan L., Class A Trustee, is recommended to serve on the Grapevine Board, keeping the board membership at eight. Joel C., Pacific Regional Trustee is recommended for service on the Grapevine Board and Richard B. is recommended for the AAWS Board.
- 10. Trustees' Nominating Committee chose seven prospective Class A Trustees to interview in January for the two Class A Trustee vacancies to occur at the next Conference. I don't know any of the details on this.
- 11. Trustees' Nominating Committee created a subcommittee to discuss matters of rotation in the event of a regional trustee not being able to complete his or her term.
- 12. The General Service Board will undertake a comprehensive feasibility study of our current business model, corporate structure and long term sustainability of the Board and its affiliate corporations.

- 14. The Grapevine Board agreed to move forward with a plan to bring the Grapevine to mobile devices, through Newstand on iPhones and Google Play on android devices.
- 15. The Grapevine Board agreed to move forward with a subscription challenge for 2015, details to come later.

**Northern Light-Rodney S.** As a result of all the discussion at the Fall Assembly I created an "actual cost" 2015 Financial Responsibility Statement for the Northern Light Editor position, comparing the numbers with what was listed in the September/ October issue of the Northern Light and approved by the general assembly. The actual cost for 2015 came out to \$3435; \$4570 is what was approved at the fall Assembly, for a difference of \$1135. Also, keep in mind \$2100 is the actual printing cost, over which I have no control.

\$4290 was approved for the year 2014. Using Randy's year-todate expense number for the Northern Light at the time of the Fall Assembly which was \$2375 and adding to that expense reimbursements for the assembly, a GSR school, and this meeting (subtotal of \$268), the Northern Light position has a total expense for 2014 of \$2643—the actual expenditure being \$1647 less than what was approved.

If we had not done our Financial Responsibility Statements the way we have been doing them I would have been over budget instead of under, as I attended unforeseen events that as a new member to the Area Committee I was unable to predict with the use of the previous rotation's budget. That fact would have possibly affected my decision to participate in those events.

At our meeting this morning we discussed clarifying instructions for payment for printing and inserting a flyer in the Northern Light—how much the client would be billed and where payment is to be made. This will be presented at the January Service Workshop and February Committee Meeting.

The deadline for submissions and reports in the next issue is January 21st, 2015, not 2014 as was misprinted in the current issue.

# A.A. Definitions OUR A.A. LANGUAGE

#### Definitions of some of the terms used in A.A.

A.A.G.V. - A.A. Grapevine, Inc. / A.A. Grapevine Board: One of the two operating corporations of the General Service Board.

A.A.G.V. is responsible for the production and content of the A.A. Grapevine and La Vina magazines.

The A.A. Grapevine Board reports directly to the General Service Board and is accountable to the Fellowship through the Conference Grapevine Committee.

#### A.A.W.S. - Alcoholics World Services, Inc.:

One of the two operating corporations of the General Service Board

A.A.W.S. is responsible for producing and distributing A.A.'s literature and related material for the U.S. and Canada.

The A.A.W.S. Board reports directly to the General Service Board and is accountable to the Fellowship through A.A.'s General Service Conference.

#### Alternate:

A service worker who, at the group, district or area level, assists, supports, and participates in service responsibilities, and stands ready to step into the service position if the person occupying it is no longer able to serve.

#### Area:

A geographical division within a state or province from which the Conference delegate is elected.

Often there is one area to a state or province.

Where there are many A.A. groups close in together, there may be two, three or more areas in a state or province. For example, there are six areas in California and four In Ontario.

#### Area assembly:

A meeting of G.S.R.s and committee members to discuss area affairs and, every other year, to elect a delegate and committee officers.

#### Area committee:

A committee made up of district committee member (elected by the G.S.R.s in each district) and area committee officers. The area committee generally serves as a "steering committee" for the area. Class A (Nonalcoholic) Trustee:

There are 7 Class A trustees who are members of the General Service Board, men and women who are recognized professionals in their own fields.

They have a loving commitment to Alcoholics Anonymous and some experience in working with A.A. and its members.

Historically, A.A. has relied on its non-alcoholic friends to represent us in the media. As non-A.A.s, they do not have to worry about their anonymity.

#### Class B (Alcoholic) Trustees:

There are 14 Class B trustees who are members of the General Service Board. They are men and women A.A.s who are strong in one or more of the following areas: length of sobriety, business or professional background, leadership, and grasp of A.A structure. <u>Delegate</u>:

The person elected every two years by the Area Assembly to serve the U.S. and Canada as a whole at the annual General Service Conference in New York City.

The delegate communicates the actions of the Conference to A.A.s in his/her area.

Is the primary point of contact between the area and the rest of A.A. service structure in the U.S. and Canada.

#### D.C.M. - District Committee Member:

An experience GSR elected by the other GSRs.

The DCM is the chairperson of a geographical unit of the A.A. service structure - a district - and represents the groups that meet there.

The DCM is an essential link between the groups' GSRs and the area delegate.

The DCM is automatically a member of the Area Committee, chairs the regular district meetings, attends all area meetings, and

often attends regional meetings.

#### Director (non-trustee):

An A.A. member who serves on the corporate board of either A.A.W.S. or the Grapevine; directors are selected for business or professional experience that relates to the activities of the corporation.

(The directorate of both corporate boards also includes trustees and A.A. staff.)

#### District:

A geographical unit within the area that is coordinated by a District Committee Member.

Where there is a large number of A.A. members who speak another language, linguistic districts have been formed.

#### **District Meetings**:

Meetings of the DCM's and GSR's of groups in a district.

#### GSB - General Service Board:

The legal entity that oversees the operation of A.A.'s service corporations, A.A.W.S., Inc. and the A.A. Grapevine, Inc., as well as the General Service and Grapevine Offices.

#### **GSC** - General Service Conference:

For this event, the 93 delegates from the U.S. and Canada come to New York City for a week each April for a closed business meeting to conduct the business of A.A. in the U.S. and Canada. The 21 members of the General Service Board, G.S.O. staff members, and nontrustee directors of A.A.W.S., Inc. and the A.A. Grapevine, Inc. are also voting members of the Conference.

#### G.S.O. - General Service Office/ New York:

Provides services to groups in the U.S. and Canada and publishes A.A. literature.

#### G.S.R. - General Service Representative:

An A.A. member elected by the group to participate in discussions and activities at the group, district and area level.

GSRs vote for the District Committee Member (DCM) and the delegate and area officers.

GSRs are sometimes involved with group inventories or helping the group look at its challenges in the light of the Twelve Traditions.

GSRs serve as mail contact for the group.

Keep the group informed about activities and information from the district, area and G.S.O.

#### GV - Grapevine - A. A. Grapevine Magazine:

The international journal of A.A. and "our meeting in print" published monthly.

The group, district or area contact with the Grapevine office. Third Legacy:

Recovery is A.A.'s first legacy, Unity its second, and Service is the third legacy.

In this sense, service is the sum total of A.A.'s services, from a Twelfth Step call, to A.A.'s coast-to-coast and worldwide service activities of carrying the message of recovery and hope.

There is also a Third Legacy voting procedure that is sometimes used in A.A.

(More information on this can be found in the Service Manual, Chapter 1).

#### Trustee:

The General Service Board is composed of 21 trustees.

The trustees of Alcoholics Anonymous are concerned with everything happening inside and outside A.A. that may affect the health and growth of the movement.

Trustees of the General Service Board have a spiritual and legal responsibility to protect A.A.'s Steps, Traditions, Concepts, principles and the integrity of the message of Alcoholics Anonymous.

- (See Class A trustee and Class B trustee.)

#### Region:

A grouping of several states or provinces from which a Regional Trustee is elected to serve on the board of trustees.

There are six regions in the United States, two in Canada.

#### Service Manual:

First written in 1951 by Bill W. to outline basic service principles and procedures.

#### **NORTHERN LIGHT PRIMARY PURPOSE:**

The Northern Light (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the N.L.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should in-

- clude the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report - NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the Grapevine or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. Committee** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and edi-

#### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

#### TWELVE CONCEPTS for WORLD SERVICE (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional sonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- "Right of Participation," allowing a voting representation in a rea- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
  - XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
