





# **The Delegate's Duties**

- Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee •
- Remind G.S.R.s to inform groups and individuals about the A.A Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
  - Visit groups and districts in the area whenever possible.

members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.

- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to . better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

# **DELEGATE'S REPORT**

Greetings fellow A.A. members. I hope you are enjoying summer. Some are attending the International in Atlanta (sounds like they are having a blast), others enjoying campouts, some spending the day with family and friends and I am sure many others are sitting home alone wondering what they are missing out there this summer! Sometimes I get so caught up in my own sobriety that I forget about those that sit on the fence waiting for a magical change to happen in their lives. Not hopeless enough to ask for help, still trying to figure it out by themselves. A.A. is a fellowship that shares its experience, strength and hope with each other to help each other recover from the daily woes of alcoholism. By joining and participating in saving lives you will never have to be alone again.

As your Delegate in beautiful Area 35 Northern Minnesota I often ponder on how I can best serve fellow AA. members and their families. Is it just my job to talk about agenda items such as pamphlets, changes in literature, and finances of AA.? Or am I given a bigger purpose, that of helping to find ways to carry our message to the alcoholic that still suffers from this deadly disease. By reaching out to you in my reports and articles and reminding each of us that have stayed sober that our primary purpose is to be of service to God and our fellows. Or do I shy away and follow the actions of those who are trying to encourage our differences to be more important than our common problem. [If we do,] We are allowing the outside world to direct our actions rather than follow our traditions and stay unified in our primary purpose which is simply to help drunks get sober and find a life in helping others.

As we take inventory by looking back in our history do we forget?:

That Bill's purpose in getting together with Dr. Bob was to stay sober himself? That Bill learned in his early sobriety that even though he was trying to help others the primary fact was that through his failures he remained sober and that completed the recovery process? First he needed to admit, then ask God for help, start cleaning house and finally helping others. How Bob said that Bill's message sounded good but he certainly could not do certain parts. How he got drunk one last time and decided he would do what it took to stay sober. How after a short time of experiencing this new found fellowship they realized they needed to find other drunks to work with lest their problems drag them back down. A simple message for complicated people. We have only one purpose and we must be unified to do it. We cannot complicate it with personal beliefs on such thing as whether or not there is a God, what sex am I or what gender I think I should be. I will die an alcoholic death if I stray and forget that I was graced to be sober simply to help others.

I am blessed to share my experiences in New York with the districts throughout Area 35. I have many in July and if you have not had a chance to hear it please encourage your DCM to invite me to come share with you. Area 35 has always tried hard to seek unity and care for each other. We need the groups to care enough about keeping this thing on track that they are willing to come and share with us how they carry the message and how we can help. I love A.A. and the people in it, as they are the reason I have been able to enjoy life through all its trials. Do you know what is going on with the members in your home group? Do you have a home group? Are you participating in A.A.? If not "join us as we trudge the road of happy destiny." May God bless you and keep you until then. Thank you for allowing me to serve as your Delegate. have ever attended in A. A. and I am looking forward to spending it with some wonderful people. I cannot think of a better way to spend my summer vacation than with the people I love who have given me so much gratitude for living today!

This year's West Central Regional Forum will be held August 21 -23 in Casper Wyoming. I thought I would share with you just what a Regional Forum is.

Regional Forums originated in 1975 at the suggestion of Dr. Jack N., then Chair of the General Service Board of Alcoholics Anonymous. They were to be weekend sharing and informational sessions designed to help the General Service Board, A.A. World Services, Inc., the Grapevine Corporate Board, the Grapevine Staff, and the General Service Office Staff stay in touch with A.A. members, trusted servants and newcomers to service throughout the A.A. service structure.

Originally, at the invitation of a region, four Regional Forums were held each year. Since the U.S./Canada service structure is composed of eight regions, a Regional Forum was held in alternate years in each region on a rotating basis. In October 2006, the General Service Board approved the concept of an Additional Regional Forum to be held upon request in each region every eight years also on a rotating basis, bringing the possible number of Regional Forums held each year to five. In 2012 the General Service Board agreed to discontinue Additional Regional Forums after completion of the eight region cycle in 2016.

The location and agenda for Regional Forums are decided jointly by the Regional Trustee, Area Delegates and G.S.O. The responsibility for initiating contact with the hotel is assumed by a local A.A. Host Contact working with the Forums Coordinator and Regional Trustee. The Forums Coordinator at G.S.O. distributes registration forms to groups and service workers throughout the region and, working with the Host Contact and Regional Trustee, coordinates the details of the Forum.

There is no registration fee for Regional Forums or Additional Regional Forums. The General Service Board covers the expenses of meeting rooms. In many places, area committees, districts and groups cover or defray the transportation and lodging expenses of the trusted servants representing them at a Forum.

As all Forums are intended to be sharing sessions, no formal actions result. Sharing at Forums is captured in Forum Final Reports which are distributed to all attendees. Regional Forums Final Reports are available on G.S.O.'s A.A. website. Forums provide unique opportunities to share and exchange valuable experience, ask questions and spark new ideas. Regional Forums and Local Forums carry A.A.'s message of love and service by improving communication at all levels of our Fellowship.

Unfortunately I am not able to attend the Forum this year. In the past this has been held in September and this year they changed it to August. I have a work related commitment that I have done several years now on that weekend that I feel is important to continue to be a part of. I do hope however to see you all at our Fall Assembly in October. As always thank you for the opportunity to be of service.

## **TREASURER'S REPORT**

Greetings! It's been a very good summer so far with lots happening in the Area. It is hard to imagine that the rotation is slowly winding down, and it's time to start looking for interested persons willing to fill service positions. It can be quite challenging in some areas as there seems to be a lot of vacancies in certain districts. It takes a firm commitment to Alcoholics Anonymous and to be able to find the time to serve. Self-sacrifice is instrumental to our survival and growth as a fellowship. Not only to our groups but also to be able to serve at the district and area level. There are a lot of willing trusted servants out there if they are given the opportunity.

The Area contributions for the year are holding steady. Total contributions for the first three periods (January1 through May 31, 2015) are \$10,836.36 with total birthday contributions at \$13.00 compared to the total for the same period last year (Jan.1 thru May 31, 2014) \$10,636.74 with total birthday contributions at \$43.00, for a difference of +\$199.62 for the year, and -\$30 for Birthday contributions.

We need to step-up our birthday contributions for the year and let our groups know about the birthday plan for the Area. For those who don't know about the birthday plan it is a plan where A.A. members contribute a dollar for each year of sobriety they have to the Area, and can contribute more if they wish to. It is a way that we show our gratitude to A.A. Please encourage the birthday plan in your groups along with 7<sup>th</sup> Tradition contributions. Concerns were expressed that the aMeetingLocator software was not processing all meetings in the FNV database. I did a code walk through to see that the FNV data was processed and that the meeting list on aaMeetingLocator matched. We did find 20 groups that did not have a district number in the FNV database. Our Group Records Secretary corrected all but two of these groups immediately.

We have a request to list ASL meetings in aaMeetingLocator. The ASL meeting were not identified in the Area 36 FNV database. I asked for a list of the ASL meetings. This request is still pending. This will be a major software addition to aaMeetingLocator.

aaMeetingLocator is only listing groups that have the status of "Active" in the FNV database. The groups with a status of "Unknown" in the FNV database is considered an active group by GSO. I asked the aaMeetingLocator ad-hoc committee if we should be listing "Unknown" groups. This question fell on deaf ears. I will bring it up at out area35/36 joint workshop.

• The ability to be open-minded, to sit down with A.A.s in the area and with other delegates to discuss and act on matters vital to A.A.

• Have you talked with past delegates to get an idea of the time and effort required and

the sort of work you will need to do?

A recent conversation with a sponsee brought to mind some lessons learned while doing service...

1. I mustn't get caught up in thinking "it will be like this forever." A few weeks/months down the road few if any will remember what was said or done. We just aren't that interesting and our memories just aren't that good.

2. Some things have to die before they can return whole again. Each group has the "right to be wrong." Even if things are going down a path seemingly filled with trouble and frustration, this may very well be the path filled with the most insight and learning opportunities.

Often times our groups and districts have to learn pervious lessons over again. It's called discovery learning and unfortunately with a transitory population like ours, we have to do a lot of discovery learning over and over again. It's just the way things are and getting frustrated over it would be akin to getting frustrated over the sun rising and the moon setting.

3. "Do well your part for therein lies all the honor." Remember this isn't about being popular, liked, or well thought of—this is about the best way to carry the message to the alcoholic who still suffers.

## **LETTER TO THE EDITOR:**

I read with interest a letter on Safety in A.A. in the most recent edition of the Northern Light. The question I would pose is this. How come when the Area Treasurer steals Area funds, the area reacts by setting up a special committee to oversee the handling of area finances, but when it comes to predatory behavior within the Groups/Districts/Area, the Area says there is nothing we can do about it? Both are criminal behaviors, yet with one we set up safe guards to ensure the behavior doesn't happen again and with the other we say "we just have to practice love, patience and tolerance."

It appears that there is a difference between our deeds and our creeds. It appears that we aren't putting principles before personalities because if we were then our approach would be more consistent, i.e., in both cases we would say let's put some safeguards in place, or in both cases we would say "we just need to practice love, patience and tolerance."

I also find it sad that we would put a higher priority on safeguarding money than we would on safeguarding members of an A.A. group.

The letter went on to say...

"The only solutions I have come to are Responsible Groups that do their work well, and sponsorship, all acting under the guidance of a loving God. It is only through the group conscience as found within our traditions that we can be more cohesive and less separate in developing our conscience. If we don't talk together about issues, we are part of an ongoing problem."

I agree with the above, but here is how I interpret what the author is saying.

1. Responsible groups talk about these issues. Responsible groups have a plan on how to deal with these issues. They put parameters and safeguards in place - just like the Area did with the Area

ior is not tolerated; include statements at the start of meetings that announce that abusive behavior will not be tolerated. Groups can set boundaries; do what is necessary to keep meetings safe. Ban persons who repeatedly engage in disruptive conduct that prevents the meeting from fulfilling its primary purpose. Do what is best for the whole group. Address disruptions when they occur." (The full 6 pages of this report can be read online at: http:// www. nhaa.netwpcontentuploads/2012/11SafetyInAA 2012.pdf).

A statement that comes up repeatedly when the issue of "Safety in A.A." is discussed is: "We don't want GSO/NY telling us what to do."

This kind of hyperbole only confuses the issue. It is not unreasonable or unprecedented for GSO to publish guidelines on particular matters. For example, there are guidelines on: A.A. Answering Machines, A.A. and Clubs, A.A. and Members Employed in the Alcoholism Field, etc.

So, if this precedent has already been established, is it really unreasonable for A.A. to publish guidelines entitled "Safety in AA"?

Response: This letter was sent with what I considered an "easy out"—the intro, "For your consideration…"

It is a serious enough matter, one that is discussed repeatedly at Regional Forums and Conferences, and our own Area 35 Spring Assembly, as to be included in this issue.

Unlike other newspapers, where a "letter to the editor" is usually expected to evoke a direct response from that editor, my opinion will not be presented here as it reflects that of the Area Committee. Whether or not a question or opinion is valid doesn't matter—if it is expressed through a motion at an A.A. Assembly and that motion fails then that is the position I must abide by. The voice of the general A.A. community in Area 35 is important and welcome and will be printed in future editions should someone wish to contribute.



# **TWELVE CONCEPTS for WORLD SERVICE (Short Form)**

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."

VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal

IV. At all responsible levels, we ought to maintain a traditional sonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

> XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of ungualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
