



AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- ♦ Area Chair calls to cancel and/or re-schedule.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job • goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
 If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and
 GSO
- Provide leadership in solving local problems involving the A.A.
 Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation
 - Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
 - Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

AREA CHAIR'S REPORT

I attended the 2015 WCRAASC with an Alt. DCM from Area 35. It was a wonderful trip! I was present for all of the area presentations and agenda item discussions. I witnessed some good sharing on A.A. unity, the importance of leading with our traditions, and remembering that when I share, I should take care that my sharing supports our primary purpose and be clear that it is my experience, not A.A. talking. I was reminded that with great power comes great responsibility and had a wonderful discussion (after the presentation) on the traditions and Facebook. I sat in on the area officers/trustees breakout session where we discussed rotating positions, keeping unity at service functions, the election process for becoming trustee, why are the nonvoting trusted servants non-voting? Why do we have so many trustees? (it provides a broader range of views.) I also attended the CPC breakout session and the issues discussed were: working with treatment facilities. What things is your area doing well in CPC, and what is your area's CPC committee having problems with? How do you encourage people to participate in PI/CPC work. I also participated in the agenda item discussion as well and have included some highlights below. Of course, all of this is my own perception of the events in question and may have no direct correlation with reality. If anyone would like my full notes, or my assistance with the agenda item discussions at your group or district, please don't hesitate to call! As we began our agenda item discussion, our regional trustee, Andrew W., shared that the reason we go through the agenda item discussion is to get a sense of the region on these issues and allow for discussion. It provides us the opportunity to raise concerns, ask questions, start dialogue, and work toward a well informed group conscience. He also reminded us not to clap as it might discourage minority opinion.

I. Agenda, Item E. Members shared being pleased with GSOs response to an additional consideration from the last conference (one this area/region has been supportive of and working toward in the past) to look into the scope of the agenda committee. The subcommittee recommendation was that Conference committee chairs be allowed to participate in board meetings regarding agenda item proposals on which no action was taken and have a voice. This item is a huge deal! It addresses/brings the conference item back into the fold of the process as we've been asking.

Adding a review of the conference so the agenda committee will participate in the process and have some input on conference week schedule that has been missing in the past. This is a great opportunity to give the committee a voice to make recommendations.

IV. Finance, Item A: Increasing the annual individual contribution amount to GSO. Ken B. (past WCRAASC trustee) despite concerns about this being good for individuals or A.A. as a whole— the important thing to note is the trustees put this on the agenda to let the conference discuss/decide, which is a good change. Carl B. (past WCRAASC Trustee): Any time we allow individuals this right we weaken the power of the purse for the groups, as Bill intended, for the ultimate way for the fellowship to own the responsibility for supporting A.A. If you want to give away your groups responsibility to the power of the purse, just give it to individuals (let them put more money in).

General observations:

- It is reflected in the agenda items, that the trustees are bringing many more items forward for conference considerationthis is a hopeful, good move.
- They are now including supporting statistics in background information which is very helpful.
- Materials from GSO should be available in a format accessible to all and manipulable for translating/formatting/copying (not pdf).

Andrew W., Trustees Talk:

"I wanted to stop (service in A.A.), but it was good that this is going on." He reminded us that Regional Trustee elections are coming up and we should be thinking of who would make the best WCR Trustee—this is typically a past delegate. Think, within our region, who might we want to stand for this.

General Sharing: Carl B. shared a story about Jack N. and substantial unanimity. The question was raised, when deadlocked on fourth ballot in an election, why not just skip the fifth ballot and go right to the hat. Jack's response was, and I paraphrased, this not a direct quote of what Carl shared, that Bill was always challenged to find a way for us to have complete substantial unanimity in all our decisions. So we built it into everything we do, but had a hard time trying to build it into the election process with 3rd legacy. At area elections, we always ask if the person in the (clear) minority would like to withdraw, since it is obvious the area's choice is the person with the most votes. But at GSO, the delegates can't withdraw their names if asked, so you are asked to do that for them. The idea was always with Bill, if in the election of a trustee in where one was almost unanimously elected, but the other had only enough to stay in, the person with the most votes had the support and trust of the most people, so in keeping with the process of substantial unanimity this gives the minority the opportunity to change their vote and become united. If the elected people are close, like one has 60 and 40, then you should go to the **4. Finance:** hat because there is no clear favorite, but in a far spread, where one is barely hanging on, and then you go to the hat you are not achieving sub unanimity. When we find that we are in the minority then, it is up to us to make a spiritual sacrifice and step down to make it right for A.A., and substantial unanimity. You could always hold out and try to get your way even when there is a clear majority in support of one candidate/idea. If you think that is best of alcoholics anonymous, but you're probably wrong. Don't choose selfishly to ignore substantial unanimity and go to the hat. I don't endorse or oppose any causes, but I do think it might behoove us to think about God's will and get out of the way and not demand our way.

SECRETARY'S REPORT

Since the February 22 Area Committee meeting I have attended the WCRAASC in Norfolk Nebraska and completed the minutes from the February Area Committee meeting.

I would like to thank Area 35 for sending me to the 2015 West Central Region A.A. Service Conference. I travel to the conference with Mike J., our Area 35 Delegate. Spending travel time with Mike increased my knowledge of the conference structure and process as he is a second year Delegate Chair for A.A.

I attended each of the general sessions on agenda items, presentations from areas and break-out sessions from Friday February 27 through Sunday morning on March 1, 2015 my notes on these sessions and presentations follow. For this report I have omitted agenda items for which there was no discussion by conference participants.

Friday Evening:

Opening and Welcome- Bill O. Nebraska Delegate

General Session I: Area 36 Southern MN Presentation highlights: Honesty, open-mindedness and willingness important in service. Early A.A. fears of diversity were not warranted.

Meet the Delegates-four new delegates shared their area reports **Discussion of General Service Conference Agenda Items**

Andrew W.—Purpose of service conference is to develop a well informed group conscience for our delegates from our west central region.

1. Agenda:

C. Safety items is one of those things that are an outside issue in our traditions, should not be more important than our common welfare.

E. Recommendation of the subcommittee, conference committee chairs participate with trustee committees, during January Board Weekend—on items that were not moved forward by trustee committees. My thoughts are that this is a good move in the right direction. However, our conference agenda is still set by Trustees Committees and Boards. I suggested to Anne F. who is a delegate from South Dakota and on the Agenda Conference Committee that it might work to have a sub-committee with voting members from both a delegate conference committee and trustees conference committee decide on agenda items.

F. This and item E. are good opportunities for the Agenda committee to participate in the conference.

3. Corrections:

A. CCS awesome service – lets get it going. Important for facilities that do not have or allow meetings of A.A. Inmates are very grateful for any piece of contact outside with A.A.

B. People who qualify to go into institutions and can pass background checks are really needed. Contact GSO and they will send you a name of someone to write that is in another region. Don't forget who governs A.A.—it is God. Taking meetings into a prison is not service but is step 12. They can get really high and drunk in prison. It is our responsibility to carry this message. Remind people that they can get sober regardless of this situation. May need to start small with one meeting a month—took nine months before meeting got going in a remote area. Lots of support for this item from group conscience. Prisoners need to be encouraged to submit to the GV and La Vina. We need to share information from those who have been successful in getting folks involved with corrections on how they did it.

A. One district proposed this. With this minimal support Trustees Finance moved it forward to the conference.

Seems like a pretty high jump. Yet it is okay to think about raising it. What is the cost of gratitude? No big deal on 3 or 5. Issue is those that are doing it for recognition. Only 20 members gave the max of 3 last year. Amount is raised every 8 years or so. No limit on what we put in our baskets. If only 20 gave the 3 x max is it prudent to raise it to 5? \$7.29 per member to cover GSO expenses but we are at \$1.49 now. Should not be on members to give large amounts to keep A.A. solvent. When we allow individuals to give large amounts we weaken the power of the purse. Gives away groups power by allowing individuals to support A.A. and possibly bail, which the groups won't do.

B. Difference in conference costs between Westchester and NYC is 200,000. Needs to be looked at before raising delegate conference fees. Groups send in money to GSO to help pay for the conference. This is raised periodically but there is no rationale for the need in background information. GSO currently covers some of costs of delegates going to conference. Areas do not cover all of the costs of delegates at conference. GSO covers costs for areas that can't afford delegate expenses. After last years conference GSO started converting information into languages. All of the information given out at the conference needs to be in three languages. Volunteers in Canada translate background information. Canada contributes more per capita than the US to GSO. GSO has fifteen days to get background information done, once agenda is set—so can't translate due to a timing issues. GSO is working to get items that they can early. Some delegates have translators at the conference if they can't speak English. One participant asked, Why aren't we using readily available translation software – easy to translate 1000 pages in seconds. Phyllis from GSO does not agree that this technology is available for our purposes.

Saturday Feb. 28

General Session II

Safety and respect begins in our home groups. How can we make our home groups safe, what role can sponsorship play, how can groups address inappropriate behaviors?

Greeters are important in welcoming. Then the greeter passes on newcomer to a regular member. Be respectful to get respect. Refrain from forming small groups or cliques. Stay off technology/phones in meetings. Kindness and feeling of belonging. Show up early and stay late. Separate men's and women's meeting lists.

Sponsorship—let men handle men. Sponsors need to be aware of potential issues with male-female relationships. Differing opinions on one year, no dating rule. Keep primary purpose in fore-front. People are in A.A. to recover—not to find partners.

Disruptive behavior can be preempted by chair reading guidelines. Meeting chairs have a responsibility to maintain order. Focus on Tradition 1—unity. Groups can set boundaries. Do what is best for group. Meeting chair is first line of defense. Escort our wet drunks by two or more members. Remind disruptive folks that they are not being kicked out of A.A.—only a meeting until they can be in order. Can call police and 911 if need be. Safety in meeting rooms should be taken seriously. We are not above the law in A.A.

Inappropriate behavior/13th-stepping. Targeting vulnerable new members—older members need to keep an eye out. Newcomers both male and female are vulnerable.

Don't hesitate to call 911 if a life is threatened. Consider safety measures when evaluating meeting places.

Value of having a home group. Problem if no one reaches out to a new alcoholic. So new alcoholic may walk out the door if insecure, frazzled. If someone reaches out, introduce member and others, others offer assistance and their phone numbers. Ask new one to sit with them. Respect of personhood. Everyone has a voice in the group.

Keep language respectful to all. When he worked steps and lived by them things changed—didn't 13th step and wasn't 13th stepped either. No choice —do A.A. or die. Came to love traditions and concepts.

We tolerate too much inappropriate language and behavior in meetings.

Poor sponsorship leads to unhealthy behaviors. Safety is freedom from fear and inappropriate behaviors.

Participation: We have a responsibility to live up to the miracle of A.A. Don't know anyone who got here out of virtue. No need for separate men's and women's meeting lists—we are all in A.A. Experience of Jenny is that there should be separate lists to avoid predatory behaviors. Difference between seeking relationships, 13th stepping, and actual predatory behavior. Problem when men lie abut their sobriety and are predators. We are all the guardians of ensuring all are safe here and can recover. Go to police right away if member says they have bombs in their car and at home. Smoking is also a safety issue.

V. Grapevine:

- **B.** Written by a trustee—problematic that that La Vina was misspelled.
- **D. 1.** Need more fellowship; wide support and representatives for their two periodicals. Can purchase online versions of the periodicals too.

Working on getting GV into school libraries and hotels .Issue with gray pages causing loss of GV support. Need to focus on why GV is an awesome publication. Creates diversity awareness and is invaluable. Use it in corrections. GV literature is great for schools. Voice of our region on GV seems to not be heard. There are over 22 GV book titles available.

Get GV on TV screens in hospitals. GV meetings are a good idea and work. TV screens in hospitals is iffy on promotion versus attraction.

- **E**. Nice to Give GV. Buy newcomer a subscription—if they stop coming the GV is still coming to them...Big purple box in club for people to drop GV in is a good idea. Can use old GV for doctor offices or for corrections. It is all of our job to spread GV's through town. Traditions saved my life. GV is our meeting in print, yet grey pages are a gross tradition violation. Our voice is not getting anywhere. Maybe we need to stop sharing so much so people get their own damn subscription. Jake—GV Committee was tied at 4-4 on grey pages items in committee last year. Conference decided to leave the grey pages in ... Gift certificates are a nice way around GV not able to take contributions. Andrew—goal is to get GV in the hands of incarcerated. One area bought subscriptions for all corrections institutions. Considering at GSO on what to do when a corrections institution asks for GV or La Vina—considering sending this on to delegates. Gift certificates are at prices of a GV subscriptions.
- **F.** Two choices of working titles. Negative feedback from folks who lost their eyesight compared to minor life changing experiences of others. Flo—need to see something on the body part—weighing out the physiology of the disease and how that allergy of the body functions.

Need literature on how to sponsor someone with special needs. I come to A.A. to relate to people about alcoholism.

VI. Literature:

- **A.** Considering a title change here. If we remove service agencies we do not need GV statement that it is not a service agency. Change service agencies to services.
- C. Should state alcoholics before differences in sexual orientation
- D. If we start talking about mental illness and differences then we aren't able to do our 12 step work. 50% of those with mental illness also have substance abuse. Supports the pamphlet. "I am duel diagnosis and am bi-polar—if it wasn't for that diagnosis that I learned in treatment ..." Newcomer might have other things going on—that pamphlet might get someone to a doctor. This went to the conference last year, did not come out of committee with a recommendation. Did not pass as a floor action too. Pamphlet on medications says that is between you, sponsor, doctors and God. Don't want A.A.'s opinion on my mental illness. See page 4 on motion from area 79. Seems to be a rationale for motion.
- E. Comments ranged from leave it alone to this is really right on many levels. Make our current literature available in ASL and brail before we make more literature. Brie is blind and has been in service for three years but has not been able to get a brail service manual. Question on whether this will be a new book with new writing or a cut/paste of existing literature. Item says produce a book.

It would make it so much nicer to have this all in one place and it makes perfect sense. Why aren't the three all covered together? This came before Panel 63 Literature Committee. Did not feel that AAWS needs to do this. Weren't sure if AAWS has the copyright to the 12 x 12?

- **F.** We already have too many pamphlets. Pamphlet is dated in material. Maybe we need to review all pamphlets on a cycle—A.A. for the Woman was published originally in 1951. There is a need to reach out to women alcoholics. Whatever gets new members in is valuable.
- G. Full policy is in front of the Conference Committee on literature. Lots of confusion and discussion here. This is a very important item. Last year the committee saw only a snippet of this policy. Committee did not see the asterisk on Editorial Changes...(see Literature Item G.) There were changes in first 164 in Fourth Edition of Big Book. I suggested that editorial changes be limited to non-substantive, factual, statistical, capitalization, punctuation and spelling. That any other starts a second line to avoid a run-on sentence.

VII. Policy and Admissions:

C. Does not seem to be of harm to record a speaker and provide it to each member of the GSC. Question on what is the cost of this?

Area Officers and Chairs Break Out session

1. Non- rotating positions. Area 36 has five non-voting, not reimbursed. Voting on moving to four year terms and reimbursing. One non- rotating position for Archivist in Area 52. Webmaster is renewable. Are they reimbursed for expenses at Area Assemblies. Area 52 Archivist is four years and Pink Can Chair

was there for 8 years; are voting and reimbursed.

- 2. How to keep unity during discussions at area functions. If yelling and screaming is happening, chair has to step in. Job is to facilitate the meeting not to force your opinion. Unity comes from knowing when to stop. Need to manage the conversation. Inform that when we get done we need to still love each other. If you want the right to be you, you have to give them the right to be them. Leader says you have said your peace so it is time to stop. Sponsor said once your idea is out it is not yours anymore—it belongs to the group. They are just as passionate about what they believe as I am on what I believe.
- **3.** Elections—Andrew—time for areas to be thinking about the next WCR Trustee.

8 delegates and then an equal number of trustees from trustees nominating committee and 4 other delegates from delegate committee on trustees. Third Legacy voting is followed and often goes to the hat. Different voting committee make-up for trustee at large.

- **4.** Why are there non-voting chairs. Tied to non-rotating. Can't vote on motions.
- 5. Why do we have three boards and 20 trustees? Bill did not want too much power concentration in one board. Originally there were 5 trustees. In 1962 when Bill proposed new structure went from 18, majority being non-alcoholics to 8 regional and 2 from Canada, trustees at large and four general service trustees and 7 class A trustees. Experience on board by Andrew was that at times seemed like there weren't enough trustees to cover functions and conferences. Fellowship is large in numbers.

General Session 2 Safeguarding our traditions through the evolution of Technology

Area 40 Montana

Nice to Facebook folks who she meets at conferences and through service. Stay away from announcing anything related to A.A. on Facebook. Newcomers look up to us in how we communicate and what we communicate on Facebook and other sites.

A.A. Guidelines are a place to start on Anonymity in Digital Age. There is no anonymity on Facebook or smart phones. Need to be on private use in cites like Google.

Google drive and Google Docs can work for us. Can't fight technology.

Comments: Can refer to A.A. groups as Facebook groups. Lilian R. story. Drudge, TMZ and Twitter. Tradition is to protect the fellowship from us. Lets not forget the guy under the bridge. People look to us for leadership on technology. Issue is personal integrity. Lots of new media that isn't the way of Facebook to get our word out using technology.

1967 recommendation of Bill approved to 21 trustees. So not sure where 22 came from. 21 is current number of trustees. Could be 22 in an unusual situation which does happen.

Report: Andrew W., Central Regional Trustee—Nearing end of his 4 year rotation.

Chair of Grapevine Board. Introduced the subscription challenge. State or area with largest subscription increase will get a GV issue written about them. See subscription challenge. Audio version of Language of the Heart soon available. Worked on what it means to have organization wide support for the GV. Whirlwind tour as a board member and then chair for a year. Served on ad hoc JITF (Joint Imitative Task Force) on how they operate as a board, how they communicate, cooperate. 14 different imitatives, ad hoc committee ensured follow through. Three on governance went to Trustees committee and it decided not to implement. Exchanging minutes between boards. Attended an AAWS Board meeting. AAWS Directors visited GV Board meetings. Large GSO office remodel planned so AAWS and GV will be located on same floor. Construction will start after

International Convention. GITF Committee recommended that their job is done. On three conference committees, Finance, Audit and Conference Committee. Recommended to Board that Delegate Chairs participate with trustee committee's and observe if they wish to. Saw new Doors PSA, snippets of stories that were called in to GV, appointed committee member on PI took story snippets and added animation- used members own voices. Good cooperation between AAWS and GV on this PSA spot.

Finances. AAWS 2015 expected on budget to break even. 2014 AAWS profits up about a million dollars- due to orders before price increases. 75 Anniversary, good initial sales, then went down so there is some overproduction. Financial situation is good.

Rotation. How does this process work for the next WCR Trustee. Each area will select a candidate. Typically a past delegate. Huge privilege and time commitment. Candidates need job flexibility – don't need to be retired. Get to serve A.A.

Our biggest challenge is our unity in A.A's future.

Carl B. asked to speak on substantial unanimity. Passing this message on from one generation to the next. Jack N. passed onto Carl thoughts of 3rd Legacy voting. In electing a trustee or area officer. If deadlocked on the 4th ballot—why not go to the hat then. Sitting with Dr. Jack N. who thought up the regional forum idea. Head of medical department for Kodak. Said Bill was always working for us to achieve substantial unanimity in all our decisions. But had a hard time to make it work in election and use third legacy; always ask person with much fewer votes if they want to withdraw to avoid going to the hat. At conference candidates are not there. So can't ask for candidates to withdraw. So this gives all an opportunity to change their votes to achieve substantial unanimity. We are going to the hat more than we should. Should change votes on 4th and 5th ballots, to support candidate who is ahead in votes—so we don't need to go to the hat and can achieve unanimity. Often candidates stay in an election when they have minimal support because they think they can come out of the hat. We need to get out of the way (egos) and let God work instead of going to the hat to much.

TREASURER'S REPORT

Greetings! It's been starting to get very busy with lots of events going on around this time of year. On Saturday, February 21, 2015 I attended the 12 Traditions Workshop in Albany MN., hosted by District 15. I was asked to do a presentation on the 7th Tradition, which went quite well. There was a very enthusiastic group of people present and had lots of participation and questions. It is great to see so many people involved that show a genuine interest in the Traditions. The presentation outline consisted of our 3 Legacies of Recovery, Unity and Service, especially on our 2nd Legacy "Unity" – which is vitally important for our survival in Alcoholics Anonymous and how the long form of Tradition Seven relates to Unity. The first presentation on Diversity in A.A. –Our heritage of inclusiveness was presented by Area 36 southern MN. They did an excellent job. I especially like the definition presented which stated: "The quality or state of being different by culture, or race in an organization-Inclusivity". There was very informative and interesting sharing from the floor from different areas. The topic brings awareness to the diversity in Alcoholics Anonymous and not how different we are, but how much we have in common. It also teaches the importance of our Third Tradition. There are some who believe that the two topics of Safety and Respect, and Diversity should not be on the conference agenda topics because they are outside issues and not in the realm of our Traditions. Although some sharing got off tangent from the floor on these two topics, most were well aware and were inclusive to our Spiritual Principles and Traditions.

On Saturday I attended breakout session I—Area officers and trustees. The topics were on 1. Non-rotating positons/ spirit of

rotation. 2. How to keep Unity at Area functions 3. The Election process of Trustees—service structure of the Board. AREA COMMITTEE REPORTS

PUBLIC INFORMATION (PI)

I just returned from the West Central Regional A.A. Service Conference in Norfolk, NE. There were more than 350 passionate A.A. members in attendance and there was lively discussion about the service workshops and the agenda items presented for consideration.

Public Information items presented for consideration on the agenda dealt with two primary concerns, the membership of Alcoholics Anonymous and the spiritual principle of anonymity. The PI Workbook starts off with a simple statement about the role of Public information. "Like all of A.A., the primary purpose of members involved with public information service is to carry the A.A. message to the alcoholic who still suffers. Working together, members of local Public Information committees convey A.A. information to the general public, including the media."

As A.A. members we walk the fine line of personal anonymity in order to make the message of hope and recovery available to the people in our neighborhoods, communities and social circles. At the public level we do not seek personal recognition because we do not want to take credit for the work that god has performed in and through us. We need to be particularly thoughtful in regards to this balance in our lives on social media. A.A. Guidelines on the internet are pretty clear that we ought not associate our A.A. accomplishments or work with a public profile. And it's pretty hard to keep anything anonymous on social media. Each individual and group must make these determinations for themselves. Those of us who strive to understand and practice the steps, traditions and concepts have to make an effort to set a good example.

This past weekend was my fourth WCRAASC so I am beginning to get pretty comfortable with the format and pretty tolerant of the process. In Area 35 we have always been pretty conservative about wanting to spend money on new PSA's and new literature. This conservatism is reflected in the opinions expressed at the regional meeting too. Many people including myself say that we have a program of action outlined in the pages of the Big Book of Alcoholics Anonymous and that we don't need any other literature. There is a feeling that pamphlets for specific groups detract from the message that we have a primary illness and a primary purpose. Alcoholics Anonymous is for people who suffer from alcoholism.

While I completely agree that Alcoholics Anonymous is for people who suffer from alcoholism, and that we need to hold strict to the process of recovery as outlined in the Big Book, I believe that we need to be as accommodating as possible when it comes to making our message available to the still suffering alcoholic. There was a great deal of impassioned conversation about a proposed pamphlet for the alcoholic with mental health issues. Up until this conference I would have been against the development of such a pamphlet, however one comment from the microphone made me change my mind. One individual said, and I am paraphrasing, that when we create all these special groups within A.A. we are giving people the chance to talk about whatever they want in our meetings. Another individual quoted very eloquently from the big book all the passages that said we suffer from one problem, a spiritual malady. And then it hit me. I didn't know what was wrong with me when I first got to A.A. It was recommended that I go to five meetings. Okay; I was required to attend five meetings and report back to my counselor or I wouldn't make it through treatment. My point is, I didn't really know what alcoholism was. I wasn't sure that is what I had and I certainly didn't see any large blue book as the solution to my prob-

I went to A.A. because I had to. I stayed because I felt the empathy and love in the rooms. I stayed long enough to find people who knew the solution and were willing to share it with me. If a pamphlet for the alcoholic with mental health issues will make it easier for some people to stay long enough to hear the message of hope and recovery then I say we ought to have such a pamphlet. We need strong and compassionate leadership in our home groups, meetings and club houses. We need to keep our message clear and consistent on our primary purpose and maintain singleness of purpose. But we have a responsibility to carry our message to all who suffer from alcoholism even if they think their problem is different.

I look forward to seeing many of you in Fergus Falls for the

Spring Assembly in April. Thank you for letting me be of service.

TREATMENT

Greetings! I attended the area 35 Committee meeting in Aiken February 22 we had in attendance including district 5, 21, 12, two from 7 and 6. We discussed two topics at the meeting: one regarding approaching treatment facilities and bringing a meeting into their facility; second one was commitment of chair people being their responsibility. We read two articles in the treatment facilities workbook about bringing meetings into psychiatric wards and dealing with staff. We had great discussion on both of these. District 12 reported all meetings covered in treatment facilities. Some people would like to rotate out of their positions as they have been doing it for a long time. District 6 reported teen focus trying to get a meeting in there still; meetings at Dellwood are covered. District 5 reported Treatment Chair stepping down. They are trying to get a meeting back into Riverplace where they have issues with insurance and licensing. District 21 reported on meetings covered in the district. District 7 reported Treatment Chair stepped down; most treatment facilities in the district are covered. I also attended the West Central regional A.A. Service Conference in Nebraska. It was an amazing event! I attended the breakout session for treatment facilities. Two members from Area 35 chaired the meeting—thank you Rolene and Sandy for doing a wonderful job! One of the big things we talked about in that session was about being insured and licensed in bringing meetings into our treatment facilities. Other areas seem to have the same problems because of the HIPA act and confidentiality issues. Some areas visit treatment

facilities during regular visiting hours to carry the message. I also attended the special needs/accessibilities breakout session. We had a lot of discussion on wheelchair accessibility at meetings. CORRECTIONS

Paul M., Area 35 Treatment Chair

Greetings, my name is Jacob C. and I am serving on your Area 35 Corrections Committee. I attended the 2015 West Central Region Alcoholics Anonymous Service Conference (WCRAASC) in Norfolk, Nebraska. This is my fifth or sixth conference attendance. Approximately a third or more of the attendees were attending for their first time, and another poll had shown that only about a third of the attendees had received the full background material for the Agenda items. I am happy to report that all in Area 35's party had the background. Thank you to our delegate Jake, and to our Area's considerable combined work in sharing information. I am happy to report that I only approached the microphone twice during general sharing, and did not run over the allotted 2 minute time limit! That is spiritual growth. The same cannot be said for the two breakout sessions that I attended, one for literature and the other for corrections.

Jim S., our Area Literature Chair joined me for the Literature breakout session, where discussion ensued over the topics of how the Areas utilize their bank accounts and electronic payment options. Iowa reported to accepting credit card payments for literature, and passing the service fee on to the purchaser. Some Areas do utilize debit cards, linked to their bank accounts, allowing servants to not have to rely on the reimbursement system Area 35 enjoys. Some areas do have separate bank accounts for different committees, and so allow those areas more speed and transparency in utilizing funds during committee work. One big item of discussion was how areas perform inventory, with one Literature Chair using their inventory spreadsheet as an order form and instant tool for checking availability of stock. There were technical questions related to the literature ordering process, as well as which literature media is reproducible. Apparently, I was one of only two in the room, during the session, who has read the A.A.W.S.'s "Fair Use" declaration on <u>www.AA.org</u>'s website, and questions of copyright law were asked and answered. A request was made, by an A.A. identifying himself as dyslexic, for A.A. to produce more literature on audio media. There was shar ing by another A.A. who was legally blind, also requesting more audio media.

During the Corrections breakout session, we discussed the need for getting participation into institutions, and the difficulties arising from doing so. The discussion plateaued with an airing of difficulties, and only generalized answers, though it is worth mentioning how past servants can be of maximum aide to a body. Two former trustees spoke, and both did not drive the discussion, rather related experiences on the questions asked. They were both direct, humble and to the point. Chuck (T.?) spoke about how when approaching an institution that we are the first big book a person may see, and we are a representative of A.A. He said we should always be professional and kind, and remember that it is not about us as individuals, but what is good for the whole of A.A. This is a point that is often missed by A.A.'s out to save the world. I shamelessly promoted the Joint Committee for Corrections of Areas 35\36's corrections workshop, on October 10th. Several A.A.'s asked for more information after the session.

I attended all of the workshops during the conference, and attend-

ed all but one of the general agenda items meetings. I decided having a good discussion about corrections experiences was more important than continuing during some of the heated discussions of the Literature Agenda items. I have found the access to other A.A.'s and their experience is the largest benefit to the conference, followed by the sharing that happens during the discussions of agenda items. Being subjected to several past servants' seemingly resentful critiques of actions past, by A.A.s or service committees, is not what the microphones are for. It is almost the same people every year, and Area 35 isn't paying me to listen to the opinions of a couple of bleeding deacons. Either people are expressing concerns as directed by our creator or I'm grabbing a donut and talking up an A.A. from one of the far corners of the region, about the agenda items, or my committee. Consequently, I now know there is a considerable amount of Minnesota alcoholics serving time in North and South Dakota, and who will also be coming back here when released. Nebraska doesn't see many Minnesotan alcoholics, and finally, a homosexual couple from Sioux City Iowa doesn't care for the "I'm special and alcoholic" attitude they feel is prevalent in A.A. Rather, they both identify as alcoholic first, find it amusing how many are threatened by their lives, and are not interested in another pamphlet. If I can answer any questions about agenda items in your district, I would be happy too. Please call or invite me to a meeting.

Definitions:

Unique Visitor:

A unique visitor is a person or computer (host) that has made at least 1 hit on 1 page of your website during the current period shown by the report. If this user makes several visits during this period, it is counted only once. Visitors are tracked by IP address, so if multiple users are accessing your site from the same IP (such as a home or office network), they will be counted as a single unique visitor.

The period shown by AW Stats reports is by default the current month.

However if you use AW Stats as a CGI you can click on the "year" link to have a report for all the year. In such a report, period is a full year, so Unique Visitors are number of hosts that have made at least 1 hit on 1 page of your web site during the year.

Visits:

Number of visits made by all visitors.

Think "session" here, say a unique IP accesses a page, and then requests three other pages within an hour. All of the "pages" are included in the visit, therefore you should expect multiple pages per visit and multiple visits per unique visitor (assuming that some of the unique IP's are logged with more than an hour between requests)

Pages:

The number of "pages" viewed by visitors. Pages are usually HTML, PHP or ASP files, not images or other files requested as a result of loading a "Page" (like js, css... files). Files listed in the Not Page List configuration parameter (and match an entry of Only Files configuration parameter if used) are not counted as "Pages".

Hits:

Any files requested from the server (including files that are

"Pages") except those that match the Skip Files configuration parameter.

Bandwidth:

Total number of bytes for pages, images and files downloaded by web browsing.

Note 1: Of course, this number includes only traffic for web only (or mail only, or ftp only depending on value of Log Type). Note 2: This number does not include technical header data size used inside the HTTP or HTTPS protocol or by protocols at a lower level (TCP, IP...).

Because of two previous notes, this number is often lower than bandwidth reported by your provider (your provider counts in most cases bandwidth at a lower level and includes all IP and UDP traffic).

WEB TECHNOLOGY

Here is an aaMeetingLocator help question from today: "I keep trying to find a meeting in Vermont, but it won't leave Minnesota. How can I change the location on that website?"

Hot off the press:

The TCS Committee met on January 29, 2015 and discussed your correspondence. The following is from their minutes:

The TCS Committee considered a suggestion from Area 35 Northern Minnesota to "... encourage the use of FNV database to create a meeting locator encompassing the U.S. and Canada" and took no action. The Committee reiterated that the local A.A. offices provide the best and most accurate meeting information along with the ability to put people searching for meeting information in direct contact with A.A. members. The Committee also noted that G.S.O. continually strives to improve how it assists visitors to aa.org online or on mobile devices in contacting these local A.A. resources.

On behalf of the A.A.W.S. TCS Committee, we thank you and Area 35 for your correspondence and thoughtful suggestion.

From the sound of things it does not look like GSO will be supporting a searchable meeting database.

#

The WEB Technology position is a two year temporary position that ends this year. I have toughly enjoyed coming out of my comfort zone and writing software to find and map A.A. meetings in Minnesota. Last year we had 76,859 user access aaMeetingLocator to find A.A. meetings in Minnesota. aaMeetingLocator supports Area 35 and Area 36. After development, Area 36 has let Area 35 continue support. Going forward, if we want to continue aaMeetingLocator, we need a support plan. I will review what has been learned, provide a coding example, and make a recommendation.

The first aaMeetingLocator was supported by an outside company that was run by an A.A. member for a token price of \$250 per year. aaMeetingLocator was used as an example of web work supported by this outside company. The person supporting aaMeetingLocator was not a member of the A.A. service structure. Over time aMeetingLocator did not meet or keep up with the needs of A.A. members. The work to continue supporting aaMeetingLocator exceeded the abilities of the company supporting aaMeetingLocator. We first looked at a professional development company to do aaMeetignLocator and the estimate was \$32,000. At this point we decided to do aaMeetingLocator in house

Over the past couple of years I have supported both District 3 and District 7 websites. We thought that we could do this remotely without being part of the District Committees. While I was able to attend all the committee meeting the web sites did well. We moved to a remote support and both web sites suffered. Over time communication slows to a stop.

There are a number of requests to improve aaMeetingLocator. A.A. members want to know if meetings are open or closed, what language is spoken, do they have Handicap Access, are the meetings signed, are the meetings restricted to men or women, and other important meeting information. They want to be able to

search for meeting using meeting information. Let's walk through what it will take to add Handicap Access information.

Before we can use data in aaMeetingLocator, the meeting information has to be in the Group Records FNV database. There are 1902 meeting in the aaMeetingLocator database. 1399 meetings need to have Open or Closed meeting information added. Handicap Access will also need to be updated in the Group Records database.

In the Group Records database each group can have four meetings per day seven days per week for a total of 38 meeting per week. Time is defined and Type is defined. The add new field is for additional meeting information. This is where additional information, like "Handicap Access" would be stored. Look at Tuesday on the example below. Time 7:00 PM, Type: Closed, Non-Smoking.

Here's how the data looks when it's sent to aaMeetingLocator.

This is one day—all the information is in one field.

9:00AM 6:00PM(O)(Women's gp handicap Accessible) 8:00PM (C)(Candle Light, Handicap Accessible)

> First meeting is at 9:00 AM no open or closed information, no additional information.

Second meeting is a 6:00 PM (Open) and (Women's gp handicap Accessible)

Third field 8:00 PM (closed) and (Candle Light, Handicap Accessible)

Software has to extract this information. Software had to be written to pull the hour, AM or PM out, and open or closed if available. Software will need to be written to read the remaining information, and determine if the information contains words like Handicap Accessible. In software "handicap Accessible" is not the same as "Handicap Accessible"

The aaMeetingLocator database will need new fields for the additional information. Searches will need to be updated to include the new fields. aaMeetingLocator is live software. A test area will need to be set up to test the new software.

All the above is doable. This is just a small example of the programming that makes aaMeetingLocator work and the type of technical ability needed to support aaMeetingLocator.

Based on my experience aaMeetingLocator needs to be supported by person with programming skills. To meet the needs of A.A., the position needs to be active in the Area service structure. Rotating service positions is preferred. The technical and programming skills for aaMeetingLocator need to be met first and rotation second. Many areas throughout A.A. have run into the problem of meeting their technical needs and rotating positions. These needs are being met by not rotating technical positions and/or paying for I plan to attend the District 12 Meeting on the Agenda Items and the technical service. The Areas that are paying for the service are also the Spring Assembly. paying an A.A. member less, sometimes much less, than it would cost to hire software developers. I am confident that our combined group conscious will continue to support aameetingLocator. Bob B., WEB Technology

I am grateful for the opportunity of service which at this time is allowing me to grow in many areas outside of Alcoholics Anonymous. Thanks for approving the funds to facilitate my participation at the West Central Regional Alcoholics Anonymous Service Conference in Norfolk Nebraska, for which I traveled and bunked with Randy A., the Area 35 Treasurer.

Somewhere during the opening presentation on Friday night, given by Area 36, I realized what I felt was perhaps a common thread among the suffering A.A.'s of today—the ones who get here but cannot seem to stay. Part of this awareness came in seeing the similarities and the differences between me and the presenters at the point in which we entered our sober journey. Not being a social person, rather than being the source of fear, my diversities afforded me a defense to my fears, up until the point where I either had to change or society would destroy me. Many of the "chronic relapsers" leave due to their fear of losing the good they see in their diversities before they ever have an opportunity to give them a fair look. As I continue to grow in service I see that the important thing is to channel and utilize our diversities in our common goal of passing on the message of recovery.

Judging by the discussion on the Agenda Committee it sounds as though we have made heavy progress in giving the delegates more say as to what items will be up for consideration and in having access to background material in a timely manner to get a good area conscience. Later on during the conference our Regional Trustee, Andrew W. made specific points as to the fact that both boards recognize that our delegates and areas are well informed as to the workings of A.A. and therefore need and deserve to be a part of all that transpires.

Throughout the weekend, no matter if the discussion was about financial items where the power of the purse plays a major role, issues relating to treatment and correctional facility meeting facilitation and processes, special needs and accessibilities, pamphlet consideration and revisions or other literature sources, or social media and new technology, I kept hearing two distinct themes; 1) that we need to protect our singleness of purpose, thus providing for our unity (with this need comes safeguarding our anonymity), 2) that we are not in charge—that our responsibility lies in "carrying" the message, not owning it.

CHAIR-Sarah K. Greetings Area 35 Trusted Servants. It is time to start considering who might make the best trusted servants for the next rotation. This means area committee chairs should be paying attention to who comes reliably and enthusiastically participates in committee work. I think Dr. Bob had a great suggestion when he said that in measuring a person we listen to what s/ he says but more importantly, we look at what s/he does. And Concept 9 sets out these essential qualities of good future servants and trusted leaders. Along these lines, we need to start thinking about nominations for our next Delegate. Candidates are nominated by a district prior to the June Area Committee meeting, at which time every nominee submits their resume to me. Resumes will then be published in the Northern Light for the area to review. Feel free at that point to invite any of the nominees to your districts or groups to get to know them better. Also, all of us need to be thinking of future trusted servants for the other Area positions. If you or anyone in your district or group have an interest, getting involved in Area committee work now is a good way to learn how the area operates and test if it might be a good fit for

For our upcoming area events in 2016 and 2017, I sent emails to the DCMs asking them to consider if they have a facility and would like the honor of hosting one of the upcoming 2016/2017 events and will be calling on and working with them for future assembly locations instead of the Helms-Briscoe service. Helms-Briscoe really wasn't able to get us anything I couldn't have negotiated on my own, or do anything more than any local Chamber of Commerce could do. In looking at the 2016 Fall Assembly, I am just waiting to get the contract to sign for the St. Cloud River center (Civic Center) facility. St. Cloud hasn't had an election assembly in their district since 1991, which is over 24 years ago, I and I strongly believe in the importance of rotating our events to allow people who normally might be prohibited by distance to attend and vote. So, to find a location near St. Cloud, I probably called every single meeting location in St. Cloud, Elk River, Sauk Rapids, and Little Falls (the Tech center there is a good option for future consideration). I called churches (obviously Sunday don't work), public schools (must carry your own insurance), Chambers of Commerce and city halls (no space for breakout sessions). So, while the Rivercenter is more expensive than I would have liked (it will cost us \$1,800 for meeting rooms for both days), it is the only available option in St. Cloud.

Financial Concerns:

I was able to attend the February District 13 meeting to address group concerns regarding the Area's budget, budget process, and expenses. It was a wonderful time, and I thoroughly enjoyed our discussion. I really appreciate their passion and I admire their devotion to making A.A. in Area 35 better. Several groups there reported that they were withholding contributions from the Area. Part of their concern was that the budget wasn't distributed according to the timeline set forth in the SOFR. This brought up the

discrepancy between the Area Chair and Treasurer guidelines and the SOFR, which have conflicting instructions on when the budgets should be distributed (the SOFR says 60 days before the Fall Assembly and the guidelines say in the NL edition prior to the assembly (Sept./Oct.) which is what I did). This highlights the absolute necessity of all Area Officers and Area Chairs making sure their guidelines are updated to reflect current practices for future servants. For instance, we all need to make sure our guidelines point directly to the SOFR policy guidelines for creating budgets, and the SOFR says to budget for projected, expected expenses—that is, it explicitly says you should budget for what you actually expect to spend (so if you will be traveling with someone, budget that way, etc.). I will be collecting updated guidelines by the August Area Committee Meeting.

I know there is concern regarding the current meeting frequency and composition of the Financial Oversight Committee, and I previously stated that the area officers asked the treasurer to look into the Statement of Financial Responsibility (SOFR) and come back with a recommendation today, but plans recently changed. So, instead I invited two DCMs to form an ad hoc committee to look at the current SOFR and make recommendations with an eye to costs, composition, and frequency of meeting. So far one has confirmed—Christine from District 13. Thank you for her willingness to take action on this task. I know we can expect their due diligence in assessing the parts of the SOFR policy which set out the current practice and procedures for the Oversight Committee. I expect they might have something to report to the body by the Spring Assembly.

Finally, with new input from the Area Officers and Committee Chairs, I have created a revised document outlining more realistic expected expenses in accordance with the area SOFR and guidelines. It will be published in the NL and I have copies here today. It basically shows spreadsheet with a column with their overall approved 2015 budget amounts, a second column with their revised expected expenses, and a final column with their actual 2014 expenses. Feel free to share this with your groups. It isn't an official document of any kind, but serves as an informational piece for the area and a useful resource for future planning. Why Do We Need A Conference?


The late Bernard B. Smith, nonalcoholic, then chairman of our board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting:


"We may not need a General Service Conference to insure our own recovery. We do need it to insure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to insure recovery of a child being born tonight, destined to alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth which brought us back to life.

"We need it because we, more than all others, are conscious of the devastating effects of the human urge for power and prestige which we must insure can never invade A.A. We need it to insure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing overintegration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

"We need it to insure that changes within A.A. come only as a response to the needs and wants of all A.A., and not of any few. We need it to insure that the doors of halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to insure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

The following article is some historical data from the GSO website on the birth of A.A. and its growth in the U.S. and Canada .

A.A. had its beginnings in 1935 at Akron, Ohio, as the outcome of a meeting between Bill W., a New York stockbroker, and Dr. Bob S., an Akron surgeon. Both had been hopeless alcoholics. Prior to that time, Bill and Dr. Bob had each been in contact with the Oxford Group, a mostly nonalcoholic fellowship that emphasized universal spiritual values in daily living. In that period, the Oxford Groups in America were headed by the noted Episcopal clergyman, Dr. Samuel Shoemaker. Under this spiritual influence, and with the help of an old-time friend, Ebby T., Bill had gotten sober and had then maintained his recovery by working with other alcoholics, though none of these had actually recovered. Meanwhile, Dr. Bob's Oxford Group membership at Akron had not helped him enough to achieve sobriety. When Dr. Bob and Bill finally met, the effect on the doctor was immediate. This time, he found himself face to face with a fellow sufferer who had made good. Bill emphasized that alcoholism was a malady of mind, emotions and body. This all-important fact he had learned from Dr. William D. Silkworth of Towns Hospital in New York, where Bill had often been a patient. Though a physician, Dr. Bob had not known alcoholism to be a disease. Responding to Bill's convincing ideas, he soon got sober, never to drink again. The founding spark of A.A. had been struck.

Both men immediately set to work with alcoholics at Akron's City Hospital, where one patient quickly achieved complete sobriety. Though the name Alcoholics Anonymous had not yet been coined, these three men actually made up the nucleus of the first A.A. group. In the fall of 1935, a second group of alcoholics slowly took shape in New York. A third appeared at Cleveland in 1939. It had taken over four years to produce 100 sober alcoholics in the three founding groups.

Early in 1939, the Fellowship published its basic textbook, Alcoholics Anonymous. The text, written by Bill, explained A.A.'s philosophy and methods, the core of which was the now well-known Twelve Steps of recovery.

The book was also reinforced by case histories of some thirty recovered members. From this point, A.A.'s development was rapid.

Also in 1939, the *Cleveland Plain Dealer* carried a series of articles about A.A., supported by warm editorials. The Cleveland group of only twenty members was deluged by countless pleas for help. Alcoholics sober only a few weeks were set to work on brand-new cases. This was a new departure, and the results were fantastic. A few months later, Cleveland's membership had expanded to 500. For the first time, it was shown that sobriety could be mass-produced.

Meanwhile, in New York, Dr. Bob and Bill had in 1938 organized an over-all trusteeship for the budding Fellowship. Friends of John D. Rockefeller Jr. became board members alongside a contingent of A.A.s. This board was named The Alcoholic Foundation. However, all efforts to raise large amounts of money failed, because Mr. Rockefeller had wisely concluded that great sums might spoil the infant society. Nevertheless, the foundation managed to open a tiny office in New York to handle inquiries and to distribute the A.A. book — an enterprise which, by the way, had been mostly financed by the A.A.s themselves.

The book and the new office were quickly put to use. An article about A.A. was carried by Liberty magazine in the fall of 1939, resulting in some 800 urgent calls for help. In 1940, Mr. Rockefeller gave a dinner for many of his prominent New York friends to publicize A.A. This brought yet another flood of pleas. Each inquiry received a personal letter and a small pamphlet. Attention was also drawn to the book Alcoholics Anonymous, which soon moved into brisk circulation. Aided by mail from New York, and by A.A. travelers from already-established centers, many new groups came alive. At the year's end, the membership stood at 2,000.

Then, in March 1941, the Saturday Evening Post featured an excellent article about A.A., and the response was enormous. By the close of that year, the membership had jumped to 6,000, and the number of groups multiplied in proportion. Spreading across the U.S. and Canada, the Fellowship mushroomed.

By 1950, 100,000 recovered alcoholics could be found worldwide. Spectacular though this was, the period 1940-1950 was nonetheless one of great uncertainty. The crucial question was whether all those mercurial alcoholics could live and work together in groups. Could they hold together and function effectively? This was the unsolved problem.

Corresponding with thousands of groups about their problems became a chief occupation of the New York headquarters.

By 1946, however, it had already become possible to draw sound conclusions about the kinds of attitude, practice and function that would best suit A.A.'s purpose. Those principles, which had emerged from strenuous group experience, were codified by Bill in what are today the Twelve Traditions of Alcoholics Anonymous. By 1950, the earlier chaos had largely disappeared. A successful formula for A.A. unity and functioning had been achieved and put into practice. (See Page 9.)

During this hectic ten-year period, Dr. Bob devoted himself to the question of hospital care for alcoholics, and to their indoctrination with A.A. principles. Large numbers of alcoholics flocked to Akron to receive hospital care at St. Thomas, a Catholic hospital. Dr. Bob became a member of its staff. Subsequently, he and the remarkable Sister M. Ignatia, also of the staff, cared for and brought A.A. to some 5,000 sufferers. After Dr. Bob's death in 1950, Sister Ignatia continued to work at Cleveland's Charity Hospital, where she was assisted by the local groups and where 10,000 more sufferers first found A.A. This set a fine example of hospitalization wherein A.A. could cooperate with both medicine and religion.

In this same year of 1950, A.A. held its first International Convention at Cleveland. There, Dr. Bob made his last appearance and keyed his final talk to the need of keeping A.A. simple. Together with all present, he saw the Twelve Traditions of Alcoholics Anonymous enthusiastically adopted for the permanent use of the A.A. Fellowship throughout the world. (He died on November 16, 1950.)

The following year witnessed still another significant event. The New York office had greatly expanded its activities, and these now consisted of public relations, advice to new groups, services to hospitals, prisons, Loners, and Internationalists, and cooperation with other agencies in the alcoholism field. The headquarters was also publishing "standard" A.A. books and pamphlets, and it supervised their translation into other tongues. Our international magazine, the A.A. Grapevine, had achieved a large circulation. These and many other activities had become indispensable for A.A. as a whole.

Nevertheless, these vital services were still in the hands of an isolated board of trustees, whose only link to the Fellowship had been Bill and Dr. Bob. As the co-founders had foreseen years earlier, it became absolutely necessary to link A.A.'s world trusteeship (now the General Service Board of Alcoholics Anonymous) with the Fellowship that it served. Delegates from all states and provinces of the U.S. and Canada were forthwith called in. Thus composed, this body for world service first met in 1951. Despite earlier misgivings, the gathering was a great success. For the first time, the remote trusteeship became directly accountable to A.A. as a whole. The A.A. General Service Conference had been created, and A.A.'s over-all functioning was thereby assured for the future.

A second International Convention was held in St. Louis in 1955 to celebrate the Fellowship's 20th anniversary. The General Service Conference had by then completely proved its worth. Here, on behalf of A.A.'s old-timers, Bill turned the future care and custody of A.A. over to the Conference and its trustees. At this moment, the Fellowship went on its own; A.A. had come of age.

Had it not been for A.A.'s early friends, Alcoholics Anonymous might never have come into being. And without its host of well-wishers who have since given of their time and effort — particularly those friends of medicine, religion, and world communications — A.A. could never have grown and prospered. The Fellowship here records its constant gratitude.

It was on January 24, 1971, that Bill, a victim of pneumonia, died in Miami Beach, Florida, where — seven months earlier — he had delivered at the 35th Anniversary International Convention what proved to be his last words to fellow A.A.s: "God bless you and Alcoholics Anonymous forever."


Since then, A.A. has become truly global, and this has revealed that A.A.'s way of life can today transcend most barriers of race, creed and language. A World Service Meeting, started in 1969, has been held biennially since 1972. Its locations alternate between New York and overseas. It has met in London, England; Helsinki, Finland; San Juan del Rio, Mexico; Guatemala City, Guatemala; Munich, Germany; Cartagena, Colombia; Auckland, New Zealand; and Oviedo, Spain.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

TWELVE CONCEPTS for WORLD SERVICE (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge. XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
