The Delegate's Duties

- Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee •
- Remind G.S.R.s to inform groups and individuals about the A.A Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
 - Visit groups and districts in the area whenever possible.

members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.

- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to . better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Why We Need a Conference

The late Benard B. Smith, non-alcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting:

We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the dark one block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life. "We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and of all of its services.

few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

TREASURER'S REPORT

It has been a very busy spring and lots of events going on in and out of A.A. There is never a dull moment and nothing to keep us bored, so love the busy life. I attended a lot of non-service events, which included a lot of open speaker meetings and other service commitments for different committees. I was able to send out some "thank-you" letters for last period and will be sending out more this week. Your contributions to the Area are greatly appreciated and if I missed any groups, please let me know and we will get a letter sent out to you. It is important to acknowledge groups that send in contributions on a frequent basis. It expresses our gratitude for our 7th Tradition and A.A. Some contributions do not have return addresses, some are incomplete, and some do not have current information such as group service numbers so it can be hard to track the groups and it takes a few telephone calls or emails to get it right. We have not received much for birthday contributions so far this period, but we still have a ways to go this year. Birthday Contributions were established in 1955 by the General Service Conference, under which some members of the fellowship send in a dollar a year for each year of sobriety they have in A.A. The current amount cannot exceed \$3,000.00. Group Contributions are direct mail-in to Area, District or GSO through utilization of contribution envelopes. The contribution envelopes may be dispersed by Area, District and GSO. Online contributions —A.A. members can make online contributions at GSO's website; Area 35 does not take A.A. contributions online, although it has done so in the past through PayPal. The Area decided that this idea was no longer feasible and eliminated it through a past action. I have received a few email requests for the current address of "Treasurer", which is not surprising as some groups that have not sent in contributions for this rotation are just now sending money in and have the last treasurer's address. One was even sent to a past Treasurer about 4-rotations ago maybe 8

years. It is imperative that DCM's get the correct information to the groups who request it. We put the current address on the Area Website and bring contribution mail-in envelopes to all service functions. A lot of these groups that send money in on an infrequent basis are sometimes not involved with district activities and are non-participating, so they do not get the proper information. It is important that we get them the right information.

In closing, we are winding down to the last 6 months of the rotation and are looking for available members to help carry the message and to be of service, whether in our groups, districts or area. So please, encourage each other and help those who need it and are struggling. Service has enhanced my sobriety tremendously and will continue to do so. I will always remember something I read from a writing of one of the past delegates who said "not to ignore those who are struggling in service, but to always lend a helping hand to insure we are practicing 'Unity' within our fellowship and doing the right thing," and to always search out ways to make the fellowship stronger.

PUBLIC INFORMATION (PI)

Since the spring assembly I have buried my grandfather. A good friend lost her mother and we in Area 35 have said goodbye to two long time friends and trusted servants. I am more and more reminded of the fragile nature of this life and the importance of placing first things first. I need to work diligently to keep my own house in order so I can see the opportunities to be of service to others and to be able to accept the love that they so freely offer.

We are coming in to the busy summer months. Definitions:

Unique Visitor:

A unique visitor is a person or computer (host) that has made at least 1 hit on 1 page of your website during the current period shown by the report. If this user makes several visits during this period, it is counted only once. Visitors are tracked by IP address, so if multiple users are accessing your site from the same IP (such as a home or office network), they will be counted as a single unique visitor.

The period shown by AW Stats reports is by default the current month.

However if you use AW Stats as a CGI you can click on the "year" link to have a report for all the year. In such a report, period is a full year, so Unique Visitors are number of hosts that have made at least 1 hit on 1 page of your web site during the year.

Visits:

Number of visits made by all visitors.

Think "session" here, say a unique IP accesses a page, and then requests three other pages within an hour. All of the "pages" are included in the visit, therefore you should expect multiple pages per visit and multiple visits per unique visitor (assuming that some of the unique IP's are logged with more than an hour between requests) Note 2: This number does not include technical header data size used inside the HTTP or HTTPS protocol or by protocols at a lower level (TCP, IP...).

Because of two previous notes, this number is often lower than bandwidth reported by your provider (your provider counts in most cases bandwidth at a lower level and includes all IP and UDP traffic).

WEB TECHNOLOGY

I attended the District 7 committee meeting on April 16th. During breakout meetings I met with their DCM, Alternate DCM, and WEB Master. We talked about meetings on aaMeetingLocator. aaMeetingLocator is populated from the list of "Active" meetings that I get from our Group Records Secretary. I was told that aaMeetingLocator is missing about 25% of the known registered district 7 meetings.

I investigated the tools that are used to populate aaMeetingLocator. I took the active groups from the list that I get from our Group Records and walked the data through the software. The meetings are getting pulled from the Group Records data and updated on aaMeetingLocator. What I did find was 20 groups in the Group Records data did not have a district. The district field was left blank. One of the 20 groups belonged in Southern Minnesota, Area 36, and another group belonged in Southern Wisconsin, Area 75. Our Group Records Secretary updated the missing district numbers and I received a new Active group list from Group Records.

I processed the Updated Group Records data and aaMeetingLocator was updated. I reviewed District 7 meeting on aaMeetingLocator. I found 69 meetings listed in aaMeetingLocator for District 7. There are 96 meetings listed on aacentrallakes.org. aacentrallakes.org is district 7's web site. I compared meeting for meeting between the lists. aaMeetingLocator has about 8 meetings that are not listed on District 7's web site. The eight meetings are probably meetings that are no longer meeting. This put the difference at 37%.

District 7 boarders District 17. District 17 is not an active district. The line that divides District 7 and 17 passes through Nisswa. Some meetings in District 17 are registered in District 7 so they remain active in service and Area 35. District 7's meeting list also includes meetings from District 17. This will explain some of the differences between aaMeetingLocator and aacentrallakes meeting lists.

I was asked by a Group Contact why their meeting was moved from District 7 to 17. I reviewed the message from the General Service Office: "Friday Renewal Group (Service #711227) had its district changed from "" to "17". The meeting was not moved from district 7 to 17—it was moved from no district number to district 17. When this group registered it filled out the Group Registration Form for District 7, ended up registered without a district number, and is now moved to district 17.

I have read the "Fellowship New Vision Process Manual". This is the manual for our Group Records database. I'm including some definitions for the group status codes.

IT IS IMPERATIVE TO UNDERSTAND THE GROUP STA-TUS LISTINGS THAT ARE ATTACHED TO EACH GROUP RECORD; BELOW IS A LIST OF THE CURRENT STATUS-ES AND WHAT THEY MEAN TO THE GROUP RECORD PROCESS.

Pages:

The number of "pages" viewed by visitors. Pages are usually HTML, PHP or ASP files, not images or other files requested as a result of loading a "Page" (like js, css... files). Files listed in the Not Page List configuration parameter (and match an entry of Only Files configuration parameter if used) are not counted as "Pages".

Hits:

Any files requested from the server (including files that are "Pages") except those that match the Skip Files configuration parameter.

Bandwidth:

Total number of bytes for pages, images and files downloaded by web browsing.

Note 1: Of course, this number includes only traffic for web only (or mail only, or ftp only depending on value of Log Type).

- New: Indicates a new group record has been added to the database by the Area Registrar and its status has not been changed to "Pending Active" by the Records department staff. The status change occurs the business day following the database entry, and review. If the New Group form has no anomalies or omissions of information the record is updated to "Pending Active".
- **Pending Active:** Indicates a group that was recently added to the database is in the 30 day pending period which is assigned to all newly added groups. Once the 30-day pending period has elapsed the status will change to Active.
- Active: The Group's record indicates that it is active when it has a primary mail contact on record along with meeting information.
- **Pending Inactive:** The Records department is processing a request to inactivate a group. If the record in the database has a contact's name, a letter is sent to verify the request to inactivate is genuine. If there is no contact on the record the groups (*Continued on page 9*)

status is changed to inactive immediately.

- **Inactive:** The Records department has received and verified information that a group has disbanded or is not currently meeting.
- **Merged:** Two groups have decided to join and become one group. The Records department receives the information as to which group will remain the active, who will be the GSR, and the meeting place, days and times. Then the records are combined and cross referenced. The active group will show a status of active and the merged group will show the status of merged. The merged group can request to be unmerged at anytime by contacting the Records department and providing updated contact, meeting place and meeting time information.
- Unknown: A group is still active; however their group record at the GSO does not have a GSR or Primary mail contact attached to it; which indicates there is no one receiving the group's mail. Anyone in the group can volunteer to receive the group's mail it does not need to be a GSR. Also a group can become "Unknown" when the GSO receives returned mail and is unable to confirm a new mailing address.
- **Incomplete:** Indicates a new group record was added to the database without all of the information necessary to show up on the Records departments' daily "New Group" report. The status remains incomplete until the registrar receives the remaining required information from the group or when the Registrar queries the database for "Incomplete" groups and reaches out update and completes the record. Until then the "New Group" remains in limbo.
- With Staff: Indicates there is a question about information on a New Group form that requires one of the A.A. Staff members to review the form and reach out to the new group's contact for clarification. It usually has to do with the way a group is named.

Should there be any questions about the information on a new group form, it will be referred to an A.A. staff member for further review/resolution.

In these cases the 30 day "Pending-Active" period will not begin until the outstanding questions have been answered.

The status would be changed from "New" to "With Staff" and will remain until there is an answer to whatever question has arisen during the New Group review process. At that time the status would be updated to "Pending Active".

**THE ABOVE REASON IS WHY IT IS IMPORTANT THAT YOU DO NOT RELAY THE GROUP SERVICE NUMBER TO THE NEW GROUP UNTIL THE 30 DAY PENDING PERIOD HAS EXPIRED. TECHNICALLY, THE SERVICE NUMBER BELONGS TO THE GSO FOR THOSE 30 DAYS. **

to take the "work" out of service. For the assembly, I rode up and roomed with a new GSR and am glad we had made plans to attend the District 3 Round Robin upon arriving in Fergus Falls on Friday night. The entire weekend was a great experience.

I am always interested in feedback from those attending their first assemblies, especially Spring Assemblies where we discuss the Agenda Items. I heard little that was negative and I think it was a good idea to stick to general sharing instead of the break-outs.

In preparing the last two issues of the Northern Light I have become more upset at minor obstacles (most of them technical) than I feel I should. Part of it, too, is sticking to the deadlines and in both instances, what I call "crunch week"-the week when reports and minutes come in-coincided with personal deadlines I had to meet.

I apologize about forgetting to send out a reminder to the committee chairs and officers about the deadline, but thank you for getting them to me in a timely manner anyway. Some were earlythat was great. I want to thank those of you who have sent in article contributions.

Whenever I encounter something that seems like a surefire solution to whatever difficulty I may be having in preparing the Northern Light, I try to employ it with as much consistency as possible in hopes of making the position smooth and easy for the person in the next rotation who fills this spot. Difficulty arises though, because I am such an explorative minded person that I continue to learn easier ways to do the things that I had trouble with last time, or the time before. I guess all I'm really saying is what I-and everyone else in service already know-that when I finally know what I'm doing it will be time to give it to someone else.

When I first got sober—I'm talking before anyone was able to reach me, and draw me out—I would try to talk with folks, answer questions that required revealing any in-depth ideas, beliefs, and concepts, and would usually end up throwing my hands in despair, saying, "it's all connected." That was my simplistic reason for the exasperation over my inability to answer questions that everyone else seemed to have no trouble at all with. It seemed to me that the rest of the world saw everything in black and white, when to me anything and everything was relative, totally dependent on everything else. I also couldn't understand why others did not find my "it's all connected"-answers as enlightening and explanatory as I found them.

My point to all this, as with so many other things in my life today, is that even though I had to see that I needed to take ownership of many things in my life and their outcomes, make some decisions and be responsible for those decisions or else I would always be like the steel ball in a pinball machine, living a purely reactive life rather than the *proactive* life that the God of my understanding intended me to have, it is "all connected," though not in the illformed interdependence that it used to be; it is connected in my openness to sharing it with others, and theirs with me.

It seems to me that there has been an abundance of life happening recently but that is only because I am more and more a part of it on a daily basis. Of course I am talking about the deaths, the illnesses, and health issues but not any more than the births, the happy marriages, the inmates blessed with freedom and the most rewarding-those that come into our program because there is nothing left, but whose lives are turned around through the Grace of God and they begin a life renewed with hope.

Contribution from Sarah K.

Recently I had the opportunity to share my experience applying the traditions at a workshop in Thief River Falls. The topic I chose to address was safety in A.A., as it seems to be of some concern to the fellowship. I selected this topic because I had read a really excellent presentation by a member of Area 10, and it got me thinking. I think some of you may find her comments inspiring as well, so here are some selected excerpts from the Area 10 presentation:

> As A.A. members, as A.A. groups, we have chosen the highest form of freedom by not limiting our message to

one class of person. We have chosen the highest amount of individual liberty within our groups by making the groups autonomous, responsible to their own authority, even the right to be wrong. We have no A.A. police, even if we sometimes wish we did. Who is going to deal with the chronic 13th stepper or other predator, if not the members themselves? We are taught and told to practice love and tolerance and respect. We have chosen to live among the sick and the mentally ill. We have chosen this because they are us, and because it is what has been asked of us. (Continued on page 10) May/June 2015

My instructions have been clear. I am to work with others, and to be a home-group member to the best of my ability. We should not be afraid to have principles that are unpopular. We should not fear talking face to face with others. Of taking a stand when necessary. Of looking at each other eyeball to eyeball and telling the truth. Chapter 2 says that respect for others' opinions, tolerance of their shortcomings makes us more useful. Everyone should be able to find something that is pure and good here in AA –this program offers everyone the opportunity to change, nothing less. It is personal change that lets us become safer people. You cannot create safety in A.A. without taking the alcoholic out of the group. And yet, is it possible for A.A. to be safer from the behavior of A.A. members, its own life's blood? The only solutions I have come to are Responsible Groups that do their work well, and sponsorship, all acting under the guidance of a loving God. It is only through the group conscience as found within our traditions that we can be more cohesive and less separate in developing our conscience. If we don't talk together about issues, we are part of an ongoing problem. We don't know who we are electing as leaders, because we don't know what they think, or what they stand for, or what they do after they are given our trust. Leadership functions at our lowest level, but the vibrations of either good or bad leadership are felt at our highest group level. Jl, CO, March 2015

Now, not that I can say it any better, but because at the very least it may spark some further conversation, I'll share some of my presentation given at District 2 here as well:

The author started her presentation with a great question that really got me thinking, "what is it we are really concerned with, is it a *safety* issue, or is it really a demand for *security* " (I'm sure you're all familiar with that tricky part of self listed in the fourth step! I know it is a continual process for me to avoid demanding that others make me feel secure!). Of course, making me feel secure is not the primary purpose of the group (tradition five). In fact, quite often my home-group denies my unreasonable demands for security, as they well should when my defects of self (fear) get out of hand and I step on the toes of my fellows! She also asked, "are we really more concerned with our public image than our desire to do good?" If so, then fear is driving a lot of our discussion, and fear is never a good starting place for action as far as I can see. Added to this is tradition three which means our rooms are open to anyone with a desire to stop drinking, and this includes some very sick people (I believe it is safe to say that I would have fit that description.). So, essentially, our traditions bring this situation on us! We are obligated to help, and we can't keep any alcoholics out! Now, one solution to the safety/ security situation that has been floated is to have GSO devise some guidelines or literature on it. I appreciate some of the literature provided by GSO. I learned a lot about how different people sober up and deal with group difficulties through the shared experiences contained in our literature. But, really, asking GSO to created guidelines or literature on this is getting flipping the inverted triangle so that the servants become senators. All that GSO does and can do, by our own concepts, is pass on the shared experiences of other groups in dealing with this issue (See concepts one-groups have ultimate responsibility and authority, three-groups have the right to decide for themselves, and four-groups have the right to participate). So, it seems if we are concerned about safety in A.A., we need to start the conversations in our own home-groups. Through informed group conscience discussions based in the traditions and concepts, we can begin to establish some solutions that can then be shared with other groups, and perhaps GSO, for the benefit of all! This is the action that fits with our traditions: one (our common welfare...), two (ultimate authority...), and four (groups are autonomous). And really, since the safety/security issues present themselves in our groups, what better place to address them! This is where miracles occur! When we join together, in brotherly and harmonious action, learning how to work with the trusted power of God, individually and within our groups. But this is no easy task! I will quote the author again, "Don't you think that it is our fear, and our dependence on the opinion of others that allows us to put our own spiritual principles second?" I know, it's easier to keep quiet when outside issues are brought into our meetings. It's always easier to keep quiet when speaking up would be unpopular, and thus uncomfortable, but we need to begin talking to each other about A.A. group issues.

How Service Relates to My Recovery

I was attending Alcoholics Anonymous meetings for approximately three months, when my home group elected me as their General Service Representative—it was definitely a blessing. Before this, I had attended A.A. meetings during different periods of my adult life, though; I was not ready or willing to go to any length for sobriety. *When I walked in the door this time, I knew in my heart that I now had that willingness*. It was then that my Home-Group was seeking out a G.S.R., and upon hearing what the position entailed; I put myself in as a candidate. It was voted unanimously that night, for me to represent the group.

To tell you the truth about becoming a G.S.R., I had no idea what I was getting myself into—but I was willing to learn. I worked with my sponsor on how the A.A. service structure operates, and what to expect at my first assembly. When I started studying how the G.S.R. position worked; I also divulged heavy amounts of time reading other A.A. literature—doing this helped me immensely to grow in the program. Learning about the program to the best of my ability, consumed a majority of my freetime. Not only was I going to at least one meeting a day (sometimes two), I was involving myself as much as possible with people in the program. These members gave me hope, strength, and inspiration on a daily basis—they taught me to live and enjoy life. Learning the G.S.R. position, and staying involved, played a big role in recovering from the disease of Alcoholism.

I attended my first Assembly in Bemidji, MN—my first impression of *this kind* of service work, was that of awe. In other words, *I enjoyed it*. My perception of that first Assembly was: that you had a group of A.A. members gathering together to try and do the best they could, for the still suffering alcoholic. I was also impressed with the way that these members conducted and presented themselves to the first time attendees. (I have heard that it is a good idea to dress nicely for these events—though not *required* to do so, I can say that at my first Assembly; *I did notice the amount of ties worn*. Also, if *you didn't notice* I placed a little bit of humor within this paragraph—*nothing is required* in A.A.)

We do the best we can, *through any type of service*—to help shape the future of Alcoholics Anonymous: in our Groups, our Districts, throughout the Area, and in A.A. as a whole. There is no rule however, that says "you must have a service position to be of service." Any member can be of vital service; by simply sweeping the meeting hall floor, washing out a coffee pot, or giving a warm welcome to a newcomer—these are just a few examples I came up with *on-the-fly*. Sometimes all it takes is a handshake and a smile, to brighten someone's day. I can personally say that seeing members in A.A. who accepted me for who I was, and greeted me with a smile (insistently telling me to keep coming back); is why I am sober today. Giving *any* A.A. member a warm welcome, along with a hot cup of coffee, is equally important to any service position I hold—though I am not perfect, I try to do this the best I can.

It's funny though, how *my* plans may differ from God's plans; the reason I put it *that way* is because, a year-and-a-half into service I was voted in as the District Committee Member of District 2—this was not my plan; but again, turned out to be a blessing. The more I do in all of these activities; is bettering my sobriety. In Step 12 it says "In all our affairs." Helping out the best I can, by being in service, *is my own personal way of carrying the A.A. message in all my affairs*—it's what works for me, plus I enjoy it. I find more happiness in sitting at a business meeting discussing possible solutions or suggestions to anything related to alcoholics

Anonymous, than I ever could have imagined. Yeah there are times of frustration, but that's with anything in life—I am going to keep doing what I am doing, and if anything I do or say possibly helps one alcoholic recover from this terrible disease; than I have done a good job.

And on that note: I thank all of you sitting around the tables of whom welcomed me in and helped me become who I am today. It is because of those of you who believed in me, when I did not believe in myself; that I am writing this today. I hope that this finds you well on your journey, and that you keep coming back. Prudence Versus Alcoholism

Service work has been a continuing litmus test of my spiritual fitness. It is an honor to serve my fellow alcoholic, but that honor is not free of burden. I am a better man because I participate in keeping our program available to the still suffering alcoholic. Here are two experiences that have added to my spiritual tool kit:

The first happened while I was making coffee for my then home group. Not being a coffee drinker myself, yes, we do exist, I relied absolutely on other's opinions and experience to make the coffee. I soon discovered that I could never please any three alcoholics. For one, it was too strong, the next it was too weak, and the final didn't like the color or some mundane aspect. I changed it up, and received the same criticism. I soon found it was best to never argue, and so found a formula that caused the least amount of complaining. One time, I felt generous and God inspired to splurge on the coffee, and purchased gourmet coffee as a gift to the group. One of the founders of the meeting took me aside to complain of the waste of group resources that resulted from my luxury selection. I curtly informed him that I did not waste precious group resources, rather, the coffee was a gift to the group. With the quick snap of self-righteousness that only an alcoholic could so express, he told me that I shouldn't have spent as much on the coffee. He elaborated that I could have bought the same old stuff and placed the difference between that and the gourmet coffee, into the basket. After all, the group needed the money more.

The second experience is happening as of this writing. I made arrangements to attend the WCRAASC. As a sense of duty, and a fear of mandate, I invited three other individuals to attend with me. A DCM and group level servant committed, while an Area level servant said he would tentatively travel with me, but had his own room. A GSR soon committed, and the group level servant backed out without further confirmation. About a week before the event, the Area level servant never firmed up their plans so I made a decision for him and offered his seat to an eager DCM. A third DCM asked for assistance in obtaining a ride and room, and after the GSR backed out, I offered a seat to this third DCM. After texting the offer to the wrong servant, I received an inquiry and then commitment by the wrong servant, and a tentative commitment on behalf of yet, another servant. On Tuesday of this week, it looked like five other people would be traveling with me, and we'd be splitting two hotel rooms. Later that Tuesday, the newest members of my party backed out and I was back to three DCMs. Due to a last minute illness, one of the DCMs had to back out, so now I am left with two other traveling and lodging companions. I am glad that my budget was for myself and one other. I am thankful for patience, tolerance, and love, or there would be even less servants to attend as I would have just told everyone where to go.

The reason for relating these two experiences is to illustrate that participating in our program is rarely easy. If it involves other people, conflict will arise, often times over petty things. We will never please the whole group, but our society is based off a premise of simple majority or considerable majority rule, with respect to the minority—though our minority is expected to respect the will of the group, as that is our understanding of what God's will is for us. Think 2nd Tradition. Service work has exposed me to more personal growth than sponsorship and the 12 Steps combined. I needed the Steps for a foundation to a new way of living. Sponsoring others provided the first lessons in patience, tolerance, and love. It has been in service work where my spiritual muscles have exponentially gained mass. It is in service work where I found true mentors, spiritual guides, living experiences, and a safe place to make mistakes. Though, in addition to our 12 Steps, 12 Traditions, and 12 Concepts for World Service, I would like to offer the 12 Lessons of Service Experience, where Lesson 2 would require a deposit by other servants to make travel plans with.

Contribution from the editor

An older member who frequented several of the same groups as I did back in southeast Kanas picked up the habit of printing old Grapevine articles, then leaving them at the tables when no one expressed interest—most expressed annoyance if anything. I saved some that seemed to work well for me, one in particular that established itself as an extra page in my Big Book where it made its appearance off-and-on throughout the years at appropriate times of my disturbance.

From the May 1997 issue of *Grapevine*:

'Take My Advice—I'm Not Using It'

I was feeling rather depressed and called my sponsor and found her in a similar mood. I said, "What shall I do?" At first she said, "I don't know. If you figure it out call me back." Then because she is a loving person, a good friend, and has a terrific grasp of the A.A. program, she shifted into sponsorship gear and told me to do the following:

- 1. Wear life like a loose garment.
- 2. Don't take myself so seriously.
- 3. Count my blessings.
- 4. Find another alcoholic to work with.
- 5. Read the Big Book and go to a meeting.

Then she laughed and said, "Take my advice—I'm not using it."

I called one of my sponsees, and she was also in a negative frame of mind. I addressed her problem and suggested one through five listed above. She said she had a sponsee in a melancholy mood. I proposed that I and my sponsor, she and her sponsee could form a singing group called The Depressions and sing the blues. She was not amused.

Later in the day my sponsor dropped by with another friend for coffee—and what a change! She'd made a Twelfth Step call and taken another alcoholic to a detox. They recounted how she looked like ten miles of bad road, was ill and full of fear and remorse. Suddenly we were all full of gratitude and laughing at the insanity of self-pity and self-imposed depression. We remembered all the pain and confusion of our early days in Alcoholics Anonymous.

The simplicity of this program never changes—what works is constant trust in God, clean house, and work with others.

The following is a snippet from "Dr. Bob *and the Good Oldtimers*" regarding Bill's first meeting with Dr. Bob:

Describing their talk as a completely *mutual* thing, Bill said, "I had quit preaching. I knew that I needed this alcoholic as much as he needed me. *This was it.* And this mutual give-and-take is at the very heart of all of A.A.'s Twelfth Step work today.

In "Alcoholics Anonymous," published almost exactly four years after their first meeting, Dr. Bob noted that Bill "was a man ... who had been cured by the very means I had been trying to employ, that is to say, the spiritual approach. He gave me information about the subject of alcoholism which was undoubtedly helpful.

"Of far more importance," he continued, "was the fact that he was the first living human with whom I had ever talked who knew

what he was talking about in regard to alcoholism from actual experience. In other words, he talked my language. He knew all the answers, and certainly not because he had picked them up in his reading."

Whatever Bill said—and in the course of some five hours of conversation, he must have thrown in everything he ever knew or thought or guessed about alcoholism, and told the long version of his story to boot—Bob stopped drinking immediately.

Bill seemed to place more emphasis on what he was saying than on the fact that it was he himself saying it, while Bob indicated that, although it was helpful, he had heard most of it before. Important to him was the fact that *another alcoholic* was telling him. If William James, Carl Jung, and Dr. Silkworth, along with Frank Buchman and all the members of the Oxford Group, had been doing the talking, it would have been just another lecture.

 Some facilities do not allow AA meetings, so this service is important.

One stated that this pamphlet could help somebody come in the door as an outreach tool and see that they belong. Singleness of purpose was a concern to one district. One district said it was a sensitive issue and referenced beginning of How it Works chapter. Said this could be helpful to some. Another district discussed this and decided it was up to the AA members to be welcoming rather than a pamphlet. One individual expressed that this pamphlet could be helpful to some. One district said pamphlets can reach people who think they are different or don't belong in AA and there seems to be a need for this. One issue is that this agenda item has been discussed and voted down the last three years. One member expressed the need to acknowledge mental health issues as well as alcoholism. One member suggested the idea to have a pamphlet geared towards sponsors on this issue as to how the sponsor should address this. One point was that 7 areas brought this forward and the rest were silent. One member said maybe new stories could be added to existing pamphlet and mental health issue are for professionalism and alcoholism is for AA. Sharing experience, strength, and hope is far more important than a pamphlet. What is cost of pamphlet? This is not listed. Overwhelming majority against producing pamphlet: ~90/10% - 95/5%.

- Question about is it different with each individual with what they are comfortable with.
- Would a newcomer be more comfortable with what might be better for them, would they know?
- DCM role would only provide guidance if asked, would not provide direction/rule on this.

How do districts maintain websites?

- One district has their website through Area 35. No need to maintain it or create it; it's already there.
- One district has a web technology position. Another district has a web master position too and cross-trains other positions to maintain it.
- Two districts have their own website. Two districts have websites through the Area website.
- A few districts are interested in utilizing the Area website.
- Question about what is appropriate for a District website. Please provide feedback. Look around at other district websites.

How do you maintain focus and motivation for service?

- Rotate into other positions and keep going if you are asked to serve and if you can.
- Ask for help from other group/district members.
- Delegate tasks you are unskilled in to other members/ positions. Ask Area officers or chairs for assistance.
- Remember what service is: gratitude made visible. The benefits pay off. Seeing new people come in and changed because of service is rewarding.
- Comment about how an individual can learn talents and skills by going through service positions (such as typing).
- Remembering that you can only do what you can do.
- Keep a "to-do" list and keep working on things little by

- It is not necessarily the Alternate DCM to step into the DCM role in the rotation.

of the area depends largely upon the servants place in chair positions, carefully consider the traditions and concepts when looking for candidates (principles before personalities, and qualities of a good leader). Recommendations for any position should be based on traditions and concepts, and not on personal feelings (such as, I fish with him, or this position would help him) because our servants are the guardians of our traditions, the one's who will establish the health of service in Area 35 for the next 2 years. So, carefully consider the 9th Concept which talks about qualities of a good leader, and decide who'd be the best person for the position (that is the best position for AA): who shows up and has the passion and humility for service, who does the work, who is knowledgeable on our traditions, concepts, and history, etc. Elections for area officers will take place at the Fall 2015 Assembly, and recommendations for area chair positions will be sought thereafter by the newly elected Area Chair. Descriptions of chair duties can be found on our Area 35 website, and the Service Man*ual.* Elected positions to be filled:

- 1. Secretary (basic word processing and typing knowledge recommended)
- 2. Treasurer (basic knowledge of banking processes and financial programs (Quickbooks & Excel)
- 3. Area Chair (see Concept 9)
- 4. Alternate Delegate (see qualifications for Delegate)
- 5. Delegate (5-6 years continuous sobriety, experience in service)
 - Delegate candidates need to be nominated by the Districts, and must submit their resume to the area chair by the June 7, Area Committee Meeting. [See the Service Manual for the delegate position duties and eligibility (the *Service Manual* is found on AAWS website and a brief description will be included in the next edition of the Northern Light)].
 - Since you are the ones active in service, you will be an essential part of the selection process. You know and can talk to people that are active and meet the qualifications this weekend to see if they are willing. You will want to bring your thoughts and recommendations up at the district meeting in April so the GSRs can take the options back to their groups, have them discuss possibilities and bring back for a vote at the next district meeting before the June Area Committee Meeting.
 - The resumes will be published in the Northern Light for review and the vote for delegate will take place at the 2015 Fall Assembly.

Additionally, at the Fall Assembly there will be an election for our Area's nominee for the West Central Regional Trustee position. Before the Fall 2015 assembly, consider/meet/discuss with potential WCR trustee candidates. Candidates usually have similar qualifications as delegate candidates. Further details on the trustee position can also be found in the service manual, and a summary of qualifications will be published in the Northern Light.

I have had the opportunity to participate in a couple of GSR schools, one in District 2 and one in District 13. Both were very informative and well attended. The Twelve Traditions of Alcoholics Anonymous—long form

Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any 6. considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alco-8. holics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It re minds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

A few words on Social Media:

Social media websites such as Facebook, Twitter and LinkedIn provide unique opportunities for colleagues to get to know each other, share experiences and keep in contact. It is important to be aware of the risks associated with using these sites, to act in a manner that does not embarrass yourself and to refrain from sharing your private information publicly. Despite site privacy settings, you should always assume that anything you post online can never be removed and can be viewed by anyone with an Internet connection, including cyber and traditional criminals as well as identity thieves. Not only does this present a risk to you personally, it can also be a risk to Area 35, AA, and any members on a "friends" list.

They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. TWELVE CONCEPTS for WORLD SERVICE (Short Form)

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."

VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal

IV. At all responsible levels, we ought to maintain a traditional sonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

> XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of ungualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
