



### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to
   receive Conference materials.
- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping

- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
   If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. • members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.

I would like to thank Carl B. and Brooke C. for traveling to our workshop and their excellent service presentations. I would also like to thank Districts

11,5,14,12,13,8 and 3 for preparing and delivering excellent presentations at the service workshop.

#### **Workshop Presentations:**

#### **District 11: Connecting With The Newcomer: Home**

Group – Where It Begins Welcome newcomers. Welcome court ordered. Don't sign court cards until after meeting. Home group is where I am at home. Hang around winners at AA rather than users who still drink. Lost all, gained self respect, family and community back. Slogans work, one day at a time, first things first. If you want what we've got keep coming back and do it. If we have a higher power we are going to pass it on. Importance of giving newcomer a directory so they can call someone. Pass it on by picking up newcomer in trouble and taking them to a meeting. Without a sponsor never would have learned the 12 steps. Get newcomers into service work. Change group positions 5-6 times a year and have 5 positions in Happy Joyous and Free Group- successful for 15 years. Nice summary of what home groups do. Found home group from felony section of Pine County Jail- went to meetings there. People in jail meeting told me where the groups meet. Fellowship social evens are important. People can see we are having fun. Keeps them coming back.

Home group is the most important part of AA. Where we finally learn responsibility. Showing up, its all about change, making people comfortable, giving them a desire to stay sober. Jail attendees know it all and it works for them- 1/75 stay sober. Welcome them home to their jail meeting. Learned about nuts and bolts of AA as a GSR. Had 2 sponsors, one for service. Issue with people moving away from AA. Main step is step 11 today. Try to get a few points across to newcomers. Keep things simple- from Dr. Bob. Each of us has a wall we built in drinking- our program has a way of breaking down our wall. Puncture that wall with steps and sponsorship. Did what they told me, went to lots of jails and treatment centers.

Participation-Why is it important for a newcomer to have a home group? Best to encourage newcomers to have a home group so people get to know them and they learn to trust people.

#### **District 5: Anonymity- The Spiritual Foundation**

Dr. Bob and Good Old Timers- Dr. Bob, said all group members need to know each -other's first and last names. Long form tradition 11 and 12. Genuine humility. Anonymous to the public. Dr. Bobbreaking anonymity at level of press radio and film is for ego, not humility. Can also break anonymity at group level in too much privacy. History informs us on what does work.

Tradition 11. Can add TV, internet and social media. Each member is an active guardian of our fellowship. Anonymity is important for each of us and our groups.

service to God and people about us. Lack of power, where and how were we to find this power. Responsibility pledge. Tradition 1 Important to have all principles involved in AA. Introduction to SM by Bill W. Concept 5 minority opinion.

District 12: Informed Group Conscience – The Key to <u>Unity.</u> Group comes together in group conscience over one person prevailing. Minority voice is always heard. Tail wags dog if minority always influences majority. How do groups get more people to go to the groups conscience meeting? How to structure group conscience meeting. If one person tries to run the meeting it is a problem. Example; Leader said- too much positivity, to much greeting. Criticized treasurer who left and did not come back. 60 member meeting dwindled to 10. Thought about leaving but sponsor said he would screw up another meeting. Meeting is back to 40. Comfortable, safe, non-judgmental place to go. Solution- elect someone to run the group conscience meeting. Ensure everyone speaks. Don't let folks speak twice, manage the meeting. Substantial unanimity means almost everyone. (Presentation based much on experience.)

#### **District 13: Singleness of Purpose-Staying Pertinent in A Changing World**

(Well researched from AA literature and presented with PowerPoint slides.) History and background of Singleness of Purpose: Washingtonians started by 6 alcoholic members. Grew quicklybegan in 1840. Became involved in many issues and eventually faded away. AA Comes of Age- first reference by Bill W on our single purpose. Traditions. We stay whole of AA dies p. 129 12x12. Research from AA literature. Traditions 1, 3, 5, 4 hit singleness of purpose Steps 1, 12 also hit singleness of purpose. Closed meeting announcement. Open meeting announcement. Participation- 5 questions posed.

When do we know if we are dong something that affects AA as a whole? Example of Good Book-Big Book meeting can affect AA as a whole. Traditions will have more to determine our failure. If you violate one tradition it also violates 2 or 3 other traditions. Traditions are so tightly knit that they can't be "torn apart." Traditions define what AA stands for and what will keep us together- also inform us on what outside issues will tear us apart. We should cooperate with everyone but can't affiliate with anyone. We have but one primary purpose to carry the message. If the issue has very little to do with carrying our message- it is an outside issue. We neither endorse nor oppose any causes. If we neither endorse or oppose any causes we will not have arguments that could tear us apart. Traditions don't do any good if you just hang them on the wall or do one a month. Need to learn how to use the traditions in their entirety to keep AA whole. Nice to see this kind of workshop. "First place in ten years where I have hard a good discussion of the traditions" -Carl B. commentary,

"Exposed to steps in meetings that read How It Works at the beginning of almost every meeting."

District 8: Understanding Self- Support. Hit up envelopes for area, GSO and district. Also birthday contributions. Use of literature profits at GSO is an issue. Provide services we ask to provide through literature sales- is not self- support. Solution put more money into our baskets, reach out to groups who are not contributing with 7<sup>th</sup> tradition literature. Important to have 1-12 months of prudent reserve for groups. Do not have policies in place to define this. Amount of contribution is secondary to spiritual connections that bind us. Early Rockefeller dinner, John D. Rockefeller, said to AA, "money will only spoil this." Mothership is GSO. Two sources of revenue: contributions from us and literature sales. Lit. sales are from us and non-AA members. 2014 around \$7 million in group contributions by 41% of listed groups, whereas \$16 million plus total revenue with literature sales 50% of GSO's income. 2014 AAWS had to ask for more contributions or raise literature prices. 1.5 % increase in contributions. Questions: How do we feel about not being self-supporting or continuing to allow literature to support GSO in an age when the publishing industry isn't dong so well? Where is this going in the future. Where will it leave AA?

Tradition 12. We started as a secret society.. Tradition 12 is a key part of fellowship.

#### District 14: Be Involved, Be Inspired, Be of Service-Participating in all of AA.

District 14 went dark for a few years. A few decided to change that. Involvement in service is for the newcomer. Introduced 2 scenarios: 1-How do new people in AA get introduced to service? 2-How do people involved in service move on? Recovery does not end in steps- first part of 12. Reference to Concepts in SM. Invite and encourage sponsees to attend district meeting. Get them willing, excited. Service sponsorship plan in district works.

Scenario 1: Traditions are just as important as the steps. Living happy joyous and free. Most important in AA to greet the newcomer. Feel welcome and see a solution- that things can change is the most important thing we can do.

Scenario 2: p. 77 BB. AA comes of age. Bills intro to service. Concept 9 service leadership. GSB Concept 5- each AA group ought to be a spiritual entity with one purpose to carry message. Into Action- our real purpose is to fit ourselves to be of maximum

### **Brooke C.: 12 Concepts Presentation/Sharing Session**

Demystify the concepts. Bring conference approved literature if you have any challenges with me. Liked circle and triangle, three legacies. Recovery, unity and service. Was never ours. What is the point of the tree legacies- Are we willing to grow along spiritual lines? Service- it's the concepts. Recovery it's the steps. Steps are "number I" for me. Until I admitted powerlessness I wasn't ready for recovery. Traditions are about protecting our message, not carrying it like our 12 steps. Traditions are about "we". We are one brilliant idea away from total disaster. P. 2 SM declaration of unity. Protect our message long enough for our great- great grandchildren.

January/February 2016

All 3 legacies are handed to us when we walk in the door of AA. It is an equilateral triangle. Being willing to grow on spiritual lines. God is or is not. God is. Show up and listen to the Delegates Report- don't have to be a delegate. Need Unity sponsors before Service sponsors. Need three legacy sponsors.

Concepts- in SM. Structure of the conference. Skip concept 6 and 8 for now-. It is steps 1 and 12, traditions 2, 9, concepts 1, 2 and 5 that identify our structure. Groups are on the top. Concepts 1 and 2. About a history lesson. Alcoholic Foundations Book published in 1939, foundation renamed to GSB, alcoholic and non-alcoholics. Foundation board depended on Bill and Bob to guide them. Loaning money to drunks is not a good idea.

Opposition to the conference. Late 40's Dr. Bob is very ill. Bill decided to take responsibility and give it to the groups of AA. We are the shareholders. **Concept 1** the groups own AA- all of the responsibility and authority is ours. Concept 2 addresses a logistical problem. How do all of the groups communicate? Delegation is the principle- can make a decision on the next International Convention to the conference. What is the highest you can get in AA- sober. Trust one of our trusted servants to do something for us. Delegation is concept 2. Concept 3- talk about the right of decision. If we delegate to you we are going to let you decide how to do it. Never use right of decision not to consult with those you should, stay in the scope of what you should be doing and always report honestly what you have done. Concept 4 The right of participation and responsibility of participation. Has to do with belonging. Say you are a member and you are. YOU can show up, participate and vote. Amazing democracy- no member is above any other. Comes from the unity of the traditions and sense of belonging. Concept 5. Petition-redress of a grievance- want it fixed. If not fixed- take it to the next level for an appeal. Bad coffee is not addressed- take it to the group. Call NY, or then you pray. There is no place above the group that you can go. Final appeal is to the groups. Voice of the minority to protect against uninformed, hasty group conscience. If you believe that something's really wrong- then you have that responsibility to say so. Sponsorship is a real leadership position. Read commentary on **Concept 9**. Always going to have a problem with leadership. Great leader- rotate he/she out. There is always a newcomer watching you. Concept 10. If we are going to delegate to you, we will give you what you need to do it. Match authority and responsibility. Concept 11- get the best people for the job, most qualified help. Don't elect cuz someone has a pulse. She still has shakes and was spilling coffee – after a week she was ok as coffee maker. Concept 12 Warranties- also in resolution of 1955 and Article 12 of conference charter. Article 12 is protected. Need to send a letter to every known group- 3/4 need to agree to changing warranties or can't be changed. AA's Bill of Service Rights. 1 says conference will never be a seat of perilous wealth or power. Traditions describe this. Warranty 2 - Bill says middle path between recklessness and paralyzing fear. Warranty 3- no unqualified authority- you aren't the boss of me Warranty 4- substantial unanimity. Discussion, vote, discussion. We keep talking things out and eventually we come to an informed group conscience. Pay attention to abstentions, sometimes they could sway votes. Loving god expressed in our group conscience is not Robert's rules. Abstainers don't know or don't care. Don't call the question before we are done discussing. If we are split we are not done... Warranty 5, we don't do things that are publically controversial. We don't punish or shoot people. Who is going to play judge, jury and executioner to his own sick brother. Warranty 6 – we are going to be democratic but no acts of governments- hey groups- this is what you are going to do. District can send things up to groups. Box in GSO achieves on opposition to the conference. Purpose of conference to uphold the traditions. Trustees didn't want to worry about the traditions. Bill takes a year off to talk to the groups. Was talking about the idea of a conference. Letters started coming into GSO. Bil- Got the Trustees into the traditions because of the revolution going on with the groups. Trustees thought Bill made them up - Bill said no the traditions made themselves. 1946-12 points to assure AA's future.

tee and had been out of general service for 16 years. Every service job is on the job training. I love AA cuz it saved my life, my dads and my sons. All three would long since be dead. Dad sobered up at 70 and died with 20 years of sobriety. Principles of AA work in spite of us. That's why this fellowship is worthwhile. Dr. Bob and Bill just asked us to keep the principles and pass them on to the next generation with an enhanced content. That is what you are figuring out.

At 16 took a couple drinks and it gave me courage to face life and do what I wanted to do. Would have been a teenage suicide without alcohol. 1952 went to work in oil fields. Hard work and hard drinking fit. AA is the language of the heart. Current agenda item to translate BB in plain language. We need to put the language of the heart in plain language? Bill and Bob predicted that book would save lives- it has for 80 years. We need to change that?

Lucky to have a sponsor who taught me how to think- not what to think. Got involved in service at 9 months. Delegate learned Carl did not have a service position at 9 months. Took what came along that others did not want to do. Coffee, GSR, DCM, delegate, area chair, elected to board of AA. God needed a dummy like me and gave me an opportunity to be involved in service.

Dad wanted to visit- didn't want to, sponsor said nothing to loose- that is the language of the heart. Took dad to open AA meeting. Dad was dead silent at 60- hadn't talked in 15 years. God makes AA work in spite of us. Bill – AA being the language of the heart – I believe was provided by God to guide them in writing the BB.

#### **District 3: Getting Others Involved in AA Service**

Many say they did service, remind them that they need to stay involved. Was doing signs at 2 months. Sponsor took her to district at two months. Key is letting others see what you have.

Support other groups that are struggling, and individuals who are struggling. Hold meetings at home of struggling folks and put money in basket for them.

Sponsor people into service. Otherwise they will sit there and wait for things to happen. We need to be sponsored in. Low percentage of groups have a GSR and attend district meeting. Sponsor taught me what I have to do in AA. Sponsorship and ensure group supports their GSR.

Bring people to workshops. People say they don't have time - need to make the time for service as we did in sponsoring. Talk about the concepts at regular meetings too. Participation We are part of the heart of the spirit od AA. Bring sponsees to service functions. Personally ask people to get involved. We see a talent in you and would like you to get involved.

#### District 7: Reaching Out to the next Generation of AA's

Get Grapevines out to medical offices. Get more CPC materials out to professionals. What is said and done should not be different. Don't be too pushy with newcomers. Talk to them after the meeting. Make sure they have phone lists. Offer to take them to a meeting. First meeting is make or break- -need to be gentle. This is a journey- not a destination.

Experience with daughter in and out of recovery. Family is the next generation, family is everything. You can't make a horse drink water if he still wants beer. Leave them alone if that is what they want to do. Important to volunteer to become temporary sponsors. Don't preach. Allow newcomers to come to their own perception of a higher power. Anyone who declares they are a member is a member. This is a program of suggestion, didn't do that at first.

From As Bill Sees it. Began to have success with milder

Carl B. : Open Speaker Meeting Elected to GSB as a trus-

alcoholics. Younger people appeared. They needed to hit bottom emotionally but not every possible bottom. First duty to AA's future is to maintain in full strength what we have now.

12 Traditions Presentation/Sharing Session-Carl B. Denver, Colorado "We are jumping over the traditions to the concepts. Traditions are the foundations of the concepts. GSC inventory spent 140,000 to publish this abortion. Three years with 93 delegates, staff and trustees = 279 people worked on this. Inventory is assets and liabilities. To get to the truth about what I really was-about nothing. Figure out what I had done wrong so I could move on. Document is 30 pages and not one word on AA's traditions. Inventory left out one legacy and you tell me we are in good hands? We must get back to the priceless traditions, given to us by Bill and approved in 1955 at St. Louis- he gave us the fellowship. Also knew our propensity to fix things that are not broken. Also gave us the responsibility to protect it. Re- writing the Big Book in plain English is like changing the smile on the Mona Lisa painting. Didn't have much intelligence when he first read the BB. We will have a BB for dummies if approved at the next conference.

"If we have nothing to look forward to and nothing to look back to with pride- then we are dead, like he was when he came to AA. Told him that he would be pulled up to a level never dreamed of by AA. We use the language of the heart in AA and that is the language of the Big Book. So lets pull all the smart people down to the level of the few who don't understand the English language? I was pulled up by people not brought down. I've been learning by what you have done- not said.

Traditions were the guidelines Bill gave us to create unity. Stop having group conscience meets to get more involved in AA. Before 1946 until Bill gave traditions to fellowship in 1951- lots of fighting. Even the board thought the traditions were BS. Talked delegates into accepting them on a trial basis and if the were useful in four years-they would take them on permanently, which they did.."

We are flying blind if we are trying to discuss a problem in AA without using the traditions. Anything in AA that does not involve carrying our message is an outside issue. If you do not understand the traditions it does not work. In all group conscience meetings- traditions need to be used to solve the issues. Don't use opinions to solve problems-use our traditions. Only authority we have is a loving god as expressed in our group conscience. Fighting at group conscience meetings chases away newcomers. Group conscience needs to be informed by our traditions. If GSO/AA does not endorse any causes then we don't have anything to oppose.

Unity means we can all think differently and get along in solving our problems. If you are violating one tradition you are likely violating several. If we do not use the traditions they won't be used at the GSC. At best 30% of the delegates will be familiar with the traditions. So 70% will be using opinions to solve issuesflying blind. Groups can let autonomy ruin themselves. Use AA Comes of Age as the basis for a traditions workshop. Study the traditions so we know about issues like affiliation vs cooperation, attraction vs promotion.

Key is to use our traditions to solve problems or AA won't last more than 20-30 more years.

#### Ask it Basket

-Plain English BB? Jake: Won't be voted on in next GSC. -Home group member always bringing religion into meeting.? Brooke: Group needs to be aware of traditions. Ask member to keep religion as an affiliation outside of AA.

-Why we do 2 change forms for a new GSR-for area and GSO. Tin C.: Area is quicker than GSO.

-Recovery, unity and service. Is it necessary that recovery comes first. Tom A.: Need to go through the first 11 steps before doing service work. Its not apathy for service- unrecovered alcoholism. Traditions inform us on how to be of maximum service to God and others. Bill wrote traditions and concepts after steps.

-Does the white ballot circumvent our voting process? (?): Not if we follow things properly, and do not nominate people who will not be good leaders. Pick the right people.

-What is the importance of the spirit of rotation? Susie: If we have the same job for more than 2 years – we get to be experts.

-Non- alcoholic person attending open meetings, breaking anonymity of members. Bruce B.: Traditions broken, common welfare, unity. Get lots of members to talk with that person.

-How can we better educate members on differences between open and closed meetings.? Jake: Card describes the difference but most don't get it. Members of the group make it open or closed. Otherwise use the blue card.

-What is the power of the purse and how is it affected by literature

Chair-Sarah K. Greetings all. As I complete my responsibilities as area chair, I look forward to passing the responsibilities and bins on to Jim! In preparation for the next rotation, I put together a few packets of information for each incoming area committee chair. The first is the updated guidelines for each position, and the second is a packet to use in budgeting for 2016. I would remind all outgoing, and incoming, committee chair people that the very first of their responsibilities is to fill out a budget according to the updated guidelines and the Area's Statement of Financial responsibility. The packet contains a blank budget sheet, a document listing the 2014 actual expenses (2015 actual expenses can be found on the period 6 reports in the back of the room), and a cover sheet that includes the location of all upcoming events, cost of hotel rooms, and expected gas prices for 2016 so budgets can be framed as close to what you realistically expect to spend in the course of serving the Area. The budget is our Area's way of demonstrating and evaluating the services you provide to the area. As such, we want to go beyond attending the meetings and provide those useful and needed services the fellowship desires, so take some time to think about the current state of the Area and where your committee might be able to meet some unique needs. It will help to have a talk with the outgoing chair to get their perspective on how things went, what additional services were provided, and what needs remain. You might also look at the board minutes and Box 459 to see what your committee is discussing.

One of the final two events of my rotation was the Zonal Forum held in Duluth. I shared a little about what people coming to area events can expect, how we operate, and parliamentary procedures. There was wonderful discussion including great questions about the financial relationship between AA and Alano Societies, and the cost of the Area's Financial Oversight Committee from some very curious, interested people.







#### **EDITORIAL POSITION & N.L. COMMITTEE:**

**Editor** - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. #### **TWELVE CONCEPTS for WORLD SERVICE (Short Form)**

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and con-

duct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities. IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.

XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by sub-

#### TWELVE TRADITIONS OF ALCOHOLICS ANONYMOUS—LONG FORM

#### Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be

that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

8. Alcoholics Anonymous should remain forever nonprofessional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.

Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our overall public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise our-
