

Call to Order: Vicki R Called meeting to order at 10:30 and opened with the Serenity Prayer.

Recognition of Past Area 35 Delegates in Attendance: Michael "Jake" J Panel 64 and Steve L Panel 72

Chair Welcomed GSR's for this special assembly session - GSR's were able to attend in person or virtually using Microsoft Teams. There were 17 in attendance via Microsoft Teams. There were 3 GSR's that were not able to access Microsoft Teams therefore they phoned in. This was accepted by the body.

Vote on GSC Proposed Agenda Item (PAI) - Proposed Agenda Item submitted and unanimously approved by the Biwabik Sunday Night Group (District 8 Area 35) - Unanimous approval for the PAI by District 8 Area 35. Steve L read the complete PAI stating Area 35, Northern Minnesota, would like to add to AA's Current Conference Charter under article #3, that A.A.W.S., Grapevine publications and personal correspondence of pre-1972 "Founders Writings" have no contextual changes to their writings without a super-majority of 3/4 approval from the full General Service Conference. This includes but is not limited to AAWS publications of the books; Alcoholics Anonymous (Big Book), Twelve Steps and Twelve Traditions, As Bill Sees It, Alcoholics Anonymous Comes of Age, Our Great Responsibility, and the Twelve Concepts currently in the Service Manual. AAWS Pamphlets: Problems other than Alcohol and Let's be Friendly with Our Friends etc. Including Grapevine publications, Language of the Heart and Best of Bill along with any archival articles pre-1956 written by our Founders both alcoholic and non-alcoholic. Alcoholic Founders include: Bill W., Dr. Bob S., Hank P., Bobbie B., etc., and non-alcoholic Founders include: Dr. Silkworth, Father Dowling, Henry Tiebout, Bernard Smith, Frank Amos, etc. these writings should be left intact.

Motion John J. DCM Motioned to approve Biwabik PAI as written- Jeff GSR Seconded-

Discussion- None

Motion carried 64 in favor 7 opposed Minority Opinion given-

- This proposal is to change the Conference Charter that isn't a legal document which implies suggestive only therefore not clear that the proposal would achieve its goal.
- writers of this proposal think 2/3 substantial unanimity is not enough and should be 3/4 vote,
- this proposal contains a highly charged emotional language,
- careful reading of this proposal suggests real problem the writers had was woke language included in the 12 by 12, revisions already cited.
- our group discussed this proposal's intent to forever limit what and how certain decisions can be made at future General Services conferences.
- this assumes that we, in our current time based on our current sobriety and spiritual progress, can look into the future and decide what's best for AA in the future
- we oppose the proposal on those basis.

During the month of July, I had two report backs. One in District 18 at the Long Prairie Alano Club which had participation from many towns in their district and I attended their district meeting. District 18 has lots of active committees. Another report back was with District 8 in Virginia Mn. District 8 had a short business district meeting. There were some GSRs, District Committee members, and four past delegates also good fellowship and food. Brainerd is on the schedule for August. If any other districts would like to have a report back, please contact me. It is the fellowship that makes these reports worthwhile and knowing that they love Alcoholics Anonymous as much as I do.

The deadline for Proposed Agenda Items(PAI) for 2025 General Service Conference will be 9/30/24 at 11.59pm. Other key dates for materials related

Keep in mind, individual A.A. members, groups, delegates, trustees, area assemblies, area committee members, directors, and staff members of A.AW.S. and Grapevine can submit PAIs. If they do not meet the deadline, they would be considered for the 2026 conference.

The 75th General Service Conference will be electing a Trustee-At-Large for the US. Each area can select one candidate. The nomination(s) from our area will take place at the Fall Assembly in Alexandria. If there are more two more interested, we will have a Third Legacy Election.

On July 20 I attended the Area 35/Area 36 Joint Meeting. We split into Breakout Groups, and I attended the Grapevine La Viña and Literature. We had six in attendance with two from Area 35 and 4 from Area 36, including the Area 36 Grapevine (GV) La Vina (LaV) Chair. Many topics were covered including the new American Sign Language GV/LaV YouTube video sharing stories for deaf members, the Grapevine La Viña Apps, new literature catalogs, purchasing literature through the area chair, and other topics that will be covered in the minutes from that meeting.

In the AAWS Highlights for June 2024 it stated that the ERTC (Employee Retention Tax Credit) will not be applied for. The Auditor said based on consolidated GSB, AAWS, and AAGV financials, neither AAWS nor AAGV was eligible.

Box 4-5-9 stated that online registration and housing for the 2025 International Convention will be open September 10, 2024. Print registration and housing forms are being prepared for distribution during the summer. Check the IC2025 Webpage for updates.

The two latest videos from the Young People's Video Project are now available on aa.org. These are the two in English. They are also available in Spanish and French. Young and Sober in AA: It could save your life | Alcoholics Anonymous Young and Sober in AA: I thought drinking made me an artist | Alcoholics Anonymous

I attended the West Central Regional Alcoholics Anonymous Service Conference (WCRAASC) meeting in July. It is up to the host committee to decide if they will have Zoom at the West Central Regional Alcoholics Anonymous Service Conference. They asked for feedback regarding having Zoom and a call in option. No decision was made yet. Our West Central Regional Trustee, Charlie H., attended General Service Board (GSB) Weekend at the end of July. I am looking forward to his report from that board meeting. It was his first.

There was an announcement from the General Service Board. After letters of concern, appeals, process concerns, and letters of support; the discussion resulted in the General Service Board affirming its desire and responsibility to implement Advisory Action regarding the Plain Language Big Book. They will also make ten minor editorial changes. The Plain Language Big Book, A Tool for Reading Alcoholics Anonymous, will cost \$11.00 and expected to be available in November 2024.

Please remember our tradition of anonymity when publishing on our websites. I received an email stating that there was the full name of a trustee on a website in our area. Remember that on a website, anyone can view that website and it is an anonymity break.

West Central Regional Service Alcoholics Anonymous Service Conference

- There is a suggestion for raising the Prudent Reserve from \$9,000 to \$12,000. WCR administer believes that this should cover the liability exposure for each WRC Service Conference and we will not end up without cash in the bank if an event requests money before the event. Currently there is \$12,819.05 in the bank. Expenses for 2022 were \$11,526.47 and 2023 were \$13,983.88. There is talk of having a tech fee. Tech people in 2024 cost \$800.00 to do Zoom at WCRAASC.
- \cdot Based on feedback from the delegates, providing a virtual option for the WCRAASC is a positive and well used service by the AA members of the WCR.
- -Is it time now to consider having a WCR Virtual IT Tech for consistently and continuity of the virtual option?
- -This person would be responsible for setting up the virtual controls referring to the Virtual IT document Nebraska started in 2023 and North Dakota updated in 2024.
- -Like the reimbursement structure for the WCR Admin, suggestion would be

to fund the Virtual IT Tech to the WCRAASC including travel, room and meals. Costs for budgeting would be comparable to the WCR Admin.

- -The Virtual IT Tech would be on site during the conference. There could be other AA volunteers from the host area on site or at home to assist
- -Possible cost for couple of cameras and microphones. The in no equipment or hardware required.
- -Is it now time to consider having the WCR purchase its own FM frequency translation headsets? Area 24 Iowa has graciously offered their translation headsets for the last two years.

I have not yet written to the most recent request from MCF-St Cloud, so if you have someone already in mind, feel free to pass that information on. If not, I am more than happy to contact that in-

Cathy (D6 Corrections Volunteer): Isanti County jail, meetings are going very well.

Mark R. (A35 Corrections Chair): I take a meeting into Mille Lacs County jail on the 2nd Tuesday of the month. Meetings are strong with attendance each Tuesday around 12-14 men. Every Thursday, I facilitate an AA meeting inside MCF-St Cloud. Very powerful meeting with usually 21-25 men in attendance. We read from the Big Book and are now in "We Agnostics". God's presence is definitely with us, these men are opening up and no one is shying away from talking about what God is doing in their lives, and how the program of AA is keeping them alive and giving them hope while they are incarcerated! I also share a story from one of our men at Mille Lacs County jail. He was released from Mille Lacs County jail and was on his way to Teen Challenge. He has been attending AA meetings in the jail for a year now and had also joined a church group in Milaca. While on his way, he stopped to visit his girlfriend in Mora who was at a Recover Center there. When done, he found his ride had left. Another woman in the Recovery Center had her boyfriend there and he said he would give this man a ride downtown Minneapolis to Teen Challenge (he said he was sober). On the way this guy told our Mille Lacs man, he was gaming his girlfriend and proceeded to stop at a liquor store, then a bar. Our man from Mille Lacs jail did not partake or go into the bar! He actually had to drive the car and drove to one of his "old friends" to get away from this dude. Our man from Mille Lacs County jail thought he was fine, but when he got in with his "old friend" he could smell the odor of Meth. This is when his relapse ended, and his SLPI happened! This 1 ½ hour episode landed him bak in Mille Lacs County jail – so sad. I have asked the Program Coordinator at Mille Lacs County jail to contact one of us willing volunteers, whenever someone attending our AA meetings is being released to a treatment center and needs a ride to call one of us and we can make sure they get from point A to B. We need to help more in Bridging the Gap in our County Jails

We have used our current process since 1977- page 20 of the Area Actions Book dated 3/27/1977 "The Area Assembly decided to adopt a nominating and electing procedure for future Delegates whereby etc.... each District will submit a resume to the Assembly of the person it feels is qualified to become Delegate etc..."
- I would like to discuss changing these procedures to coincide with Original and Current Conference Charter from our Service Manual page 120-7. Area Assemblies, Methods of electing Area Committee Members and Delegates. Whenever practicable, committee members are elected by written ballot without personal nomination. Delegate in Area 36 about their voting procedures as examples- Area Chair reads the qualifications from the Service Manual, Duties/Responsibilities from the Area Manual then proceeds to ask the Area Officers, Area Committee Chairs, DCM's if they are willing to stand for the position- after that they may also have nominations from the floor

- The Service Manual gives Qualifications for Delegate we can use along with our Area 35 Duties and Responsibilities. We could use these as our guides in choosing Delegates being selected from the Area Officers, Committee Chairs and DCM's.

Discussion:

-Question of why in 1977 did they do that? - There is no reason listed in the Actions book - recording or past minutes could provide that information. -People that would be able to serve would then be Area Officers, Area Committee Chairs and DCM's currently serving? Is that correct? - Yes

- Archivist found recording of 1977 meeting however that is not official minutes of the meeting and would be unsure of who would be able to listen to the recording. No Northern Light in 1977 to find official minutes therefore the Actions book would be our only source of information.

-There are 93 Areas each one is autonomous, we can choose delegates as we see fit- Service Manual is suggestive only- other Areas see what we do and might like to try what we do having resume's ahead of time to see who they are voting for- taking people from the floor who may not know what is involved in the position and end up resigning-

- we could still have resume's ahead of time in the Northern Light by asking who would stand for Delegate at the Spring Assembly- there are other options-

-a member who proctored Area 36 Elections stated his experience was it is a long process and members don't appear willing to stand-there is merit in people being willing to be nominated-their experience showed some members stand because no one else will-

- a DCM asked if we have had people outside the Area Committee Members become delegate?- we have-

- this could be done on a trial basis, a rotation or 2 - since doing it this way since 1977- try something new-

why do you think it's broke and want to fix it? - not in favor of nominations
 it feels like a personal "stamp of approval" based on personal relationships-Believe we should follow the Conference Charter having members who have read the qualifications and responsibilities from the Service Manual, Actions book who are qualified and willing to stand, no personal endorsements

Discussion ended

- Inventory Ad hoc Committee Recommendation-

Jeff GSR had a recommendation from the Ad Hoc Committee- We met on Sunday, July 14.

In attendance were Jake J, Mike U, Jeff O, Fred T, Heidi B, Nels P. We continued our discussion from Spring Assembly on GSR orientation. We received positive feedback from GSR's regarding the GSR Orientation at Spring Assembly as well as a clear interest/need for an orientation at the beginning of the rotation. We discussed adding the GSR Orientation to the January Service Workshop, instead of Spring Assembly, so that GSR's have the information they need to vote and participate at the assemblies. Our recommendation to the Area is to add a GSR Orientation/Training to the January Service Workshop. This could follow the opening/announcements and the Meet Your Area Officers & Action Committee Chairs, first thing in the morning. It could replace at least two district (possibly three) presentations, depending on the amount of time needed. Details to follow if approved.

Steve L. stated last Fall Assembly before elections- discussion was to make ad hoc committee and we've done that-

the committee made changes, will forward PDF to Chair and they can send to all DCM's, GSR's to be voted on at the Fall Assembly-

business filings show it has to be renewed every 2 years-Treasurers have been doing this- Treasurer has password protected access to the Secretary of State website for this reason and will do some research-

Listed as a "registered agent" in the articles of association is a past member of the Area along with their address, this should be updated-could possibly use the Area Chair as acting registered agent and use the address of the Archives building as a more permanent address?

We could pay outside agent to be Acting Agent- technically they need to be available 24/7

Will the Committee put forward a recommendation? Discussion ended-

- WCRAASC proposals-

Delegate Diane brought forward that our WCR Administrator would like to increase the Prudent Reserve to \$12,000 instead of our current amount of \$9,000- They feel they need more to be able to pay all the bills when needed - currently there is \$12,819 in the checking account, they would simply take \$12,000 of that and put in Prudent Reserve. Expenses in 2022 were \$11,526 and in 2023 expenses were \$13,983.

Previously an Event Center submitted a bill early and we were down to \$700 with no backup

Discussion-

If the reserve goes under \$12,000 do they want Area's to Contribute to make up the difference? Not at this time-

They did discuss being able to send contributions to the WCR - this has been a self supporting Conference and if not self supporting we need to take a look at that-

How many in favor of raising the limit? Majority was in favor- yes

-Based on feedback from Delegates virtual option for the WCR has been positive and a well used service by AA members in the West Central Region, however this does not apply to this year-

Is it time to have a WCR Virtual IT Tec person for consistency and continuality in having the Virtual Option?

The person would be responsible for setting up all virtual controls - costs for position would include travel, rooms and meals with a budget comparable to the WCR Administrator- virtual IT Tec would be on site during the conference- - . Is our Area interested in this?

Discussion-

Treasurer noted that our next WCRAASC is in Casper Wyoming and our funds are limited so most of us probably won't be able to attend and not having a virtual option is a bad idea.

- Diane clarified for this upcoming 2025 WCR in Casper Wyoming it is still up to the host Area to decide if they will have a virtual option, they have that right of decision- at this time there is not a virtual option for the upcoming WCR in Casper Wyoming

DCM asked why can't hosting Area provide the tec instead of creating a new position? Each Area could have an IT person that could take care of it?
a DCM believes we, Area 35, won't have the money to cover the expenses of providing a good virtual option for our upcoming responsibility of hosting the WCR and believes we need this IT tec position to continue with the virtual option

- We have the WCRAASC coming here in 2027 and we don't have money or equipment to do this-

all for WCR creating the position

- Clarification question- would WCR Committee buy equipment and staffing? Microphones and Camera's would need to be purchased as well as the IT person- Budget the IT person and equipment separately-

Diane - Who is In favor of having a personal IT person for the WCR - Vote passed with most voting yes-

Minority opinion- Who is paying for this?

The WCR service conference is funded by the Conference, self supported. There may be a fee for those that register for virtual- It is suppose to be self supporting-

Question- Will there be a Two-Tier registration system then for in person and virtual? - Correct it is a possibility-

Member stated -there is no cost mentioned- having a hard time deciding when we have no costs given to us.

Member stated - we have a lot of GSR's that don't approve of having virtual meetings and doesn't know if we should have this vote without the GSR's voice

A DCM stated I carry my GSR's vote here at the ACM-

Tradition Four

Each group should be autonomous except in matters affecting other groups or AA as a whole.

- 1. Do I insist that there are only a few right ways of doing things in AA?
- 2. Does my group always consider the welfare of the rest of AA? Of nearby groups? Of Loners in Alaska? Of Internationalists miles from port? Of a group in Rome or El Salvador?
- 3. Do I put down other members' behavior when it is different from mine, or do I learn from it?
- 4. Do I always bear in mind that, to those outsiders who know I am in AA, I may to some extent represent our entire beloved Fellowship?
- 5. Am I willing to help a newcomer go to any lengths-his lengths, not mine-to stay sober?
- 6. Do I share my knowledge of AA tools with other members who may not have heard of them?

Tradition Five

Each group has but one primary purpose-to carry its message to the alcoholic who still suffers.

- 1. Do I ever cop out by saying, "I'm not a group, so this or that Tradition doesn't apply to me"?
- 2. Am I willing to explain firmly to a newcomer the limitations of AA help, even if he gets mad at me for not giving him a loan?
- 3. Have I today imposed on any AA member for a special favor or consideration simply because I am a fellow alcoholic?
- 4. Am I willing to twelfth-step the next newcomer without regard to who or what is in it for me?
- 5. Do I help my group in every way I can to fulfill our primary purpose?
- 6. Do I remember that AA old-timers, too, can be alcoholics who still suffer? Do I try both to help them and to learn from them?

I have been told A.A. first started in Northern Minnesots in 1941, with the help of Pat Comp, the founder of A.A. in Minnesots. I understand it was rather slow in growing the first few years, but at present we have approximately thirty groups with a membership of about five hundred. They are not, however, all active in our Northern Assembly, and by checking, we find those groups who aren't, don't grow. Our present group in Bemidji was started five years ago with four of us and our average attendance now is from fifteen to twenty.

There are some Institutional Committees active in this area now. It seems we are rather backward up here and only very recently divided the Forthern Assembly into Areas. By electing good, active Area Committeemen, I'm sure we will have more success here in helping new groups get started, and having various committees for hospitals, prisons, etc. I have high hopes for our Northern Assembly in the future, but it does take time when you try to start something new.

I know of very few new groups in our area, although just recently several from our group went to an Indian Reservation to help them get started. They show a great deal of interest end have the law, clergy and all public officials backing them. I sincerely hope they will continue because A.A. is surely needed there as well as in all communities. We feel if they have a group of their own, they will be more successful, and we have promised to help them get started in any on their own.

The surrounding groups helped us a great deal when we first started by driving fifty to one hundred and fifty miles to put on meetings, and any time we can do the same, we will.

We hold open meetings once a month, as do most groups in this area, and we all encourage all interested non-A.A.'s, including the clergy and all public officials, to attend. At these meetings, we try to have an outside speaker. It never fails to amaze me how ignorant some of our public officials are about A.A. I recently was called to another city in our area to get one of our men out of jail. The judge there knew nothing about A.A. and how we work. Bouse of his questions surprised me, such as - "Are you connected with A.A. in a professional capacity? Surely you don't do things like this without getting paid! Why?" There is an active group in that city and he has been invited to attend neetings but hasn't so far. Perhaps now he will, to learn more, and by so doing, may help others.

There are not many women in A.A. in this area that I know of. I would may about a dozen. In my own group, although there are three women now, most of the time I am the only one present at meetings, and in many groups there are no women at all.

It is always wonderful to connect with our A.A. fellowship because they love A.A. as much as I do. Thank you to Pat for attending many of the report backs with me. I greatly appreciate his support. In August I also attended Friday night Keep It Simple and heard our friend Julie share her story. Good times and Fellowship.

The International Convention of Alcoholics Anonymous Registration and Housing Processes will open on September 10, 2024. There is online registration and housing process and a print form registration process. For more information check online at $\underline{www.aa.org}$.

The link to the 2024 General Service Conference Final Report is available online at www.aa.org. This is the 74th General Service Conference that was held April 14-20, 2024, in New York City. The 2024 General Service Conference Final Report, printed version, should be available at the Area 35 Fall Assembly.

At the Area 35 Fall Assembly we can submit our ideas for the 2026 General Service Conference. This would include ideas for the theme, topics, and workshop presentations. A list of previous themes, topics and workshop presentations was sent to all DCMs.

AAWS announced that the **Plain Language Big Book, A Tool for Reading Alcoholics Anonymous** will be out November 1, 2024, with a price of \$11.00. Other new items available in September are a pamphlet, Black in A.A. – Experience Strength and Hope; Literature Workbook; and **Reflexionas Diarias.**

The West Central Regional Alcoholics Anonymous Service Conference for 2025 in Casper Wyoming will have a hybrid option. There may be an added fee for the hybrid option. They are still working out the details. A.A. Second Quarter reported the following information for the first six months of 2024. Contributions were \$5,600,000 which is 15% greater than last year. Net Literature Sales were \$3,700,000 which is 11% less than last year. Operating Surplus before Depreciation is \$529,000. We now have 6.33 months of Reserve Coverage.

Grapevine net loss for the first six months of 2024 was \$487,000 versus a budgeted loss of \$357,000. This is a \$130,000 more than budgeted. This was due to delayed print subscription price increase and greater than budgeted expenses for professional fee and cost related to App development. Reforecasted loss for Grapevine in 2024 is \$672,449 which is \$89 thousand more than was expected.

The reforecasted full-year revenue and expense for LaVina approximated the original budget. So far in 2024, LaVina loss is \$297,000. Development of the Fifth Edition of the Book Alcoholics Anonymous continues. Story submissions have been narrowed from 2,500 to 159. Selected stories are being reviewed to narrow them to about fifty for the committee to review.

The literature subcommittee reported that work on expanding the existing ideas in Appendices III and V continues. Current and past Class A trustees are being contacted for professional references and content development.



Service: Coffee Cups To the Conference

Of the Three Legacies bequeathed by A.A.'s founders, the Third Legacy, Service, is perhaps the most misunderstood, Many A.A.'s recoil at the words "service structure," pointing out that everyone knows A.A. is not organized. Others brush the idea off as unrelated to individual recovery.

What is service, anyway? There's no short, sweet answer. A non-A.A. who attended the opening dinner of the 1982 General Service Conference remarked that every cup of coffee among A.A.'s leads ultimately to the Conference. He might have been echoing the words of cofounder Bill W., who, in a talk at St. Louis in 1955, described services as ranging all the way from making coffee to national and international action.

Jim O., Southern California area delegate, has strong feelings on the matter. He wrote: "When the subject of A.A. service comes up, you sometimes hear a member say, 'I don't care about that stuff. It's just business and politics. All I need is my own recovery in my own group.'

"What this member doesn't realize is that he has been dependent on A.A. service, not just from the time he called A.A., but for many years before that. How did he know there was an A.A. to call? Or how did his wife or doctor or pastor know about A.A. to tell him? Because a public information committee, a basic part of the service effort, has worked for years to tell people what A.A. is and how to reach it.

"How did A.A.'s number get in the telephone directory? Why was a concerned A.A. at the other end of the phone when he called for help? A.A. service put them there. If he is in a prison or institution, he can't go out to find sobriety through our program, so A.A. service takes the program to him.

"He received A.A. literature at his first meeting. How did that literature get written and printed and distributed so it would be there for him when he needed it? A.A. service, through our literature committees, made sure that it would be.

"The member who dismisses service as having no rela-



tion to his own recovery has missed the point. He is sober today because service made it possible. Service is our Twelfth Step, extended to reach thousands of suffering alcoholics we would never reach acting as individuals."

The local group is where service begins. There, it takes the form of coffee-making, ashtray-emptying, serving as a group officer. For most groups, service moves outward through the G.S.R. (general service representative), its link with the overall service structure. When a group elects a G.S.R., it gains a voice in worldwide A.A.

In a flyer sent out before the 1982 Conference, Jeanic H. invited participation in an interdistrict meeting to discuss topics on the Conference agenda. She pointed out that A.A. groups actually own A.A.'s service entities, and asked, "Is your group an absentee landlord? Silent partners have no voice and no vote. To be an active, fully franchised 'owner,' your group needs only to elect an interested, active G.S.R. who conveys your wishes. When your delegate goes to New York for the Conference, will he or she know what your group thinks? Or you?"

A D.C.M. (district committee member) from Western Ontario, R. M. D., related service to personal recovery after completing his term: "Selfishness and self-centeredness — this very basic problem can prevent us from placing A.A. principles over our own personalities. If service has not enhanced your sobriety, then just maybe your true motive is still somewhat selfish. Our primary purpose is to stay sober and help others to achieve sobriety. 



NORTHERN LIGHT PRIMARY PURPOSE:

The Northern Light (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the Groups, Districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- ◆ Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the N.L.
- ◆ Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe to the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

NORTHERN LIGHT SUBMISSIONS:

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. All submissions will be approved by the Northern Light committee, in accordance with Tradition Two; For our group purpose there is but one ultimate authority – a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- Area Chair asks for weather reports from all DCMs from respective Districts, either by email or phone.

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
